



and getting a job. I was walking off from school more times than I like to remember. A teacher by the name of Mary Jack Waddell must have sensed that I wasn't very happy. She had a long talk with me and I changed my mind. I spent fifty-three years in school.

Did you know that Stella Madden also taught John Dillon in school? Mr. Dillon was her principal at Central.

Most elementary teacher back then did not have a degree. They probably did as good a job teaching as those teachers with degrees.

Miss Marjorie Waddell ended her teaching career at Deer Lodge teaching in the same room where I started my teaching career.

Mr. Knisley and Miss Waddell had identical 1948 two tone Chevrolet cars. Mr. Knisley ended up in Miss Waddell car several times. When it wouldn't start, he slipped over to the right car, hoping no one saw him.

Allen Nance, Shirley Melborn, Lucy Sweat and Tom Redmon all from the Central Class of 1954 once taught at Wartburg Central.

Coach Homer Rice is still living in Atlanta, Georgia. He is ninety-three and just recently retired from teaching a leadership class at Georgia Tech. What a career he had.

Mr. E. Utley went on to get his PHD at the University of Tennessee and ended up teaching the U.T. Chattanooga Campus.

The Morgan County High School at Wartburg became Wartburg Central in 1917 when Sunbright got a high school.

The Wartburg School burned on January 19, 1940. The new school was not completed until mid-year of the 1945-1946 school year. For five years students had to go to school anywhere they could put them.

I liked and respected Mrs. Madden. I still remember many things she taught us and the one that is still clear in my mind is what she told us about doing a good job. "When a job is once begun never leave it till its done, be the labor great or small do it well or not at all." I would have counted my eighth year of school a success even if Mrs. Madden hadn't taught me anything else, but she taught me a lot more.

We were allowed to carry knives to school back in those days and Mrs. Madden told all the boys, "don't carry around an old dull knife. If I ask you to use your knife it had better be sharp."

Mrs. Madden had a way of motivating us to work hard and do our best in academics. When she caught many of us loafing, she would say, "it looks like only three or four of you would be going on to high school next year." I looked and saw many intelligent girls and I knew right away I wasn't one of the four so I buckled down and worked harder. Only one boy was held back and he didn't want to go on. He was around sixteen years of age and the teacher just let him sit in the back of the room and read western books.

I loved history and geography and Mrs. Madden must have loved it too because I learned a lot under her. For some reason at county fair time my classmates thought that since I loved geography so much that I should draw and color a Tennessee map and enter it in the fair. I must admit and confess to you that I didn't think the map I drew was very good, and Mrs. Stella thought the same. But it won a blue ribbon so I guess the judges were

this, I'll tell you that the seventh grade is a hard one to teach. I respected Miss Ruth as much as I did any of my teachers, but I still ended up talking back to her. The only time I ever did this. I suppose I deserved a good paddling, but Miss Ruth stopped with a

strong reprimand.

Miss Ruth had good discipline and I learned a lot from her because later on I would be a seventh-grade teacher in Wartburg, and a middle school principle in Florida. One of my teachers said, "Mr. Redmon they should put all the seventh-grade students on an island and educate them." The seventh graders were always picking on the sixth graders and complaining about the eighth graders. Many of my discipline problems were ninth graders.

One day a Gobey boy, (sorry I can't remember his name) didn't want to be disciplined by Miss Ruth, so as she was getting her paddle out, he was jumping out the window and headed for town. Every student stood up and yelled, "Run ??? Run!" That's seventh grade for you.

I guess the boys father brought him into Mr. Dillon's office the next day and took care of business. Remember the parents back then (for the most part) supported the teachers.

Miss Thelma our fourth grade teacher scared the devil out of most of us. I learned under Thelma Fretag because I was afraid not to. She had reading groups that went something like this; the red birds were the top reading group, the bluebirds wee the second best, the yellow birds third, and the blackbirds the fourth and worst group. I never thought of it before but today that would be called raciest.

I started out as a yellow-

elementary school and Miss Thelma was still teaching fourth grade. One day when we met on the playground, I said to her, "Miss Thelma you remind me of a little Bantam rooster strutting around here". She looked at me unbelieving that a former student would say that. Then she kinda smiled and said, "wait here I'm going to go get my ruler."

Mrs. Eva Adcock our third-grade teacher was a very gentle person and we were thankful that she lived by the school with a well full of cold drinking water. Many times, before the new school was finished, we had to draw water from the well. We all drank from the same dipper. It seems that we were fearless back then, even with germs. I started loving geography that year and I guess I carried that love to high school because in study hall when I was bored, I looked out the window and dreamed about being in Florida or Hawaii.

Rose Brock was my fifth-grade teacher and about every week she assigned us something to memorize. I had a problem with that and when my time came to get up before the class and recite, I wanted to miss school.

My sister Rosella had Mrs. Brock for a teacher and one day she took them on a field trip in the hills above Wartburg. She was strict in enforcing rules and set a location where they were to return to at a certain time. Some of them went on up in the hills and they were having fun, lingering there too long. They were in trouble when they got back where Mrs. Brock was. Rose was in the bunch. Mrs. Brock told them to pull their coats off and line up for a whipping. Rose got in what she thought was the last one in line. Her reasoning was that Mrs. Brock would be too tired to swing that switch. But Mrs. Brock walked down the line and started with Rosella.

History

Historically Speaking John Hendrix – Oak Ridge "Prophet" Part 2

While I will not print the whole story of the John Hendrix family here, some interesting and basic facts are included. I hope they help provide you a context for the life of John Hendrix.

John Hendrix's great-grandfather was Garrett Hendrix. He came from Wilkes County, North Carolina to Beaver Creek in Knox County before 1794. David and Samuel Hall, who had been Revolutionary War soldiers also came from Wilkes County.

The Hall and the Hendrix families lived in the same neighborhoods and intermarried. Samuel Hall's wife was Letitia Hendrix. David Hall is buried in a cemetery near the Bull Run Steam Plant

close to where John Hendrix lived at one time.

John Hendrix's grandfather was Morgan Hendrix, one of the first settlers in Morgan County. He moved back to Knox County by 1830 and died there in 1843. Morgan had seven children by his first wife, one being Luke S. Hendrix. Morgan married a second time to Sally Bowman. They had 10 children. Dr. E. L. Hendrix of Oak Ridge is a great-grandson of Tarleton Hendrix, a half-uncle of John Hendrix.

John Hendrix's father was Luke S. Hendrix.

John Hendrix was born November 9, 1865 in Anderson County. He was the eighth son of Luke S. and Jane (Wallace) Hendrix. His family lived in Morgan

County at the times of the 1850 and 1860 census. Just prior to John's birth, his father sold the farm in Morgan County and

moved to the Robertsville area (John Hendrix may have been born while his parents lived on a rented farm in Bear Creek Valley - the present location of Y-12!).

In 1888, John married his first wife, Julia Ann Griffith of Morgan County. She was the daughter of Joel and Cloe J. (Hall) Griffith, and granddaughter of John and Sara Griffith. They had four children: Jessee, Elzora Elizabeth, Lela and Ethel Perrgold Hendrix. Donald L. Gray of Oak Ridge was the son of Elzora, who married Roy Lee Gray.

John and his family lived on the west side of the hill above the present-day site of the Bull Run Steam Plant. Their youngest daughter Ethel who was only two years old died of diphtheria. John's wife, Julia Ann, blamed John for her death. It seems John had spanked Ethel sometime earlier and, in her mind, Julia Ann somehow blamed John. Ethel was buried in the Black Cemetery that was moved from the Bull Run Steam Plant site. Her grave is in the relocated cemetery, marked by TVA with an "unknown" marker.

Around 1900, Julia Ann took her three children and went with her brother to Arkansas. She later wrote John a letter telling him that she and the children were not returning. She later married a Mr. Bradley near Camden, Arkansas.

John took the death of his young daughter and his family leaving him very hard. It was about this time in his life that he began to think more seriously about religion and to see visions. He prayed to God to tell him the future and he heard a voice say if he would lay with his face on the ground for 40 nights and pray, it would be revealed to him.

John stayed in the woods for 40 days and nights, praying and sleeping on the ground. A neighbor lady found him lying with his hair frozen to the ground and brought a quilt to cover him. She stated that hearing him pray would make your hair stand on end. The cold ground may well have contributed to his tuberculosis.

When John began to describe his visions, people thought him insane and he was imprisoned for a time at the

county farm. John "dug out" and es-

caped but was spotted by authorities. John shouted to them from outside the fence that the farm was an evil place and that within a month God would strike the building and burn it down. When lighting did strike and burn the building, some people began to fear him as a witch.

However, many of the things he said were not taken seriously by those who heard him talk about his special gift of visioning...at least not while he lived. Later they would remember and wonder at the accuracy of what he foretold.

By the way, the "county farm" known also as the "poor house" where John Hendrix was placed was located

on the east side of the Clinch River just across from the Oak Ridge Marina and a bit north toward the railroad bridge. It was not rebuilt when it burned from a lightning strike. Its location is still noted on topographical maps.

For many years, the figure of John Hendrix sitting in a rocking chair was the featured attraction at entrance to the Oak Ridge story at the American Museum of Atomic Energy - now our American Museum of Science and Energy. This display was removed when a Washington DC bureaucrat felt the folklore had no place in a "prestigious museum of science" and the museum staff was coerced into removing the display.

Judd Brown tells of remembering when the display was an often-visited attraction and when visitors would ask questions after seeing the unique representation of the "Prophet of Oak Ridge"

at the entrance to the Oak Ridge Story display.

Another interesting fact about John Hendrix is that for a number of years, Harry Carper – a singer, a very religious man, an amicable soul, a talented calligraphist, a gifted speaker and a dedicated supporter of the legend of John Hendrix – portrayed Hendrix at various functions. There is even a film that was made of his John Hendrix presentation.

So, now you have read the known facts regarding John Hendrix and his intriguing legend as Prophet of Oak Ridge. You have also read about some real people who are descended from the source of this story that is often used to introduce the history of Oak Ridge and especially

It is for you to decide if you choose to believe in such visions into the

future and the telling of things to come. Regardless of your chosen path, surely you must admit that it is an intriguing story with a whole lot of appeal to our heritage tourism visitors. I chose to tell the story and leave the conclusions to the listener.

Oak Ridge was created as a part of the Manhattan Project in 1942 to help stop World War II. The atomic bomb, Little Boy, fueled by uranium 235 separated at Oak Ridge helped to do just that.

Oak Ridge began in war, has continued to support our nation's efforts through the Cold War, and even now in the age of terrorism. Oak Ridge has also produced nuclear medicine, nuclear power and fuel for the US Navy nuclear submarines and

ic-mail Systems and additional secure


communication systems in support of the Secretary and the State Departments Intelligence and Research Unit. James retired from the Air Force in November 2004 with twenty years

Reasons Your Stimulus May Be Different Than Expected

Some people may receive a stimulus amount different than they expected. Payment amounts vary based on income, filing status and the number of dependents who qualify for additional stimulus.

Only children eligible for the Child Tax Credit qualify for the additional payment of up to \$500 per child. The child must also be under the age of 17 at the end of the year for the tax return on which the IRS bases the payment determination.

A qualifying child must have a valid Social Security number (SSN) or an Adoption Taxpayer Identification Number (ATIN). Parents who are not married to each other and do not file a joint return cannot both claim their qualifying child as a dependent. The parent who claimed their child on their 2019 return may have received an additional \$500 for their qualifying child. When the parent who did not receive an additional payment files their 2020 tax return next year, they may be able to claim up to an additional \$500 per-child amount on that return if they qualify to claim the child as

their qualifying child for 2020.

If the IRS has not yet processed your 2019 return it will use the 2018 return information to calculate your stimulus. Remember, the IRS accepting a tax return electronically is different than completing processing; any issues with the 2019 return mean the IRS would've used the 2018 filing. The 2018 return may have higher or lower income and would not include the birth or adoption of a child in 2019. In many cases, however, these taxpayers may be able to claim an additional amount on the 2020 tax return when they file next year. This could include up to an additional \$500 for each qualifying child not reflected in their stimulus. The stimulus is offset only by past-due child support. The Bureau of the Fiscal Service will send the taxpayer a notice if an offset occurs. For taxpayers who are married filing jointly and filed an injured spouse claim with their tax return, half of the total payment will be sent to each spouse. Only the payment of the spouse who owes past-due child support should be offset.

If you filed an injured spouse claim with your return and are impacted by this issue, you do not need to take any action. The injured spouse will receive their unpaid half of the total payment when the issue is resolved.

The stimulus is not protected from garnishment by creditors by federal law once the proceeds are deposited into a taxpayer's bank

In many instances, eligible taxpayers who received a smaller-than-expected stimulus may qualify to receive an additional amount early next year when they file their 2020 federal income tax return.

The stimulus is technically an advance payment of a new temporary tax credit that eligible taxpayers can claim on their 2020 return. Everyone should keep the letter they receive by mail within a few weeks after their payment is issued.
