

2019 Tourism to Obed WSR Created over \$4 Million in Economic Benefits: Report Shows Visitor Spending Supports 47 Jobs in Local Economy

[Oneida, Tennessee] – A new National Park Service (NPS) report shows that over 221,000 visitors to Obed Wild & Scenic River in 2019 spent \$4,100,000 in communities near the park. That spending supported 47 jobs in the local area and had a cumulative benefit to the local economy of \$4,000,000.

"Obed Wild & Scenic River welcomes visitors from across the country and around the world," said Superintendent Niki Nicholas. "We are delighted to share the story of this place and the experiences it provides. Visiting one of the 13 units of the National Park System in Tennessee is a great way to introduce visitors to this part of the country and all that it offers. National Park Service tourism is a significant driver in the national economy, returning \$10 for every \$1 invested in the National Park Service, and it's a big factor in our local economy as well. We appreciate the partnership and support of our neighbors and are glad to be able to give back by helping to sustain local communities."

The peer-reviewed visitor spending analysis was conducted by economists Catherine Cullinane Thomas of the US Geological Survey and Lynne Koontz of the National Park Service. The report shows \$21 billion of direct spending by more than 328

million park visitors in communities within 60 miles of a national park. This spending supported 341,000 jobs nationally. More than 278,000 jobs exist in communities adjacent to parks. The cumulative benefit to the US economy was \$41.7 billion.

According to the 2019 report, most park visitor spending was for gas (29.15 percent), restaurants (26.48 percent), followed by groceries (17.99 percent).

Report authors this year produced an interactive tool. Users can explore current year visitor spending, jobs, labor income, value added, and output effects by sector for national, state, and local economies. Users can also view year-by-year trend data. The interactive tool and report are available at the NPS Social Science Program webpage: https://www.nps.gov/subjects/socialscience/vse.htm.

care of Tiffany became so daunting that the couple divorced. But Roy's care did not diminish. The question came up, "what was best for Tiffany"? Should she be put in a group home where she could get the medical care she needed or was individual attention more important. Roy believed the latter; he just couldn't give her up. He was granted full cus-

tody in November 1988. For fifteen years of Tiffany's life she went wherever Roy went. He finally found another woman who had enough love in her heart for a broken little girl. They were married in 1999.

The full story of how Roy loved and cared for Tiffany is hard to believe. The members of the motorcycle club also fell in love with her and soon Roy declared them "uncles".

When Tiffany's condi-

Jesus said in John 15:13 Greater love hath no man than this, that a man lay down his life for his friends. Christ laid


> down his life for all us sinners. God is love, even while suffering on the cross Jesus said, "Father forgive them for they know not what they do". He loved us that much.

2020 NOVEMBER ELECTION NOTICE

On November 3, 2020, in all precincts of Morgan County, TN there will be a Federal and State General Election, plus Municipal Elections for the City of Sunbright and Town of Oliver Springs in their precincts.

November General Elections: US President and Vice President, US Senator, US Representative-3rd Congressional District, TN State Senator- 12th District, TN State Representative-41st District. Municipal Offices; City of Sunbright in Sunbright Precinct 5-1: Mayor, Alderman-1 seat At-Large. Town of Oliver Springs in Coalfield Precinct 1-1: Alderman- Ward 3-1 seat, Alderman- Ward 5-1 seat Alderman- Ward 6-1 seat.

For Independent Presidential Candidates Candidate petitions are available to be issued starting May 22, 2020 and will continue through the qualifying deadline at 12:00 NOON, Thursday, August 20, 2020.

For all November Municipal Elections Candidate Petitions will be available beginning Monday June 22, 2020 and will continue through the qualifying deadline at 12:00 NOON, Thursday, August 20, 2020.

Military and Overseas Voters (UOCAVA) are required to file a new request for ballot by mail or email in each calendar year of the election. This may be done with a Federal Post Card Application (Form 76) and can be submitted anytime after January 1st of the election year. This annual one-time application is then good for all elections in that calendar year. Local family members are encouraged to remind those persons living or serving out of state or country to submit their new requests to the Election Commission office.

Elderly voters and voters with disabilities assigned to vote in precincts where the polling place is inaccessible may vote early at the Election Commission Office during the early voting dates or by an absentee ballot by mail, or may vote at the Election Commission Office on Election Day. Any elderly voter or voter with a disability desiring to vote for their first time at the Election Commission Office on Election Day must notify the Election Commission Office in writing by October 24, 2020 for the November 3, 2020 Elections. The last day to register to vote in the November 3, 2020 elections will be October 5, 2020.

List Maintenance: The Morgan County Election Commission is required by law every 2 years to perform "List Maintenance" on voter roles and to purge registrations classified "Inactive" for various reasons meeting certain criteria. This List Maintenance was last performed in 2019. If you have received a notice or believe that your registration may be "Inactive" and subject to purge, or simply want to check the status of your registration, please contact the Morgan County Election Office immediately as you may need to register prior to the deadline for registering in the next election.

John Hendrix Prophecy Article

– Earliest documented account

known to exist, part 2

NOTE: The following is the conclusion of a two-part story which reprints an article about John Hendrix, originally published in 1944 in The Oak Ridge Journal.

His troubles with the authorities over, John Hendrix returned to his ascetic life. Each day he would go into the woods, to meditate and pray. And one day, Braden said, he came out with a wondrous tale.

"John came out from the woods, accordin' to his wife, lookin' like he'd seen a ghost," Braden went on. "They asked him what was the matter and he said he'd been spoke to. He said a voice as loud as any clap of thunder had spoken to him.

"John, sleep with your head on the ground for forty nights and I will show you the future developments of your country in visions," the voice said.

"Old John decided he'd do what the voice told him. He went out there to a clump of trees near Scarboro School and he slept with his head on the ground for forty nights. About the twenty-fifth or twenty-sixth day, I forget which, it came a wet spell and he got pheumonie, but he toughed it out,"

"Taughed it out did he?" I salved

"Toughed it out, did he?" I asked.

"Toughed it out," said Branden nodded solemnly.

"Did a vision come then?"

"No," said branden, "not just then. It wasn't until a coupla months later he was shuckin' hay over above Edgemoor and he got overhet. Well, he fell over and while he was in bed he got the first vision. He foresaw the surveyin' of the L & N railroad. He said the Southern would survey

it first but the L & N would beat 'em to puttin' through the spur. That must've been around 1901. Well, about 18 months after he died they sarted surveyin', and it wasn't more'n a month after that they begin construction work.

"Old John told
where each and every
station would be. He said it
would run from Joe Cox's
place, at Edgemoor, to Tom
Braden – my father's farm
– down to Katie Worthington's placy at Elzy. He said
a Clinch River bridge would
be built at the lower point of
Bradley's Bluff, where it was.
He said the Black Oak Ridge

tunnel would be made under the Butcher Spring and that it would sink the spring, which it did." Hendrix's second vision came about two months later, Braden explained. In between times, the prophet told of spending three weeks in Paradise. "He said an airyplane with wings two hundred foot long, painted all white, come and get him," Braden explained. It was a metal airplane, he said.

"The second vision come while he was shuckin' hay again," Braden's story went on. "This time he took sick in Ben Wilkins' meadow and while he was in bed from bein' overhet he foresaw the buildin' of 300 miles of branch line of railroad from that main line he prophesied at Katie Worthington's right down Lupton Valley to and through the New Hope Gap. He said a Union Depot would be built at Holloway's Tanyard – that's where Scarboro School is now. That's the only part of the prophecy that wasn't fulfilled.

"John said that Bear Creek Valley would contain factory buildins and that they would hep toward winning the greatest war that ever was or ever will be.

"Then John said that there would be a city on the Black Oak Ridge, and would finally be called Paradise."

"Paradise?" I queried.

"That's right, "said Braden, 'Paradise. Furthermore, John said that the center of government of the city would be in the fields halfway between Joe Pyatt's farm and Sevier Tadlock's. That's where the Administration Buildin' is right now.

"There wasn't much more I could say

to that. If the old man's prophecy was indeed as Braden described it, he had hit everything on the nose. He would have been a great man for the horse-playing ring. I asked Braden what he thought about the prophecy.

"Well," he said slowly, Sometimes I think he really had visions and sometimes I don't. I don't know what to think. All I know is that when they built the railroad a coupla years after old John died, the people all around said,

"Well, Old John just happened to hit it. But now, with this project here and all, it makes you think."

Braden and I went out later to see John's house. It's overgrown with weeds, vines and bushes, and hasn't been occupied for years.

A redbird flew across the porch and a couple of jays squawked in the bushes. There was an old rocking chair sitting in the front yard and

an atmosphere of decay and death all around. Braden stood and looked over the place, occupied with his thoughts. He didn't say much of anything.

The next day I got John Malone, a Roane-Anderson employee who knows the ex-

act spot where the grave is located, and he and Sgt. Abe Levitt (who had told me about the story in the first place) and the photographer and I went up to see it. The grave is located at the top of a hill in an overgrown field, surrounded by a flimsy wire fence. A huge boxwood grows at the foot. The grave is marked by a rude, scratched little stone. We stood looking down at the grave while Ed Westcott took pictures. It was a cloudy, quiet day, and somewhere off in the distance, thunder sounded in the sky. It gave me kind of a funny feeling.

This ends the reprint of the earliest documented account of the John Hendrix Prophecy that I have been able to locate up to now. If you know of earlier documented evidence of any part of the John Hendrix prophecies, please contact me at draysmith@comcast.net Ed Westcott gave me some insight into the author of the above article reprinted as first published. Joe Oakes (Journal Prophecy Expert) is the way the author signed the article. Ed sent me an e-mail stating that "Joe Oakes" was actually one of the many bylines used by Richard B. Gehman.

He spent four years in the US Engineer Corps. He was a close friend of Ed's. He was Associate Editor for the Oak Ridge Journal. Gehman also published under the pseudonyms Meghan Richards, Frederic Christian, Martin Scott, and F. C. Uffelman (a friend of his who worked at Y-12).

As you must know by now, the amazing John Hendrix story intrigues me and I delight in finding new evidence regarding his life and unusual circumstances. Many descendants of his have contacted me as a result of the material I have published on www.SmithDRay.net, even those who are descended from his first wife and children who went to Arkansas.

Many local individuals, such as John Rice Irwin can claim kin through some Hendrix relatives. Several families locally still cherish their ties to arguably Oak Ridge's most famous

> character even if he did die 27 years before the major elements of his prophecy were fulfilled.

Interestingly, Faye Childs, a granddaughter of John Hendrix and a daughter of John's son Curtis Hendrix and his wife, Thelma Lee (Linda) Haney Hendrix recently mentioned to me that there was one part of the John Hendrix prophecy that had not yet come true.





MIA'S View From the Mountain: **Ann Edenfield Sweets**

I am so grateful for the amazing people I have had the opportunity to meet in my life. We see people but do we really and truly see them? Everyone has a story, some more extraordinary than others. But, if you listen carefully, and look with the eyes of your heart, you will learn from others journeys. When I first met Ann it was at a Prison Fellowship Angel Tree Conference. Everyone there had an interest in working and ministering to families/children of those incarcerated. Then, I had the opportunity to hear Ann speak. I got to see/hear first hand what a remarkable woman Ann is. The strength and faith she had in the Lord was amazing. As you read her story, told by Ann herself you will see how she unwillingly lost it all and then willingly sacrificed it all again for Christ as He called her into her Ministry.

I grew up in Michigan, the oldest of 4 children. I had loving parents, grew up in the same church and neighborhood my whole life, and basically felt I had it all. I had been the first female Student Council President, Cheerleading Captain, Who's Who in American High Schools and Colleges, Phi Beta Kappa, University Homecoming Queen, Outstanding Delta Zeta in the United States, Miss Michigan contestant, flight attendant for 3 different airlines, world traveler, real estate broker/mogul, was married to an airline 747 captain and had a loving marriage, and I was mother to four precious boys.

And suddenly, August 5, 1986, my world came crashing down and changed forever. I now say that I "died" that day, for my husband was arrested and 11 months later plead to a 15-year prison sentence. I was now facing a nightmare that no one could or had prepared me for. It didn't matter who I had been or what awards I had won before- for now I was ONLY known as the "wife of a prisoner".

I became penniless immediately, for every bank called every loan we had. I ended up with a \$3.5 MILLION IRS lien that took 15 years to erase. I'm proud to tell you that I am no longer the \$3.5 million woman! We had 4 young boys ages 6 months – 7 years old and had been members of a church in Albuquerque for 12 years. NO one called us from the church!

I knew I needed a church home so we found a wonderful Senior Pastor that welcomed us to his church. He prayed WITH us and FOR us. I got so involved that soon he had the courage to hire me as Youth Director. For 5 years the boys and I thrived. The youth program grew from 8 to over 250 youth and children.

One morning my husband called to tell me he would be home in 5 months and would serve only 6 years. I went into the church staff meeting and excitedly shared that my husband would soon be home. We now had a new Sr. Pastor and he looked at me..... and in front of the whole staff said, "Then I can no longer be your pastor."

I thought he was kidding until one of our female pastors left the room in tears and only then did I realize he was serious.

The good news is that if he hadn't said that, I would have thought all family members of prisoners were loved and welcomed into churches and I'd probably still be youth director today.

With a husband in prison, I was treated like a leper, or a walking AIDS case. When I share my story about not being welcome in two churches to family members of inmates, usually their eyes fill with tears, for they too haven't been welcomed in a church. Unfortunately, most people believe when a pastor or priest doesn't welcome them into their

church, it's almost as if God had not welcomed them. I grew up in the church and I knew I was still a Child of God and God would never turn from me.

Being suddenly thrown into the world of incarceration was like being thrown into a foreign culture without knowing the language, the people, how to act, or what to do. I needed advice about how to deal with the incarceration, raising 4 boys by myself, the rejection, and I needed to learn this "new world of incarceration".

My pastor didn't have any books. I finally called the head of the psychology dept. at the Univ. of NM. He had a book. I got there – he pulled a book off the top shelf – it was a study of Norwegian fisherman who went to sea for 9 months and the impact on the family. I laughed and left the book

That day was the start of my book – Family Arrested – How to Survive the Incarceration of a Loved One. I'm not a writer – never dreamt of writing a book – but that's what I did. I guess it was my positive way of dealing with all the pain, anger, and shame of having a loved one incarcerat-

Of course no one wanted to print my book! I received more rejection letters from publishers than I want to remember. I heard about Prison Fellowship and went to the NM Area Director to see if he would be interested in my book. He didn't think they would want my book, but he told me about Prison Fellowship's Angel Tree Project. I thought it was strange my husband had played Santa Claus at the prison for 6 years and I was Youth Director in a Church and yet I had never heard of this program.

I set up a meeting with PF officials & received a small grant to start the Wings Ministry as an extension of the Angel Tree Program in 1995. As I shared with them, a Christmas present is fine, but the greatest gift we can give a person is the gift of our caring, and the gift of being welcome somewhere – especially into a church!

Our logo is an angel with wings, with a trumpet proclaiming the Good News. And what do "wings" do? Support, comfort, protect, and lift you up and hopefully help you fly to new heights. The mission of the Wings Ministry is to connect family members of inmates to local churches.

Christmas 1995 we hosted our first Wings Party. It was so successful that all the volunteers said we can't stop now – let's do an Easter Party. Jesus didn't have a Back-to-School Party, but we do, because that's when church programs start again in the fall, and we want the family members of prisoners to start at the beginning, with all the other new members.

In 1999 the pastor who had originally hired me as Youth Director invited me to meet a friend of his who was starting a new publishing company in Albuquerque. I was going to ask him for money for the Wings Ministry. Instead, he offered me a job! I didn't know a thing about the publishing world, but when he mentioned he wanted to publish my book, I knew I needed to take this new job.

I became VP of Sales. We primarily produced audiobooks and became the largest supplier to truck stops in America. After 3 years they produced my book in print, and I actually even read my own audiobook!

But now I had completed my reason for working at the publishing company. Starting January 1st of 2005, I took a giant step of faith and quit my job as VP of a publishing company. I started full time with Wings. We had \$1582 in our newly formed 501 (c) 3 checking account. The Board of

Directors voted to pay me \$1500/month. The questions was asked – how do we pay you next month? I told them I felt I was called by God to do this ministry and if there wasn't money to pay me next month, then I would have to get a "real job". Well -I'm here in front of you today, 4 years later! People believe in what we are doing and I know God has uniquely qualified me to do this job!

Wings Parties are based on Acts 2:42, where the early disciples got together and did 4 things – Sang together; studies the Bible together; played together – we do games and crafts; and ate together. We use the LOGOS Ministry model, for those of you familiar with LOGOS. In fact if you aren't familiar with LOGOS, it is the finest model of youth ministry in the world in my opinion.

The Wings Parties help plant or water a seed. We now do Wings Parties in prisons and juvenile facilities too.

But I knew we needed more. My book is a "how to book" and I knew that people needed support. So we started Wings for L.I.F.E. – Life-skills Imparted to Families through Education.

Wings for L.I.F.E. is an "empowerment group", for the whole family. Former inmates are invited to join us as well. I firmly believe we need to teach parents and caregivers "old fashioned" parenting skills, for we have generations of Americans that have never grown up in a healthy household where manners and discipline were taught. One of Search Institute's 40 Developmental Assets is shared at each meeting, and families are encouraged to help one another.

I'm proud to share that in 2009 WFL won the prestigious American Probation & Parole's National Award of Excellence in Crime Prevention and has been recognized as a Best Practice Model.

In our society where children are all at risk in one way or another, children whose parent(s) are in prison, face even more challenges.

It is now estimated that 7 out of 10 children of incarcerated family members will be incarcerat-

Over 50% of the children who have a parent in prison NEVER visit their parent in prison.

78% of inmates claim to have had a relative in prison.

1 in 10 children in America has a parent in jail, prison or probation.

1 out of 8 African-American children has a parent in prison.

If current trends continue, 1 out of 15 Americans will spend time in a State or Federal Prison sometime within their lifetime.

Because of these staggering statistics, we believe that committed, caring people in our communities need to take an interest in our children Education and life-skills are necessary to help prevent another generation of inmates and to cut recidivism. We provide group mentoring for children of prisoners, family members, and returning citizens who are positive role models.

Ann's book is available on Amazon and a great resource for families of incarceration.



Your Career **Questions Part 2**

This week's question comes from Stephen in Morgan County: How can I practice for a job interview?

I recommend you practice and re-

cord a real-world job interview scenario. Find a friend, family member, educator, or a professional, and have them ask you a list of questions while you provide answers just as if it were an actual job interview. Technology nowadays makes it easier then ever to practice a mock interview. Record these practice interviews with a computer webcam, smartphone, tablet, or just a plain, old, video camera. Use the interview questions listed pany on zackballinger.com and practice on video. Whether you are a beginner at interviewing or a seasoned pro-

fessional, this is an essential step to becoming a master at the interview process.

Who is the best person to administer the interview? Multiple people could help you with your mock interview. If you happen to be on a on a short time crunch, conduct the mock interview with a friend or family member. Choose a relative who may have had experience as a manager, or a friend who may have climbed the corporate ladder. Most career centers on university campuses offer this service for free. Take advantage of this service! The career counselors can often offer advice on your posture, pinpoint any annoying habits, or give objective, professional feedback on your answers to the interview questions. You would be surprised at some habits you aren't aware of.

These might be simple things as saying "like" all the time, picking your nose, making off-the-mark gestures, or some other off-putting practices. The hiring manager may be more focused on your annoying habits than your terrific answers. We have all sat through a presentation for school, church, or some informative session, and you found yourself focusing more on the presenter's distracting quirks than the mate-



> rial. While the way you deliver information during an interview is important for the hiring manager, it is also equally important to direct their attention to the information you are presenting.

I had this one professor in college who smacked his lips after every sentence. I think I learned more about how he smacked his lips in front of a group than I did about macroeconomics. That explains my final grade in the class. There are no right answers to common interview questions, but there are some wrong ones. You need to make sure you aren't saying anything that is making an employer doubt your abilities to do the job.

I was interviewing a gentleman years ago for a job. I asked him, "What is something you need to work on as far as a develop-

mental area from a previous job or a perceived weakness?" He responded by saying he had a



ing. The position required the individual to work independently, working mornings, and arrive promptly to begin work. Do you think he was hired? He did so well on all

the other questions in the interview, but this one answer was a deal-breaker. He might have been an extremely qualified candidate—if only he could manage to get out of the bed in the morning. The poor guy will never get a quality job if he keeps answering that question the same way. Catch those missteps on video before the actual interview. If you

can master interviewing on video, you can definitely master a real world interview.

Hebrews Chapter 3

(Hebrews 3:1-6) Christ in contrast to Moses: The readers are addressed as "holy brothers" who are "partakers of a heavenly calling". They were called by the gospel (2 Thes. 2:14) into a special saved and set-apart relationship with God, namely the church (the origin of that term signifying "called out). Jesus is, in a special sense, designated as an "Apostle" because the word means "sent forth", and God "sent" his Son to earth to die for sin (Jn. 4:34). Christ's role as high priest is the major theme of this book (see 4:14). "Confession" suggests the Christian's commitment to Christ in obedience.

Jesus was faithful to God to the point of perfection; Moses, Israel's great leader, was "faithful" (relatively so) as well. Moses was faithful in God's house (v. 2). The argument now unfolds that Christ was superior to Moses in several particulars, the point being the new covenant (of Christ) is greater than the old covenant (of Moses). (a) Jesus was the builder of God's house; Moses was an inhabitant in God's house. The builder is worthy of "more glory" than the resident (v. 3). (b) Every house is built by someone. This is the law of causation. Every effect must have an adequate cause! God is the builder of all things (v. 4)! The pre-incarnate Word (Christ (Jn. 1:14) was the active agent in the construction of the entire universe (Jn. 1:3; Col. 1:16; Heb. 1:2, 10). (c) Moses was faithful in his house as a servant; Jesus was over his house as a Son (v.5).

The argument is clear; Judaizing apostates are leaving the greater for the lesser! These Jewish Christians must hold fast their hope to the very end (v. 6). Christians can forfeit their salvation, Calvinism to the contrary notwithstanding.

(Hebrews 3:7-11) Israel's unbelief in the wilderness: the sacred writer quotes from the Holy Spirit, a divine person who speaks, and who speaks through Scripture (Psa. 95:7). There is an urgent warning to the reader. "Today", do not "harden your hearts". Hardening is a gradual process, and if allowed to continue, becomes fatal. Many church members today have religious arte-

riosclerosis. This is what the nation of Israel did during the days of Moses in the wilderness of Sinai, even though they saw the wonderful works of the Lord; God was not pleased with them (v. 10). Jehovah, with the measured "wrath" of justice, took an oath that they would not enter into his rest. As will be apparent subsequently, the "rest" was a symbolic picture of heaven. The unfaithful Christian risks losing his hope of heaven.

(Hebrews 3:12-19) the application of the example: the Old Testament example had an appropriate application to straying Christians in the first century. Note: (a) The warning is addressed to "brothers", not those outside of Christ. (b) It is possible to develop an "evil heart of unbelief". (c) Such results in "falling away" from God. (d) That falling away leads to eternal punishment (10:27; 30-31).

Accordingly, the saints are to exhort (encourage) one another every day, while there still is a today (of opportunity), so that sin does not "harden" them to the point of being beyond feeling (v. 13; Eph. 4:19). (The inference is that there is no postmortem plan of salvation---contra the theories of purgatory, baptism for the dead, a second chance, etc.)

If, therefore, one is to be a "partaker of Christ", he must "hold fast" the confession (pledge of faithful obedience) which he made at the beginning of his Christian life; yes, grasp firmly to the very end (v. 14). Again the psalm is cited to buttress the point (v. 15). Was it not Israel who was led from Egypt by Moses? Was not God displeased with them for forty years? Did not their sins cause them to die in the wilderness (v. 17)? Those disobedient unbelievers were forbidden to enter his rest. The suggestion is: "Those of you flirting with apostasy had better take note; learn the lesson of history!"

Center preparing Marines for deployments to Kuwait and Iraq.


Two of the duty positions held by GySgt. Redwine were as a Communications Cen-

The IRS has sent 159 million stimulus checks so far. But there is still an estimated 30 million to 35 million payments that remain to be sent.

The IRS had previously announced that it

would be sending stimulus checks to people that it does not have bank account information needed for direct deposit. However, the IRS is now planning to send prepaid debit cards to some of these individuals.

If you have not received your stimulus yet, be careful when throwing away junk mail. If the IRS sends a stimulus debit card, it will be sent in a plain envelope from Money Network Cardholder Services.

If you have a question about your stimulus payment the IRS phone number for stimulus questions is 800-919-9835. The IRS still has a reduced number of employees so you should expect a long wait time. However, if you have a tax pro, they may be able to get through to the IRS on the Tax



Practitioner Hotline in a matter of minutes. Currently, IRS employees don't have the ability to adjust stimulus payments. Most people who need to adjust their stimulus if it is too low will need to make the correction when they file their 2020 tax return. Taxpayers will reconcile their amount of stimulus when filing their 2020 tax return. The pandemic has had a huge impact on the IRS. They are beginning to slowly bring back employees in order to work on essential services such as processing mail. Millions of pieces of mail have piled up while their offices were closed. Consequently, there will be huge delays in processing taxpayer's mailed tax returns and other documents.

Due to the long delays in processing IRS mail you may want to consider efiling your return even if you have always mailed it in the past. By efiling and using direct deposit, you can normally expect to receive your refund in about two weeks. Mailing your return could result in having to wait months for your refund.

The IRS has announced changes with its use of the private tax-debt collection pro-

gram.

The IRS must also allow two years to elapse since the assessment for the tax to become eligible before being turned over for private debt collection. Previously the amount of time was one year.

The IRS has been barred from turning over low-income individuals to private collection.

Taxpayers will soon be able to set up an installment agreement to pay off their taxes in seven years instead of five years. However, you should consider paying off your tax debt as quickly as possible to avoid paying additional amounts of interest.
