

New Program Provides Much Needed Relief for Tennessee Small Businesses

The current COVID-19 public health crisis has triggered devastating economic consequences throughout the state. Small businesses were among the first economic casualties of crisis and I have received heartbreaking calls from local business owners tottering on the brink of total disaster. Even now, many businesses are only partially opened or still closed.

Governor Lee appointed a blue chip group called the Financial Stimulus Accountability Group to find ways to help struggling businesses. That group has worked with the Department of Revenue to provide a lifeline to local business affected by the Governor's stay-at-home order. The new Tennessee Business Relief Program will direct approximately \$200 million from the Coronavirus Aid, Relief, and Economic Security (CARES) Act appropriation to qualified businesses in the state.

Barber shops, beauty and nail salons, gyms, restaurants, and marinas are eligible. Businesses who may have remained open but whose sales were reduced 25 percent as shown on their April sales tax returns are likewise eligible. Go to the state website at www. tn.gov to find the link to the Department of Revenue for more eligibility information.

Recently, I invited the Commissioner of Revenue, David Gerregano, to participate in a call with the local chambers of commerce CEOs in my district regarding this program. I'd like to share some of the information we learned.

Approximately 28,000 Tennessee businesses are expected to qualify, including many in the 12th Senatorial District. The amounts awarded will be based on gross sales. Relief payments under the program will range from \$2,500 to \$30,000, depending on the business's gross sales. The payment will be made by direct deposit if

the business has previously provided bank information to the Department of Revenue. If not, payments are made by check. No application is necessary. Although currently not included, the hope is to include non-profits. Payments should be delivered by the end of July. In order to timely receive it, it is critical that each small business's information be up to date with the Department of Revenue. I encourage you to go to the department's website to double check your information. Incorrect or old information should be updated to prevent delayed payment.

I am very pleased that the Governor and Financial Stimulus Accountability Group have developed this plan to help small business, the backbone of our economy. If you have questions or need help, don't hesitate to call my Nashville office at 615-741-1449 or go to www.tn.gov.



Where We are Today

For sometime I have been debating with myself about whether I should write an article about

Freedom and Sacrifice- Captain Kangaroo, Lee Marvin and Mr. Rogers

Soon we will be celebrating America's 244th Birthday. For many Americans, that means spending time with family, firing up the grill, and lighting up the sky with fireworks. For other Americans, it means reflecting on our Nation's history, remembering time served in our military, or thinking of loved ones who are currently serving

currently serving. Independence Day means many things to people. I always loved the Fourth of July, but then I love all holidays. I love celebrations, happiness, joy and laughter. The Fourth of July to me means families come together to celebrate our Independence and freedom as Americans. America's Birthday!!!! It's also a time to reflect on all those who paved the way to make our Country great. For the next several weeks, I will be focusing on Freedom and Sacrifice. In doing research for this column, I came across an interesting story that I think you will enjoy. Captain Kangaroo passed away on January 23, 2004 at age 76, which is odd, because he always looked to be 76. (DOB: 6/27/27) His death reminded me of the following story.

Some people have been a bit offended that the actor, Lee Marvin, is buried in a grave alongside 3 and 4-star generals at Arlington National Cemetery. His marker gives his name, rank (PVT) and service (USMC). Nothing else. Here's a guy who was only a famous movie star who served his timewhy does he rate burial with these guys? Well, following is the amazing answer:

I always liked Lee Marvin, but didn't know the extent of his Corps experiences.

In a time when many Hollywood stars served their country in the armed forces, often in rear echelon posts where they were carefully protected only to be trotted out to perform for the cameras in war bond promotions, Lee Marvin was a genuine hero. He won the Navy Cross at Iwo Jima. There is only one higher Naval award – the Medal of Honor!

That is a comment on the true character of the man. Additionally, Lee Marvin credits his sergeant with an even greater show of bravery.

Dialogue from "The Tonight Show with Johnny Carson": His guest was Lee Marvin. Johnny said, "Lee, I'll bet a lot of people are unaware that you were a Marine in the initial landing at Iwo Jima and that during the course of that action you earned the Navy Cross and were severely wounded."

"Yeah, yeah... I got shot square in the bottom and they gave me the Cross for securing a hot spot about halfway up Suribachi. Bad thing about getting shot up on a mountain is guys getting shot hauling you down. But, Johnny, at Iwo, I served under the bravest man I ever knew... We both got the Cross the same day, but what he did for his Cross made mine look cheap in comparison. That dumb guy actually stood up on Red beach and directed his troops to move forward and get off the beach. Bullets flying by, with mortar rounds landing everywhere and he stood there as the main target of gunfire so that he could get his men to safety. He did this on more than one occasion because his men's safety was more important than his own life.

That Sergeant and I have been lifelong friends. When they brought me off Suribachi we passed the Sergeant and he lit a smoke and passed it to me, lying on my belly on the litter and said, "Where'd they get you Lee?" "Well Bob, if you make it home before me, tell Mom to sell the

outhouse!"

Johnny, I'm not lying, Sergeant Keeshan was the bravest man I ever knew. The Sergeant's name is Bob Keeshan. You and the world know him as Captain Kangaroo."

On another note, there was this wimpy little man (who passed away) on PBS, gentle and quiet. Mr. Rogers is another of those you would least suspect of being anything but what he portrayed to our youth. But Mr. Rogers was a U.S. Navy Seal, combat-proven in Vietnam with over twenty-five confirmed kills to his name. He wore a long-sleeved sweater on TV to cover the many tattoos on his forearm and biceps. He was a master in small arms and hand-to-hand combat, able to disarm or kill in a heartbeat. After the war Mr. Rogers became an ordained Presbyterian minister and therefore a pacifist. Vowing to never harm another human and also dedicating the rest of his life to trying to help lead children on the right path in life, he hid away the tattoos and his past life and won our hearts with his quiet wit and charm. America's real heroes don't flaunt what they did; they quietly go about their day-to-day lives, doing what they do best. They earned our respect and the freedoms that we all enjoy. Historically Speaking

My Day With The Oak Ridge Boys

The Oak Ridge Boys were the entertainment for the 2007 Secret City Festival and I was privileged to get to tour them through the Y-12 National Security Complex and have dinner with them prior to their concert.

Jane Miller asked me if I would give The Oak Ridge Boys a tour of Y-12 to include the calutrons. Katy Brown had indicated to her that in conversation with The Oak Ridge Boys publicist she had learned that they were quite interested in the history of Oak Ridge...not just how their name tied to it, but the real history of Oak Ridge. I said, "Yes, I will be happy to tour them."

From this conversation grew a full half-day tour of selected Oak Ridge history and a reception at the Scarboro Road Gatehouse. Jane and I picked them up at the Hampton Inn where their bus was parked and the band members were staying. We arrived at 12:15 PM to get them at 12:30 PM. Almost as soon as we got there, Joe Bonsall came strolling by, obviously finishing a run, with his shirt in his hand saying he had lost a bus. I knew right away that I was going to have a fun afternoon.

Our first stop was the City of Oak Ridge sponsored reception at the Scarboro Road Gatehouse. I explained the history of the gatehouse before they got off the bus. The details I gave them were that this gatehouse served as a checking station for entry into Y-12 starting March 19, 1949 and was used as such until 1953 when the gates to the Y-12 site were moved back to the site proper.

When they got off the bus, the immediately began shaking hands and introducing themselves to all who were there. Before long they were looking closely at the historic Ed Westcott photographs lining the walls of the gatehouse. I made sure they understood that if it were not for Ed Westcott, official Manhattan Project photographer, that we would not have the rich photographic history we enjoy today. They closely examined most of the photographs lining the walls asking questions and making keen observations.

I immediately understood that their interest in the history of Oak Ridge was genuine. They were looking forward to the tour of Y-12 and later a tour of Wackenhut facilities. The festive atmosphere included the several staged photos of the Oaks sitting at 1940's era desk with historic artifacts and props.

There were a number of photographers there and many photos were made. Refreshments were served. And the Oak Ridge Boys Way sign was unveiled. This road that runs just north of the Civic Center has been designated the Oak Ridge Boys Way. They were pleased to accept the honor. This ceremony was repeated later at the concert and one of the signs was provided to them to take with them. Joe Bonsall said they should put it up somewhere near their home town as they have yet to name a street for them.

Soon time came for us to begin the tours after badges were provided by Wackenhut. We took them on much the same route as the Secret City Festival Y-12 Public Tour had taken on Friday except the only stop was on Chestnut Ridge at the Water Tanks Overlook. The view of Y-12 gave them an appreciation of the size of the site and the unique historic role Y-12 has played over the years.

We then took them to see the calutrons in Beta 3. There they gained a full appreciation for the magnitude of the task required to separate the uranium needed for Little Boy.

Next, we traveled to Wackenhut's Central Training facility where they saw the protective forces weapons, equipment, canine searches and even got to see the active weapons systems used for training.

By the time we arrived back at the hotel, they indicated that they had drawn a much fuller appreciation for the history of Oak Ridge. With barely enough time for them to eat dinner before the concert, a portion of the Magnolia Tree restaurant was reserved for a quiet dinner for a few guests and the band. This dinner was also an opportunity to have them meet Bill Wilcox, Official Oak Ridge City Historian.

Duane said of Bill Wilcox and their dinner conversation, "I sat at the dinner table with Mr. Wilcox. Wow, what a character, he started me back in 1942 and tip-toed me through the high points of how things came to be. What a wonderful old gentleman! I could have listened

to him for days!"

Duane also wrote a lengthy post on Sunday AM for the Oak Ridge Boys web site's "Oaks Talk" bulletin board for fans. He told of the impact of the Oak Ridge visit on him. He said, "The day began at 1:00, and everything we did during that time was planned to the minute. We were carried into facilities that very few people have ever been. We were shown how the atoms were separated to manufacture the components of the atomic bomb that ended World War II."

He went on to describe more of the tour, "So many questions about our history, and the history of the Secret City were revealed to me. I will later include these historical facts in a book, if I ever get around to finishing it. I was happy to learn, for a fact, that most everything I have been writing about the history of our group, in relation to Oak Ridge and our group singing there in the 40's is true. I learned so many things that I did NOT know. I will try and sort them out and write them in a way that will be a very interesting read. I learned so much yesterday that my brain is in overload and I am

still cataloging all this wonderful history!" The four Oak Ridge Boys, Joe Bonsall, William Lee Golden, Duane Allen and Richard Sterbin are really nice guys. They are down to earth and easy to talk with. They asked very good questions and were intent on learning all they could about Oak Ridge history.

Here is a personal note of interest about William Lee Golden. He and his family own a home in Hendersonville, TN that was originally built in 1786. It has been hit by tornados twice, once about 100 years ago and the second time just a few years ago. It has been restored both times. The first time the ceilings were lowered, but after the second tornado, William Lee said they decided to raise the ceilings back to the original height. The house was rebuilt using the most modern and strong materials, yet remained authentic to the original design. He is rightly proud of that historic home.

There is a DVD The William Lee Golden Story, a sixty-five-minute documentary film that includes interviews with friends, family and music industry family. His mother, Rutha Mae Golden, has published a book of poems, Golden Verses, poems of life, love, family and faith

Joe Bonsall has written two books, one about thirty years with The Oak Ridge Boys, An American Journey, and the other, GI Joe & Lillie with a foreword by Barbara Bush and the story of Joe's beloved father and mother. I received a signed copy of GI Joe & Lillie and have found it to be a really good read about two World War II veterans who made a wonderful life together and whose love for family is something the world needs to better understand and practice. Reading this book made Joe Bonsall's life take on an even more special meaning for me.

Duane Allen is proud of his boots. He showed them to me. They have the presidential seal on them and are a present from George Herbert Walker Bush, our 41st president. He has worn out three pairs of them! He wears them almost daily! Duane is intent upon learning and documenting the history of The Oak Ridge Boys to the fullest and most accurate extent possible. I am pleased to have been able to help him some with this endeavor and hope to be able to be of even more assistance as he proceeds with the project.

Richard Sterban's trademark bass singing voice and the signature "Omm Bop A Mow Mow" is not the only use he makes of his tremendous vocal abilities. He has recorded public service announcements for the National Oceanic and Atmospheric Administration (NOAA) weather radio network, the "voice" of the National Weather Service. Richard is also the "voice" for the Classic Country channel on Sirius Satellite Radio. He is quiet but keenly interested in everything around him. During the tours in Oak Ridge he watched intently at every new detail and when he asked a question, it was insightful and clearly stated. His ready smile and warmth makes him easy to talk with.

And then there was the concert. A huge crowd gathered in Bissell Park as the hot sun slid slowly toward the horizon. The "Blue Moon Rising" band served some excellent bluegrass music as the opening act.

When the welcoming remarks were ended and The Oak Ridge Boys took the stage, the sunset provided some welcome relief from the heat and the excitement swelled in the crowd. After a couple of songs, Joe took a moment to mention to the crowd how the activities of the day thus far had held much meaning for The Oak Ridge Boys. Their visit was more than another concert and they had learned much about Oak Ridge history.

Of course, I wore my Oak Ridge Boys cap with pride throughout the concert and showed it to all who indicated any interest in what had happened during the afternoon. Scott Fraker, of The Oak Ridger, called me wanting to know the details of the afternoon tour for the newspaper. I tried to tell him on the phone what we had done, but may have been too tired to make much sense. So, I sent him an email later in the evening hoping that would be of use to the newspaper.

The music of The Oak Ridge Boys was the capstone of a wonderful day for me. The singing was great, the crowd support was strong and the evening was a delightful relaxing time in the twilight and early night with the superb weather and clear sky. The Secret City Festival's premiere concert was a huge hit and I feel the entire day was a whopping success!

Over the years since this unique opportunity to meet and tour The Oak Ridge Boys, Fanny and I have stayed in touch with them and attended most all their concerts in this area. I still swell with pride when they take a few minutes in a concert to explain where they got their name and often mention the tour behind the "secret" location at Y-12 where they saw the Manhattan Project Calutrons up close and personal.

We almost were able to schedule them to return for the 75th anniversary of Oak Ridge, but they had already filled the date before we asked them. I believe they would come again if asked and we could arrange it.

The Oak Ridge Boys Executive Vice President contacted me not too long ago asking for a personal tour of Oak Ridge. He remembers fondly being here in 2007 and wanted to see what else we had opened up for folks to see since then. I assured him I would be pleased to give him a tour and include the Manhattan Project National Historical Park as well as the museums opened since he was here last.

Oak Ridge was created as a part of the Manhattan Project in 1942 to help stop World War II. The atomic bomb, Little Boy, fueled by uranium 235 separated at Oak Ridge helped to

Oak Ridge began in war, has continued to support our nation's efforts through the Cold War, and even now in the age of terrorism. Oak Ridge has also produced nuclear medicine, nuclear power and fuel for the US Navy nuclear submarines and ships.

This "Secret City" nestled in Appalachia near Morgan County and where many from Morgan County go each day to work, continues today to produce scientific discoveries used worldwide and still routinely makes history. 
This week's question comes from Teresa in Wartburg, TN: Should I send a thank you letter after my job interview?

When it comes to the topic of job interviewing, most publications—whether books, articles, or newspapers—highly recommend you send a "thank you" note afterwards. There is normally a specified time frame each author suggests for taking this step after the interview has ended. Some experts are adamant it should be right after the interview, others have stated you have a maximum of a 24-hour window, and some often argue that it's reasonable to take up to 48 hours to send a note.

I would argue that 48 hours seems a bit

too long and right after isn't always feasible. The Hot Seat generally recommends sending the note within a 12-hour time frame. Why? Technology controls most of our lives today. Most smartphones are equipped with email features. You can easily submit a "thank you" email right after the interview via your phone, tablet, or a laptop. Just do it and get it over with. Besides, the longer you procrastinate, the greater the chance of forgetting to email it at all. I would send a note the day of the interview or later that evening. This effort is one more

thing that sets you apart from your competition. A prompt "thank you" note may show the hiring manager you're excited about the position and enjoyed the conversation.

templates and examples floating around on the Web. While these boring pre-formatted, unoriginal examples are readily available, your note still needs to be customized to you, the job, and the interview that took place. It doesn't need to be a cookie cutter note you copy and paste. Do you think the interviewer has seen that same template before? Do you want to give the impression that you are sloppy, lazy, or uninterested in thanking the interviewer for their precious time? Make sure you customize your thank

you email after the job interview.

Compose a handwritten "thank you" after the interview. I always write both an email commu-

> nication within a 12-hour window and a handwritten thank you note. Have a blank thank you card with you and fill it out immediately after the job interview. The hand-written note doesn't need to be a novel. A paragraph or two will completely suffice. Your detailed letter will be composed and sent via email. A common excuse I hear is, "but my handwriting is terrible". Well, my own handwriting looks like chicken scratch from a one-legged bird. It's absolutely terrible! That's no excuse for me not to leave a handwritten note for the hiring manager. My handwriting is still terrible, but I can take my time to make it look legible as possible.

With handwritten notes, the general rule thumb is that it's like the bad Christmas present Aunt Kathy gives you each year: it's the thought that counts.

Not many people write notes nowadays, which makes them even more distinctive. The best place to leave the handwritten note is underneath the meeting room door after the interview, with a receptionist, or someone who can be trusted at the venue to get into the hiring manager's hands. Most of the time the address on the hiring managers business cards are from

Hebrews Chapter 5

(Hebrews 5:1-10) qualifications for priesthood: under the Mosaic regime, the high priest was selected from among men (specifically, from the lineage of Aaron). He was divinely appointed to officiate over religious ritualism, offerings that pertained to pardon of sins (some living, other non-living). He was to have a compassionate disposition for the ignorant and the wayward. He had to acknowledge his own sin, thus offering sacrifice for himself as well as others. He was not to arrogate the office unto himself, but conform to the will of God (1-4).

The high priest, to a degree, symbolically foreshadowed Christ; but there were significant differences as well. Jesus "glorified not himself" as high priest. He was appointed by God. Psalm 2:7 is quoted to that end. The language is flexible, the same text being used elsewhere for Jesus' birth and his resurrection from the dead (1:5; Acts 13:33). Jesus was a priest after the order of Melchizedek (a contemporary of Abraham). See chapter seven.

The sacred writer now speaks of Jesus "in the days of his flesh" (v. 7)---implying that he had a pre-flesh existence (Jn. 1:14; 1 Tim. 3:16). The emotional "humanness" of our high priest now is underscored. Especially are the Gethsemane and Calvary ordeals referenced (2:12; Psa. 22:1; especially v. 24). With strong crying and tears (not mentioned in the Gospels), he prayed to God, confident that the Father was able to "save" (deliver) him "from" (out of) death (an allusion to his resurrection). He was heard for his godly reverence, being raised from the dead (v. 8). The Lord's resurrection is the key evidence of his legitimate qualification as our high priest for sin. Combining figures of speech, Jesus is both the priest and the sacrifice.

Even though the Savior, in his relation to the Father, was "Son" in nature, he had to "learn" obedience. Such is a part of the human experience. As the Lord "grew" intellectually (Lk. 2:40, 52), his comprehension for complete obedience did as well. By his experiences, he "was made perfect". This is not moral perfection; he always was that. "Perfect" suggests he was "completely qualified" for his priestly role. He was

the source of eternal salvation. Who are the recipients of this salvation? Not everyone, as argued by "universalists". Nor are a mere select few, unconditionally ordained as the "elect" before the world's foundation, as Calvinists contend. Rather, those who pursue "obedience" (the Greek tense reflects ongoing action) are bestowed salvation (v. 9). Jesus is the source of salvation for all, but only the obedient will be saved. Calvinistic attempts to harmonize the "obedience" of this passage with their "faith-only" theory would be humorous if not so pathetically tragic.

(Hebrews 5:11-14) the tragedy of spiritual degeneration: the writer now wishes to address the spiritual condition of many Hebrews who will read his epistle. The things under consideration are not intrinsically "hard" to fathom, but they are hard when exposed to "dull" listeners. "Dull" is the opposite of the "honest and good" heart (Lk. 8:15; Acts 17:11). With the passing of time (probably thirty years or so with some), when they should have developed into informed, stable teachers, they were in need of learning the ABCs of Christian doctrine. They were still in spiritual kindergarten. Some never get beyond "first principles", others recklessly abandon them!

Consider the cartoon-like picture of a thirty-year-old person who still is sucking on a bottle of milk! The imagery marks one as "inexperienced" in God's righteous word, and like an overgrown, undernourished "baby" in Christ. Such cannot chew and digest solid food, for they have never grown in the faith (v. 14). They may have been in the church for twenty years, but they only have one year's experience twenty times! These have not developed "their senses" to discriminate the difference between "good and evil". How very vulnerable they are. Little wonder there was a Hebrew-Christian apostasy danger. Without the ability to discern the

difference between moral good and evil, or religious truth and error, one is blown to and fro with every wind of false teaching (Eph. 4:14). People are responsible for whether they grow or not and for what they believe and teach.

The benefits of tax-saving business strategies

Using tax-saving business strategies can substantially reduce the amount of taxes paid by a business.

Maximizing the tax savings requires determining the best tax strategy. Tax-saving business strategies have

completely changed as a result of the 2018 Tax Cuts and Job Act. If you haven't changed your strategy to take advantage of the new tax laws, you could be paying a substantial amount more in taxes each year than you should be.

The 2018 changes created the 20% QBI deduction for businesses. This can reduce your taxable business income by 20%. However, not all business income is qualified for the 20% deduction. The 20% QBI deduction is too involved to be covered in one article and will be covered in future articles.

When determining the best tax-saving business strategy there are several entities to take into consideration. These include the sole proprietor, partnership, LLC, S corporation and C corporation. There are several variables to consider in order to determine which one is best for you.

Some of the factors that you should

consider when determining your strategy is the amount of your profit and whether you have other sources of income. Other factors that will impact your strategy are your marital status and whether your spouse has income. Additionally, if you have children, this may also affect your strategy.

A substantial amount of money may be saved by taking advantage of an S corporation. By forming an S corporation, a business owner may be able to substantially reduce self-employment taxes. The owner of of an S corporation does not pay payroll taxes on the profit, which could provide significant tax savings. As an example, if a sole proprietor has a profit of \$100,000, the self-employment (SE) taxes would be about \$14,130. By forming an S corporation and taking a reasonable salary of \$60,000, it would eliminate the payroll taxes by 40%. This strategy would reduce payroll taxes by about \$5,652 (\$14,000 x 40%). Another strategy is having your spouse rent property to you, since there are no SE taxes on rental income.

As an example, your spouse rents a building to you. You pay your spouse \$2,000 rent each month. This strategy reduces your self-employment income by \$24,000 which reduces your taxes by SE taxes by \$3,391 each year.

Hiring your children can provide a tremendous tax savings. The standard deduction for a child is \$12,400 in 2020. Any W-2 wages to the child less than the standard deduction is tax-free. As an example, you pay your child \$100 a week. This would reduce your taxable income by \$5,200. Consequently, your self-employment taxes would be reduced by \$735 and your income taxes would also be reduced. The amount of your income tax savings would depend on your income tax bracket. If you were in the 22% bracket your income tax savings would be \$1,144. This would result in a total tax savings of \$1,879.

These are just a few of the many possible strategies. Before implementing any strategy, it is important to research all of the details since this article only provides a brief synopsis. Additional strategy information will be provided in future articles.
