The Tennessee Football Game I Can't Forget

snowy day in November, 1953. It was coach Robert Neyland's last home game, and Kentucky would come from behind to tie Tennessee 14-14. My greatest love for Tennessee football didn't happen that day or even in the next few years. I loved to see Johnny Majors play and I kept up with the Volunteers during the 50's. As-a-matter-a-fact I went to see a few games during this period before I went into the Navy in 1958. In 1962 the Vols were really down. They had lost to Chattanooga and for a storied history that Tennessee had that was a no-no.

In 1964 an assistant coach on Frank Broyles Arkansas Razorback's staff by the name of Doug Dickey was called to be the Vols Coach. The 1964 team was not very good but there were better things to come. Dickey had done a good job recruiting and two players really stick out in my memory. They were (the swamp rat) Dewy Warren a quarterback from Savannah, Georgia and Johnny Mills a wide receiver from Elizabethton, Tennessee. Jimmy Gibson as many of you know Coached at Coalfield and Wartburg before going up there. He helped Coach Mills in high school. I heard from a reliable source that not only was Johnny Mills a great football player, but also a great person. He and Warren would star in the game I'm going to tell you about.

It was to be the last game of the 1965 season pitting Tennessee against UCLA. The game was to

be played at the Liberty Bowl in Memphis, supposedly a neutral field, but the UCLA Coach, Tommy Prothro didn't like it at all. He said it was like the Catholics meeting the Pope in Rome. He knew the stadium would be filled with fans dressed in orange. UCLA was in the top 10 and favored by two T.D.'s. Tennessee was a much-improved team over the 1964 team, but still not what Dickey hoped for.

My Dad and I would have to listen to the game on the radio, because back then very few games would be carried on T.V. Dad had become a football fan after the Wartburg vs Kingston game in 1953. We would sit the radio on the stump and place chairs around it. Mom use to watch us out the window and get a kick out of us playing musi-

year and he was my favorite player in the 1960's. He had some good rushers in Walter Chadwick, Stan Mitchell and Hal Wantland. Wantland and Chadwick along with Austin Dennay were good receivers. However, on this day Johnny Mills would top them all. UCLA kicked off to the Vols and Chadwick fumbled on the return. The Bruins took it in from 30 yards out and the Vols were behind 7-0. But the Vols came back and scored a T.D. and the score was tied 7-7 at the end of the first quarter.

Tennessee with a mixture of passing and running would score two touchdowns in the 2nd quarter and led UCLA 20-7 at halftime. But early in the 2nd half Bepan made a long run for a T.D. and UCLA intercepted a Warren pass and in

cal chairs. Every time Tennessee would score or make a good play we would stand up and celebrate a while and end up in a different chair. It was a good family gathering on a pretty Saturday afternoon during football season. Dad would always be whittling and when the game was over there was a pile of shavings under the chairs. The better the Vols were doing, the faster he whittled.

Most sports figures figured this game would have a lot of passing in it because of two hot quarter-backs. UCLA had All-American Gary Beban who would be the Heisman Trophy winner the next year. Dewey Warren, although not excellent he was having a good

less than a minute UCLA led Tennessee 21-20. But the rest of the game was the exciting part. UCLA would score a touchdown and Tennessee would score to make it close. It was Warren to Mills for eleven catches. Every time the Vols needed a good play Warren would come through.

My Dad and I were setting on the edge of our seats. The last 20 minutes in the Liberty Bowl Stadium was like fireworks and it looked like the last team to have the ball would win the game. With less than 3 minutes to go Tennessee was leading 30-27, but Beban led UCLA down the field and scored making the score 34-30 with just a little time left on the clock. Not

to worry the Swamp-rat was up to the task. He drove the Vols down the field with both passes and runs. Mills was a big part of this with 4th and goal on the 1-yard line. It was do or die for the Volunteers who had a few seconds left. You talk about tense in that stadium. George Mooney, the announcer said you could hear a pin drop. What play would Dickey call? Warren could sling the ball but as a runner he was slow, big and strong but slow.

Coach Dickey called the quarterbacks number. He only had a couple of feet to go but would he make it. One player on the line that day said that Swamp-rat must have ran in the same place for five seconds because he killed the grass where he ran.

When the play was over the officials did not signal a T.D. for a while. Warren was under the stack and the officials needed to be sure. They signaled a touchdown and the crowd went wild. Tennessee 37 UCLA 34.

UCLA still had a few seconds left but Beban was intercepted on a long pass by Pat Patella, and instead of just taking a knee he ran for it down the UCLA sideline. A UCLA player came off the bench and really laid a lick on Patella. Dickey said it was a dirty scene. Tommy Prothro said even more as he went ballistic. He said the officials had stolen the game and as a southerner he was ashamed to admit he was born in Tennessee. But all I can say it was an exciting game and both teams played their hearts out.

Since November 1965 I have seen many exciting games. The come back game against Notre Dame in 1991 was one, and the 1986 Sugar Bowl against Miami was another great game for the Vols. The hail Mary pass in a recent game against Georgia was something else but the UCLA vs Tennessee game in November 1965 had it all – Tennessee 37 UCLA 34.

MIA'S View From the Mountain:

Birds of a Feather Flock Together

As I was growing up my mom was famous for always quoting idioms; such as "Birds of a feather flock together". The other day as I was sitting on our back porch bird watching, that saying came into my mind. My observation proved it to be truth. If the Finches were at the feeder and the Cardinals came, all the Finches flew away. In our yard, we have two Eastern Bluebird birdhouses. Earlier in the Spring/Summer, Starlings tried to take over one house. The Starling male would fight with the Eastern Bluebird male to maintain the house he was building his nest. Several times, I went and took down the nest hoping the Bluebird would come and build. Yet, everyday the Starling would return and rebuild the nest. Finally, I said to myself, the house is yours. The Starling's nested and raised their young birds. What was so interesting is that the Eastern Bluebirds took over the other house and they too settled in and raised their young birds. There would be times during the early morning that the two males would perch on top of the house like centurions protecting their domain. "Birds of a feather flock together", my mom would say. I bet I heard that thousands and thousands of times during my growing up years. Every time, I would bring home someone that was a bit sassy, or not polite, mom would quote "Birds of a feather flock together". That was my clue she did not approve of my choice or my behavior.

I work for a Prison Ministry and over the years I have had the opportunity to sit with many of these incarcerated; individuals. As I have listened to their stories, I have seen the truth of that statement. If only.....they had chosen another group to stand with......if only.

birds of a feather (flock together)

Individuals of like character, taste, or background (tend to stay together), as in The members of the club had no trouble selecting their yearly outing-they're all birds of a feather. The idea of like seeks like dates from ancient Greek times, and "Birds dwell with their kind" was quoted as early as 1545.

While this phrase can be understood by simply observing

human behavior, I make the case that it is Biblical as well.

Let's first look at the parable of the unjust steward. In this parable a rich man had a steward, or manager, of his goods. The steward did not do a good job and therefore the rich man was going to replace him. Upon finding out, the steward made deals with the rich man's debtors thinking that they would help him in return after he was fired. Here was how Jesus viewed this behavior:

"The master commended the dishonest manager because he had acted shrewdly. For the people of this world are more shrewd in dealing with their own kind than are the people of the light. I tell you, use worldly wealth to gain friends for yourselves, so that when it is gone, you will be welcomed into eternal dwellings." – Luke 16:8-9 NIV The steward was dishonest in his dealings, and when he was found out, he gravitated towards others who were similarly dishonest – birds of a feather.

The other side of the coin is how we as Christians should "flock". And it's no coincidence that we are considered to be in the "flock" (sheep flock, not bird flock) of God with Jesus as our Shepherd. In 2 Corinthians we read: "Do not be unequally yoked together with unbelievers. For what fellowship has righteousness with lawlessness? And what communion has light with darkness?" – 2 Corinthians 6:14 NKJV

And further in the Book of Hebrews we read:

"Not forsaking the assembling of ourselves together, as the manner of some is; but exhorting one another: and so much the more, as ye see the day approaching." – Hebrews 10:25 KJV

We are God's birds, birds of light, and as such we should "flock" together and keep ourselves out of the dark.

More idioms and lessons learned:

It is better to be alone than in the wrong company. Wise is the person who fortifies his life with the right friendships.

Tell me who your best friends are, and I will tell you who you are. If you run with wolves, you will learn how to howl.

But if you associate with eagles, you will learn how to soar to great heights.

A mirror reflects a man's face, but what he is really like is shown by the kind of friends he chooses.

You become like those with whom you closely associate for the good and the bad.

The less you associate with some people, the more your life will improve.

Any time you tolerate mediocrity in others, it increases your mediocrity.

Historically Speaking Back Valley Library Heritage Day Honors Dortha Byrd

I know you enjoyed meeting Dortha "Dot" Byrd in the previous Historically Speaking column where you were provided the summary of my wonderful hour or so spent interviewing Dot. What an amazing woman with extraordinary memory recall for her advanced age.

Last May a special event was held to place a historical marker at the Smallest Library. Joani Trout, Annetta Watson and Cathy Bird provided the following details about an honor provided Dortha Byrd. Enjoy the details of that special honor awarded to the "Smallest Library in the U. S." and to Dot Byrd:

At 10:00 AM on Saturday May 25th, 2019, the Coalfield community joined with the Morgan County Genealogical and Historical Society as well

as county and regional officials to honor the first librarian of the Back Valley Public Library, Dortha ("Dot") Byrd. Once considered the "Smallest Library in the USA," the Back Valley Public Library was established by local teacher May McGlothin in July 1956, and operated by Dot with her daughter Barbie from Dot's front yard on Back Valley Road.

Dot and the Library were featured in a May 1989 episode of The Tonight Show with Johnny Carson, and the funds she received from her appearance were used toward construction of the current Coalfield Public Library. The Back Valley Library building was moved to its current site adjacent to the Coalfield Public Library in 2006, where the "Smallest Library" is still operated as a public library and "the door is never locked."

The Heritage Day was organized by the Coalfield Librarian, Joani Trout, who welcomed the community; over 50 people attended the open-air event, held in front of the "Smallest Library." Matthew Jordan, Regional Director of the Clinch River Regional Library, provided a further welcome and shared excerpts from the numerous clippings and interviews surrounding Ms Byrd's recognition as a leader in the Tennessee community library movement of the 1950's and her later appearance on The Tonight show. Ms Byrd then shared some of her many experiences in serving the community as well as details of her television appearance.

Coalfield resident Annetta Watson represented the Historic Marker Committee of the Morgan County Genealogical and Historical Society; together with Ms Byrd, Ms Watson presented and unveiled the Historic Marker for the Back Valley Library. The Historic Marker program has been developed and designed by the Morgan County Genealogical and Historical Society to recognize historic structures and sites that are at least 50 years' old, and which are important to the history of Morgan County and its communities.

Such historic resources deserve to be honored and preserved, and these markers are one way to accomplish that objective. The Historic Marker program is funded by donation from a Morgan County resident, so individual markers are provided free of charge. The program is managed by volunteers who review each application and select the sites to be honored by considering the structure's historical significance as well as its condition and maintenance.

Ms Watson pointed out that the Historic Marker Committee was pleased to recognize the historical heritage and community spirit represented by the Back Valley Library and its early supporters: May McGlothin, Dortha and Barbie Byrd, Louise Crowe, and many other members of the Back Valley and Coalfield communities. The Historic Marker Committee also

recognized Alma Jones for her vision in helping move the Back Valley Library to its present location, and especially honors Dortha Byrd's hard work, dedication, knowledge and generosity.

The reception following the unveiling was held under the shaded entrance to the Coalfield Library where Ms Byrd received friends and well-wishers, including Morgan County Executive Brian Langley; Morgan County Commissioner Randy Roberts of Coalfield; Morgan County Library Board member John

and Jim Godwin, Chief of the Coalfield Volunteer Fire Department. Chief Godwin also contributed to advance preparations for the event by painting and repairing the Back Valley Library building.

The reception was very much a community event; flavorful cakes enjoyed by the reception guests were provided by Nancy Hall, Angie Hunter, Barbara Jackson, Wilma Overton and Jonell Gebauer, while the Mount Carmel Presbyterian Church of Coalfield provided chairs, flatware and goblets for the day. Farrah Meridith served the reception guests, and all photographs of the event were taken by Cathy Bird, Coalfield Photographer.

I must tell you a bit more about the interview. Dot told me about arriving in California when she was met by a man holding a sign for a "Mrs Bird" spelled with an "I" rather than a "y." She told him she was Mrs Byrd. He said, "I am your chauffer." He offered to take the scenic route to the hotel and show her the homes of some of the movie stars. Dot said she only knew of one, Bob Hope. He said, they would drive around Bob Hope's house which she vividly recalled and described its appearance to me.

The Tonight Show hostess asked Dot if she had ever watched the show. Dot said she had not. The hostess said, "Please watch it." Dot said, "Well, if I don't forget." The hostess then said to Dot, "I dare you to tell Johnny Carson that you have never seen his show." Well, Dot did watch it once, but when Johnny asked her if she had ever seen his show, she replied, "No, I have not, I like comedy and I watch Car 54!"

She said when she got back home she had a letter from Car 54.

During the show, Johnny pointed to a part of a picture of the library and said, "What is this little thing here, is that your post office?" Dot said, "You idiot, that is the book return!" Well, Dot said they got onto her for saying "idiot" on television and for calling Johnny Carson such a name. Now she did not mean anything

by that remark. It sounds just like her to me. Surely he should have recognized such an obvious thing as a book return for a library!

They also did not want her to say anybody's name, but she ignored that and gave credit to May McGothin because she bought the lumber for the library and had it delivered along with a door and a window! Rightly so, May should be recognized and Dot saw to it that she did!

Johnny gave her two books for the library. Dot fondly recalls all the good that

resulted from those times.

She can still get excited when talking about the publicity that she still relishes much because of the end result - a really great Coalfield Public Library and the Smallest Library located nearby. I am glad I was able to meet Dot and experience such a wonderful interaction as well as see the "Smallest Library in the U. S."

Dot still credits John Rice Irwin with starting it all and rightly so. John Rice is such a special person and I am pleased to get to visit with him some and look forward to even more suggestions for Historically Speaking. I hope you agree

with me that he has certainly hit a home run when he suggested Dot Byrd and her Little Library.

And thanks to John Rice Irwin, a much broader spectrum of our world now knows about Dot and her "Smallest Library in the U.S.!" or what she still affectionately calls her "little library."

Hebrews Chapter 12

(Heb. 12:1-11) Christian suffering: it has been perfectly transparent throughout this document that Jewish Christians are under siege from Judaizing forces seeking to destroy them by seducing them away from the faith. Surely the example of the faithful in history can provide encouragement. Figuratively speaking, the heroes of the previous chapter are depicted as a great cloud of witnesses in a grand arena, surrounding the struggling Christians and cheering them on as they run the race of their lives, attempting to remain faithful. (This does not suggest that those in the realm of the dead actually observe earth's activities.)

The faithful must lay aside every impediment that hinders, especially the sin that so easily encumbers (namely the forfeiting of one's faith), and run with endurance the race. This is possible only if one looks forward, keeping his focus on Jesus, who has gone before us as the leader and perfecter of "the faith". This concluding expression may refer to our personal faith, "the faith" system, or both. It does not suggest we are "given" faith unconditionally by the Lord. The expression, "for the joy set before him", may mean "instead of the joy he could have retained had he not come to bring salvation" or "to obtain the joy of seeing lost souls redeemed". He "endured" the agony of the cross and "despised" the idea of bearing the penalty of human sin; but by his resurrection he has been seated at God's right hand (v.2).

The Christian must focus his mind on the fortitude of Jesus, who endured the indignities of vile sinners against himself. Thereby we become determined not to grow tired and soulsick (v. 2). Though these Christians were suffering various forms of harassment, they had not yet shed their blood on the Lord's behalf in their war against sin, as he did for us (v. 4). These brothers appear to have forgotten that God allows hardship to harden (toughed) us (v. 5). They must be reminded of Scripture (Prov. 2:11-12), namely that discipline is permitted as an expression not disciplined, it would be as if we were not true children (v. 7-8). If one honors his father, who admittedly chastens him, why should we not honor God, who is the Father of our spirits (Num. 16:22) so that we might live (v. 9)? How can cultists, the Watchtower Witnesses, contend that humans are wholly mortal?

Our earthly parents have only a few days (relatively speaking) to discipline us, as such seems good to them, But God's interest in us pertains to the development of our holiness---supremely important for our eternal welfare (v. 10). Discipline certainly is not a pleasant experience while being administered; it's painful. However, in retrospect, it proves to be

valuable, yielding fruit that issues in peace in the recipient. It becomes evident it was the right thing to do (v. 11).

(Hebrews 12:12-17) exhortation to duty: using the imagery of physical disabilities, the Hebrew recipients are encouraged to get a grip on and tighten up their weaknesses, and not allow themselves to be turned aside from the way of truth; instead, they must strive for spiritual health. The same principle is involved in helping the weak along the way. One of the most difficult admonitions to follow is: "Pursue peace with all people". Some are hateful, vicious, and vindictive. It is difficult not to react, but one must remember the model of the Savior (1 Pet. 2:23). Moreover, one must develop sanctification, dedicated and consecrated service to Christ, without which one will be barred from the Lord's holy present (v. 14). Every Christian must constantly examine himself carefully to make sure he does not fall short of divine grace (Gal. 5:4).

The danger of apostasy from the faith manifests itself in various symptoms. (A) Some turn bitter, sour---negative within themselves and hateful toward others. One must guard against such. Without such diligence, a bitter root could spring up, troubling you and contaminating others (v. 15). (B) Immorality, sexual license (fornication), has been the downfall of many; one must dedicate himself to purity. (C) Profaneness is a common weakness. It is the subordination of the holy to the material. Esau, Jacob's brother, is a prime example. In a time of physical hunger (certainly not starving), he surrendered to a temporal, physical-material impulse and traded his precious birthright for immediate gratification. Impulsiveness can lead to disaster. Later, he regretted his rashness, but it was too late; the consequence of his decision could not be reversed (v. 16-17).

(Heb. 12:18-29) the tragedy of rejecting Christ: the scene now changes. The mind is transported back to Sinai and the reception of the law of Moses. The application will be plain. The writer is dealing with those who are being seduced to surrender Christianity and return to the Mosaic system, thereby leaving in the dust the teaching of the real Messiah.

When the ancient Hebrews observed the material effects (sights and sounds) and the supernatural phenomena (the very

voice of God) that accompanied the giving of the law (Ex. 19:9-23, Dt. 9:8-19), they were terrified (Moses included) (v. 18-21). In contrast, "You (Christians) have arrived at a wonderful spiritual location (environment)". Stick with it!

A small company could hire their own bookkeeper to handle payroll duties, but this may not be cost efficient and even company bookkeepers can embezzle mon-


