about a lot of classes. The 1950's were a different time than we have today. The students in my class of 1954 were born near the end of the depression, and many of them had older brothers who served in World War II and the Korean War. Very few before us had gone to college. Most graduates looked for jobs near home and a few were lucky enough to get on at Y-12 or K-25 in Oak Ridge. Some headed up north where jobs were plentiful. Some went into service and fought in the Korean War: a few died there.

The class that I graduated with not only came from the Wartburg area, but also from Lancing, Petros, Joyner, Gobey and Plateau. The ones from Wartburg had to endure a make-shift school from 1941-1946, because our school burned in January 1940. We went to school in the gym that was saved from the fire, or the white maintenance building in back of the old school. It was not good but they did the best they could. We didn't miss any school. In mid-term of the 1945-46 school year we moved into the new building. I remember it well; I was in Ms. Thelma Fretag's room.

The class of 1954 started out with many more students then we had at graduation: probably over seventy-five. At graduation we had a total of 55 students; 38 girls and 17 boys. Many boys dropped out when they were Juniors or when they reached the age of 16. I almost became one of those boys. It was pretty common back then and parents didn't seem to object, as long as their

hoped to get a lot of classes with her. As I look back, I can't understand why because I was too bashful to talk to her. Margaret now you know.

When you are young and in high school you don't give much thought about growing old and facing death. Many of us didn't even give much thought about working or what we were going to do after graduation. In the back of my mind I knew that some way I was going to go to college, but I didn't think about it too strongly, because if I had my grades would have been better. My junior year was spent in boredom and thoughts of dropping out. My senior year was spent in socializing, being in a club us boys called the Joe D. Club, and seeing how many girls I could go with. What a change came over me! I took on the personality of an extrovert it seems all at once. I was one of the few boys to have a car and if you had a car back then you were popular.

We had a fair football team

Darnell from Greeneville, Tennessee. She was no doubt the richest student from our class. All of these students married right out of high school.

Several students would go to college and most of them would complete their degree. They were Allen Nance, Lucy Sweat, Shirley Melhorn, Billy Keeten, Frank Osborne, and Tommy Redmon. Three of these would get advanced degrees. Four would teach in the school building we went to school in. Allen Nance would become principal at both the elementary and secondary levels. He would also be elected School Superintendent of Morgan County schools. Lucy Sweat would teach at both Joyner and Wartburg Elementary. Tommy Redmon would teach at Deer Lodge, Central Elementary, Putnam Senior High, Southeast High (Florida) and Administrator at several schools in Manatee County, Florida. Shirley Melhorn would teach at several smalls schools before teaching at Central Elementary.



the year of 1953. Our biggest win was over 13-7 victory over Kingston. Too bad coach Homer Rice didn't stay a few more year. He was there my sophomore year and he was no doubt the best coach Wartburg ever had.

The class of 1954 had a lot of great students in it and I just don't mean the college grads. Several of our classmates married other classmates. They were Earl Sisson/Tilley Hensley, Alan Nance/Mildred Vespie, Ralph Melhorn/Evonne Johnson, Dean Peters/Barbara England, Lo Ann Stott would marry Ralph Emerson who had graduated in 1953. Margaret Brasel would marry Howard Walls who graduated in 1955. Marcella Petree would marry Clyde Most of the sixteen boys served in the military. I'll probably leave some out and apologize if I do. I know Allen Redmon, Clarence Shannon, Frank Osborne, and A.B. Heidle served in the Army. Tommy Redmon, Russell Duncan and Thomas Harney served in the Navy. George W. Harney served in the Air Force.

A.B. Heidel served 30 years in the Army and reached the highest

good attendance. I'm sorry to say we have lost over 21 classmates; all the rest of us have medical issues, but our dear Lord has left us here long enough to enjoy our children, grandchildren and great-grandchildren. I can't tell you that all fifty-five of us have fulfilled our dreams but I know many of us have. As for me I have had a good life. Going through some dark valley's was hard but Christ was always with me. He said, "I will never leave you, nor forsake you."

I remember our entire class was sitting in the library at good ole Central on our last day of school in May 1954. I was at the table with Clarence Shannon, Allen Redmon, and Ed Hall. Ed said, "Boys look around to see all your classmates because all of us will never be together again." It was so true. Never again would all 55 of us be together again. We went through so many emotions because we knew life would never be the same. Now we had to face the real world of work, college, marriage, family and the military. Class of 1954 you have accomplished a lot in life. I've enjoyed being with you all these years. I love all of you. **Historically Speaking** The Russells: a remarkable couple

who made a difference

This is the third article in the series Carolyn Krause has created to honor Lee Russell and the memory of her husband Bill. They were truly special Oak Ridgers and accomplished a great deal of significant impact on the world in which they lived. Yet, the humble nature of Lee is still an example to all. She was one of my favorite people. Enjoy Carolyn's research as she focuses on yet another aspect of the life of Bill and Liane (Lee) Russell.

As an Oak Ridge couple, Liane and Bill Russell were 20th century, world-class scientists who traveled the world and cared about life on Earth. Just as they focused on visible signs of genetic mutations in newborn mice, they later looked for potential threats to the natural environment they loved.

In their first two decades in Oak Ridge, the Russells and their children had frequently enjoyed hiking and white-water canoeing and rafting in East Tennessee and on vacation trips. Once they took their children on a two-week canoe trip down the Green River in Utah.

"Before the mid-60s we had been sadly negligent of our wonderful Tennessee environment," Lee Russell told Steve Stow in an oral history interview. "We awoke to it because of a river that we had just discovered, the Obed River, which is only about a half hour's drive from Oak Ridge. It turned out to be threatened by a dam about to be built on it by the Tennessee Valley Authority. So, we devoted quite a bit of time to fighting TVA on that issue."

In the summer of 1966, a number of Tennesseans became outraged about a government proposal to build yet another road to fragment the Great Smoky Mountains National Park. People preparing to organize a Save the Obed group joined with those concerned about the Smokies to form Tennessee Citizens for Wilderness Planning. TCWP was incorporated in October 1966 as an organization with a mission to achieve and perpetuate protection of natural lands and waters. greenbelt areas the 11-mile-long North Ridge Trail, which was designated both a state and national trail. TCWP efforts also gained protected status for the Cedar Barrens and Worthington Cemetery, smaller ecologically significant areas in Oak Ridge.

from Cape Horn to the Panama Canal. Bill and I had some very wonderful trips."

Bill also found time for hobbies. He was skillful at making wooden pendants from dozens of kinds of wood, Lee said. During the interview with Stow, Lee wore a sumac pendant Bill had made.

"He was also a great photographer," she said. "He used to be very active in the Carbide Camera Club. He exhibited his photos almost every year, mostly black-and-white photos. Filmmaking was one of his very big hobbies."

The Russells were also subjects for Margaret Burke-White, the famous photographer. She came to Oak Ridge to shoot photos of the scientific couple for Life magazine.

"She set up a camera in our gamma source room, on the third floor, and photographed us in there many times," Lee said. "But, she also wanted to take photos of us outdoors, so we had to pitch a tent in the greenbelt, up above Delaware Avenue.

"It was supposed to look in the magazine like we were out in the wild somewhere. And, she asked me to jump on a pogo stick for one of the wonderful pictures she took here."

The picture we get of the Russells is that, as parents, scientists, scientific colleagues, and environmentalists, they made the world a better and safer place. And Lee at 90 remains active: her history of ORNL's famous Mouse House has been accepted by a scientific journal and may be made available to the public.

Thank you, Carolyn for yet another excellent Historically Speaking series. I am so proud of the collaboration and help! The Russells were examples of the greatness we have in our midst and I am afraid we all too often take them for granted. We should be singing their praises in many ways and showing the world how proud we are of them and their accomplishments.

Maybe, just maybe, the introduction of the Manhattan Project National Historical Park and the involvement of the National Park Service in our Oak Ridge heritage will help to show us that what we have here is truly unique in all the world. A recent museum workshop reinforced that for me when all the visiting museum directors cited our unique heritage as having great heritage tourism potential.

According to Lee's history on the TCWP website, "TCWP's unearthing of pertinent facts, plus application of appropriate political pressures, managed to kill the dam project." As a result, the wild, beautiful gorges of the Obed River system in the Cumberland Mountains were not flooded. And the proposed trans-mountain road through the Smokies was defeated.

"We then worked toward getting some legal protection of the river we saved," Lee said. As a result of their efforts, the Obed was classified in Oct. 12, 1976, as a national wild and scenic river under the National Wild and Scenic Rivers Act.

The act, which President Lyndon B. Johnson signed into law on Oct. 2, 1968, was designed to protect wild and scenic rivers from dams and other developments that would alter the streams' wild or scenic nature. The Obed River is the only river system in Tennessee and one of just three river systems in the Southeast to be designated as a wild and scenic river.

Perhaps the greatest achievement of TCWP began with its success in stopping the Corps of Engineers from impounding the Big South Fork of the Cumberland River, creating what would have been the highest dam east of Mississippi River. In 1974 TCWP won permanent federal protection of the 125,000-acre park, which was designated the Big South Fork National River and Recreation Area.

TCWP helped write legislation and found sponsors for three bills enacted into state law, including the Natural Areas Act of 1971. As a result, Tennessee has more than 100 legislatively designated and registered state natural areas.

Locally, TCWP developed in the Oak Ridge

Lee, who has written TCWP's newsletter for many years, told Steve Stow when being interviewed for an oral history at the Oak Ridge National Laboratory that TCWP had become a highly respected environmental organization in the state. "It is very effective because it relies on good research and background information before getting into issues. It also has influential administrative and political contacts."

Lee was a recipient of the prestigious Marjorie Stoneman Douglas Award from the National Parks and Conservation Association for the total work she had done in conservation. The Russells also were bestowed a Lifetime Environmental Achievement Award from the state of Tennessee.

The Russells traveled extensively outside Tennessee. Lee and Bill's first trip abroad together was in 1955 when they attended the international "Atoms for Peace" conference in Geneva, Switzerland. She was the only woman in the U.S. delegation, and she gave a talk on her discovery in mice that X-rays can damage an embryo when a woman doesn't yet know she's pregnant.

In their travels they gave talks and participated on committees that ended up setting maximum tolerated doses for radiation. "A lot of the maximum tolerated doses that are now in effect were based originally on the work that we contributed on the genetic effects of radiation," Lee said.


"In the '80s and '90s, we got to take some interesting trips like trekking in Nepal and going to Indonesia for snorkeling. We went all the way up and down the coast of South America, There are NO OTHER "Bill and Liane Russells" in any other location on the planet! They are ours. The only ones in the world. Oak Ridge began in war, has continued to support our nation's efforts through the Cold War, and even now in the age of terrorism. Oak Ridge has also produced nuclear medicine, nuclear power and fuel for the US Navy nuclear submarines and ships.

This "Secret City" nestled in Appalachia near Morgan County and where many from Morgan County go each day to work, continues today to produce scientific discoveries used worldwide and still routinely makes history. 




said, My spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years.

## Acts of the Apostle's chapter 1

There is no information in the book that emphatically establishes the date or place of composition. However, since Luke was with Paul during the apostle's two-year incarceration in Rome (Acts 27:1-28:16), and as the book ends so abruptly with no information provided as to the outcome of Paul's appeal to Caesar (25:11-12; 27:23-24), one may reasonably conclude that most likely Luke penned the historical record during this time frame. A. D, 61-62 is thus the most probable date.

The primary thrust of the book of Acts is to record a history of the establishment and expansion of Christianity in the first century world. From Jerusalem to Rome, the cause of Christ spread like a raging fire in the antique world. Luke wanted Theophilus, most likely a Gentile Christian, to know "the exact truth about the things (he had) been taught" (Lk. 1:4), and that would include information about how the Christian movement began. These are, of course, many details of that era between A.D. 30-62 that are not included in the divine record (for example, the history of the church in Galilee (9:31). Luke's narrative, however, was sufficient to establish the case he was attempting to make.

had entered heaven and in due time he would return in the same visible manner as he had gone away. This nullifies the false "preterist" theory that the Lord returned invisibly in A.D. 70.

The eleven apostles (Judas being dead) returned from the Mt. of Olives from which Jesus had ascended. They assembled in an upper room along with certain women, including Mary, the Lord's mother. This is the final mention of her in the New Testament. Luke assigns no special titles to her and gives no hint that she was to be singled out as a "Mediatrix" or "Co-redeemer" with the Lord, as Catholicism alleges. Also, Christ's half-brothers were there, an indication that they had now come to believe in Jesus as the Son of God. What brought the change? The resurrection!

(Acts 1:15-26) the selection of a new apostle: at a certain point within the ten-day interval between the ascension of Jesus and Pentecost, an assembly was convened (about one hundred twenty people). Peter spoke, reminding the group of David's prophecy regarding the fall of Judas and the need to fill his office (Ps. 69:25; 109:8). Even though Judas was "numbered among" the apostles and was involved in the apostolic "ministry," he had betrayed Christ and, in remorse, committed suicide by hanging (Mt. 27:5). He may have been left hanging so that eventually his body crashed and his intestines burst out (v. 18). His only "reword" for his foul deed was a field--called a potter's field (for "the field of blood")---for the interment of strangers (Mt. 27:7). Accordingly, his apostolic "office" needed to be filled by another (v. 20). A candidate was to be selected from the body of disciples who had composed the faithful band from the time of the Savior's immersion until the day of his ascension---one who had seen the resurrected Lord (v. 22). Two names were put forth---Joseph Barsabbas and Matthias. The group addressed a prayer to the Lord (most likely a reference to Christ) to show which of these men he had chosen (v. 2). The successor was to take the place of Judas, who "fell away" and was consigned to his "own place," namely "perdition" (Jn. 17:12). A child of God can apostatize and be lost. Trusting in Providence for the proper determination, they drew lots, and Matthias was chosen to be numbered with the other apostles (v. 26). (Acts 1:1-5): Theophilus was a notable official who had been converted to Christ. This book is designed to be a follow-up treatise to the Gospel account Luke earlier wrote regarding the life and teaching of Jesus up to the time of his ascension. The Lord's resurrection was amply demonstrated during the forty- day span between his resurrection and the ascension. Christ promised his disciples an overwhelming measure of the Spirit's power as a prelude to the establishment of his kingdom.

(Acts 1:6-14) the promise of the kingdom: the disciples still clung to a political perception of the kingdom, reminiscent of David's Old Testament regime. They wanted to know if the time had come for that "restoration." In view of their confusion, Christ avoided a direct answer; instead, he directed their attention to the coming promise of the Spirit and the power associated with that event (v. 8). His coming "kingdom" had been associated with the reception of "power" (Mk. 9:1). The church's evangelistic mission, beginning at Jerusalem and eventually extending to the whole earth, was sketched.

Afterward, Jesus was taken up into a cloud out of their sight. Angels informed the disciples that the Lord



If your business needs funds, there is relatively inexpensive money available right now. The Economic Injury Disaster Loan (EIDL) program which is administered by the Small Business Administration (SBA) is

providing loans.

The federal Paycheck Protection Program (PPP) that gave forgivable loans to businesses ended on August 8. However, PPP loans could return if Congress passes a new stimulus bill.

Your business can apply for an EIDL even if it already received a PPP loan. However, you can't use an EIDL to pay the same payroll costs or other expenses that you could pay with a PPP loan.

If you received a both a PPP loan and an EIDL advance, your bank must deduct the advance amount from the amount of your loan forgiveness.

EIDLs are still available throughout 2020. Your business is eligible for an EIDL if it suffered "substantial economic injury" due to the financial effects of Covid. You qualify if your business is unable to pay its normal operating expenses or to sell or produce its goods or services. Your business revenue isn't required to decline by any particular amount.

Your business must also have fewer than 500 employees. Sole proprietors with no employees are eligible.

It also requires that your business has been in operation since January 31, 2020. The SBA is currently setting a maximum amount of \$150,000 for the EIDL. You apply for the EIDL directly from the SBA.

The SBA has a streamlined application and there is no cost to apply for the EIDL. The SBA may approve it without requiring an applicant's tax return based solely on it's credit score. EIDL loans are often approved without any interaction with an SBA loan officer.

The purpose of an EIDL is to cover six months of your business's operational expenses.

The loan amount for most small businesses is the gross revenues minus cost of goods sold (COGS) during the period from February 1, 2019, through January 31, 2020, divided by two.

If you have a service business that doesn't have a cost of goods sold, enter "0" in the COGS line in the loan application.

Unfortunately, EIDLs are not forgivable. They are 30-year loans with a 3.75 percent interest rate. Commercial loans typically have terms much less than 30 years which makes the EIDL monthly payments lower. The SBA doesn't require any collateral for EIDLs under \$25,000 and the first EIDL payment isn't due until one year after you receive the loan.

An EIDL can be used for a wider range of expenses than PPP loans and you don't necessarily have to use it for payroll at all. An EIDL can't be used to replace lost sales, start a new business or to fund a business expansion.

If you are interested in receiving money from an EIDL, it is important to learn the details before applying for the loan.
