TVA Partnership Awards Sunbright Middle School STEM Grant

Nashville, Tenn. — The Tennessee Valley Authority, in partnership with Plateau Electric Cooperative and Bicentennial Volunteers Incorporated (a TVA retiree organization), recently awarded Sunbright Middle School, \$5000 for a STEM (science, technology, engineering, and math) education project. The grant award is a part of \$800,000 in competitive STEM grants awarded to nearly 200 schools across TVA's seven-state service territory.

Amy Jones, Sunbright Middle School STEM Teacher said. "First, I would like to thank TVA, Plateau Electric Coopera-

tive, and BVI for providing such an opportunity to area schools and without them none of this would've been possible. For a small rural school such as Sunbright to be selected amongst so many other great school's is a real blessing. This is only the 2nd year our school has had a STEM program. This monetary award will provide many more STEM opportunities for our students that may not otherwise get this kind of chance to have hands-on learning using modern technical based kits, projects and materials. Although this grant will immediately make an impact in our current student's education; the items that will be purchased will be utilized for many years to come to keep students engaged, interacting and thinking which are some of the core functions of our STEM program. Once we were notified of this award, my classes and I started planning what projects they wanted to pursue. All the materials will be interchangeable across all (3) grade bands but each grade was able to pick 2 focus areas of interest. 8th Grade wanted to pursue projects in Engineering and Architectural Design, 7th Grade plans to focus on Engineering and Computer Animation; while 6th Grade wants to learn more about circuits and electronics. All (3) grade bands want to learn more about renewable energy with Solar Panels. We previously had a solar panel lesson on planning and designing a solar classroom. In this lesson, we used an energy consumption meter to determine how much energy different items in my classroom used. They had to price solar panels, determine how much energy would be needed to run each item, and plan out the design of their Solar Classroom. It was amazing what our students came up with. They absolutely loved it and I would like to put what they've learned into action by possibly obtaining a solar panel to put outside our classroom.



Across the valley, educators submitted projects large and small, to further their STEM education initiatives in the classroom.

The project Sunbright Middle School submitted will be Using STEM - Science, Technology, Math and Engineering to Solve Real World Problems.

The competitive grant program provided teachers an opportunity to apply for funding up to \$5,000 and preference was given to grant applications that explored TVA's primary areas of focus: environment, energy, economic and career development and community problem solving as well as pandemic related projects. Schools who receive grant funding must receive their power from a TVA distributor. "Despite the new challenges Valley teacher's faced in 2020, they are still focused on providing the best STEM education possible and have adjusted to new ways of teaching,' said Community Engagement Senior Program Manager Rachel Crickmar. "I am proud of the partnerships we have built with these amazing educators across the Tennessee Valley over the past few years and are pleased to be able to provide some support through this program. Through the grants awarded this year, over 72,000 students will be directly impacted across the Valley." A full list of the grant recipients can be found at www.tvastem.com.

The Tennessee Valley Authority is a corporate agency of the United States that provides electricity for business customers and local power companies serving nearly 10 million people in parts of seven southeastern states. TVA receives no taxpayer funding, deriving virtually all of its revenues from sales of electricity. In addition to operating and investing its revenues in its electric system, TVA provides flood control, navigation and land management for the Tennessee River system and assists local power companies and state and local governments with economic develop-

ment and job creation.

"This was an abhorrent crime," said Sen. Yager, who represents Roane County in the Tennessee Senate. "About 99% of adoptive parents do an outstanding job. However, there is a fraction who abuse children while pocketing their adoption subsidy, which is intended to help support the child's needs. That is who this bill targets. We must do everything we can to ensure this never happens again."

The arrest warrant said the children were fed a "starvation diet of light bread and water" by their adoptive parents. They

were also locked in a basement and caged in isolation. Roane County law enforcement authorities found the body of one of the deceased children, a young girl, buried in the family's barn in Roane County. The second child, a boy, was found buried in the back yard of the adoptive parents' adult biological son in Knox County. Authorities believe the children were buried several years before discovery. The adoptive parents continued receiving financial benefits for both children after their death.

"This legislation would ensure that DCS receives an annual notification on any child when the adoptive parents are receiving subsidy payments," added Sen. Yager. "Most importantly, it provides DCS with the authority to check on the child when that information is not received and foul play is suspected to hopefully prevent such tragedies."

The adoptive parents each face multiple counts of felony murder, abuse of a corpse, aggravated child abuse and aggravated child neglect. They also each face counts of abuse of a corpse, theft, TennCare fraud, and falsification of educational or academic records. The adoptive parents had claimed the children were home schooled.

Presently, DCS gives an incentive for foster families to adopt their foster children by promising a monthly adoption subsidy until the children are age 18 to 21. Once the adoption is finalized, DCS caseworkers do not check back in. Parents are requested to sign an affidavit to promise they are adhering to the agreement every two years.

The bill now must pass the House of Representatives, where it is sponsored by Representative Mary Littleton (R-Dickson), before it goes to the governor's desk for his signature.

Legislation would aid Tennessee's Volunteer Firefighters

Yager urges all local volunteer fire departments to apply for grant program

How many people would leave their bed in the middle of the night and risk their lives for others for no money and little reward? Our volunteer firefighters do it all the time. We are very fortunate to have many people across our district who are willing to put their hands up and fight throughout the night to save someone's home – and potentially their lives.

Our volunteer firefighters exemplify our state's nickname as the Volunteer State, making up 64% of Tennessee's firefighters. They put their lives on the line for our communities every day and we need to do everything we can to support their efforts.

Earlier this year, I filed legislation to provide an annual payment to Tennessee's volunteer firefighters upon completion of their training. I was delighted that Governor Bill Lee has included \$4.9 million in his 2021-2022 budget for this purpose. It provides an annual \$600 payment upon completion of at least 30 hours of training. Currently, the cost of any training or equipment is often at their own expense.

The proposed budget also includes \$1 million to provide support grants for volunteer firefighter departments under a program set up by 2019 legislation which I was very happy to co-sponsor. Just as they keep us safe every day, we need to make sure our volunteer firefighters have the resources they need to do their job safely and

effectively. The Volunteer Firefighter Equipment and Training Grant Program helps secure the equipment, training, and support they need. Applications for these grants are made through the Tennessee Department of Commerce and Insurance. The proposed funds for these grants are doubled from the previous 2020-2021 budget year and I want all of our local volunteer fire departments to apply.

In addition, legislation I am co-sponsoring has been approved by the Senate to incentivize volunteer firefighter recruitment by establishing an innovative retirement system called a Length of Service Award Program (LOSAP). The bill authorizes the State Treasurer to inquire with local governments and the volunteer fire departments about establishing a LOSAP plan for volunteers providing firefighting and prevention services, emergency medical services, and ambulance services.

LOSAPs may be defined contribution plans, similar to 401(k), or defined benefit plans, like a pension. Such a program is funded by contributions from the local government or nonprofit entities that utilize the services of eligible volunteers. To be eligible to receive benefits from the LOSAP, an individual must be a bona fide volunteer who receives no compensation for the services and instead receives only reimbursement for reasonable expenses or benefits and nominal fees customarily paid to them.

Our volunteer fire departments must recruit individuals to take their place as they age and complete their service. Unfortunately, we are seeing a decline in the number of volunteers to take their place. This program will hopefully provide an incentive that will help them in their recruitment efforts, while providing a needed benefit for the brave men and women who put their lives on the line for the fellow citizens.

I am looking forward to seeing all of these proposals pass in the coming weeks. I hope you will join me in support of this legislation and in appreciation for the great service that our volunteer firefighters do for our communities.

The Sullivan Brothers of WWII

Thomas and Alleta Sullivan of 98 Adams Street in Waterloo, Iowa had five boys they were proud of and like any

parents of this many strong good-looking boys they

wanted the best for them. They were all born before 1920 except for Al; barely missing WWI but going through the Great Depression where there was little work for young men in the Midwest. This family was of Irish descent. They didn't have a lot but Thomas worked on the railroad and they made it the best they could. All of the boys dropped out of school when they were in the 9th or 10th grade. They were never into a lot of trouble, but they couldn't find work because of the depression and they did hang out at the pool rooms in Waterloo and ended up in a motorcycle gang. One of the boys said he loved his motorcycle more than anything in the world. His name was Joseph but they called him "Red" because of his red hair. The other four boys were George 27, Frank 26, Madison (Matt) 22, and Albert (Al) 20; Joseph (Red) was 24, when the big part of this story takes place.

The boys really loved fishing and hunting. One of their principals went hunting with them some and he said they all were experts with a rifle.

Two of the boys George and Frank had already served one four-year hitch in the Navy from 1937 to 1941. They were not out long when the Japanese attacked Pearl Harbor on December 7, 1941. One of their best friends, Bill Ball, died in the attack on the U.S.S. Arizona. All five of the boys talked it over and they all agreed that they needed to join the Navy and pay the Japs back. Back then it had been okay to put brothers on the same ship if no war was going on, but when the Sullivan Brothers joined in January 1942 there

was a war on two fronts. The Sullivan Brothers, were so close they begged the Navy officials to let them stay together. It worked and it was one of the worst things that could happen to a family.

The boys were put on the U.S.S. Juneau, a light cruiser that had been launched recently at a cost of \$13,000,000. The Captain of the ship was Ly Mark Swenson and the ship had a crew of around 700 men.

The Navy spent several months training the men and getting them acquainted with the new ship. Many of the sailors were fresh out of Boot Camp. George and Frank had been on a ship somewhere around 1938-40. So, they no doubt had a jump on the other brothers and crew members.

After months of training the sailors were given leave to return home. One of the boys Joseph (Red) had been writing to

boys went on to see their folks back in Waterloo, Iowa. They had a sister by the name of Genevieve. She was a beautiful girl of twenty-six and she really loved all her brothers.

Red's pen pal in Pittsburgh turned out to be a real beauty and before he left Pittsburgh he and Margaret were engaged to be married, but this was the first and last time that they would see each other. When the Sullivan's came back to the ship the U.S.S. Juneau headed to the South Pacific. Their assignment was around the Solomon Islands were much of the early battles in WWII were fought. The United States wanted to hold off the Japanese, and keep them away from Australia. This turned out to be some of the fiercest battles the U.S. Navy and Marines fought in WWII. The Juneau was off the coast of Guadalcanal on November 13, 1942 when they joined the big

got the word that their five sons were missing at sea. They held hope that somehow their boys had survived but after a few days of no-good news Rear Admiral Randell Jacobs, Chief of Naval Personnel notified Mr. and Mrs. Thomas Sullivan that their sons were given up for dead but according to Naval records they are listed as missing in action. Later the parents were awarded five Purple Hearts, one for each son.

All the family took this great loss hard but their sister seemed to take it the hardest. After much grieving Genevieve joined the Navy Waves because she felt her brothers paid the ultimate cost, the least she could do was join the Waves. She would stay in the United States mostly recruiting women for the Waves. Mrs. Sullivan was asked to help the government in several ways. She would get to dedicate a new ship and later a destroyer was named "The Sullivan" in honor of the five boys lost. They also made a movie about the life of the Sullivan boys with only about 3 ½ minutes depicting the ship in battle.

Pretty Margaret Jaros, Red's girlfriend he was engaged to would come to Waterloo to be with the boy's mother. Many honors were placed upon the Sullivan family but nothing could take the place of their five boys. Thomas would die in the early 60's and Alleta would die in 1972. Their daughter would die in 1975 at the young age of 60. Waterloo, Iowa still remembers the Sullivan Brothers and a memorial has been built. The American Legion Post has been named in their honor. The U.S. Navy has made a new ruling that says brothers cannot be put on the same ship. Do you know that 63 brothers died at Pearl Harbor and only four bodies were recovered? Serving on the U.S. Arizona was a father and son, and 23 sets of brothers.

A Mrs. Bixby lost five sons in the Civil War and was consoled by President Lincoln.

I think one of the saddest sounds is that of a bugler playing "Taps" at the funeral of a serviceman who gave his all for his country.

We all should love this country because much blood was shed to preserve our freedoms, look what the Sullivan's did.



a girl in Pittsburgh and she wanted him to stop over and see her before going home. The way they had become pen pals was quite a story in itself. A girlfriend of Margaret Jaros had dared her to write one of the Sullivan Brothers they had heard about from an article in the paper. She took the dare and wrote a letter to the Sullivan's and "Red" was chosen to write her back since he was the only one who didn't have a girlfriend back in Waterloo. Al had a wife and they had a 21-monthold son by the name of Jimmy. The other three were either engaged or had someone back in Waterloo they went with. Since the boys only had fifteen days of leave Red stopped in Pittsburgh to see Margaret for the first time while the other

The Jap destroyer Amatsukqze let loose a torpedo that ripped into the side of the Juneau killing nineteen men. The Juneau tried to withdraw but a Japanese submarine sent a torpedo toward her and the ship received a fatal blow, the ship sank so fast that most of the ship's 697 men went down with her. There were thirteen survivors. One of the men who survived said that George Sullivan was on the life raft with them but died from his wounds. The other Sullivan's had to be on the ship when it went down.

Historically Speaking Oak Ridge and the Red Cross, Part

Last week we looked at the beginning of the American Red Cross. This week we continue our examination of that history with regard to the local chapters and focus on the Red Cross response to the July 6, 1944, troop train wreck. The history of the Red Cross in Anderson County has some unique aspects to it with regard to the Manhattan Project in nearby Oak Ridge.

One person seems to have been a key player in the early history of the Red Cross in Anderson County: Maurine Owen. She was involved in much of what was going on during the Manhattan Project and also was personally very involved in the response to the troop train wreck.

In an article published in the Clinton Courier News on April 2, 1981, Katherine B. Hoskins authored "Oak Ridge was branch of county unit during war." In the column she addressed the history of the Oak Ridge Chapter American Red Cross.

The Manhattan Project brought substantial changes to the area of Appalachia near Clinton that had been quietly existing and continually growing for 100 to 150 years. The people were comfortably able to take care of themselves with their farms and the produce they marketed. Some areas had extensive peach crops. However, the people were about to experience drastic changes. The land they had lived on for generations was being taken by the government for the war effort.

In my research, I learned that Katherine Hoskins was the executive secretary of the Anderson County Chapter of the American Red Cross from September 1942 until December 1942, when Maurine H. Owen became the executive secretary. Owen still held that office during the response to the 1944 train wreck and continued to hold it until 1952

That means that Maurine Owen was the key individual who managed the service provided by the Red Cross to the new and unique Manhattan Project. For the first time the Red Cross was being asked to manage services to civilians as well as military. And this was not the only radically new approach being asked of the Anderson County Chapter of the American Red Cross.

For the first time, the Red Cross was being asked to use extreme precautions to prevent divulging any secret information. Even the location of the area they were servicing was protected. Just the mere mention of a person's name in association with the secret operations at Oak Ridge was unacceptable. New methods had to quickly be devised to allow the necessary services to be provided, yet to protect the very special war effort being mounted right in the middle of Appalachia.

The Oak Ridge Chapter American Red Cross began in December 1943 as a branch of the Anderson County Chapter American Red Cross. The first Red Cross office in Oak Ridge was located at the Elm Grove Shopping Center where it opened in December 1943. In January 1945 the office was moved to its present location at 908 Oak Ridge Turnpike. It is now known as the American Red Cross – Appalachian Chapter.

Let's pick up our story with the changes in the local Red Cross required in the Anderson County chapter upon the arrival in Robertsville and Scarboro of the Army Corps of Engineers and their most secret Manhattan Project. The changes affected everyone in the small communities that were taken over by the Army, but also the surrounding communities and cities were impacted as well.

For example, think of the increased population of 3,000 people moving out of Bear Creek Valley, East Fork Valley, Bethel Valley and Wheat. These people had to

relocate to surrounding communities. There was not a lot of available land, and with that influx of families, the price of land naturally increased because of the increased demand.

History

Almost immediately, the small communities of Robertsville and Scarboro, along with several other communities such as New Hope, Bethel and other small farming communities, no longer existed. Some of the major buildings, such as the school buildings, were spared, but the homes were almost all demolished right away.

Some of the larger homes served as offices for the Corps of Engineers as construction began immediately. Those people who sacrificed their homes did not know that this country was in a race with Germany to build an atomic bomb. They only knew they had to get off their land in a hurry.

The residents had been told to leave in October and November 1942. They were gone by December 1942 and massive new construction activities began, in early 1943, to bring huge numbers of new people into the "project" area. This influx of people taxed the system for helping the needy. Something had to be done almost immediately.

Many of the people coming to work on the secret effort only knew that work was available there, and if they could get hired and find a way to get to this unknown place, they could earn some money for their families. Upon arrival, many of the workers had exhausted their funds just getting there. Therefore, help was needed in many different ways.

The military could see the needs but were not equipped to meet them. A Red Cross was needed. Being familiar with Red Cross support in other locations near military bases, they looked to the closest local chapter, the Anderson County chapter.

The needs were met as best they could be under the unusual circumstances. By December 1943 it was obvious the needs inside the secret city and its various construction sites required a presence of a local Red Cross office in Oak Ridge.

The National American Red Cross considered the Anderson Chapter the parent organization in the county and all other Red Cross organizations in the county would be branch offices. That is the primary reason the Oak Ridge organization was first established as a branch office. Later, in 1947, the Oak Ridge chapter was given its own charter.

The unusual circumstances of Oak Ridge required some most unique arrangements be made. Information about the "secret city," that was not even on any maps, had to be protected. The people there could not be identified with the project. There were concerns that information about the hospital being built there would compromise security. Yet when the troop train wreck occurred, the hospital was quickly opened to the injured soldiers.

During the Manhattan Project, the secrecy of the Clinton Engineer Works at Oak Ridge was such that even operating a Red Cross required special precautions. All correspondence was sent through the Anderson County Chapter.

Katherine Hoskins, Anderson County Historian, says in her April 2, 1981, Clinton Courier News article that, "all mail going from Oak Ridge Chapter was sealed, carried to the Anderson County Chapter, put in another envelope, then stamped and mailed with a Clinton postmark." Again, we see the secrecy associated with the Manhattan Project also had an impact on the neighboring city of Clinton as the Red Cross was involved in protecting the identity of individuals involved in the project.

Before the Oak Ridge branch office was opened, all requests for assistance were handled by sending them to the Anderson County Chapter executive secretary, Mrs. Maurine Owen, who forwarded them to the Red Cross field director, T.W. Brownback, stationed at the University of Tennessee in Knoxville. Brownback would clear the case through Captain T.W. Taylor, special services military officer at Oak Ridge. When the case was approved, Owen would be granted the necessary pass into Oak Ridge to interview the person involved in the case.

Hoskins wrote in a March 26, 1981, historical article in the Clinton Courier News of the actions of the Red Cross during the 1944 train wreck. She notes that Oak Ridge was the closest military installation and that many of the survivors were sent to Oak Ridge to stay in the barracks there; injured were taken to the hospital there. She further notes that as Oak Ridge was a "secret city" or as she says, a "top secret installation," the Oak Ridge Branch Red Cross chapter was also secret. Casualty messages were sent by the military personnel.

She said, "Every family who had a boy recently inducted from the Virginia area began telephoning or coming to Clinton Red Cross office. Volunteer workers were recruited to answer phone calls and talk with the families arriving in person; even so, the Anderson County executive secretary, Mrs. Harry L. (Maurine H.) Owen, one time during the disaster aftermath worked for 36 hours without lying down or sleeping. She also was sent to Jellico and Lafollette to visit the hospitals and homes there, where some of the injured were taken. Some died in private homes."

Hoskins continued, "Emergency canteens were established by the Oak Ridge Red Cross office in the hospital to serve those bringing in the injured. Volunteer workers were stationed at Elza Gate to assist families coming to Oak Ridge to visit the injured soldiers. Financial assistance was furnished some of the wives who came to Oak Ridge to stay until their husbands were transferred."

Next, we will look at the details of the disaster report prepared by the executive director of the Oak Ridge Branch of the Anderson County Chapter of the American Red Cross.

Oak Ridge was created as a part of the Manhattan Project in 1942 to help stop World War II. The atomic bomb, Little Boy, fueled by uranium 235 separated at Oak Ridge helped to do just that.

Oak Ridge began in war, has continued to support our nation's efforts through the Cold War, and even now in the age of terrorism. Oak Ridge has also produced nuclear medicine, nuclear power and fuel for the US Navy nuclear submarines and ships.

This "Secret City" nestled in Appalachia near Morgan County and where many from Morgan County go each day to work, continues today to produce scientific discoveries used worldwide and still routinely makes history. These Historically Speaking stories will provide insight into the people of Oak Ridge and the work they do to help humankind. Historically Speaking is written by D. 





pulling, and even carrying Rick in races to include the most

> extreme triathlons such as six Ironman Triathlons.

Through each of the six Ironman Triathlons, Dick would use a rope attached to his body to pull Rick in a boat during the two-mile swimming portion, then race 150 miles

on a bike and a 26.2mile run.

Throughout each race event you would see sheer dedication in the race of Dick and pure jubilation in the face of his precious son Rick.

Although Dick died due to a heart condition, I can only describe his heart with one word, "pure". I like to thank that Jesus Christ welcomed Dick Hoyt into the gates of Heaven by telling him, "you have fought a good fight, you have finished your course, you have kept the faith:" - 2 Timothy 4:7

Acts Chapter 25

(Acts 25:1-5) The charge before Festus: it is believed that Festus served as Palestine's procurator ca. A.D. 56-59. He would be headquartered at Caesarea. After three days, he was prompted to travel up to Jerusalem, probably to "take the temperature" of the political and religious climate. The Jewish leaders could scarcely wait to "inform against" Paul. They begged him (repeatedly, so the verbal force) to have the apostle brought to Jerusalem. Their idea was to lie in wait and kill him. The hate they harbored for this man is beyond human description. Festus denied the request. He was about to go back to the coastal city. If they had a case, they could pursue it there.

(Acts 25:6-12) the hearing at Caesarea: after a little more than a week, the procurator went down to his city. He presently convened for court and commanded Paul to be brought to the proceeding. The Jerusalem Jews surrounded the apostle and furiously hurled numerous and reckless charges, none of which could be proved (v. 7). Paul responded that he had committed no violation against Judaism, the temple, or Rome. He was resolute.

Festus, however, was a weakling politician, coveting the favor of the Jews, so he attempted a compromise. Would Paul go up to Jerusalem for a trial and judgment (v.9)? The apostle applied the pressure. "I am here at the site of Caesar's judgment throne. Do you speak for Caesar, or do you belong to the Jews?" It was burning question from a tough defendant, for whom not even the "judge" was a match. Paul said with force: "You know what is going on here? If I have committed a capital crime, I will not resist the penalty. But these accusations are false. If I cannot get justice here, I appeal my case to Caesar" (v.11). The reference was to Nero (A.D. 54-68). Those were "magic" words, and they were his right as a citizen. His case would now go to the "supreme court"! His ambition to go to Rome would now be realized (Rom. 1:10). The Christian does have the right to use the legitimate provisions of civil government for his protection. Both Festus and the council now knew their hands were tied. "Unto Caesar you will go" (v. 12).

(Acts 25:13-22) Festus seeks Agrippa's advice: after the passing of several days, two other important persons arrived on the scene. This brother-sister team may have come to welcome Festus to his new post. Agrippa II was the son of the brute who murdered James (12:1). He was about seventeen when his father was slain by God's angel (12:20-23).

He ruled over certain territories in northern Palestine.

Bernice and Drusilla (24:24) were sisters of Agrippa II. According to Josephus, it was rumored that Bernice and her brother had an incestuous relationship (Antiquities of the Jews 20.7.3). Agrippa and Bernice remained in Caesarea "many days." Eventually, Festus decided to approach them with this interesting case regarding Paul, the Christian preacher. After all, they were familiar with the intricacies of Hebrew law; maybe they could help with this difficult case.

Festus prepared the two by rehearsing the history of Paul's case so far as he knew it. There were charges by the Jews against this man. As he surveyed the matter, the accusations had nothing to do with civil law, but involved questions regarding "their own religion" (v. 19), thus would be of no concern to Rome. It seemed to revolve around a man called Jesus who was dead, but whom Paul claimed was alive. Festus confesses he is woefully confused concerning how to handle the matter. He mentioned that, ultimately, Paul had appealed to Caesar. He said he was keeping the prisoner safe until the opportunity arose to ship him to Rome and Caesar's court. Agrippa expressed an interest in hearing Paul, and Festus promised a meeting the next day.

(Acts 25:23-27) the next day's events: as the new day dawned, excitement charged the atmosphere. A significant group of spectators entered the chamber where the proceedings were to be conducted, and Paul was brought into the room. Festus opened the meeting with a brief statement of explanation. The Jews have vigorously protested that "this man... ought not to live any longer" (v. 24). The ruler confessed he had been unable to find sustainable charges. Paul had appealed to Caesar, and a determination had been made that he should go. But Festus was perplexed; he had not figured out how he would explain to the emperor why he was sending this celebrated Hebrew, who was also a Roman citizen. Hence, he declared that the purpose of this session was to allow Agrippa the opportunity for examination and subsequent assistance with framing a sensible bill of particulars. It always helps to add the name of an authority figure when one lacks the courage to take full responsibility!



Third Stimulus Ben-

The third stimulus will help more people than the first two stimulus. The amount of the new stimulus is

College students and adult dependents will be eligible for the stimulus.

Young adults may be eligible for a stimulus check by filing their taxes independently. This can be of particular benefit to students whose parents make too much to receive the stimulus. Since the parents wouldn't be eligible for any stimulus due to their income, their dependents would be eligible to receive the stimulus by

filing independently. Individuals who want to qualify for the stimulus on their own should file a tax return as soon as possible to try to

become eligible. Additionally, young adults who didn't file independently in 2019 and weren

claimed as a dependent, will still be able to receive their first stimulus check. They will be able to receive the first stimulus by claiming the Recovery Rebate Credit from the Cares Act on their 2020 tax return.

The Center on Budget and Policy Priorities (CBPP) estimates as many as 15 million adult dependents and older children were not eligible for the previous stimulus payments under the CARES Act.

The amount that adult dependents will receive will depend on the income of the person claiming them on their taxes.

The phaseout range starts at \$75,000 for singles, \$150,000 for married couples filing jointly, and \$112,500 for heads of households.

If the income is at or more than \$80,000 for singles, \$160,000 for married couples filing jointly, and \$120,000 for heads of households, they won't qualify for the third stimulus.


If you are past due on child support, you can still receive the entire stimulus payment. Unlike the previous stimulus payments, it won't be used to pay late child support payments. Any past-due federal or state debts won't affect the stimulus. However, private debt collectors may be able to use the stimulus to apply toward a debt.

The IRS overpaid stimulus to some parents when the first two payments were made. This was due to the fact that some divorced parents alternate years for claiming their children. The IRS looked at both 2018 and 2019 to determine eligibility for the first check. So, if one parent claimed the child in 2018 and the other parent claimed the child in 2019, both parents received the stimulus for the same child.

The second stimulus check was based only on the 2019 tax return. However, if one parent got the stimulus and the other parent claimed the child on their 2020 tax return, they would receive the stimulus for the same child by claiming the Recovery Rebate Credit.




