




Veteran of the Week

United States Army veteran Major Drew Dennis Dix served in the Vietnam War as a Staff Sergeant assigned to Senior Advisor Group, IV Corps, U.S. Military Assistance Command.

On January 16, 1969 he was presented with the Medal of Honor at the White House by President Lyndon B. Johnson for his heroic actions in combat from January 31 – February 1, 1968.

Major Dix's Medal of Honor citation reads: For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. SSG Dix distinguished himself by exceptional heroism while serving as a unit adviser.

Two heavily armed Viet Cong battalions attacked the province capital city of Chau Phu resulting in the complete breakdown and fragmentation of the defenses of the city. SSG Dix with a patrol of Vietnamese soldiers, was recalled to assist in defense of Chau Phu. Learning that a nurse was trapped in a house near the center of the city, SSG Dix organized a relief force, successfully rescued the nurse, and returned her to the safety of the Tactical Operations Center. Being informed of other trapped civilians within the city, SSG Dix voluntarily led another force to rescue eight civilian employees located in a building which was under heavy



mortar and small-arms fire. SSG Dix then returned to the center of the city. Upon approaching a building, he was subjected to intense automatic rifle and machine-gun fire from an unknown number of Viet Cong. He personally assaulted the building, killing six Viet Cong, and rescuing two Filipinos. The following day SSG Dix, still on his own volition, assembled a 20-man force and though under intense enemy fire cleared the Viet Cong out of the hotel, theater, and other adjacent buildings within the city. During this portion of the attack, Army of the Republic of Vietnam soldiers inspired by the heroism and success of

SSG Dix, rallied and commenced firing upon the Viet Cong. SSG Dix captured 20 prisoners, including a high-ranking Viet Cong official. He then attacked enemy troops who had entered the residence of the Deputy Province Chief and was successful in rescuing the official's wife and children. SSG Dix's personal heroic actions resulted in 14 confirmed Viet Cong killed in action and possibly 25 more, the capture of 20 prisoners, 15 weapons, and the rescue of the 14 United States and free-world civilians. The heroism of SSG Dix was in the highest tradition and reflects great credit upon the U.S. Army.

Law Enforcement Officer of the Week

Police Officer Loren Michael Courts of the Detroit Police Department, Michigan was shot and killed on July 6, 2022 while responding to a shooting call.

When Officer Courts and his partner arrived on the scene, the subject immediately began shooting at them, striking Officer Courts while he was still in his patrol car. After being shot, Officer Courts put their patrol car in reverse, and he and his partner jumped out of the car to take cover. His partner tried to save him by applying pressure to his wound, with her back toward the approaching gunman. The subject



had come downstairs from the building, pointing the gun at the two officers. Other officers who had arrived on the scene shot and killed the suspect.

Officer Courts was transported to Sinai Grace Hospital, where he succumbed to his wounds a short time later.

Officer Courts had served with the Detroit Police Department for five years and was assigned to the 2nd precinct. He is survived by his wife, son, daughter, and parents. His father had recently retired from the Detroit Police Department.

For the Good of the Country, Biden Shouldn't Run Again

Perhaps the best decision Joe Biden could make as president is to stand down.

It would be a welcome act of statesmanship and self-awareness if the 79-year-old president dropped the insistence that he's running for a second term, and instead announced sometime after the November midterms that he isn't running again.

He was too old to run in 2020 but made his way into the office he had coveted for decades by default.

In two and a half years, Biden won't be any younger and the chances of something going catastrophically wrong only increase with time.

The country's experience with a 78- and 79-year-old president hasn't been pretty. Just wait until Biden is 82 (at the time of his theoretical second inauguration), or 84 (after the second midterms), or 86 (at the end of his second term).

A New York Times report confirms about what you'd expect of White House aides. They fear that Biden, who increasingly shuffles when he walks, will trip over a wire. They hold their breath hoping he can get to the end of remarks without making a gaffe. They generally don't have events for him at night and try to keep the weekends free.

In an office that requires vigor and forcefulness, he's mumbly and bleached out. In a position that makes young men suddenly look much older, he's already quite aged. In a job where words matter, he can't keep his straight.

Yes, there have been elderly leaders of nations who have been unquestioned giants -- Konrad Adenauer, Charles de Gaulle, Ariel Sharon. No one is mistaking Biden for a statesman of such caliber, though. He's more like President Jimmy Carter with a quarter century more on the odometer.

Even if in the unlikely event Biden's age isn't affecting how he can do his job now, it will at some point.

Then, there are the disaster scenarios. We should all hope that Biden lives to be a 100 but were he to die in office of natural causes, it would be a significant national trauma. We haven't had a president die in office in half a century and it would create comparisons to the gerontocracy of the late Soviet Union.

If anyone thinks American politics is poisonous now, just wait till there's an unelected president (the vice president would succeed Biden in this scenario) and an unelected vice president appointed by the unelected president. All this would be the process set out by the 25th Amendment; it would generate legitimacy concerns all the same.

If a health event prevented Biden from performing his duties, meanwhile, it would create a crisis at the top of our government. The natural tendency of politicians and their loyalists is to be less than forthcoming about health problems. What Edith Wilson did when Woodrow Wilson had an incapacitating stroke -- hide it as much as possible and carry on regardless -- wouldn't be possible in the current media age. That doesn't mean there'd be -- the members might be older (I saw

The process for sidelining a debilitated president under the 25th Amendment is a mess, especially if the president doesn't think he's incapable of discharging his duties -- such a scenario would make an impeachment look neat and clean by comparison.

Perhaps none of this would ever come to pass and a reelected Biden would make it to the finish line with ease, proving that 85 is the new 75. It's also true that anything could happen to anyone of any age -- even a 45-year-old president could fall ill. But the longer Biden serves, the higher the risks.

And for what? Biden isn't uniquely gifted, ideologically compelling, irresistibly likable, or very good at being president. His claim to be the only Democrat who can beat Donald Trump in 2024 looks more attenuated by the day.

In short, there's no good reason for Biden not to make the best call of his presidency and prepare for retirement.

Make Pounded **Pansy Pouches**

I don't know a young child who doesn't love a hammer. Watch when kids grab one tightly in both small hands, lift it high and pound. Thud! They see it do something. It might only be a nick on a board, or, if lucky, they'll hit a nail square on. Throughout the action, it's a thrilling feeling of control and an introduction to the adult world.

Hammers can be the perfect tool for kids to make imprints of fragile flowers, too. When they tap, tap, tap a wax-paper-covered flower on fabric, they magically see the bloom's natural colors and shapes appear right before their eyes.

No wonder families recently filled the benches at a craft booth at our local weekend farmer's market. Pounding natural designs of violet pansies onto fabric was the first step. Then the children learned to hand-sew pouches with simple stitches after the pounding. Even some preschoolers could sew handily with adult assistance.

Here's how:

- 1. Cut two pieces of plain white cotton or muslin fabric 2 3/4 inch wide by 3 inches long with pinking shears.
- 2. Put one of the fabric pieces on a cutting board or a flat piece of wood. Carefully set a fresh pansy bloom in the middle of the fabric — front side

down and stem side up. Cover it with a sheet of wax paper and hammer over the wax-paper-covered flower until its color has been absorbed into the fabric. Remove the wax paper and pansy to reveal the natural, colorful floral

3. It's time to sew the two fabric pieces together to form the neck pouch. Thread a large needle with a 30-inch length of embroidery floss. Stack the fabric pieces with the floral print on top and, beginning at the top right corner, sew the sides and bottom together with a running stitch. Guide your child's hands when needed. When complete, remove the needle and knot the end of the floss to the starting corner of the pouch.

Historically Speaking More on Melungeons and DruAnna

First let me thank Joe Stephens who called to remind me to be more diligent in fact checking and rightly so. I placed John Rice Irwin as Superintendent of Anderson County Schools much

too late and even put his office in Oak Ridge. Joe thought that was just too much error and called to tell me so. I plead guilty, Joe, of being lax and relying on my faulty memory without checking details.

The error was totally mine. I recalled when John Rice had an office in the same building as the Children's Museum of Oak Ridge and I knew he was once Superintendent of Schools in Anderson County. I just mixed up the two.

Fact is, John Rice Irwin was the youngest ever Superintendent of Anderson County Schools, being elected at age 31. Having been

born in 1930, would put him being elected in the early 1960's, I found a quote from him placing the election in 1962. Well before the incident I related. By the time John Rice was using an office in the Children's Museum, he was no longer the Superintendent of Anderson County Schools.

Thanks to Margaret Allard, a long-time exhibit designer at the Children's Museum of Oak Ridge who, at my request, contacted Shirley Gadd who used to work for John Rice Irwin. She helped me identify the position he held at the time being discussed in my previous article. He was the director of the Tennessee Appalachian Education Corporative.

Okay, now back to the story of DruAnna and her attempt to preserve the history of the Melungeons. While she says in her book, "Purposefully I have steered away from the research of anthropologists and sociologists who have hashed and rehashed the mysterious origins of the Melungeons," she did participate in the recent DNA studies. I asked her about that.

DruAnna said, "Yes, I participated in two DNA studies: one which was patrilineage which showed a propensity of Welsh DNA (with Brent Kennedy) and the other matrilineage (with Jack Goins) which I never got the report back on that one. I can only surmise that I was one of the eight which had a direct female line to the Melungeons---but I am not sure since it ran this way: me to my mother to my grandmother to my great grandmother and then to my great, great grandmother who was a Bunch and not a Collins or a Goins. We have known before any DNA studies that the Goins' tribe was African."

She went on to say, "I do have a 'spin' though on the recent article concerning DNA and would love to talk to you about it sometime in the future. I have no worries about the DNA results, but I am a bit upset that comments from some writers who debunk our oral histories. For instance, I am from Vardy but if I go to another part of the country, I will say that I am from Morristown. (Does that make me a pathetic liar?)

"One halogroup of my DNA may show a connection to the Sub-Saharan strain but does that mean we should ignore all other halogroup connec-

tions? Nobody has ever denied that we are a mixture of different people, but I really think that the 'science' here is ignoring other factors of our origins.

"And, for our ancestors to have said they were 'Portahee' may have had hundreds of interpretations. They lived in Portugal before coming to this country, they may have traveled on a Por-

tuguese ship (after all 'melungeon' supposedly means shipmate), they were part of the Portuguese ship crew, etc.

See the strange pull of the history of Melungeons? While they are obviously a people of mixed-race origin, while they have been maligned over the years from prejudiced groups and while they are struggling to define a cohesive history, they are still having a difficult time with the basic details of their ancestry.

About John Rice Irwin, DruAnna said, he was Anderson County School Superintendent when she was hired to teach at Lake City High School in 1965. DruAnna said, "He had been my brother's roommate at Lincoln Memorial University, and I was very honored to have been 'hired' away from Knox County School system to teach under his leadership."

"At the time of the anthropologist's presentation at the Children's Museum, I believe that John Rice had devoted a major part of his time to the Museum of Appalachia." He was doing both by then. His focus was turning to the preservation of the history of Appalachia through the preservation of their heritage and history. Yet, he remained engaged in the educational aspects of the Appalachian region.

DruAnna continued, "As a matter of fact, I participated in a program that he offered interested teachers of Anderson County who wished to take their students to the museum for Living History presentations in the early 80s. He also was instrumental in bringing Appalachian Storytellers to our classrooms."

"Luckily, I wrote a request to have the storyteller 'Bad Hair Williams' to my classroom in Clinton which Irwin had obtained a grant to fund. And from that, I fell in love with oral histories.

"At any rate, after my second son's birth, Paul Bostic, the supervisor of Anderson County Schools asked me to move my teaching assignment to Clinton High School because as he said it he wanted me to teach his daughter Jo Ellen Bostic who now works with John Rice Irwin's daughter at the Museum of Appalachia. Jo Ellen was such a wonderful student as were so many that I was fortunate enough to teach at Clinton.

"Later I discovered that my uncle Bob Williams had been one of Mr. Bostic's boyhood friends and

that Mr. Bostic's sister-in-law taught at West Haven Elementary School in Knoxville where my father was principal.

"My outburst at the Children's Museum worried me greatly because I did not want to offend Mr. Irwin in any way. He was my older brother's friend. Nor did I want to offend Mr. Bostic by giving a bad impression of one of Anderson County's teachers...And, I certainly did not want to upset not only my mother but my father.

"I had really gotten myself into a "pickle" to say the least. Irwin and Bostic were family

friends, and I knew that I better mind my "Ps and Qs!" or I would hear from my father whom I admired more than anybody.

Next, we will continue with DruAnna's personal story about coming to grips with the heritage she inherited and her efforts to preserve the history of the Melungeon people. She is quick to point out that the Museum is a product that the Vardy Community Historical Society put together, through the donations, works, and efforts of a dedicated board and appreciative alumni of Vardy Community School.

She points out, "Our board has been great: Troy Williams, charter president; W.C. Collins, Jack Mullins, Charles Sizemore, R.C. Mullins, Anthony Collins, my husband Fred Overbay and so many other board members who put so much time and love into this project. I am only one of many others."



Money Taken From Emergency Services to give Executive Assistant 74% pay raise

According to information received from the Finance Director's office in a response to our freedom of information act request, approximately \$20,000 was taken from the emergency services budget and given to the county executive's assistant.

Under the first half of Brian Langley's term as County Executive, his assistant was given a nearly 74% pay raise with monies from the Ambulance service.

This occurred while our EMTs have a starting pay of \$10.22 an hour. The turn-

over at the EMS has been high of late due to various reasons one of which is the lower pay rate as compared to the same job in surrounding areas.

When asked about the reason for the decision to move money from emergency services to give to his assistant, Langley spoke to his assistant doing work for the ambulance service with their budget.

Unfortunately this answer creates even more questions. Did the assistant work double hours for nearly double the pay?

After all this is tax dollars we are talking about. If the hours did not increase where is the justification to pay a nearly 74% increase to the assistant. Even more troublesome is to have taken the money from emergency services when our first responders are paid so low to begin with. Could that money have been better served as pay increases for them? Would that have helped keep some of them from leaving to make more money elsewhere?

The History Channel

- * On Aug. 4, 1753, George Washington, a young Virginia planter, becomes a Master Mason, the highest basic rank in Freemasonry. The ceremony was held at the Masonic Lodge No. 4 in Fredericksburg, Virginia. Washington was 21 years old and would soon command his first military operation. Freemasons trace the origins of masonry back to the erecting of King Solomon's Temple in biblical times.
- * On Aug. 6, 1911, Lucille Desiree Ball, one of America's most famous redheads and beloved comic actresses, is born near Jamestown, New York. Ball starred with husband Ricky Ricardo on television's "I Love Lucy" from 1951 to 1957.
- * On Aug. 2, 1939, Wes Craven, the man responsible for terrorizing millions of moviegoers with his "Nightmare on Elm Street" series, is born. Craven began his directing career with 1972's "The Last House on the Left," a violent teen horror film.
- * On Aug. 1, 1943, a Japanese destroyer rams an American PT (patrol torpedo) boat, No. 109, slicing it in two. The destruction is so massive, other American PT boats in the area assume the crew is dead. Two crewmen were, in fact, killed, but 11 survived, including Lt. John F. Kennedy, who would later become president.
- * On Aug. 7, 1964, the United States Congress approves the Gulf of Tonkin Resolution, giving President Lyndon B. Johnson nearly unlimited powers to oppose "communist aggression" in Southeast Asia. The Johnson administration began heavy bombing of North Vietnam in early 1965 and sent U.S. combat troops in March 1965.
- * On Aug. 3, 1977, "The Spy Who Loved Me," starring Roger Moore as James Bond, is released in theaters. The film features one of the most memorable Bond vehicles of all time -- a sleek, powerful Lotus Esprit sports car that does double duty as a submarine.
- * On Aug. 5, 2002, the rusty iron gun turret of the ironclad warship U.S.S. Monitor is raised from the floor of the Atlantic, where it had rested since it went down in a storm off North Carolina during the Civil War. She sank in December 1862, while being towed from Cape Hatteras.




mation act to help us better prepare for the debate.

Strategies for reducing the increasing self-employment tax

The self-employment tax can be an enormous tax burden on a self-employed business owner. It can often be more than the income tax for a self-employed individual.

The self-employment tax is how the IRS collects Social Security and Medicare taxes on self-employed individuals. The Social Security tax rate is 12.4 percent of the business profit until the ceiling has been reached. For example, the Social Security tax on \$100,000 profit would be \$12,400. In 2022 self-employment tax limit is \$147,000. Any

profit which exceeds the limit would not be subject to self-employment tax.

The Social Security Administration issued its latest projected ceilings for the next five years. The projected ceiling in 2023 is \$156,000 and will increase to \$180,600 in 2027.

Fortunately, strategies can reduce the amount of Social Security tax paid by a self-employed business owner.

Tax strategies can reduce the amount of business profit, reducing the self-employment tax and income tax.

Some of my favorite tax strategies for self-employed business owners include:

Hiring your spouse Renting from your spouse Hiring your children Two-car strategy Forming an S corporation

Hiring your spouse can provide a substantial amount of money when done correctly. You would receive no tax savings from paying your spouse with cash wages. Doing this would essentially be moving income from one place on your tax return to another. You must pay your spouse with as many tax-free employee benefits as possible to reduce your taxes.

Employee benefits are tax deductible for the business owner but not taxable for your spouse-employee. These benefits include health insurance,

life insurance, medical reimbursements for doctor bills and prescriptions, tickets to sporting events and concerts, small gifts, and flowers and fruit trays for special occasions.

Renting from your spouse reduces your self-employment tax since rental income is not subject to self-employment tax.

The two-car strategy can save thousands of dollars a year without driving any additional miles. This strategy involves taking the mileage deduction on the primary vehicle and taking the actual expense on the secondary vehicle.

Hiring your child has many benefits, including tax savings. Generally, if you hire an employee, you are required to take Social Security and Medicare tax out of their wages paid, and the employer must match those taxes. You and your kids pay no payroll tax when your kids are under 18. The standard deduction in 2022 is \$12,950. They would pay no income taxes if their earnings weren't more than their standard deduction.

Another strategy is changing your business to an S corporation. You would be required to pay payroll taxes on your salary, but an S corporation's profit is not subject to payroll tax.

Tax saving strategies can provide a substantial amount of tax savings and provide other valuable benefits.

Around The World and Back Again



Chimichurri verde is an uncooked condiment made from parsley and cilantro, garlic, olive oil, red wine vinegar and red pepper flakes. A variation called chimichurri rojo adds red bell pepper and tomato.

While mainly thought of as a condiment for grilled beef, it's beautiful on pork, chicken, shrimp and fish, too. But wait, there's more! It's amazing on tofu, eggs and lentils. Slather it on grilled or raw veggies or use it as salad dressing. Chimichurri can be used as a marinade or basted onto meat as it cooks, or onto cooked meat as it rests. Add it to sour cream or Greek yogurt to make a dip, or mayonnaise as an herbaceous sandwich spread. My family schmears it on bread and eats it with a spoon. Because it goes on everything!

This is a perfect recipe when you have too many herbs in the garden or fridge and want to use them up and make them last longer than they would otherwise. Every time I make it, it comes out a bit differ-

ent because I use whatever I have on hand. Parsley is essential to this recipe but, sometimes I have more cilantro than parsley, or I might add other herbs. Sometimes I have shallots instead of green or purple onions. I've used lemon juice instead red wine vinegar. It's all delicious.

If you're a purist, you'll want to sharpen your knife and bust out the mortar and pestle. I have nothing but respect for that. Personally, I let my food processor do the work for me, just don't overprocess this sauce. It's supposed to be a little chunky.

CHIMICHURRI VERDE

The measurements are flexible. Use this as a place to begin, adjusting the recipe until it speaks or sings to your taste buds.

Total Time: 15 minutes Servings: 1 1/2 cups total

2 cups flat-leaf parsley (or 1 cup each parsley and cilantro)

3 to 5 garlic cloves, peeled and coarsely chopped

1/4 cup chopped onion (I used a combo of purple and green onions)
1/4 cup extra-virgin olive oil
3 table process red wing vine gar

3 tablespoons red wine vinegar 1/2 teaspoon dried oregano 1/2 teaspoon kosher salt

1/4 teaspoon red pepper flakes

Start by preparing the herbs. Measure 2 packed cups of the washed leaves and tender stems of parsley and/or cilantro. I love that you can use stems in this recipe. They're so flavorful and they're often discarded.

In your food processor, process the garlic and onion until chopped. Add the herbs and process until finely chopped. Add the oil, vinegar, oregano, salt

and pepper flakes and process until combined. Let sit at least 10 minutes for flavors to meld. If making ahead of time, cover tightly (imagine that raw garlic and onion invading your fridge!) and chill until ready to use. Leftover sauce can be kept refrigerated for a week.

Here's my favorite appetizer using chimichurri; roast beef crostini. Heat oven to 400 F. Slice a French bread loaf into thin slices, brush with olive oil and toast in oven. Top with slices of deli roast beef drizzled with chimichurri.

Remember: Real friends tell you when you have parsley in your teeth. I am that kind of friend. Go check your teeth.

Philippians Chapter 3

(Philippians 3:1-3) Rejoice but beware: Paul can find an occasion for rejoicing in most anything, even the nastiest of situations, dealing with false teachers. Christians must keep their heads up in spite of unpleasant circumstances. Clearly Judaizers will be the focus of what immediately follows. These were those who attempted to bind the law of Moses (especially circumcision) as a condition of salvation (Acts 15:1; Gal. 5:2 6:12-13). The apostle hates to be irksome, but he must reemphasize some points previously made.

Paul cautions the Philippians to beware (be on the lookout for): (a) the dogs, a term of contempt, suggesting perhaps their ravenous nature, or that of outcasts; (b) evil workers. Profession allegiance to the law, but being egregious violators of the same (Rom 2:1); (c) the concision (to mutilate) is a play upon circumcision; they glorify in the rite of circumcision, but actually they are nothing more than mutilators! Those who worship God by the instruction of the Holy Spirit (Jn. 4:24; Col. 3:17; 2:23) constitute the genuine circumcision, the spiritual Israel (Rom. 2:28-29; Gal. 6:16). Criticisms that the apostle's words are crude reflect upon the Spirit of God who inspired him!

(Philippians 3:4-11) Paul's personal example: Paul will now contend for the futility of boasting in the flesh, as the Judaizers do. Employing an ad hominem argument (whereby one turns an opponent's position against him), he contends if anyone had a right to confidence in the flesh, he does; and he would eclipse his opponents in qualification (v. 4). He catalogs his pedigree in several particulars: (a) genealogy (an Israelite of the tribe of Benjamin, a Hebrew of Hebrews); (b) strictness in law interpretation (a Pharisee); (c) zeal (a persecutor of Christianity); (d) blamelessness (no indictable offense) in keeping the law (v.5-6).

These things, once considered as gain to him, he now deems to be but loss. They pale compared to the excellency of the knowledge of Christ, his Lord, for whom he happily sacrificed those achievements. With a bold figure he depicts them as dung, or refuse (v.7-8). He does not disdain the legitimate elements of the law in their proper place, but rather the insignificance of those things in contrast to the riches he now enjoys in Christ. He possesses a new righteousness which issues from God and is grounded upon the basis of his obedient faith (v.9).

More and more, Paul longs for a greater knowledge of Christ, an appreciation for the power of his resurrection, and fellowship with his sufferings. If necessary, he will die with him as a partner in martyrdom---so that he too mighty partake of the resurrection of the dead (v.11)---an event that was to be realized. (This negates the common assertion that Paul emphatically taught that Christ would return during the apostle's lifetime.) It was the resurrection of Christ and his appearance to Saul on the road to Damascus that turned the bloody persecutor around. Nothing adequately explains Paul's conversion and his subsequent transformation of life---except the bodily resurrection of Christ!

(Phil. 3:12-16) The Christian journey: The fact that the apos-

tle had been forced to extol his accomplishments as a Jew to shut the mouths of the troubling Judaizers did not imply that he felt he already was made perfect, that he had reached a plateau of absolute perfection and was not in need of further growth. Instead, he determined to press on so that he might lay hold on the prize Christ intended him to have (v.12). The only way to achieve this was to forget the things behind, which could have been his credentials as a Jew or his victories as a Christian. He was determined to stretch forward to the goal of the future, namely the calling to which he had responded. This calling had various components. It was: (a) from God (Acts. 2:39; Heb. 3:1); (b) to be embraced humbly (1 Cor. 1:26-29); (c) offered via the gospel (2 Thess. 2:14); (d) designed to promote holiness (1 Cor. 1:2); (e) an incentive to heaven (Col. 1:5); (f) the realization of our hope (Eph. 4:4).

The apostle does not claim moral perfection in verse fifteen; the term means full-grown, mature (1 Cor. 14:20; Eph. 4:13). The sense is different than in verse twelve. He encourages his readers to join him in not being satisfied with past attainments, but in pressing onward. He acknowledges that he knows of some in Philippi who are otherwise minded, they entertain a view antagonistic to his admonition. Their digression would be revealed eventually---perhaps by divine message, certainly at the day of Judgment (v. 15). He urges those who will to join him in the degree of success to which they have attained already (v. 16).

(Phil. 3:17-21) Enemies of the cross: The apostle had no tolerance for those who openly taught dogma contrary to the doctrine of Christ. After encouraging them to be imitators of him (no boast, but an inspired exhortation), he exhorted them to look for others who follow the pattern of sound teaching. There is strength in Christian fellowship. Tragically, many others walk (live and teach) just the opposite, and it was breaking the apostle's heart (Rom. 9:1-3). Were tears dripping on the parchment? The defectors were enemies of the cross of Christ, adversaries of what the cross represented. Of them it is said: (a) their end is perdition (hell); (b) they were self-serving belly-lovers; (c) what should have been their glory, exalting Christ (Gal. 6:14), had become their shame; (d) they constantly allowed their minds to grovel on earthly things; they were carnal (v. 18-19).

Christians "citizenship" is loyalty that is heavenly oriented, for this is where our King is, and we wait for him to appear and consummate all earthly enterprises. When Christ returns, he will raise our bodies from their graves (1 Cor. 15:35; I Thess. 4:13). Those bodies will no longer be flesh and blood, physical in substance, but will be fashioned anew, changed in form. The present body is designated as the body of our humiliation because, though wonderfully made (Psa. 139:14), it was adapted to the lowly environment of earth, in con-

trast to the heavenly realm. The new body will conform (have the same form) as that of Christ's glorified body---a thrilling prospect indeed! The change will be effected by the Lord's power to accomplish such a feat (1 Cor. 15:43). That Jesus now has a glorified body demonstrates that he retains an identity with those for whom he died. This is a breathtaking thought!




