




My thirty plus years in Florida were



Davis Funeral Home's **Veteran of the Week**

Chief Warrant Officer Frederick Edgar Ferguson served and fought in the Vietnam War as a helicopter pilot assigned to Company C, 227TH Aviation Battalion, 1ST Cavalry Division (Airmobile).

On January 31, 1968 CWO Ferguson risked his own life in the pursuit to save the lives of fellow American soldiers. On May 17, 1969 he was awarded the Medal of Honor by President Richard M. Nixon for his action on January 31, 1969.

CWO Ferguson's Medal of Honor citation reads: For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. CWO Ferguson, commander of a resupply helicopter monitoring an emergency call from wounded passengers and crewmen of a downed helicopter under heavy attack within the enemy-controlled city of Hue, unhesitatingly volunteered to attempt evacuation. Despite warnings from all aircraft to stay clear of the area due to heavy



speed along the Perfume River toward the tiny, isolated South Vietnamese Army compound in which the crash survivors had taken refuge. Coolly and skillfully maintaining his course in the face of intense, short-range fire from enemy-occupied buildings and boats, he displayed superior flying skill and tenacity of purpose by landing his aircraft in an extremely confined area in a blinding dust cloud under heavy mortar and small-arms fire. Although the helicopter was severely damaged by mortar fragments during the loading of the wounded, CWO Ferguson disregarded the damage and, taking off through the continuing hail of mortar fire, he flew his crippled aircraft on the return route through the rain of fire that he had experienced earlier and safely returned his wounded passengers to friendly control. CWO Ferguson's extraordinary determination saved the lives of five of his comrades. His actions are in the highest traditions of the military service and reflect great credit on himself and the U.S. Army.


On May 17, 2022, Sergeant Cody Gatlin was traveling with his family on vacation when he witnessed a black SUV run a stop sign, t-boning a van and causing it to spin multiple times and almost

flip before landing directly in front of his family's car. Without pause, Sgt. Gatlin immediately exited his vehicle and began rendering aid to a pregnant woman and her two-year-old daughter who were inside the van, both of whom sustained minor injuries in the accident. Sgt. Gatlin then proceeded to the black SUV to render assistance to the other party, where he found the occupant trapped and unable to feel her legs. While he and other bystanders were unable to remove the driver of the SUV, Sgt. Gatlin remained onsite until police and first responders arrived on scene and took over.



On May 19, 2022, in a separate incident, Corporal Larry Keeton was off duty, pumping gas at the Quick-Mart in Waynesboro, TN when he observed a young man pull into the parking lot and walk into the convenient store with a loaded .45 caliber handgun in plain sight in his waistband. When the man came out, he fired two shots into the concrete ground, striking himself in the foot in the process. The man then got up, walked to the side of the gas station, sat down and eventually tossed the gun away. Concerned the man may try to hurt himself again or others in the area, Cpl. Keeton approached the man at the side of the store and restrained him until police arrived and took the man into custody.

"If you were to talk to either one of these men, they would probably say their actions were purely instinct," said Commissioner Lisa Helton. "I, on the other hand, think it's a deep-rooted passion to serve and protect others. Their actions were valiant and selfless, and I am proud to have Tennesseans like them working at TDOC."







The GOP Needs to Get Beyond 2020

It's understandable that Democrats would want to constantly revisit Jan. 6 -- to invoke it, investigate it and sacralize it even. It's a mystery, at least from a certain level of abstraction, why Republicans would want to have anything to do with that day or want to fixate on the 2020 election.

The party is on the cusp of a midterm triumph, has enormous openings on the economy and education thanks to Biden administration stumbles and left-wing overreach, is making inroads among Hispanic voters, and has a well-stocked political bench that Democrats should envy.

Yet the GOP is stuck litigating the past almost entirely because its putative leader in Mara-a-lago is incapable of admitting error or defeat and will never stop trying to excuse and explain away his infamous conduct after November 2020.

You can argue that Jan. 6 wasn't an insurrection; that the composition of the committee is unfair and lacks the adversarial element that has always been presumed to be central to the workings of such bodies; that the revelations or supposed revelations from the committee are being overhyped; and that Trump, whatever his failings, didn't commit crimes and shouldn't be charged with one.

In fact, I agree with every one of those propositions. But none of them make Jan. 6 any better or make it good.

It's not quite true, as is often said, that every election is about the future. Republicans waved the bloody shirt of the Civil War for years. Democrats ran against Herbert Hoover for as long as they could. Republicans still talk about Jimmy Carter.

In all of these instances, though, a party made a focal point of a low and embarrassing moment for the other side, not its own. Revisionist historians and writers might pop up to defend the legacy of a Hoover or Carter or argue that they'd been misrepresented or unfairly maligned. Still, the parties moved on and focused on making new memories.

This is what Trump doesn't want to allow Republicans to do. With his knack for blunt-force marketing (Fake News, Russia Hoax), he believes he can deflect any attack and redefine the terms of debate to his liking. And he's not wrong. He's brought much of his party along with him in his insistence that 2020 was stolen.

His attitude toward Jan. 6 hasn't gotten more defensive with time, but more fulsome. In a statement last week, he called it "the greatest movement in the history of the country to Make America Great Again." His 12-page memo in response to the initial hearings doubled down on his fantastical case against the election, as if to confirm every harsh thing former Attorney General Bill Barr said about him.

Trump is acting on an entirely personal and selfish priority. There's no principle at stake in embracing the Jan. 6 mob or advancing 2020 conspiracy theories.

It's possible to defend free speech and assembly, obviously, without defending a breach of the U.S. Capitol. It's possible to support tightening up the security around voting without believing massive fraud changed the result in 2020.

OIG Finds Lax Security at VA Mail Pharmacies

The Department of Veterans Affairs Office of Inspector General performed IT security inspections at two outpatient VA mail-order pharmacies to see if they were meeting federal security guidance. in 20 minutes and not saved anywhere ... and more. Inspectors even found 98 more computers onsite than the facility thought it had. That Texas facility alone processed over 19 million prescriptions in one year, servicing VA medical sites in six states.

It didn't even get parking security right. VA rules say there can't be parking right next to a facility in case of a vehicle attack. The VA medical center police department had even issued a report about there being no physical barriers. When asked, facility managers told the OIG that parking wasn't an IT

drugs), they rely heavily on IT.

The Texas facility computers were past their "sell by" dates, meaning they were no longer getting vendor updates and support. When it came to IT security, there were 22 critical vulnerabilities on 62 computers and 34 high-risk vulnerabilities on 328 computers.

Access controls were an eye-opener. The system was deficient in device lock (which prevents access to systems when users are away from their workstations), ID and authentication of users (knowing who is typing in what), multiple users sharing one high-level account, open computers with no one around in a warehouse, access logs that were overwritten (erased) .

At an Arizona facility, the OIG found a similar set of deficiencies: an inaccurate inventory list of computers, multiple vulnerabilities on hundreds of computers, missing software update patches, use of default (fresh out of the package) passwords for security camera systems, with half of the systems not generating audit logs.

The facility filled 24 million prescriptions in one year, servicing VA facilities in 12 states.

At least the Arizona facility didn't have vehicle barrier problems, with a hefty metal fence all around it -- although a check of the facility on Google maps showed the gates swinging wide open. (c) 2021 King Features Synd., Inc.

Historically Speaking Alexander Hollaender, Sunday hikes in the Cumberland Mountains and Jim Young – part 2

Last week we introduced Alexander Hollaender and his Biology Division of the Oak Ridge National Laboratory located at Y-12. There is a lot that could be said about Hollaender, and that could be the subject of other Historically Speaking articles, but this series written by Jim Young, features one of the activities for which Hollaender was well known, the epic Sunday hikes.

Jim was just a young boy at the time. Let's now continue the saga of Sunday Hikes in the Cumberland Mountains as he recalls more of his experiences accompanying these scientists on their hikes. Jim continues his story:

One of the best places to find fossils was the abandoned coal mines above Oliver Springs but fossils and wildlife weren't the only things we would find. While hiking we would find old tracks and rusty mine cars, tipples and other coal processing equipment and other abandoned items. As I was an amateur photographer, I would occasionally bring my camera along and document things like what was left of the old incline railway up Windrock Mountain. I enjoy photographing old rusty buildings and equipment to this day, trying to imagine what they must have looked like while in use.

Windrock Mountain had a lot of history and back in those days you could still see relics of the earlier mining equipment including the abandoned incline railway used to take miners up the mountain and bring coal down. The lady who cleaned for my family would talk about growing up in Oliver Springs where her dad was a miner. She said on Sundays the miner's family members got to ride the incline up to the top of the mountain for a picnic.

We hiked above Petros to Big Fodder Stack Mountain. We also hiked in what was called back then the Morgan State Forest and is now called Frozen Head State Park. Other areas we explored including rural parts of Anderson County along Frost Bottom Road and Dutch Valley Road. Spring was always time to look for wildflowers including trillium and lady slippers, the beautiful native wild orchids.

Often we would hike along the shelf cuts of old abandoned strip mines. Close to the wall you would often find sheets of slate with carbonized plant and leaf imprints as well as the typical Pennsylvanian fossils of calamites and sigillaria, the stems and roots of prehistoric plants. One Sunday on a trip to Windrock near where a deep mine was operating, we ran across a very large rock that was the giant stump of an old Pennsylvanian tree. As I recall it was many feet across and it is the largest fossil, I ever had a hand in finding. Dr. Hollaender contacted the University of Tennessee Geology Department and they made arrangements to pick up the fossil with a large brick truck with a lift on it and it was to be put on display in the lobby of the Geology building. The only problem was the giant fossil turned out to be too heavy for the floor there and it ended up in a fenced storage area under Neyland Stadium. I saw it there once on my way into a football game a few years later but I have no idea if it is still there or not. We found other interesting things as well. I vividly recall one June when it was quite warm as we hiked to a strip mine shelf we'd never been to before. It was a pretty good climb and once we got to the shelf there was a lot of vegetation there. As we walked along somebody spotted some strawberries. It turned out there were quite a lot of strawberries growing there and each person along staked out an area and we all stretched out and began to enjoy some of the best strawberries we'd ever had!

Driving to many of the places we hiked included travel down unpaved and gravel roads often seeing houses with folks sitting on the porch enjoying the Sunday morning if the weather was nice. One of the things you learn quickly is people wave because there is not a lot of traffic on some of these roads and we would always wave back. If we were going

on private property, the group would always make sure to secure permission if at all possible. The members of the group always had respect for the residents and people who lived in the country and on the back roads. Another interesting and prominent Oak Ridger I met on the fossil hikes was Waldo Cohn. Dr. Cohn was a very interesting gentleman and another well respected scientist who drove a Checker sedan and played the cello. A Checker sedan was basically one of the large old taxi cabs sold as a personal vehicle. It had the fold down jump seats and a tremendous back seat area that Cohn used to haul his cello around. The Checker was a lot of fun to ride in and Waldo was quite proud of it, explaining about its unique features and why he

enjoyed driving it.

Then there was the Sunday morning in 1973 that started like most of the other Sundays. In the earlier morning hours an event had occurred but at the time I didn't know anything about it.

The hike went on as usual and as we returned to the Hilltop Market. Because we never knew exactly when we would return usually someone would just drop me off along West Outer below Peach Orchard where I lived.

As I started walking up the hill to our house that day, my dad was in the carport and said that the high school had been trying to reach me all morning about taking some pictures. I was the chief photographer for the Oak Leaf student newspaper at the time and the unusual event that happened early that morning was the bombing of Oak Ridge High School that took out administrative offices along with lots of windows and ceiling tiles.

I grabbed my camera and headed down the hill to the high school thinking I was probably too late to do much news photography since the bombing had happened many hours ago. As it turned out my timing was actually pretty good.

As I was shooting pictures of the damage Dean of Students Billy Williams and Vice-Principal Don Bordinger were touring their shattered offices. I got a shot of Mr. Williams and Mr. Bordinger framed through the broken glass of an office window.

That picture became my first front page photo for the Oak Ridger when editor Dick Smyser saw it the next day. And since it was such a big news story, the picture ran halfway across the top of the front page.

Thank you, Jim!

That concludes Jim Young's story recalling his memories of the famous Holleander Sunday Hikes. I would welcome additional insights by anyone who was a part of these hikes. As I mentioned in the opening of the first article, I am pleased to be able to announce completed short videos focusing on the early years of the Oak Ridge National Laboratory's Biology Division located at Y-12.



Now that the dust has been knocked off this case, it's time the Coffey family's voice be heard. In 1972 when Dr. Carr was murdered, I wasn't alive, but throughout my 38 years on the earth the impact of his death on my family has been evident. Recently, 50 years later salt has been poured in the wounds once again by resurfaced rumors that were reported as facts by an Oakdale resident to the Morgan County Today.

In short, Dr. J. H. Carr also known as "Doc Carr" was a prominent man who lived in Oakdale, TN. There he practiced medicine, delivered thousands of babies and people adored him. Some even named their babies after him & let him name their newborns. If you still live in Morgan County, chances are you have heard someone speak of him with love and admiration. As they should, his life was a legacy well lived. Therefore, it was no surprise that his murder in 1972 shook that close-knit community to its core.

On the evening of Dr. Carr's murder my dad Stanley Coffey then 16, my uncle Terry Coffey then 17, my late deceased uncle Joe Coffey and my grandfather David (Junior) Coffey were in Oakdale just leaving the Virgil Smith's auto repair shop when they passed a cop car in route to the shooting that later claimed Carr's life. That evening while visiting a friend in Harriman (Walnut Hill area) several cop cars surrounded them at gunpoint, arrested & transported them to Morgan County Jail. They were kept in jail all night and late in the evening the next day. Due to no tangible evidence, they were finally released. During their stay an officer came to inform/taunt them that their beloved community was forming a lynch mob and were coming to kill them due to their (unfounded) "involvement" in his murder.

Later the man who pulled the trigger surfaced on Fred Nelson property saying he

had broken down. Nelson was kind and transported him to a neighboring town to catch a bus. The very gun that ballistics report confirmed killed Carr was discovered in Nelson's barn. Nelson testified to these facts under oath. The 2 others connected to the crime were found shortly after. Those criminals were found guilty of their crimes and imprisoned.



During that time Joe was no stranger to law enforcement & had made a foe of the sheriff Cecil Byrge. As it turns out the sheriff had a vendetta against my Uncle Joe and fixated on the idea that Joe was connected. My grandfather and his sons arrested accounted for their day with rock solid alibis including multiple witnesses proving they had no connection to the murder.

To summarize, a good man was murdered, and wrong people were arrested. My people. My dad and his family had a stigma placed upon them thereafter. Their names were tarnished in a time when your name held value. My dad Stanley just 16 & Terry 17 were rumored as connected to that murder and no restitution to clear their names were ever offered. No apologies were made from any family or jail. No reputable family would let their children associate themselves with them. Joe later was gunned down and murdered. But the lasting effects of the whole ordeal have followed my dad, his brother, and our family to this very day. They were just young boys approaching manhood struggling to survive and to find their identity. Instead, they themselves became the victims, plagued with dishonorable whispers of hearsays.

If you have had the pleasure of living in a small town you understand what value it holds. On the flip side you also understand how a misunderstanding can alter the course and perception of your life.





Unprecedented IRS refund delays

returns this year than it did a year ago. The National Taxpayer Advocate announced that people are experiencing longer delays in processing paper returns and longer wait times on the phone than a year ago. The National Taxpayer Advocate is an independent watchdog within the IRS.

The IRS has an even larger backup of tax

The National Taxpayer Advocate is required to submit a report on taxpayer challenges twice a year. The report contains proposals to

lawmakers.

"That the backlog continues to grow is deeply concerning, primarily because millions of taxpayers have been waiting six months or more to receive their refunds," said National Taxpayer Advocate Erin Collins. "Before the pandemic, the IRS typically delivered refunds to paper filers within four to six weeks."

"Had the IRS used some of the \$1.5 billion of additional funds provided by the American Rescue Plan Act of 2021, which was enacted 15 months ago, to hire and train additional employees, it could have worked through backlog," the report said.

Collins also criticized the IRS for not investing in scanning technology to speed up processing.

"The digits on every paper return must be manually keystroked into IRS systems by an employee," Collins said. "In the year 2022, that doesn't just seem crazy. It is crazy."

Collins said the IRS is trying to hire in locations where paper returns are being transcribed, but that work is only done in Austin, Kansas City, and Ogden, Utah. "The IRS is having difficulty hiring in

those cities," Collins said.

The IRS aimed to bring in 5,473 new employees to process returns. However, just 2,056 employees were hired.

According to the report, the IRS had a backlog of 21.3 million unprocessed paper tax returns at the end of May. The backlog increased by 1.3 million over the same time last year.

The National Taxpayer Advocate report also said that a customer service representative answered only 10% of taxpayer calls last year. Phone wait times have increased by nine minutes compared to last year.

Jodie Reynolds, a spokesman for the IRS, said the report's numbers "are neither the most accurate nor most recent figures." She also said, "Today, the IRS is running well ahead of tax return processing compared to a year ago,"

The IRS has been urging people to efile for many years because processing paper returns is time-consuming and can bog down their limited staff.

Even though paper returns were experiencing long delays, 17 million taxpayers mailed their returns. Additionally, businesses filed 21 million returns on paper.

Efiling your return can eliminate unnecessary delays in receiving your refund.

Revisiting Seniors-Only Grocery Shopping

If you've been depending on grocery delivery or curbside pickup for the past two years, you might not know this: Many stores are continuing to have seniors-only hours. I'd tried going to seniors-only hours once two years ago ... but only once. The whole virus/pandemic was so new to us that we assumed that we must shop and stock up for all eventualities, leading to widespread shortages. The crowds that day were so massive that the line went across the front of the store, down the side and to the back. Store personnel were stationed at the door with counters in their hands, only allowing in a set number of shoppers. When I saw a friend coming out, I asked: "What's it like in there?" The answer: "It's a nightmare. People are grabbing 10 of ev-

erything. Do not go in." And I didn't.

Recent queries among friends who use seniors-only hours indicate that things are much, much better now in terms of crowds. We know that many items are chronically out of stock. We acknowledge that COVID is still around, and we wear masks. We don't expect much in the way of variety in our diets unless we luck onto a full shelf of food. Many of us, however, haven't been to a seniors-only hour for a very long time, if ever. We depend on delivery and curbside pickup. If you're ready to try seniors-only shopping, call your local grocery and retail stores. While fewer stores are now offering it, some still do. It might be every day before the regular opening, or it might be one or two very early days per week. Take your hand sanitizer and wipe down the cart handles. Wear a mask. The bonus, I'm told, is that's when fresh vegetables and fruit are put out, and the overnight stock clerks have loaded the shelves.

Ephesians Chapter 6

(Eph. 6:1-4) Children and Parents: Now children are addressed. Obviously these are old enough to understand Paul's instruction and are expected to heed it. They are to obey their parents in all ways consistent with the Lord's will. This was a part of Moses' law (Ex. 20:12), and the principle is applicable for every age, even though that law is not binding formally. No youngster is obligated to disobey Christ to placate a wicked parent. They must always do what is "well pleasing" to God (Col. 3:20). Generally, it is assumed that parents will prescribe the best for their children, and such wise counsel would lead to a happier, longer life (v. 3).

Parents are not to "provoke" their children to wrath by being unreasonable, abusive, vindictive, unloving, unjust, tormenting, etc. The number of parents and children who are estranged as adults is amazing. Instead, fathers and mothers are to "nurture" (by training and discipline, consistent with the child's nature) (Prov. 22:6) and provide "admonition" (warnings and guidance away from things wrong) (Prov. 2:1) in harmony with the teaching of Christ (v. 4).

(Eph. 6:5-9) Servants and masters: Slavery was an institution ingrained in the fabric of Roman society. It is said there were sixty million slaves in the empire. There is no New Testament mandate to overthrow slavery. The Golden Rule would do more to eventually effect abolition than a thousand revolutions. There were Christians who owned slaves and Christian slaves who were owned by heathen masters. It was a tense society, and Paul knew that instruction was needed to calm stressful situations. Christians slaves were to obey their masters with respect and awe (except when such violated divine law; there is never an excuse for that), always remembering that their conduct would reflect upon Christ.

They should serve with genuine dedication, just as they would serve Jesus, which actually they would be doing. A true servant does not serve just when the master is watching, but he labors, doing God's will all the time, and from the heart (v. 6). The worker who served with due diligence was promised reward from the Lord, whether he was a slave or a free man, an employee (v. 8). This certainly embraces Christian workers in today's society. Verse nine is obviously addressed to Christian slave owners. They were to treat their slaves kindly and fairly, not being brutal or even acting in an intimidating way. They were to recognize themselves as servants of the Master in heaven who never shows partiality.

(Eph. 6:10-20) The Christian warfare: The child of God is at war with Satan and his evil forces who dominate this world. They thus must be spiritually prepared for the conflict, lest they become casualties---a fate too horrible to contemplate. The saints are charged to let themselves be made strong (a passive form). They have not the sufficient strength for the task. They must rely on the strength of Christ (3:16). The expression, "whole armor," indicates they must be completely prepared for Satan's offense. He does not fight fair (4:14).

The Christian's warfare is neither political nor carnal in nature---a fact far too many ignore. Our battle is spiritual, against the



sinister forces of Satan in whatever form they manifest themselves. In the apostolic age, there still were demonic forces operative, as well as more subtle influences (v. 112). Demon possessions ceased with the close of the apostolic age; otherwise, there would be no miraculous power to counter their influence (1 Cor. 13:8-13; 1 Jn. 4:4). Are there demonic spirits still functioning in the world today? Yes, in-deed there is. 1 Timothy 4:1 "Now the Spirit speaketh expressly, that in the latter times some shall depart from the faith, giving heed to seducing spirits, and doctrines of devils;" The doctrine of the Devil begin in the garden of Eden and every time a man tells you what to do religiously which is not by the written authority of Jesus. Matt. thru Rev. You best believe that it is the doctrine of devils. The so called sinner's prayer is a chief example of Satan's doctrine.

The saints therefore are to take up their armor and withstand the forces of Satan "in the evil day," this most likely being the day of assault against them. And we are not only to win the heated conflict, but maintain the territory conquered (v.13). Our armor consists of: truth, righteousness, the good news of peace, faith, confidence in salvation, the word of God, prayer, and perseverance (v.14-18).

Paul urges these Christians to pray for all the saints and for him as well. He trusts that when he speaks he may do so with boldness, as he proclaims the "mystery of the gospel," truth formerly hidden but now revealed. The apostle declares himself to be an "ambassador" for Christ (v. 20). "Ambassador" literally means "order man"; the word "elder" derives from this root. The apostle is an elderly dignitary (suggesting authority), yet he is chained as a prisoner. He needs more boldness in his preaching. He has not yet finished his course.

(Eph. 6:21-22) Regarding Tychicus: Tychicus is mentioned here and four times elsewhere (Acts 20:4; Col. 4:7; 2 Tim. 4:12; Tit. 3:12). He was a resident of Asia who was highly regarded by Paul. He apparently accompanied the apostle to Jerusalem with the collection for the poor saints. Here he is praised as: (a) a "beloved brother," a fellow Christian esteemed with great affection; (b) "faithful," a man of integrity; (c) a "minister" (not in the modern technical sense, but simply a brother who served, attended to, or helped others).

He, along with Onesimus, conveyed Paul's letters both to the Ephesians and the Colossians (v. 22; Col. 4:7-9).

(Eph. 6:23-24) The benediction: The conclusion, along with others of similar import, is generally perceived as a brief prayer on behalf of special loved ones. He asks for "peace to the brothers, peace among themselves (Jews and Gentiles) and peace from God. He petitions both the Father and the Son. May grace (divine favor) abide with all of them "who love our Lord Jesus Christ with an incorruptible love." A suggestion is bound to occur to the readers. What will be the fate of those whose love is not incorruptible (Rev. 2:4)?


