

United States Army veteran, Lieutenant Colonel (rank at the time of action: First Lieutenant) Harold Arthur Fritz served and fought in the Vietnam War while assigned to Troop A, 1st Squadron, 11TH Armored Cavalry Regiment.

On March 2, 1971 LTC Fritz was presented with the Medal of Honor at the White House by President Richard M. Nixon for his heroic actions in combat on January 11, 1969.

LTC Fritz's Medal of Honor citation reads: For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. Capt. (then 1st Lt.) Fritz, Armor, U.S. Army, distinguished himself while serving as a platoon leader with Troop A, near Quan Loi. Capt. Fritz was leading his seven-vehicle armored column along Highway 13 to meet and

escort a truck convoy when the column suddenly came under intense crossfire from a reinforced enemy company deployed in ambush positions. In the initial attack, Capt. Fritz' vehicle was hit and he was seriously wounded. Realizing that his platoon was completely surrounded, vastly outnumbered, and in danger of being overrun, Capt. Fritz leaped to the top of his burning vehicle and directed the positioning of his remaining vehicles and men. With complete disregard for his wounds and safety, he ran from vehicle to vehicle in complete view of the enemy gunners in order to reposition his men, to improve the defenses, to assist



the wounded, to distribute ammunition, to direct fire, and to provide encouragement to his men. When a strong enemy force assaulted the position and attempted to overrun the platoon, Capt. Fritz manned a machine gun and through his exemplary action inspired his men to deliver intense and deadly fire which broke the assault and routed the attackers. Moments later a second enemy force advanced to within two meters of the position and threatened to overwhelm the defenders. Capt. Fritz, armed only with a pistol and bayonet, led a small group of his men in a fierce and daring charge which routed the attackers and inflicted heavy casualties. When a relief force arrived, Capt. Fritz saw that it was not deploying effectively against the enemy positions, and he moved through the heavy enemy fire to direct its deployment against the

hostile positions. This deployment forced the enemy to abandon the ambush site and withdraw. Despite his wounds, Capt. Fritz returned to his position, assisted his men, and refused medical attention until all of his wounded comrades had been treated and evacuated. The extraordinary courage and selflessness displayed by Capt. Fritz, at the repeated risk of his own life above and beyond the call of duty, were in keeping with the highest traditions of the U.S. Army and reflect greatest credit upon himself, his unit, and the Armed Forces.





The Most Self-Destructive Force in the World

Without a doubt, the climate-obsessed green movement is the most stupidly self-destructive force in the world today, leaving a trail of irrationality and folly wherever it goes.

Consider its recent record of destroying the country of Sri Lanka, making Western Europe needlessly vulnerable to Vladimir Putin's energy blackmail and stoking higher energy prices in the U.S. that have contributed to the fastest decline in real wages in 40 years.

The greens are rapidly making up ground on the socialists as the modern world's foremost economic and social saboteurs (and, of course, the two now work hand in hand).

If a hostile actor were to consider the best way to harm a society from within, it would unquestionably be to increase the sway of climate alarmists and other environmentalists who believe it is their righteous duty to make it harder and more expensive to power a modern economy, as well as to build and grow things.

They seek to throw the gears into reverse on the millennia-long human quest for cheaper, more abundant and more reliable sources of energy, while putting new obstacles in the way of other human endeavor.

Since they are fired by a quasi-religious vision of an existential climate crisis on the verge of ending Planet Earth, they reject cost-benefit analysis, not to mention basic realism. The resulting wreckage is all around us.

Sri Lanka achieved one of the highest ESG, or Environmental, Social and Governance, scores in the world and destroyed its economy in the process. The country banned chemical fertilizers in April 2021 as it hurtled toward becoming the world's first all-organic country. It proved one small step ahead for environmental pieties and a giant leap backward for Sri Lankan farmers. A large proportion of land went dormant, and production of rice, tea and other crops dropped precipitously. The resulting economic calamity has led to the collapse of the government.

This is basically the Green New Deal in miniature.

Sri Lanka is a small island nation in the Indian Ocean; Germany is a powerhouse in the middle of continental Europe. But the green disease doesn't discriminate on the basis of size or wealth.

For years, Germany pursued a policy of making itself dependent on Russian oil and (especially) gas, while congratulating itself on its great environmental virtue as it closed down nuclear power plants and ramped up renewable sources. Berlin can't say it wasn't warned of the risks of this approach. Such is the faddish grip of climate orthodoxy that it blew past all the blinking red lights. Sure enough, now Russia may well cut off the supply of gas this winter, at the same time that renewables have proved not ready for prime time (they are too intermittent, among other technical problems that won't be solved anytime soon).

In its wisdom, Germany decided to shut down the source of energy that is clean, reliable and doesn't require dependence on an authoritarian state hostile to the West -- namely, nuclear power. It fell prey to the environmental left's superstitious hostility to nuclear. Even now, Germany is going ahead with shuttering its last three plants. It is turning again to coal to try to fill the gap this winter, underlining its disastrous mistake in prematurely eschewing such proven sources of energy in the first place. Here in the U.S., of course, Biden pledged to "end fossil fuel" back in 2019, a promise -- given our prodigious reserves of oil, gas and coal -- that would make almost as much sense as Russia or Saudi Arabia pledging to do the same. Even as inflation, with energy prices leading the way, destroys Biden's presidency, he and his supporters are determined to pursue a climate agenda that will drive up costs and create inefficiencies at home while doing next to nothing to affect global temperatures.

contracts over the years.

Unfortunately, one of the scammers was a veteran. He was talked into pretending that he, a service-disabled veteran, was the majority owner (at least 51%) of the company for the purposes of qualifying for the contracts.

The head criminal in this venture is going to have a good long time to think about it. Depending on how the sentencing turns out, he could be looking at 20 years for each of six counts of wire fraud, not to mention the \$250,000 fine for each one.

One of the co-crooks pleaded guilty to his part in the long-running theft. He's since lost his money to bankruptcy and his wife to divorce.

Historically Speaking The Vardy Museums

When I visited Vardy, Tennessee a few weeks ago to meet DruAnna Williams Overbay and learn about the Melungeon settlement there in Hancock, County, I knew it as close to Virginia. However, I did not realize just how close Vardy was to the Virginia and Tennessee state line.

DruAnna wrote, "Vardy is basically on the Tennessee and Virginia border. Lee County Virginia begins at the top of Powell Mountain behind the church. Vardy Valley runs into Blackwater, VA and that state line begins down the road only two miles away. So, geographically speaking, the community really runs into Virginia. It is snuggled between Newman's Ridge and Powell Mountain."

The purpose for my visit was to let Fred Eiler, my good friend who first introduced me to the Peak Cemetery and then to DruAnna, show me a treasure he had found. I was sure it would be a good day trip but was not prepared for the level of interest in the Melungeons this trip generated for me.

Nor was I prepared for the large number of phone calls and emails I received after publishing the first article that mentioned "Melungeons" in the headline of the article. There are many people who are intensely interested in the research into the ancestry that has led to a group of people generally known as Melungeons.

Of the many who called, Cleland Thorpe of Corbin, KY, was most helpful. He discussed the various studies of which he was aware and noted a dissertation submitted to Michigan State University by Richard Allen Carlson, Jr. He was so kind as to send me a copy. Amazing material! I was introduced to another new group of people for me, the Salyersville Indians.

I am just beginning to read this dissertation and already see a connection to Melungeons. I want to read a bit more before calling Richard Carlson. In a chapter titled, "Malungain Indians' and an Interloper at Vardy's Springs," the term "Melungeon" with variations in spelling was applied first to a composite Indian population of "Saponi, Cherokee and other tribal heritages."

Now, let's go back to the trip to Vardy. Fred and I arrived just after lunch and DruAnna met us. This is almost no parking for the Vardy Museums, so we just pulled off the road into the grass. On the Southeast side of the single road running up the Vardy Valley sits an exceptional log cabin.

The Mahala Mullins log cabin has been transported from its original location atop Newman's Ridge to the floor of the Vardy Valley just across the road from the Presbyterian Church and the site of the Vardy School. Mahala Mullins, who

convince one of the truths of it, that she was a moonshiner. There is also a story that her log cabin straddled the Virginia and Tennessee state line with two doors on her bedroom a person could enter from one state and leave into the other.

A story is told about Hancock County Sheriff George Washington Edds who attempted to arrest Mahalia Mullins during her heyday of moonshining. He traveled to her cabin and confronted her with the charge of selling moonshine. She did not deny it, but said to the Sheriff, "I would gladly go

with you, but I can't get through the door."

The Sheriff is said to have returned to the Judge Tyler and told him, "She is catchable, but she ain't fetchable!" Many other stories exist about the legendary Mahala Collins Mullins.

The Mahala Mullins cabin has been rebuilt in the Vardy Valley near the church and site of the Vardy School. It houses numerous historic artifacts that have been collected from various sources and locations. Each artifact has a story. Each room is decorated with period furniture and

glassware. DruAnna tells stories about many of

the artifacts, citing their origin and how they came to be a part of this unusual museum.

Many unusual artifacts exist in the log cabin turned museum from a most unusual set of arched windows, that is right, arched windows in a log cabin... unusual, huh, to intricate woven baskets, each nook brings another artifact with a story.

In one of the upstairs rooms is a mockup of a five-student reading classroom, which DruAnna learned in college is the ideal size for teaching reading. The Vardy School knew that.

The upper boy's bedroom of the cabin still has the original wood flooring.

There is a bed in the cabin that is very similar to the one in which Mahalia was buried. The hand-hewed logs are distinctive and well preserved. Touring the cabin is an adventure in itself.

> There is a marker for the Vardy Community School which has fallen and is being recaptured by the woods. The plaque is left as "A Memorial to the Spiritual Leaders, Teachers, Staff, and Students." This school was well ahead of other schools during its time.

Carlson continues that this mixed tribal heritage was the reason for the term being applied to the Indian population. He continues, "By 1840, however, this external label of 'Malungeon' was no longer linked to the tribal or ethnic diversity but was more overtly tied with attitudes regarding mixed 'racial' heritage.

Carlson concludes his thoughts on this by saying, "Used with more derogatory applications, this latter use of the label 'Melungeon' would nearly coincide with the national climate of the Indian removal era and the passing of strict new state laws restricting the rights of Indians, blacks, and people of mixed racial ancestry."

As I interact with Richard Carlson, we will pursue his dissertation more fully.

lived from 1824 to 1898, has become a character that is now a part of the folklore of Melungeons.

She was a kind and sweet soul afflicted with elephantiasis who became so large that she could not get through the door of her bedroom. She was ultimately buried in her bed just outside the location of her cabin when she died. This was accomplished by taking the logs out of the corner of her cabin to remove her from her confined bedroom.

It is rumored, and with enough consistency to







* On Aug. 10, 1776, news reaches London that the Americans had drafted the Declaration of Independence. Until the Declaration of Independence formally transformed the 13 British colonies into states, the conflict centered in Massachusetts was seen as a local uprising.

* On Aug. 12, 1953, less than one year after the United States tested its first hydrogen bomb, the Soviets detonate a 400-kiloton device in Kazakhstan. Known as the "Layer Cake," the bomb was fueled by layers of uranium and lithium deuteride, a hydrogen isotope.

* On Aug. 11, 1973, "American Graffiti," a nostalgic coming-of-age tale steeped in the car-centric culture of suburban California, is released in theaters. The movie went on to become a sleeper hit.

* On Aug. 14, 1985, Michael Jackson takes control of the publishing rights to the vast majority of the Beatles' catalog for \$47 million, outbidding Paul McCartney himself. In the years afterward, the catalog was estimated to be worth in excess of \$1 billion.







Correctly answer crypto question on tax return



The IRS is trying to figure out if you had crypto activity when you file your personal 1040 tax return.

You are required to answer the crypto question on your return, and you must answer the question under penalty of perjury. However, answering this question isn't as simple as it may seem.

Since it's a broadly worded question, most people assume that any virtual currency transaction requires you to answer with a "yes."

The IRS has provided guidance regarding the crypto question. If you purchased virtual currency with real currency, you are not required to answer "yes" to the Form 1040 question. This is confusing because the question asks, "At any time during 2021, did you receive, sell, exchange, or otherwise dispose of any financial interest in any virtual currency?"

The IRS is only trying to uncover virtual currency transactions that create taxable income that is required to be reported on a taxpayer's tax return.

If you were paid for goods or services in crypto, you are required to answer "yes" because you have earned income and you were paid with crypto.

The fair market value of the crypto received for goods or services is considered to be taxable income by the IRS.

If you paid for goods and services with crypto, you are required to answer "yes" because the transaction would result in a gain if the value of the services is less than your basis in the crypto. The transaction would benefit the taxpayer if it were a loss since this would lower their taxable income.

Selling crypto for real money would require you to answer "yes" to the question.

You would need to answer "yes" to the question if you traded your crypto for other cryptos since this would result in a gain or loss.

You might need to file an amended tax return if you answered the crypto question incorrectly. If you answered "no" when it should have been a "yes" answer and didn't report your taxable transaction, you need to file an amended return.

If you correct your return before the due date for the return, you can file a superseding return can be filed instead of an amended return. To file a superseding return, you write "SUPERSEDING RE-TURN" at the top of the first page.

A superseding return is treated as if it was your first return. Consequently, it would provide the benefit of eliminating any risk of accuracy-related penalties.

Crypto transactions can be confusing for individuals with little or no experience. There can be serious tax consequences if done incorrectly. You may want to use a tax professional if you deal with crypto currencies.

Discounts on Phone and Internet

Have you heard of Lifeline? Started many years ago to help low-income individuals with their phone costs, it's been expanded to include internet at home, offering a \$9.25 monthly discount. That \$9.25 savings doesn't sound like much, but if you're like me, nowadays, you're converting every dollar saved into food. That \$9.25, for example, could turn into a loaf of bread and a gallon of milk, or even a pound of ground beef, a package of hamburgers buns and most of a can of beans. You'll need to qualify for Lifeline. One way you do that is if you (or anyone in your household) receive benefits from Supplemental Security Income, Temporary Assistance for Needy Families, veterans pensions, Supplemental Nutrition Assistance Program, Medicaid

and others, or through having verifiable low income. (You'll need paperwork to prove it.) You can sign up in a

number of ways, such as by mail or online at nv.fcc.gov/lifeline. Scroll through the information on that page. Call 800-234-9473 for more information or to ask that an application be sent to you by mail.

But there's more. In addition, if you qualify for Lifeline, you likely also qualify for an even bigger assistance: the Affordable Connectivity Program. ACP is new and can give you a \$30 monthly discount on your internet. Once you're in the Lifeline program, call your internet provider and enroll in ACP with them. There's no need to fill out another application. There are hundreds of internet providers that are part of the program, including some big names like Xfinity, AT&T and Spectrum. In some cases, that \$30 gets you internet without you having to pay anything additional. In other words, free internet. Get the details from your internet provider. For a list of providers by state, go to www.fcc.gov/affordable-connectivity-program-providers. Get more information on the Affordable Connectivity Program at www.fcc.gov/acp or call 877-384-2575.

We begin by roasting one whole chicken with vegetables. Double the recipe for larger families.

Remove the giblets from the cavity of the chicken and reserve for another use, or discard. Using kitchen twine, tie the legs together and brush the chicken with melted butter. Liberally season with salt and pepper. Place the chicken on top of the veggies.

Separate the garlic into cloves and scatter amongst the veggies. Place the pan, uncovered, in the oven and roast for 75 minutes, or until the temperature registers 175 F in the thigh. Remove the chicken, tent with foil to rest for 15 minutes before carving.

For "round two" I suggest making chicken pot pie using leftover veggies and refrigerated pie crust or chicken

large stock pot, heat the oil. Saute the veggies for about 4 minutes. Add the garlic and cook for 1 minute. Add broth and poultry seasoning. Bring to a boil and reduce heat to simmer for about 5 minutes or until veggies are tender. Add egg noodles, simmer for 10 more minutes. Add shredded chicken, heat through and season to taste.

Stretching the budget has never been so comforting.

Philippians Chapter 4

(Philippians 4:1) This verse is an absolute eruption of affection for the church. They are characterized as: (a) Brothers," kinsmen in the Lord from a common birth (Jn. 3:3-5); (b) "loved" and "longed for" by the apostle; (c) Paul's "joy" and "crown of victory); (d) again, "beloved." He encourages them to "stand fast" in the Lord---perhaps implying they must not to be swayed by the "concision" (3:2).

(Phil. 4:2-3) Resolving a personal problem: Paul has already hinted earlier of a disunity problem; now a specific case, complete with names, is mentioned. The apostle "exhorts" (used twice---double culpability) Euodia and Syntyche to be "of the same mind in the Lord." Quite obviously there was friction, if not a fracture. He believed both were capable of doing better. He appeals to a brother, whom he designates as "yokefellow" to assist these women. The implications are that they are estranged, they need to be reconciled, and this brother had the skill to help them.

(Phil. 4:4-7) Encouragement to faithfulness: This letter exudes joy and encouraged to rejoice in the Lord. The sourpuss disposition is not compatible with Christian joy and hope. Moderation or forbearance, is a gentleness or a sweetness that is most attractive. One should let it be apparent (but not flaunt it) before all; the object is to influence for good. What is the meaning of the Lord is at hand (v.5). It does not imply that Paul believed the second coming was near (3:11). It may signify the need for constant vigilance, for he could come at any time (Jas. 5:8). The Greek expression can signify that which is nearby. The Lord is close to us (Psa. 119:151; Mt. 28:20).

The Christian is not to be anxious; he should have concern for people (2 Cor. 11:28), but things should not distract him from his service to God. Rather, one should stay close to the Lord with prayers, supplications, thanksgiving, and requests. The peace of God is both a peace that is with God (Rom. 5:1) and a peace that is from the Lord.

(Phil. 4:8-9) The power of meditation: The Psalmist declared that he meditated upon God's law day and night (Psa. 1:2). Meditation is a lost treasure that should be reclaimed. Paul compiles a list of sound thinking propositions upon which we would do well to meditate. There is a vital connection between that upon which one thinks and how he lives (Prov. 23:7; Mt. 12:34), which results in the tranquility of his life---or lack thereof. One must rivet his attention on qualities that are: true, just, honorable, pure, lovely, good report, and any, and all, things that are virtuous and praiseworthy should engage the Christian's thinking and actions.

This is a magnificent prescription for personal mental health and benevolent influence upon others. Paul encourages the brothers to reflect upon the things they had learned, received, heard, and saw in him. No arrogance; just fact. These they were to practice by way of emulation, and the God of peace would be with them.

(Phil. 4:10-20) Thanksgiving expressed: Paul conveys his



sincere gratitude to these precious souls by whom, lacking for a while opportunity to assist him, had been revived by the gift conveyed by Epaphroditus (v.18). They had never ceased thanking of him, but had not had occasion to express their devotion in action. Obligation can only be realized when opportunity is present.

The apostle does not want them to think he is complaining about not having had sufficient sustenance. Quite the contrary. He had learned how to be happy in whatever state he found himself. He had learned how to be contented when he had to do without and when he had plenty. Paul had learned the secret of contentment (v.11-12). The term secret may suggest that which is not commonly known or the endurance of a difficult process. He confidently affirmed that he could do all things in him who strengthens me (v.13). All things are those consistent with Christ's will. Such depends also upon his in him relationship. The power derives from Christ, not from mere inner strength.

Paul congratulates these saints for their fellowship with him in his affliction. They did more than offer prayers and send soothing words. In fact, in the beginning of the gospel (their primary establishment), after he departed from Macedonia, no church had fellowship with him except these brethren. However, he qualifies the action----In the matter of giving and receiving.

His satisfaction was not merely in the fact that he received help for himself. Rather, he rejoiced that his work, combined with their assistance, resulted in fruit being deposited to their account. How thrilling it would be to know that one shared in Paul's labor as a genuine partner! The recent gift from Philippi, as conveyed by Epaphroditus, was like the fragrant smell of a sacrifice, combined with sweet spices rising up to God (Eph. 5:2). The imagery is from the Old Testament. Paul pledged: "My God shall supply every need of yours." He felt he had a very personal relationship with his Creator. How many today feel that closeness? There is a difference between every need and every want. The riches of his glory would be administered because of their in Christ relationship. He punctuates the promise with a grand eternal glory to God. So be it."

Phil. 4:21-23) Concluding words: The apostle sends salutations to all the saints there, both from himself and from the brothers who are with him. We must again remind ourselves that saints are not dead people who have been canonized by an apostate church. They are Christians, separated unto God for holy service. We are thrilled to learn that Paul had made converts even among Caesar's household (v.22). This expression referred to actual slaves who were a part of

Nero's personal entourage of servants, or a larger company of his administration. Paul's influence was phenomenal; and it continues to this day! When he concludes with grace be with your spirit, he confesses the existence of the human spirit apart from the flesh---contrary to the assertions of materialists, both atheistic and theistic.



struggling to get women's basketball started. High schools had women's basketball before 1972 but when these girls with athletic ability graduated there was no place to take their skills. So, in 1968 girls like Merilyn Jeffers from Oneida Wanda Heidel from Wartburg, Peggy Jolly

from Sparta, and **Bobbie Blaylock** from Hendersonville saw in their physical education classes the need for women's basketball at Tennessee Tech. Wanda Heidel told me that the girls from Oneida like Jeffers, Lorton, and Voiles were just about as good as they come in women's basketball.

The first two years 1968-69, 60-70 were years of formation. Wanda and Nina Heidel from Wartburg were in a group of girls who tried out for the

team. Both girls and eighteen more made the team and they started practicing together. But getting a team that would be recognized by the officials and recorded for history wasn't easy.

To look back at the first season to celebrate the team's 50th anniversary isn't an easy job. In the fall of 2020, the Tennessee Tech Eaglettes basketball team saw the first game of its golden anniversary season at Vanderbilt cancelled due to the Covid pandemic. Then Chattanooga was added and canceled the next day. The 50th anniversary season, for one of the most storied programs in collegiate women's basketball history, is still trying to get started. It was humbling searching through our archives containing every press release from the Tech athletics department from 1970-72. There were countless pages of football, men's basketball, and baseball - the primary sports of media interest. Even the rifle team, the golf and track team and the freshmen's division of men's basketball got a lot of attention.

The first press release found about the women's basketball team came after the team had completed its regular season on March many colleges through-2, 1971. The Eaglettes had completed the

season with a 11-4 record. For a program as relatively recent as women's basketball there are no statistics on file for the first four seasons: 1974-75 is the first team where stats were filed with proof that games were played. A lot of work still had to be done and a great coach was about to come to Cookeville to put Tennessee Tech on the Tennessee Tech court. The Golden Eagles won 9 of their first 10 games and 10 of its final 12 games to end the season 22-7. As a freshman at Tennessee Martin, Pat Head Summitt's team was 1-1 against Tech. Tech defeated Austin Peay 59-46, Middle Tennessee 55-42. They took the Tennessee College Women's Sport Federation District Crown. The starters for this team were Merilyn Jeffers and Debbie Voils from Oneida, Wanda Heidel from Wartburg, Peggy Jolly from Sparta (the mother of Kelly Jolly, the present

coach of Tennessee Women's Basketball. Both Peggy and Ken Jolly, Kelly's father, played basketball at Tech.) Bobbie Blaylock from Hendersonville, Pam Smith from Hendersonville and Jackie Laxton from Oneida.

For Tennessee Tech it truly started in earnest in the 1970-71 season. Little did anyone on that team know just what they were creating. Wartburg had two girls on this team; Wanda and Nina Heidel who had played four years for the Wartburg Bulldogs, 1964-1968.

You have to remember before the 1972 basketball season there were no women's basketball scholarships. The girls I have mentioned in this article were pioneers who played

basketball at Tech because of "love for the sport." They also won a state title in volleyball. Now let's look at what Title IX says.

No person in the U.S. shall on the basis of sex be excluded from participation in or be denied the benefits of or be subjected to discrimination under any education program or activity receiving federal financial assistance. Title IX is the most commonly used name for the civil rights law in the United States of America that was passed as part of the education amendment in 1972. It prohibits sexbased discrimination in any school or any education program that receives funding from the federal government (June 23, 1972 - PL 92-318). Title IX opened up the door not only for women's basketball, but also for women's softball, volleyball, tennis, track, swimming, soccer and other sports like bowling which Vanderbilt has.

In 1971 the Eagle year book devoted three brief paragraphs and a photo for the entire season for the 1970-71 season it contained two stories. There wasn't even a team photo on file from the inaugural team until Diane Murphy, a member of the first team brought a scrapbook with clippings.

From the records that have been passed down from the first team head coach Marynell Meadors fielded a good team to put





Marynell Meadors built Tennessee Tech into a giant in women's basketball. Her first annual budget in 1970 was a whopping \$100.00. She would coach at Tennessee Tech for sixteen seasons and finish with a 363-138 (.724) record (lifetime). She won six consecutive state championships and 4 Ohio Valley Conference (OVC) championships. Early on she won seven of eight games against Tennessee and Pat Summitt. But after Pat called her daddy and asked him if he could tell her what was wrong.

She said, "I coach hard and these girls play hard but we are not winning." Her dad said, "Well, Pat let me tell you, you can't win the Kentucky Derby with mules." Pat got the message and started recruiting the best players in the nation. She won thirteen straight against Tennessee Tech. Their record is 18-12; Tennessee.

Early on Marynell Meadors not only was the class of the state but was widely recognized as one of the best in the nation. Her first four seasons she was (99-24). She became a hall-of-fame coach at Tennessee Tech and Florida State. After Florida State she would sign with the Atlanta Dreams as general manager and coach. She even won WNBA coach of the year. This lady who started coaching at Tennessee Tech certainly had a great career.

Wanda Heidel was the best defensive player and rebounder that Meadors had at Tech and when they played Tennessee Martin, she was assigned to guard Pat Summitt. I asked her if she was hard to guard and she said she was very competitive and so was Tech. She had nothing but good to say about Summitt and her career at Tennessee. In 1972 Tennessee Tech Women's Basketball won the OVC tournament championship and in the regional which was played in Boone North Carolina where Tech beat Appalachian State. They advanced to the Nationals but lost. Some of the teams they played during the year were UT Martin, Belmont, Austin Peay, Fisk, Middle Tennessee, and Morehead State. Tennessee Tech invited all the coaches and players of the first teams (1970-72) to the 50th anniversary celebration in January 2022. It was a weekend to celebrate the

passing of Title IX, and the return of Tech's pioneers in women's basketball to the campus. According to Kim Rosamond's (present head coach of women's basketball) letter to Nina Heidel it was a weekend of overwhelming show of love and support. Both Wanda and Nina were in attendance. Nina said she was overjoyed to be invited back to Tennessee Tech. She said, "We were treated like royalty."

Not many of the early players were present but I am proud of the ones who were. Kathy Howell, Merilyn Laxton Jeffers, Jackie Laxton Johnson, Wanda Heidel Turner, Nina Heidel, and Coach Marynell

Meadors were there for the big celebration (see photo). There were over 150 other players from early teams.


I was honored to have Wanda and Nina in my 8th grade class at Wartburg. They might not remember it but I opened up the gym a few times so they could play basketball. They won the Morgan County Championship that year, 1964.

I am proud of these girls for what they did for women's basketball. They had no scholarships. They played for the love of the game and for Tennessee Tech.


