

Expanded Help for Veteran Caregivers

The Department of Veterans Affairs is giving a helping hand to veteran caregivers of all eras. The Program of Comprehensive Assistance for Family Caregivers (PCAFC) has been expanded to include eligible veterans who served after May 7, 1975, and before Sept. 11, 2001.

At-home caregivers have been the glue that held together any number of veteran programs, and now more of them will get the assistance they need. The program assists caregivers with health insurance and access to health care through CHAMPVA, peer support, respite care (30 days per year), education and training, financial assistance and monthly stipend, certain travel expenses, resources and more. The program includes both primary and secondary (backup) caregivers, although there are different services for secondary.

At the same time, the VA is extending the length of time that Legacy participants, veterans and their caregivers can stay eligible for the program. This date now runs through Sept. 30, 2025. "Legacy" means that a veteran was designed as eligible before Oct. 1, 2020.

Eligible veterans include those who had a serious injury or a serious illness during active duty during any service era. The veteran must have a disability rating of 70% or higher, have been discharged or have a medical discharge and need at least six months of personal care services for assistance such as feeding, supervision, safety and bathing.

To learn more about the Caregiver Support Program, call them at 855-260-3274 on Monday through Friday from 8 a.m. to 10 p.m. EST, and on Saturday, 8 a.m. to 5 p.m. EST.

For an online application and specific eligibility criteria, go to www.va.gov/family-member-benefits/comprehensive-assistance-for-family-caregivers. Look for the link to VA Form 10-10CG. In addition, the veteran needs to be enrolled in VA health care. Apply for that on VA Form 10-10EZ on that same webpage. Don't send any medical records with your applications. The VA will ask for those later.

Great Art Is Not an Enemy of the Climate

Climate activists have found a new target -- the greatest masterpieces in the history of Western art.

Heretofore, no one thought that Claude Monet's "Haystacks" -- a sublime series studying the changes in light and color on haystacks in a field -- or Vincent Van Gogh's "Sunflowers" -- a painting that is instantly recognizable and forever associated these flowers with the troubled artist -had harmed anyone, let alone had anything to do with the alleged climate emergency.

But that was before activists showed up at museums to splatter these works with tomato soup or mashed potatoes, part of a trend of protests directed at some of the most recognizable works in the Western artistic canon.

The actions are a new low, which is saying something. The level of childishness involved makes Greta Thunberg look prudent and statesmanlike by comparison.

Fortunately, museums have had the forethought to idiot-proof their major works with special protective glass. The activists say they don't seek to harm the art, although they are not people one would naturally nominate to make fine-grained decisions about the consequences of their stunts involving spray paint, glue and foodstuffs in close proximity to delicate, priceless treasures.

Margaret Klein Salamon, the executive director of the Climate Emergency Fund, told Buzzfeed News that the protests only make sense because the activists are thinking things are "so bad that I'm gonna do this crazy thing and glue myself to a painting or a frame."

In other words, they are channeling the famous line from Otter in the movie "Animal House" -- "this situation absolutely requires a really futile and stupid gesture be done on somebody's part."

It's not the Taliban blowing up the Bamiyan Buddha statues, but the nihilistic spirit is the same.

The protesters have asked, "What is worth more, art or life?" This is a particularly juvenile false choice. Art doesn't hurt or kill anyone. To the contrary, representational art is part of the warp and woof of humanity -- look no further than the 30,000-year-old paintings from the Chauvet Cave in southeastern France -- and profoundly enriches life.

The juxtaposition of pieces of art of great subtlety and power, whose value has stood the test of time, with often pale, ill-kempt kids ranting hysterically is comical. The beauty and mystery of Sandro Botticelli's "Primavera" and the pathos of the statue Laocoön and His Sons -- both works that have been targeted recently -- inevitably diminish anyone using the art as a cheap platform for publicity.

The protesters make strained connections between the art and their causes. A copy of the Leonardo da Vinci painting "The Last Supper" at the Royal Academy in London was on the hit list, as a news report put it, "because people around the world are experiencing a food crisis." Evidently, no one told the activists that the point of the last supper is not the food.

One of the protestors targeting the Monet painting in a museum in Potsdam, Germany, declared: "Science says we won't be able to feed our families by 2050. This painting will be worth nothing if we have to fight over food."

By that logic, there is no act of cultural desecration that isn't justified. Why not sandblast the ceiling of the Sistine Chapel, sledgehammer Michelangelo's David, or bulldoze Notre Dame because they'll all be worthless in the climate dystopia awaiting us?

The activists are quite pleased with the attention they are getting. It's not true, though, that all publicity is good publicity. What they are really putting on display is their own recklessness and fanaticism.

On their own terms, they should think about how having easy access to the most awe-inspiring works of arts ever fashioned by mankind is the ultimate privilege. There are no world-class art museums in, say, Micronesia.

So maybe some respect and gratitude for the timeless contributions of true geniuses is in order, but that would require some perspective and decency, wouldn't it?

Historically Speaking

President Harry S. Truman's Grandson, Clifton Truman Daniel came to Oak Ridge

Clifton Truman Daniel spoke in Oak Ridge on March 28, 2013. I met him then and have continued to stay in touch with him since. I plan to travel with him to Israel in May 2023 and to Japan in 2024. He has participated in a video cast "Hidden History: Stories from the Secret City" with Keith McDaniel and I several times. I am proud to bring you this introduction to President Truman's grandson.

Did you know that the "S" in Harry S. Truman did not stand for anything? His parents evidently added that "S" in their son's name to please both of his grandparents, Anderson Shipp Truman, and Solomon Young.

I didn't know this, but when I sent out an email blast to the Oak Ridge Heritage and Preservation Association's membership to announce the upcoming special event where President Truman's grandson, Clifton Truman Daniel was to speak at Oak Ridge, I received the following response from Dick Raridon:

"Just a little trivia. Harry Truman didn't have a middle name so the period after the S is redundant. I researched him a lot about 40 years ago when a sign was posted in Pickett State Park overlooking a house down in the valley. The sign stated that the home once belonged to Truman's grandfather. I knew the house, built in 1790 and one of the two oldest in the State of Kentucky, once belonged to my g-g-grandfather, Washington Young."

"I found that Truman did have a grandfather Young, but it was Solomon, and there was no timeline connecting the two. I never could find who arranged for the sign to be put there. It was disturbing to the Sharp family who had bought the farm from my family in the 1870's and were still living there in the 1970's and were being disturbed by people pestering them. Dick"

This was also the case with Ulysses S. Grant. His "S" was given him at the age of 17 when Congressman Thomas L. Hamer nominated young Hiram Ulysses Grant for a position at the United States Military Academy at West Point, New York. "Ulysses S. Grant of Ohio" was what Hamer choose to put on the nomination thinking the "S" represented Ulysses' mother's maiden name of Simpson.

Interestingly enough, while at West Point, Grant chose to adopt "Ulysses S. Grant" with the middle initial supplied by Hamer. Students at the academy nicknamed him "Sam" or "Uncle Sam" using his "U. S." part of his name. According to Grant, however, the "S" did not actually "stand for anything."

Why all this interest in the "S" in Truman's name or Grants name? On Thursday, March 28, 2013, at 7:00 PM at the New Hope Center, Harry S. Truman's grandson, Clifton Truman Daniel was the featured speaker in an event sponsored by the Oak Ridge Heritage & Preservation Association.

This event was intended to be an opportunity to meet Clifton Truman Daniel personally and to hear him speak about his unique experiences regarding his grandfather. This was an exciting event for those of us who are interested in the "why's" and "what's" of the decision President Truman made to drop the atomic bomb to end World War II.

I am constantly approached by individuals who tell me emphatically that "I would not be here if not for Harry Truman's decision to drop that bomb using uranium 235 separated at Y-12!" This common sentiment is strongest for some who can easily see the alternative had we invaded Japan.

These people are serious and truly believe that the decision President Truman made to drop the atomic bombs saved their dad's or their grand-dad's life. You see, these men were on ships headed to Japan and were intended to be part of the invasion of the mainland of Japan, known as Operation Downfall.

One study done at the time for Secretary of War Henry Stimpson estimated the cost of invading Japan might reach 1.7 - 4 million causalities with

upward of 800,000 killed. Think about that...and I am convinced those creating that report did not have all the information about Japan's plans to defend an invasion of their homeland.

In a website http://www.theabsurdreport.com/2007/1945-invasion-of-japan-plans/ the following is found:

"One can only guess at how many civilians would have committed suicide in their homes or

in futile mass military attacks. In retrospect, the 1 million American men who were to be the casualties of the invasion, were instead lucky enough to survive the war. Intelligence studies and military estimates made 50 years ago, and not latter-day speculation, clearly indicate that the battle for Japan might well have resulted in the biggest bloodbath in the history of modern warfare.

"Far worse would be what might have happened to Japan as a nation and as a culture. When the invasion came, it would have come after several months of firebombing all the remaining Japanese cities. The cost in human life that resulted from the two atomic blasts would be small in comparison to the total number of Japanese lives that would have been lost by this aerial devastation."

Also noted in the recently released documents describing Operation Downfall is the fact that the plans greatly underestimated the number of kamikaze planes the Japanese had (possible over 12,000) and the plans already in place for the Japanese civilians to fight to the death to defend their homeland. I am convinced the invasion would have been far more deadly than the atomic bombs. Thus, I am certain the use of atomic bombs was the best thing that could have been done to end World War II.

Here is one of the comments to the above web site: "I just wanted to thank you...My father was one of the soldiers spared when the invasion was no longer necessary. He was part of the initial occupation and I recall him describing the Japanese preparations for every person on the island to fight to the death. Ironically, my dad and mom settled in 1946 in Richland, near Hanford where the plutonium was made for the Nagasaki bomb."

So, how does Clifton Truman Daniel deal with his famous middle name? What must it be like to live in the shadow of such a great man? The man who made the decision to use the Little Boy atomic bomb that had been the product of Oak Ridge's efforts during the Manhattan Project. Don't you think he might have wondered about that decision? Don't you think he might have had to answer tough questions?

Daniel went to Japan to the actual city where his grandfather made the decision to destroy the city with one atomic blast. The mayor of the city spoke with him. Wouldn't you like to know what was said? On the 67th anniversary of the bombing, he attended the ceremony commemorating that anniversary.

He is quoted by Abby Ohlheiser in The Slatest as stating that his attendance at the ceremony was "a good first step toward healing old wounds ... and to better understand each other." Ohlheiser went on in the article to say, "Many of the survivors likewise spoke positively of the meeting, but others made it clear they're not willing to forgive and forget," She continued by quoting, "I would like him to know that some of those who lost their family members in the bombings will never forgive (the United States) no matter what," said Reiko Yamada, a 77-year-old female survivor.

Veteran of the Week

United States Navy veteran Master Chief Britt Kelly Slabinski served and fought in Afghanistan in the War on Terrorism as a Navy Seal. On May 24, 2018 Master Chief Slabinski was presented with the Medal of Honor at the White House by President Donald Trump.

His Medal of Honor citation reads: For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while assigned to a Joint Task Force in support of Operation Enduring Freedom.

In the early morning of 4 March 2002, Senior Chief Special Warfare Operator Slabinski led a reconnaissance team to its assigned area atop a 10,000-foot snow-covered mountain. Their insertion helicopter was suddenly riddled with rocket-propelled grenades and small arms fire from previously undetected enemy positions. The crippled helicopter lurched violently and ejected one teammate onto the mountain before the pilots were forced to crash land in the valley far below. Senior Chief Slabinski boldly rallied his five remaining team members and marshalled supporting assets for an assault to rescue their stranded teammate. During reinsertion the team came under fire from three directions, and one teammate started moving uphill toward an enemy strongpoint. Without regard for his own safety, Senior Chief Slabinski charged directly toward enemy fire to join his team-



mate. Together, they fearlessly assaulted and cleared the first bunker they encountered. The enemy then unleashed a hail of machine gun fire from a second hardened position only twenty meters away. Senior Chief Slabinski repeatedly exposed himself to deadly fire to personally engage the second enemy bunker and orient his team's fires in the furious, close-quarters firefight. Proximity made air support impossible, and after several teammates became casualties, the situation became un-

tenable. Senior Chief Slabinski maneuvered his team to a more defensible position, directed air strikes in very close proximity to his team's position, and requested reinforcements. As daylight approached, accurate enemy mortar fire forced the team further down the sheer mountainside. Senior Chief Slabinski carried a seriously wounded teammate through deep snow and led a difficult trek across precipitous terrain while calling in fire on the enemy, which was engaging the team from the surrounding ridges. Throughout the next 14 hours, Senior Chief Slabinski stabilized the casualties and continued the fight against the enemy until the hill was secured and his team was extracted. By his undaunted courage, bold initiative, leadership, and devotion to duty, Senior Chief Slabinski reflected great credit upon himself and upheld the highest traditions of the United States Naval Service.

"Shut up," Merek grumbled. He flung the door open and stormed out.


Elric followed behind him, still laughing.

Helping a "Found" Cat Get Home

DEAR PAW'S CORNER: My friend found an orange cat matching the description on a paper flyer posted on a nearby telephone pole. However, the email address listed on the flyer keeps coming back as "invalid," so she has no way to contact the owner. What else can she do to return the cat to its rightful owner? — Jimmy V., via email

DEAR JIMMY: Kudos to you and your friend for caring for the lost cat and trying to get it back to the owner!

The first thing to do is to contact nearby shelters and veterinarian's offices and tell them that you've found a lost cat but cannot contact the owner. They may have you bring in the cat to scan for a microchip — the best way to identify pets and reunite them with their owners when a collar and tag are lost. Or they may ask for a descrip and have you email a photo of the cat so they can put up a "found" flyer in their lobby. Chances are, if the owner has already put up flyers, they have probably been checking with shelters regularly to see if their cat has been reported found or has turned up there.

Next, get the word out. Paws.org has a downloadable PDF flyer (www. paws.org/resources/reunite-a-foundpet/) that you can use to post your own found sign and add a contact email or number for the owner to call. Post a found notice on Facebook groups like Lost and Pound (www.facebook.com/ lostandpound), which focus on lost

Chances are, you'll locate the owner locally, but getting the word out as far and as wide as possible will help reunite that cat with its owner.

The History Channel

* On Nov. 14, 1889, journalist Nellie Bly took a page from Jules Verne's novel "Around the World in 80 Days" by following in the footsteps of the book's protagonist, Phileas Fogg, and embarked on her own adventure, starting in Hoboken, New Jersey. She chronicled the trip in her book "Around the World in 72 Days."

On Nov. 15, 1949, Nathuram Godse, Narayan Apte and six of their co-conspirators in the assassination of Mahatma Gandhi were hanged at the Ambala jail. Godse, unhappy over Gandhi's accommodation of Indian Muslims, had shot Gandhi the previous January while Gandhi was out for his evening prayers.

On Nov. 16, 1990, Fabrice Morvan and Rob Pilatus, known to the pop music world as Milli Vanilli, were humiliatingly stripped of their Grammy award for the "Girl You Know It's True" album when it was revealed they hadn't sung even a note of it.

On Nov. 17, 1827, the Delta Phi fraternity, America's oldest continuous social fraternity, was founded at Union College in Schenectady, New York. With just 10 active chapters today, it has resisted expansion in order to create an "intimate, personal experience" for its members.

On Nov. 18, 1872, American civil rights activist Susan B. Anthony and 14 of her brave female cohorts were arrested for voting illegally in the United States presidential election of 1872. Though she was fined \$100, she refused to pay a cent of it.

On Nov. 19, 1493, Christopher Columbus set foot on the island called Borinquen, which he had viewed for the first time the day before. He rechristened it San Juan Bautista, but today we know it as Puerto Rico.

On Nov. 20, 1805, Beethoven's only opera, "Leonore, or The Triumph of Marital Fidelity" (later known as Fidelio), premiered in Vienna -- not to its originally intended audience of the aristocracy and Imperial court, who had fled before Napoleon's advancing army, but a small audience of French officers. Their unsurprising lack of enthusiasm shelved the project for nearly a decade.



Employee Retention Credit scams

The IRS is warning employers to be wary of companies advising them to claim the Employee Retention Credit (ERC). Scammers are claiming the ERC for businesses that don't qualify.

Many scammers are contacting businesses and claiming they qualify for the ERC. However, they would only know if you were eligible for the credit after obtaining your records first. They often provide fake documents to support their claim.

These scams can be very costly. The scammer's fees for making fraudulent credits can be quite expensive. Improperly claiming the ERC could result in your business being required to pay back the credit and any penalties and interest.

The ERC was created to encourage businesses affected by the pandemic to continue paying their employees. The credit can be as much as \$28,000 a year for each employee.

Many firms charge 20% to 30% of the amount of the ERC refund. The large fees provide an incentive for firms to file for fraudulent credits.

Many scammers will shut down after making a substantial profit, leaving you to deal with the IRS problems they created.

There are numerous ways to prevent an ERC scam. Work with a company that has been in business for a long time. They are more likely to avoid scams that would end their business.

Demand the company to provide actual proof of your ERC eligibility.

Ask if the company provides audit protection. Audit protection requires the company to reimburse you for penalties and interest in the event of an audit.

Find out if the company is licensed with the IRS.

Beware of anyone asking for an upfront fee or promising an ERC refund from the IRS.

You should check their track record of successfully helping their helping clients receive the maximum benefit. Check online reviews and ask for referrals from past clients to determine their level of customer service satisfaction.

You can also contact the Better Business Bureau to learn about complaints against them.

If you receive an email that claims they are the IRS, do not reply. Forward the email to phishing@irs.gov and then delete the email.

As a result of the enormous refunds that the EIC can provide to businesses, it creates an excellent financial opportunity for scammers.

Be wary if you are contacted by a company claiming that you qualify for the ERC. Being scammed can be very costly.

Many reputable companies can help you obtain the ERC. By doing research, you can avoid being conned by a fraudulent company.

Social Security Benefit for 2023

It's official: Our Social Security increase for 2023 will be 8.7%. They say it's the largest increase in 40 years.

For the average senior, that's going to mean a \$146 monthly increase. Plus we're getting a small "rebate" on that massive Medicare Part B increase we faced last year when the cost went to \$170.10 to pay for Aduhelm, an Alzheimer's disease drug that was said to cost \$56,000 per year. (After facing criticism, manufacturers had to cut the cost in half, down to \$28,200.) We'll now save \$5.20 on our Part B premium, with the average monthly deduction being \$164.90. The Part B annual deductible will drop to \$226, a \$7 savings.

What's disturbing is that only a few months ago the financial gurus were expecting we'd receive a 10.2% increase on Social Security, based on all the high prices we've been seeing this year and will likely see into 2023. Instead, they've lowered that to the 8.7% ... while prices have continued to rise.

The problem is how those annual increases are calculated. They use the Consumer Price Index for Urban Wage Earners And Clerical Workers (CPI-W), which calculates the prices of goods and services for things those urban workers care about: clothing, education, electronics and so on. That CPI-W covers 29% of the population. Instead, they should use the Consumer Price Index for the Elderly (CPI-E), which focuses on goods and services that seniors spend money on: medical, drugs, food, housing and so on.

The next time you call your senators and representatives, be sure to ask why the Elderly index isn't being used. After all, they've been thinking about it since the 1980s.

Meanwhile, don't let the Medicare open enrollment period pass you by. Until Dec. 7 you have the option to make changes to your original Medicare Advantage plan, supplemental plan and prescription drug plan.

1 Timothy Chapter 2

(1 Tim. 2:1-7) Concerning prayers: Paul entreats Timothy regarding communications with God. The apostle is convinced of the power of prayer and exhorts us to engage in it on behalf of "all men" (people). One must pray responsibly, according to Bible guidelines; nonetheless, pray. "Supplications" reveal our dependence on God and our confidence that he will supply our needs. "Prayer" reflects an element of devotion. It reveals human dependence. "Intercessions" suggests that prayer goes beyond self-centered interests. "Thanksgivings" acknowledges the reception of blessings and gratitude for the same.

We are to pray for dignitaries in power, for they are under the Lord's sovereign control (Ps. 22:28; Dan. 2:21; 4:17). In this case, prayers ultimately are for Christians' sake, namely that God's people may have a peaceable environment in which to spread the gospel as they live godly and serious lives (v. 2). The Lord's universal interest is expressed in the twice used "all men" (v. 1, 4). The fact that God "wills" all to be saved does not assert "universalism" and does not harmonize with Calvinism, namely that God elected some, but not others, for salvation. His ideal will is not the same as his revealed will. There are conditions to salvation. (Heb. 5:9; 2 Pet. 3:9). The text is subject to two views. It may suggest that only those who come to a knowledge of the truth will be saved (which certainly is true in principle) (John 8:32). Or it may suggest that those who are saved must continue to grow in the knowledge of truth.

The Holy Spirit reveals what we, Christians are to pray for. Nowhere in the new covenant of Jesus Christ does the Holy Spirit tell the alien sinner to pray and accomplish the new birth. When anyone tells you to pray and ask Jesus into your heart and pray until you break through, it's like saying you are God, save yourself.

We who believe the God of the Bible, believe Jesus' words will judge us on that great day (Jn. 12:48).

When the Catholics and all the Protestants come to believe the Bible and obey the new covenant of Jesus Christ, then we will be one nation in Christ Jesus.

Paul affirms there is "one God," in contrast to the many "gods" of polytheism (v. 5). This does not speak to the broader issue of the entire Godhead. Additionally, there is "one mediator" (Christ) between the Father and humanity. (Mary is excluded as a "Mediatrix.") Jesus "gave himself" (a voluntary sacrifice) for "all" (no "limited atonement" here). "Ransom" suggests a price that purchases release. Jesus, by his death, paid the price for all who choose to let him. They access this by obedience to him. This wonderful plan was implemented at just the right time in history (v. 6). Paul was selected as a preacher and apostle for the purpose of proclaiming the gospel, that the Gentiles might know the truth and be saved by their faith in the Lord (v. 7). 1 Timothy 2:5 "For there is one God, and one mediator between God and men, the man Christ Jesus;". (Go to: BIBLETALK. TV Mike Mazzalongo "The Mary of the Bible").

leadership roles in church worship. His instruction is divine legislation, not personal opinion nor the custom of culture. The "men" (Greek: "males," to the exclusion of women) are to "pray" (the word stands for the entire worship procedure) in every place. This provides authority for male worship leadership. Leaders are to be "holy" people, not those igniting disharmony in the worship environment (v. 8). Similarly, women should not distract from the solemnity of the worship underdressed (sexually provocative). Their "adorning" should reflect godliness and good works (v. 9-10).

The woman is not to be disruptive in the assembly (1 Cor. 14:34). She is to "learn" (a progressive and consistent obligation) in "quietness." This is not total silence (which would forbid even singing) (Col. 3:16), but a submissive (nonaggressive), receptive disposition, befitting the prescribed activity of gender roles in worship (v. 11). The inspired apostle does not "permit" the woman to "teach" (exercise the official teaching role whereby the man is subordinated to the "student" status) in the church assembly, nor is she, in any other fashion (the force of the Greek), to exercise leadership "dominion" over the man. She may not function as an elder; she may not labor as a public teacher or preacher in the congregation (v. 12). The limitation is not arbitrary (1 Tim. chapter 3). There are historical bases for the restrictions. There was a divinely intentioned order of creation, and God wants that respected and demonstrated in gender roles (v. 13). Additionally, in the introduction of human sin, woman took the lead, and there was an abiding penalty of role limitation imposed as a consequence (v. 14). These premises reveal that the apostle's teaching here imposed is neither temporal nor culturally limited. It is a part of the intrinsic fabric of Christianity.

Does this mean that woman is beyond the hope of salvation? Certainly not! Woman may be saved "through her child-bearing" if the life of faith and love is pursued with sanctification (set-apart service to God) and serious dedication. This text is somewhat ambiguous and subject to more than one reasonable exposition. What does "through her child-bearing" mean? One view argues that salvation as a plan is under consideration, and woman's role is implementing that plan is the thrust of the text. Even though woman introduced sin into humankind, God nonetheless chose her as a vehicle of redemption. His Son would enter the world as a baby via the childbirth process (Gen. 3:15; Gal. 4:4). Another possibility is that the apostle's aim was to say that "child-bearing" is a term that stands for the totality of woman's domestic role (a synecdoche). Hence, being a wife and mother is the highest ideal of Christian womanhood. Such shows her at her best. (1Timothy 2:15b "if they continue in faith and charity and holiness with sobriety.")






Drying gourds

It's Time for Make-Ahead Meals for the Holidays

Have you ever wished the dinner fairy would appear with an effortless dinner for your family? I sure have, usually at 8 o'clock in the evening, dying of hunger, with 100 plates spinning and none of them dinner

'Tis the season for busyness beyond belief, but here's a solution: Spend time prepping meals now in anticipation of the busy season ahead. Let's cook pork and rice in quantity and them in the freezer with recipes to use them when you need a quick dinner fix.

To keep costs low, use boneless pork sirloin roasts. These small roasts are packaged in large vac-uum-sealed bags and are (historically) very inexpensive. I find 6 pounds of pork yields four generous meals for a family of four. You'll adjust the amounts to suit your family's needs.

OVEN ROAST PORK

Yield: 12 cups/16 servings

- Total Time: 2 hours 5 minutes 6 pounds pork roast
- 1/2 teaspoon kosher salt
- 1/2 teaspoon ground pepper 1/2 teaspoon granulated garlic
- Preheat oven to 375 F. Place pork in large baking pan, season and cover with foil. Roast for one hour, then lower the temperature to 275 F for an additional hour. Check for a tempera-

Let cool completely. When cool, cut your pork into cubes and divide into portions of about 3 cups each. Place the portions into zippered freezer bags. Divide any pan juices between the bags. Label and freeze.

BIG BATCH RICE

- Yield: 12 cups/16 servings Total Time: 47 minutes
- 2 teaspoons kosher salt
- 1 tablespoon butter 1 tablespoon olive oil
- 4 cups white or brown rice

Heat 8 cups of water to boiling. Add salt, butter, oil and rice. Return to a boil and reduce heat to a simmer. Simmer for 20 minutes for white rice, or 45 minutes for brown rice. Next, remove from heat and let stand, cov-

ered, for 10 minutes before fluffing with a fork. Let cool completely and divide into 3-cup portions. Freeze in zippered bags.

For each recipe, defrost one bag each pork and rice, overnight in refrigerator or defrost in microwave.

EASY PORK CHILI VERDE

Yield: 4 to 6 servings Total Time: 15 minutes

- 1 tablespoon olive oil 1 cup chopped onion
- cups cooked pork, cubed 1 (28 ounce) can green chili enchila-
- da sauce 1 (15.5 ounce) can great northern beans, drained and rinsed

1 (14.5 ounce) can chicken broth 3 cups cooked rice

In a large skillet, saute onion in olive oil until soft. Add pork, green chili enchilada sauce, beans, broth and rice. Bring to a simmer and serve

CREAMY PORK AND MUSHROOM CASSEROLE

Yield: 4 to 6 servings

- Total Time: 15 minutes
- 1 tablespoon olive oil 1 cup onion, chopped
- 1 cup celery, chopped
- 8 ounces mushrooms, sliced 3 cups cooked pork, cubed
- 3 cups cooked rice 1 (10.5 ounce) can cream of mush-
- room soup
- 1/2 cup sour cream 3/4 cup milk 1/2 tablespoon soy sauce
- 1 cup frozen peas

In a large skillet, heat olive oil and saute onion, celery and mushrooms. Add pork and rice, stirring to combine. In a bowl, stir together cream of mushroom soup, sour cream, milk and soy sauce. (If you don't use cream soups, increase sour cream to 1 cup and add salt to taste.) Add the soup mixture to the skillet, add peas and stir. Heat through and serve.

Other recipe ideas would be BBQ pork sandwiches, stir fry, burritos or burrito bowls.


