





Dick Lord: from secret calutrons to cyclotrons for science

The ever-increasing amount of interviews being collected are making this archive one a most effective sources of historical information. Carolyn's example shows how research can produce valuable and authentic information to support historical facts in a more interesting fashion. Her story of Dick Lord is one that will captivate the reader and makes learning history fun.

Before getting into Carolyn's story, a word about the "electricity experiment story" from a few weeks back. David Hobson wrote to say his that Dad was a millwright who had worked with Logan Emlet to install the setup in the reactor. David said, "By the way, he told me the light was a Christmas tree bulb and was accidently dropped and broken after the experiment. He and Logan were good friends."

I also was approached by Dub Shultz who told me about a very large steam whistle that was connected to the Graphite Reactor that was used to produce the steam to blow the whistle.

Now for Carolyn's story about Dick Lord which begins here:

...

In some movies the main character embarks on a journey, and in others a stranger comes to town. In real life Richard Lord, a native of New Jersey, was prepared to go on a journey almost 70 years ago to a job offered him in Oak Ridge. And he did come to the Secret City as a stranger, but only after he was able to find it.

In 1943 Lord and his father, who worked in an office for Pennsylvania Railroad in Philadelphia, could not locate Oak Ridge on a map or get information about it. So, he wrote a letter to the company that hired him before he graduated with a degree in electrical engineering from the University of Pennsylvania.

"We can't find Oak Ridge, Tennessee," he wrote. Then he received a telegram that stated, "Report to the Empire Building in Knoxville, Tennessee." That building housed Tennessee Eastman's employment office. Lord finally arrived in Oak Ridge on Nov. 10, 1943, a month after graduating from Penn.

collectors. U-235 was the first atomic bomb fuel.

Lord and Love taught a little physics to the calutron operators whose jobs entailed "watching meters and adjusting dials," according to Gladys Owens, one of the many workers who had no idea what they were producing. They trained female operators to run machines the men had never worked. Then Lord's clearance came through and he was moved from town to Y-12, where he saw his first calutron. But he was kept on as a trainer.

In an interview for Public Radio International's Bob Edwards Weekend Show on "Alumni of the Manhattan Project," aired Jan. 27, 2013, Lord said, "They had no intention of me finding out what they were doing...When I first saw the equipment, I knew it went into a magnet and I knew it was a separator. I

dropped the bomb. If you were living in those days, you knew that's what had to happen. I never had second thoughts. (Lord told McDaniel that six of his high school classmates had been killed in World War II.)

"You have a different perspective if you lived through the beginning of the war to the end, as opposed to reading about it in a history book. I remember listening to the Battle of Britain on the radio as it was going on. We feel like we ended the war so there should be some recognition for that."

"What about after the war," the reporter continued, "when the first photographs and newsreels showed up and you saw the effects" of the atomic explosions.

"We were in seventh heaven. We were celebrating."

"Even though it was largely civilians who were vaporized, in some cases?"

"During the war I don't think that mattered," Lord said, pointing out that hundreds of thousands of Japanese had previously been killed in the firebombing of Tokyo and other sites. Others have pointed out that a million Americans and a million Japanese would have been killed if the war had not been stopped by the atomic bombs.

In the summer of 1945, Dick and Kay Lord were married. During their honeymoon they heard President Truman issue his ultimatum to Japan: "Surrender or else." Lord knew what was coming.

They experienced the "chaos" in Jackson Square as Oak Ridgers openly rejoiced that the war that killed 54 million people had ended and that Oak Ridge had played a key role in bringing peace.

He worked on a team to try to make Y-12's electromagnetic separation competitive with the new gaseous diffusion process at K-25 for enriching uranium in U-235. The attempt failed, the calutron plant shut down, and Y-12's employment dropped from a high of 22,482 people in August 1945, to fewer than 2,000 people in 1947.

"I was one of the fortunate people to remain employed in Oak Ridge for my whole career," Lord said. "I never left."

After the war, Lord became involved in operating the 86-inch cyclotron located in Building 9201-2 at Y-12 cobbled together from Y-12's excess calutron parts, including the huge magnets. Then the Oak Ridge Isochronous Cyclotron was built at Oak Ridge National Laboratory. Lord moved to ORNL to work on ORIC, where he became an expert on magnet design.

"I was very much involved with the design of its magnet and the magnet coils, which nobody expected to last this long (from 1963 until 2011, when ORIC was shut down)," he told McDaniel.

In a March 17, 2011, interview for COROH with local filmmaker Keith McDaniel, Lord relayed his first impression of the town. He recalled machines he had never seen before that scooped up earth in large amounts and moved it. He remembered the dust and mud "that could suck the shoes right off your feet."

Lord did not get the technical job offered him because his security clearance had been lost. So he was placed in the Training Division in town. He worked with Leon Love to teach the young women hired to be "cubicle workers," a term not explained to him.

These girls in their mid-to-late teens were hired to operate the "calutrons" at the Y-12 Plant. These were industrial-scale mass spectrometers, based on Ernest O. Lawrence's invention in Berkeley, California, at the Radiation Laboratory which used huge magnets to deflect uranium ions of two different masses (U-238 and U-235), causing them to separate into different

didn't know right away that we were separating uranium [isotopes]...but there was a lot of talk that went on among small groups who were confident about not being exposed."

"Once you figured out what you were doing, were you at peace with that?" he was asked.

"Oh, absolutely," Lord said. "I was delighted. There has been a lot of talk about how we never should have His sense of accomplishment was enhanced further when he led the effort to inject the ion beam from the Holifield tandem accelerator into ORIC to boost the beam's energy for physics experiments at Holifield. Lord and his wife have enjoyed retirement since 1984, when Union Carbide left town as the government contractor. And he continues to stand his ground even when a stranger, like a reporter for PRI, comes to town.

Thanks again Carolyn for an excellent excerpt from COROH archives. Thanks also for tying a current interview on Public Radio International to an oral history interview. It is this type of connection that makes our history come alive to the readers.

Putin's Grip on Russia Wavering



The recent news coming out of Russia is telling a story, and it isn't a pleasant one. The Russian War with Ukraine is going badly

for Putin and now, his grip on power appears to be slipping. As evidence to the situation in Russia

are the many reports of mass exodus of Russian people fleeing Putin's mass conscription. Putin desperately needs military age citizens to fuel his manpower needs for the War in Ukraine, but it appears the Russian people's patience with the crazed dictator have finally run out. Reports indicate that Russians crossing the border with Finland is escalating day by day and the line to cross the border into Georgia is more than 5 miles long.

But that is not the only sign of distress of his power structure, there are many indicators that Putin's days are numbered.

Wagner Group-Mercenaries for Hire Putin engaged the private military company Wagner on several occasions to support his military needs around the globe. The Wagner Group was formed after the fall of the former Soviet Union and was initially made up of former Special Forces specialists from the various Baltic states. Putin used the Wagner Group in Syria and to supplant his front-line forces in Ukraine. But recent reports indicate that the Wagner Group is now having to seek volunteers from Russian Prisons. The Wagner Group's effectiveness and military acumen will wane significantly because of prison inmates finding their way into their military organization.

Further complicating the Wagner Group, is the western support of providing the HIMARS (High Mobility Artillery Rocket System) to Ukraine. According to reports Ukraine used the HIMARS System to eliminate a Wagner Group headquarters in the Eastern Luhansk region after a Russian War Correspondent inadvertently revealed the group's location.

Putin's War on Ukraine has stretched the Wagner Groups capabilities and Ukraine is receiving excellent intelligence on where Wagner group's leaders are positioned on the battlefield. Considering all the variables, the Wagner Group's combat effectiveness is quickly diminishing, which translates downstream into diminishing


Last but not least, the final sign of Putin's waning influence are the many protests throughout Russia. The protests are an apparent indicator of Putin's unpopular military conscription.

According to the Kremlin, "300,000 people with military experience would be called up to support the Special Military Action in Ukraine." Other international news agencies indicate that groups that were previously exempt from conscription such as university students are now being targeted for military service. OVD is an independent Russian human rights media project with the goal of advocating against political persecution. According to this watchdog group, at least 1,332 people were arrested at protests in 38 different Russian cities after a morning address to the nation by Putin in September.

These protests were in response to conscription efforts by Putin.

OVD reported these protests and subsequent arrests which quickly garnered the attention of Putin, who tasked government regulators to block its website. Which is just one of many moves that Putin has taken in a months-long crackdown of independent media.

In conclusion, it is clear Putin is losing his grip on power, day by day, and week by week. If Putin must abdicate his throne in Russia, who will be his successor? That is the question that I am certain many national intelligence agencies are pondering at the moment. Myself, I am just hoping for Christmas without a Ukraine War or Putin! That would be a true Christmas present indeed!

General Bulgakov was a Deputy Defense Minister who had been in charge of the failed logistics of the Ukrainian Invasion. He was replaced by the brutal commander General Mikhail Mizintsey who commanded the Russian siege at the port of Mariupol. His actions at Mariupol earned him the name of "The Butcher of Mariupol" and official sanctions from the United Kingdom (UK).

UK defense officials also assert that Putin had side-lined another senior defense official, Sergei Shoigu, after many reports that indicated he had "ineffectual and out-of-touch leadership."






Fall Flea Season

DEAR PAW'S CORNER: My cat Isaiah often gets fleas in the late spring through summer, but by September the fleas are usually gone. This year, he still has fleas, even as we get into the chillier October month. What can I do to drive the fleas out? — Maddy in Biddeford, Maine


DEAR MADDY: While flea activity tends to drop during the colder months, chillier weather isn't a guarantee that they'll go away. A number of factors could keep them around, conceivably, all year. Things like a constantly warm environment in which to live (your house) or a higher than usual flea population (this can vary from year to year).

To really get rid of Isaiah's fleas, you'll need to treat him and tackle possible flea problems inside the house.

Treat Isaiah with a flea treatment, available at the pet store or from the vet. Perfumed soaps aren't good alter-







natives; they can dry and irritate his skin.

Wash or replace Isaiah's bedding, and wash any furniture upholstery, blankets or other items where he likes to lounge for long periods.

Treat the carpet with a flea preventative, available at the pet store or online. Put Isaiah into a safe room and sprinkle the treatment into the carpet as directed, then vacuum it up. The treatment will take care of any live fleas or eggs hiding in the carpet.

If your cat spends time outdoors, consider making him an indoor cat. This will reduce the chance of him contracting fleas outside and bringing them into the house.

Hispanics Weren't What Progressives Thought

One of the most significant events in American politics is that Hispanics are, in effect, deciding that they are working-class voters rather than ethnic-grievance voters.

This is so momentous because it means that Democrats can't rely on the monolithic Hispanic voting bloc they imagined would guarantee them an enduring electoral majority, and that the shift to the Republicans may be just beginning (the migration of working-class whites to the GOP has been happening over the course of a couple of generations).

An NBC News/Telemundo poll of Hispanics has Democrats ahead of Republicans in the battle for Congress 54-33%. That's a healthy lead, but it's down from prior polls. Democrats led among Latinos by 42 points in October 2012, 38 points in October 2016, and 26 points in October 2020. Detect a trend?

Republicans don't have to win Hispanics outright to change the calculus of American politics, only eat into Democratic margins.

In specific places, they are doing even better. A Sienna College poll shows Gov. Ron DeSantis and Sen. Marco Rubio, both running for reelection in Florida, above 50% among Hispanics. A new poll for The Nevada Independent has Republican Adam Laxalt, challenging Democratic incumbent Sen. Catherine Cortez Masto, down by only 2 points among Hispanics.

It wasn't supposed to happen this way. Progressives had Hispanics pegged as "non-white" voters, which meant they'd be animated by the same worldview as Black Americans and become nearly as immovably Democratic. The arbiters of such things even cooked up a new term for Hispanics, "Latinx," to signal their assimilation into the hothouse world of "woke" politics, with its kaleidoscope of genders and other bizarre priorities.

Hispanic is an incredibly wide-ranging category including people from different countries and regions who may have lived here for generations or just got here recently.

Generalizations are inevitably simplifications, but it's safe to say they don't have much in common with Black Americans, who went through the uniquely searing experience of enslavement and systematic discrimination. Within memory, Black people had to fight for the basic legal protections of citizenship, whereas many Hispanics got here after 1980, when the most fundamental civil rights struggles had already been won.

In a piece for Spectator World, the Republican pollster Patrick Ruffini argues that Hispanics are tracing the basic trajectory of white Catholics as they assimilate, move to the suburbs, and hew to traditional values out of fashion with the nation's elite.

Analyst Ruy Teixeira has noted the clashing cultural attitudes of "strong progressives" and Hispanics. According to Echelon Insights survey, 66% of progressives reject the idea that America is the greatest country in the world; 70% of Hispanics disagree. Asked whether racism is built into our society or comes from individuals, 94% of progressives say it is systemic, and 58% of Hispanics say it is from individuals. The same divides are evident ed of paying kickbacks, misleadon transgender sports, defunding the police, and the importance of ing investors and committing hard work.

Medical Scammers Caught

Thieves must think they're smarter than the rest of us. Until they're caught, that is, and have to give up all their ill-gotten gains and spend time behind bars. Here are a few examples:

The president of a medical testing company has been convicthealth-care fraud for pushing an allergy test.

The scammer was convicted of a whole list of crimes and could face five to 20 years in prison on each of the scams. A back-ofthe-envelope calculation shows 115 years in prison.

Then we have yet another health-care fraud, this time for genetic cancer testing. The owner of a chain of laboratories paid kickbacks for referrals who sent him patients who didn't actually need the test he was providing. The scammer submitted 325,000 claims and received over \$26 million in payments.

And yet another thief, this time a chiropractor, targeted health care in the durable medical equipment niche: crutches, hospital beds, canes, walkers, wheelchairs and more -- all supposedly prescribed through telemedicine visits. It involved bribery of doctors who approved the medical equipment. Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA) was just one of their targets, and the scammers collected over \$10 million from that one source alone.

The picture is of a constituency that is going to be skeptical of a party that made excuses for the 2020 riots premised on the notion that America is fundamentally corrupt, or that is on board the rush to embrace a nonbinary future. Needless to say, this is not FDR's Democratic Party, which had such a hold on white Catholics for so long.

On the cultural questions in the Echelon survey, Hispanics are much closer to working-class voters than the "wokesters." This shouldn't be a surprise since about 80% of Hispanics over age 25 don't have a four-year degree, whereas hyper-progressives are disproportionately college-educated. Like other working-class voters, Hispanics are focused on the economy, and give President Biden failing grades.

TITLE: None of this means the Hispanic trend toward Republicans is inexorable. Rather, it shows that, despite Democratic hopes, these voters are up for grabs, and their support has to be earned like that of other Americans.







also vary. Check for doneness beginning at 50 minutes. It's cooked when it's soft and easily pierced by a fork. When cooked, the squash will have liquid in the center. Let the squash rest to reabsorb that liquid.

Beware of texting scams



The IRS is warning everyone of a recent increase in texting scams aimed at stealing your personal and financial information. Con artists are using texting scams (known as smishing) to pretend to be the IRS.

In the last few weeks, IRS simulated smishing has increased exponentially.

Smishing campaigns target cell phone users and often offer fake COVID relief, tax credits, or help setting up an IRS online account. In the latest activity, scam texts often ask you to

click a link where phishing websites will try to collect your information or potentially send malicious code onto your phones.

"This is phishing on an industrial scale, so thousands of people can be at risk of receiving these scam messages," said IRS Commissioner Chuck Rettig. "In recent months, the IRS has reported multiple large-scale smishing campaigns that have delivered thousands – and even hundreds of thousands – of IRS-themed messages in hours or a few days, far exceeding previous levels of activity."

You should report these scams to phishing@irs.gov. When you report scams to the IRS, it enables them to report the scam to the appropriate service providers for action, protecting other people who might receive a variant of the same scam.

The IRS tries to stop online fraud. However, criminals are constantly creating new tactics to exploit more victims. They are known to use algorithms to automatically create hundreds or even thousands of fraudulent domains. For example, a recent strategy used just three dozen bogus or stolen email addresses to make over 1,000 fraudulent domains.

"Particularly in these cases, the best offense is a good defense," said Rettig. "Taxpayers and tax pros need to remain constantly vigilant with suspicious IRS-related emails and text messages. And if you get one, sending the IRS important details from the text can help us disrupt the scams and protect others."

Reporting fake IRS texts to the IRS allows security professionals to track and help stop these scams. When reporting scam texts, the IRS prefers that you include both the body of the message and the sender's information in one text or email. Copying the actual text into an email is preferred. However, screenshots can be sent if necessary. You can also scam SMS/text messages by copying and forwarding them to wireless providers via text to 7726 (SPAM). Reporting scams helps the IRS to spot and block similar messages in the future.

The IRS will never send you emails or text messages asking for personal or financial information or account numbers. Emails and texts claiming to be the IRS should always be a red flag.

Thessalonians Chapter 2

(2 Thes. 2:1-12) The coming apostasy: The apostle now addresses another end-time issue about which they were confused (1 Thes. 4:13). It concerned the final coming of Christ to judge the world and the saints' gathering unto him. He pleads that they be not "quickly shaken" (unsettled) or agitated by false ideas regarding this terminal event, either by "spirit" (a false teacher) (1 Jn. 4:1), by word, or by a written document, as if it were divine in origin. The theme in question is whether the coming of the Lord "is just at hand" (v.2). Most modern translations reflect the perfect tense of the verb, hence whether "the day of the Lord has arrived." How could anyone possibly have believed the coming of Christ had occurred already? Obviously certain false teachers had spiritualized the concept, just as the radical preterists do today in claiming that the second coming occurred in A.D. 70 with the destruction of Jerusalem!

They were to guard themselves against deception. The Lord's return was not on the immediate horizon. First, there would begin to be "the falling away," a definite apostasy (1 Tim. 4:1; Heb. 3:12). The Calvinistic rationalization that these "apostates" were merely professors of the faith who had never been genuine Christians is entirely without substance. Resulting from this apostasy eventually would be a sinister character called "the man of sin" (his prevailing character), "the son of perdition" (deserving of punishment), and "the lawless one" (one who flouts divine law v.3, 8).

It is clear that this evolving apostasy was not yet identifiable by the early Christians. Three points must be made: (a) This "man of sin" is not to be identified as a solitary character; rather, it is a movement, personified by a sinister class of beings. (b) There is no basis for the theory that this is the fictional Antichrist of dispensational premillennialism. (c) The language was descriptively and chronologically ambiguous enough so that the prophecy did not nullify warnings about being constantly prepared for the Lord's return. This is extremely important to appreciate.

This movement, though developing out of the Christian system, actually was in opposition to God and true worship. It was religiously corrupt. The system would feign itself to be "the temple of God" (a divinely orchestrated enterprise) and would boast of the prerogatives of deity (v.4). The apostle reminds them that he previously had given them a degree of instruction regarding this matter (v.5). He further declares that this as-yet-undisclosed lawless one is already in an early stage of development; however an oppressive force---"that which restrains" (neuter; a secular impediment)---is holding back the godless movement to a degree (v.7). At the appropriate time, however, the "lawless one" would be revealed (v.6). According to the divine schedule, this diabolic movement would be destroyed by the word of Christ and reduced to nothingness by the Lord's arrival (v.8).

One identifying feature of this enemy would be its claim of supernatural works, wonderful powers that were set forth with the claim of divine "signs," but in reality were nothing more than "lying wonders," unrighteous feats of "deceit" for gullible people who were not disposed to receive a "love of the truth" in order to be saved (v.9-10). Paul makes a curious statement, seemingly so out of character for God. He "sends a working of error, that they should believe a lie,"



This is a common biblical idiom, however, whereby the active voice is put for the passive for the sake of emphasis. God never "sent" a lie; lying cannot be a part of his holy character (Tit. 1:2; Heb. 6:18). Instead, when men lack honest hearts, he permits them to go their reckless ways and believe lies. (For similar examples of this "idiom of permission," see Jer. 4:10, Ezek. 20:25; Mt. 6:13.) Those who have pleasure in unrighteousness and believe not (obey not) the truth will be "judged" (condemned).

Various theories are set forth to identify the "man of sin", pagan mythology, Satan, a principle of evil, Judaism, a Roman ruler, and the so-called future Antichrist. None of these fits Paul's catalog of descriptive. Neither paganism, Satan, Judaism, nor a Roman emperor were apostates from the Christian religion. The principle of evil" is too abstract for the language of the apostle. The future "Antichrist" theory does not conform to the reality that Paul's "man of sin" was already in embryonic operation at the time of his writing. Nothing fits all the details of the prophecy more precisely than the religious departure from the New Testament pattern (Acts 20:29); 1 Tim. 4:1; 2 Tim. 4:1, etc.) that fully manifested it eventually in Catholicism (with its different branches---Roman, Greek, and Anglican), together with the Protestant movement that came from that pagan/pseudo-Christian conglomerate. Though Protestantism was a noble effort, it still carried much of the baggage of the "mother of harlots" (Rev. 17:5).

(2 Thes. 2:13-17) Thanksgiving and prayer: Paul tenderly reminds these brothers of his prayerful interest in them; he is thankful for them, for they are his beloved brothers in the Lord. They had been "chosen in Christ" (Eph. 1:4). It was not the "unconditional election" of Calvinism, but the choosing of a "type" of people, namely those who would be lovingly responsive to the Lord's will. They further are depicted as saved, sanctified of the Spirit, and believers of the truth.

These expressions precisely conform to parallel truths that make the following affirmations: (a) Faith in gospel truth is required of those who would belong to God (Mk. 16:16). (b) The operation of the Spirit through inspired Scripture (Eph. 6:17; "gospel" in v. 14) motivates to obedience (Jn. 3:3-5; 1 Cor. 12:13). (c) There must be an expression of one's faith in submitting to the water of baptism (Acts 2:38; Eph. 5:26; Tit. 3:5). (d) The sum of this produces cleansing, or salvation, the equivalent of being "chose." (e) The ultimate reward is in obtaining the "glory" of Christ (v.13-14).

They thus were to "stand fast" and continue holding to the inspired traditions (3:6) which they had been taught by specially endowed men of God, whether personally or by means of epistle. Paul's letters carry an authority equal to that of his words in person.

The apostle concluded this section with a prayer that is addressed to both Christ and the Father. Jesus is honored as "Messiah" and "Lord," and the Father is praised as him who "loved us" (the past tense focuses upon the cross) and gave us "eternal comfort"; this

promise stands in contrast to the temporal comforts of this life. "Good hope" is a qualitative hope that finds its fulfillment in heaven. These are accessed through the "grace" system (Rom. 5:1). Surely these promises would establish them (and us) with "comfort" in our hearts, and motivate us toward "every good work and word" (v. 16-17).



Planting in autumn

Gardeners often think that fall is too close to bitter winter weather to plant a young tree, but cooler temps and autumn rain help to establish roots before they must contend with extreme heat or drought of the following summer. TO THE VOTERS OF MORGAN COUNTY, TENNES-SEE: You are hereby notified that by call of Senate Joint Resolution No. 2, Senate Joint Resolution No. 10, Senate Joint Resolution No. 80, and Senate Joint Resolution No. 55, the proposed amendments must be submitted to a vote of the people on November 8, 2022. In the same order as the proposed constitutional amendments will be placed on the ballot, the following contains the text of Senate Joint Resolution No. 2, Senate Joint Resolution No. 10, Senate Joint Resolution No. 80, and Senate Joint Resolution No. 55:

SUMMARY OF SENATE JOINT RESOLUTION NO. 2

This amendment would add a new section to article XI of the Tennessee Constitution to make it illegal for any person, corporation, association, or the State of Tennessee or its political subdivisions to deny or attempt to deny employment to any person because of the person's membership in, affiliation with, resignation from, or refusal to join or affiliate with any labor union or employee organization.

SENATE JOINT RESOLUTION NO.

2

A RESOLUTION to propose an amendment to Article XI, of the Constitution of Tennessee, relative to the right to work.

WHEREAS, Senate Joint Resolution No. 648 of the One Hundred Eleventh General Assembly, known as the "Right to Work Amendment", which proposed amendment of Article XI of the Constitution of Tennessee, relative to the right to work, was considered and agreed upon by a majority of all the members elected to each of the two houses, as shown by the yeas and nays entered on their journals; and

WHEREAS, such resolution proposing such amendment was published in accordance with Article XI, Section 3 of the Constitution of Tennessee; and

WHEREAS, protecting the right of Tennesseans to join or refuse to join a labor union or employee organization is a fundamental civil right; and

WHEREAS, this right to work has played a crucial role in Tennessee's thriving economy; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED TWELFTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESEN-TATIVES CONCURRING, that a two-thirds majority of all the members of each house concurring, as shown by the yeas and nays entered on their journals, that it is proposed that Article XI of the Constitution of Tennessee be amended by adding the following language as a new section:

It is unlawful for any person, corporation, association, or this state or its political subdivisions to deny or attempt to deny employment to any person by reason of the person's membership in, affiliation with, resignation from, or refusal to join or affiliate with any labor union or employee organization.

BE IT FURTHER RESOLVED, that, in accordance with Article XI, Section 3 of the Constitution of Tennessee, the foregoing proposed amendment shall be submitted to the people at the next general election in which a governor is to be chosen, the same being the 2022 November general election, and the Secretary of State is directed to place such proposed amendment on the ballot for that election.

Whenever the Governor transmits to the Secretary of State, the Speaker of the Senate, and the Speaker of the House of Representatives, a written, signed declaration that the Governor is unable to discharge the powers and duties of the office, the powers and duties of the office of Governor shall be temporarily discharged by the Speaker of the Senate as Acting Governor, or if that office is unoccupied, then by the Speaker of the House of Representatives as Acting Governor, until the Governor transmits to the same officials a written, signed declaration that the Governor is able to discharge the powers and duties of the office.

Whenever a majority of the commissioners of administrative departments of the Executive Department transmits to the Secretary of State, the Speaker of the Senate, and the Speaker of the House of Representatives their written, signed declaration that the Governor is unable to discharge the powers and duties of the office, the Speaker of the Senate shall immediately assume the powers and duties of the office as Acting Governor, or if that office is unoccupied, then the Speaker of the House of Representatives shall immediately assume the powers and duties of the office as Acting Governor, until the Governor transmits to the same officials a written, signed declaration that the Governor is able to discharge the powers and duties of the office.

Whenever a Speaker is temporarily discharging the powers and duties of the office of Governor as Acting Governor, such Speaker shall not be required to resign the Speaker's position as the Speaker or to resign as a member of the general assembly and shall retain the Speaker's salary and not receive the Governor's salary, but such Speaker shall not preside as Speaker or vote as a member of the general assembly during the time the Speaker is Acting Governor.

BE IT FURTHER RESOLVED, that it is proposed that Article III, Section 13 of the Constitution of Tennessee be amended by adding the following language immediately before the period at the end of the Section:

except as provided in Article III, Section 12 with regard to the Speaker of the Senate or the Speaker of the House of Representatives temporarily discharging the powers and duties of the office of Governor as Acting Governor

BE IT FURTHER RESOLVED, that it is proposed that Article II, Section 26 of the Constitution of Tennessee be amended by adding the following language at the end of the Section:

Section 33. Slavery and involuntary servitude are forever prohibited. Nothing in this section shall prohibit an inmate from working when the inmate has been duly convicted of a crime.

BE IT FURTHER RESOLVED, that, in accordance with Article XI, Section 3 of the Constitution of Tennessee, the foregoing proposed amendment shall be submitted to the people at the next general election in which a governor is to be chosen, the same being the 2022 November general election, and the Secretary of State is directed to place such proposed amendment on the ballot for that election.

SUMMARY OF SENATE JOINT RESOLUTION NO. 10 This amendment would add to article III, section 12 of the Tennessee Constitution a process for the temporary exercise of the powers and duties of the governor by the Speaker of the Senate—or the Speaker of the House if there is no Speaker of the Senate in office-when the governor is unable to discharge the powers and duties of the office of governor. While a Speaker is temporarily discharging the powers and duties of the governor, the Speaker would not be required to resign as Speaker or to resign as a member of the legislature; but the Speaker would not be able to preside as Speaker or vote as a member of the legislature. A Speaker who is temporarily discharging the powers and duties of the governor would not get the governor's salary but would get the Speaker's salary. The amendment would also exempt a Speaker who is temporarily discharging the powers and duties of the governor from provisions in the Constitution that would otherwise prohibit the Speaker from exercising the powers of the governor and from simultaneously holding more than one state office. 
you, Mama." She smiled through all the pain that she had endured



Rep. Windle Visits Communities in Schools program at Wartburg High School

Representative John Mark Windle recently visited Wartburg High School to learn more about the Communities in Schools of Tennessee (CIS of Tennessee) program, an affiliate of the national organization working to ensure every student, regardless of race, zip code, or history of marginalization has what they need to succeed in school and beyond. CIS of Tennessee works with Warburg and three other high schools in Morgan County: Coalfield, Oakdale, and Sunbright.

All four of the CIS of Tennessee site coordinators (Mandi Jonquet at Wartburg, Kalea Derry at Coalfield, Courtney Boido at Sunbright, and Cameron Bruse at Oakdale) met with Rep. Windle to discuss their work to establish one-on-one relationships with students and help them navigate issues and move beyond barriers in the classroom, at home, and in the community. CIS of Tennessee site coordinators are based at their respective schools and work with local service providers to help connect students and families with critical resources like food, clothing, housing, healthcare, counseling, transportation, and more. Mandi Jonquet, the site coordinator at Wartburg, showed Rep. Windle the hygiene and clothes closets that she maintains at the school so that students who need clothing or supplies are able to access what they need. The site coordinators also discussed the social-emotional and behavior She found out his real father's last name and went back to ask again using that name – but was told they couldn't share it because his mom owned money.

"We were literally pulling our hair out, trying to figure out what we were going to do, what our next step was," Jonquet said.

> A cousin advised her to call Rep. Windle's office, and his staff person immediately told her that the state should not be withholding his birth certificate because the mom owed money, and intervened to help clear up the issue.

"His staff was amazing... if they had not stepped in and held me, we would probably never have gotten anything accomplished," Jonquet noted.

Correct birth certificate in hand, Jonquet was able to take

the student to the social security office, and to get his driver's license so he could get back and forth to TCAT, where he is thriving today.

"Having to tell a kid that their real name is something different than what they've gone by for 18 years is heartbreaking... it was just a whirlwind of emotions," Jonquet said. "If he hadn't come up that he wanted to go to college, which I pushed him to do because he is such a good student to do something, he would've never known that his name was changed."



Completed paper voter registration applications must be mailed to the Morgan County Election Commission or submitted in person. Mailed voter registrations must be postmarked by Oct. 11.

The Morgan County Election Commission is located at the Courthouse room 105, 415 N Kingston St, Wartburg, TN 37887 or mailed to PO Box 266, Wartburg, TN 37887 Voters can drop off completed registration forms or register in person Monday to Friday from 8 a.m. to 4 p.m.

Election Day registration is not available in Tennessee. Voter registration forms submitted or post marked after October 11, 2022 will be held for registration and eligibility to vote in elections after November 8, 2022.
