



Page 4 Historically Speaking Bobby Copeland – World's No. 1 writer of books on western films

Bobby Copeland passed away not too long ago. This article was written several years ago now. I want you to experience Bobby as he was and so I have not altered the writing style except for the very last sentence.

I often dismay that we have people in Oak Ridge who are famous on the national or international stage, but totally taken for granted and most often unrecognized by local media or even given credit for their achievements in any way in their hometown of Oak Ridge. Shame on us!

Many Oak Ridge scientists are world renowned. Many dedicated servant leaders occupy prestigious positions on technical society boards (occasionally these folks will get a small amount of recognition when they are elected to office). Many inventors are granted patents (we should have a directory of patent holders!). Many national and international award winners get only sparse recognition and even less lasting appreciation for their hard work.

Still, we do better at recognizing technical achievements than we do some others. And that is understandable, given Oak Ridge's high percentage of highly qualified and successful scientists and engineers. Occasionally we should raise up one of our own who has done something unique and contributed to the world that is highly unusual. Such a person is Bobby Copeland.

Remember, if it is to be, it is up to me! So, I have found an example of someone who has carved out a niche for himself on the world stage of a particular special interest group...western film stars. I dare say only a handful of Oak Ridgers know about his collection of western film paraphernalia or his authorship of 22 books, and over 200 articles for various publications.

Not many cities can boast of having the No. 1 person in the world in any specialty. I am sure that we have several individuals who qualify as world leaders in technical specialties or scientific achievements.

Now let's celebrate Bobby Copeland's dedication to his chosen work and his resultant achievements in a most unusual field – "B-western" films and performers.

A little background on Bobby, his family came to Oak Ridge in 1945 when he was10 years old. His family lived in Happy Valley. He readily recalls the theater there called "Playtime." His family soon moved to other locations in Oak Ridge where he always visited the local community theater regularly. He has watched cowboy movies at the Middletown, Jefferson, Wayne and Center theaters.

I don't know about you, but I had never heard of a theater called "Wayne." So, I asked Bobby about that. He said, "The Wayne Theatre opened in the same structure shortly after the Jefferson Theatre went out of business. It was much like the Jefferson, showing older movies, double-feature, and low-budget films. The Wayne was only open for a short period of time." (Photo Submitted)

Bobby says, "B-westerns were important to me because of good moral values taught by the movies. The cowboy hero gave me someone to look up to. He set an example by always doing what was right." Do you remember that? Sure you do...

Bobby is a collector of western movie paraphilia, but his main interest is in writing about the western film performers. He began writing in 1984 and that came about after years of dedicated interest in western movies.

He said, "My first collectible was a string-tie worn by singing cowboy Eddie Dean. Other collectibles include: shirts owned by Wild Bill Elliott, Crash Corrigan, Lash LaRue, and Monte Hale; bandannas from Bob Baker, Monte Hale, Eddie Dean, Harry Lauter, Harry Carey, Jr., and Sunset Carson; belts from Monte Hale and Pierce Lyden (and also an autographed photo cup from Lyden); cowboy hat and tie clasp from

Bobby said, "My favorite star is Wild Bill Elliott." Do you remember him? He made 256 movies from 1925 to 1957. Do you recall anything unusual about the way he wore his guns? Yes, two six-guns worn facing butt-forward in their holsters.

For readers who might not be as familiar with "B-westerns," here is what Bobby Copeland thinks you might need to know to better appreciate them and their history.

"If you were fortunate enough to have lived in the 1930s and 1940s, and if you were lucky enough to obtain a dime, you could visit your local movie house to view an exciting B-Western movie. The BWestern is a true piece of Americana and reflects on a time when we believed in God, country, Mom, apple pie and Saturday matinee heroes.

"Many have asked, 'Just what does the 'B' stand for in B-westerns?' Well, it stands for budget - low budget. However, these films should not be thought of as inferior just because so little money was spent on making them.

"To a great segment of the population, these little gems are still considered very special. They made an impression on the youths of that era that is still etched in the hearts and minds of those individuals today.

"Fans of the B-Westerns now gather at Western film festivals to meet the performers whom they idolized as youths in an attempt to recapture memories from the past. At these events through the years, this group of fans have enjoyed meeting in person Roy Rogers, Lash LaRue, Buster Crabbe, Rex Allen, Don 'Red' Barry, Eddie Dean, Gene Autry, Charles 'The Durango Kid' Starrett, Monte Hale, Ben Johnson, Clayton Moore, and hundreds of others.

"The B-Westerns had simplistic and repetitive plots, and there was never a mystery about the identity of the hero or the villain. Everyone knew that there would be a rip-roaring climax, where good would triumph over evil, and that the hero would ride off into the sunset ready to fight another day.

"The cowboy hero had the fastest horse, quickest draw, fanciest clothes, sang the sweetest song, and he possessed a heart of purest gold. Even on his worst day, he could beat the daylights out of the meanest bad guy and clean up the most wicked town in the

West - without even getting dirty.

"For decades, critics have maligned the B-westerns and regarded them as nothing more than juvenile fare, or simply thought of them as a waste of film. Yet these grand old movies probably did more than any other one thing to shape our ideas and ideals.

"The films gave us action, comedy, music, and good wholesome entertainment for the entire family. They taught us faith, hope, loyalty, honesty, and gave us heroes. We knew they were not real, but we loved them just the same.

"They made no attempt to show life as it is, but rather how life should be. The B-Westerns were not a substitute for church, but they certainly complemented the message presented by the church. After watching one of these movies, you felt a tingle of goodness spread throughout your body - as if your soul had been cleansed.

I also asked him about the name "Middletown" for the theater located in what I had thought of as "Midtown," like the "Midtown Community Center." His response was that the name of the theater located in what was known as "Midtown" was actually named "Middletown."

Bobby is one of the few (perhaps the only person) to attend the Wheat and Gamble Valley grammar schools, the old Jefferson Junior High (when it was at the Robertsville Middle School location), the high school when it was at Jackson Square, and the present high school located on the Oak Ridge Turnpike. To have Bobby confirm that he attended school at Wheat of course means there was an elementary school there in 1945.

So, what about these "B-western" movies? Do you recall them? If you do, then you realize the formula.

Rex Allen; badge worn by Johnny Mack Brown to one of Ronald Reagan's functions and western pants worn by Johnny; Ken Maynard cigar band and stock certificate; duplicate of a John Wayne holster and belt made by Bob Brown, who made the original for Wayne."

Wow, what a collection. Do you collect anything? If so, you can appreciate the joy that comes from finding something special to you that you are seeking.

Since starting writing in 1984, Bobby is the author of 22 books, and over 200 articles for various publications -- including the British publication Wrangler's Roost. Bobby has also been a guest speaker at several film conventions. He is recognized worldwide for his knowledge and authorship.

When asked to name the favorite western film star,

"Unfortunately, the advent of television sounded the death knell for grand old films, and the heroes of the celluloid range are gone forever.

Several people in Oak Ridge know that Bobby Copeland is a western film fan, but I imagine they have no idea to what degree. Bobby Copeland is the world's No. 1 writer of books on western film performers.

Not many towns the size of Oak Ridge can boast of having a No. 1 in the world person in anything. Our own Bobby Copeland was internationally recognized as an expert on B-western films and performers.

Page 5 HIMARS, The King of Modern-Day Conventional Battlefield



There have been many articles on the internet recently relating to the United States Military's, HIMARS system.

Michael Nance So, what is the HI-MARS System and *Columnist* what is its capabili-

ties? Those are the questions answered in this article.

The M142 High Mobility Artillery Rocket System (HIMARS) is a light multiple rocket launcher developed in the late 1990s for the United States Army, mounted on a standard Army M1140 truck frame. We owe the genesis of this modern-day battlefield implement to the folks at Lockheed Martin.

As a former artilleryman, I remember when the HIMARS came onto the military scene, and to be honest I wasn't that impressed. At the time, I could see no substitute for a 155mm projectile from a howitzer exploding and raining down destruction onto the enemy. As it turns out I couldn't have been more wrong about this highly versatile and deadly system.

Each HIMARS unit can carry six GPS-guided missiles that can be reloaded in about a minute with a small team consisting of four soldiers. The range of the system is about 80km (50 miles). This range is effectively three times that of the conventional self-propelled howitzers that I am familiar with. The smaller crew and being mounted on a truck chassis dictate that after the HIMARS unit fires all of its ordinance it can quickly leave the firing position. This quick turn-around time prevents the enemy from targeting the launch point with artillery counterbattery. These capabilities evidence that the HIMARS system has the artillery ethos of "Shoot, Move and Communicate."

Ukraine was provided several of the HIMARS units in May and they have been devastating the Russian forces with the system. The Ukrainian forces have targeted Russian ammunition depots and even Russian sponsored foreign mercenary strongholds, all with deadly accuracy. Many experts believe that the HIMARS system has completely flipped the balance of power paradigm between the Russian and Ukrainian military capabilities. The effectiveness of HIMARS on the Ukrainian battlefield was predicted a few months ago when retired U.S. Army General Mark Hertling tweeted: "w/ fewer rounds, greater range, precision accuracy" HIMARS are "a game changer" in the Russia-Ukraine war.





The entirety of Europe has taken notice of the HIMARS system. Poland and the Baltic States have witnessed how this system doesn't have a Russian equivalent. Russia's neighbors are now seeking to acquire the launch systems from the United States.

Polish defense officials have requested 500 HIMARS launchers and accompanying ordinance – this is a huge number and would be enormously expensive.

HIMARS soon to have a presence along Russia's borders is another example of how the Russian invasion of Ukrainian has strategically back fired on Putin.

In conclusion, the HIMARS system is another example of American ingenuity, quality and creativity. All the things that a communist society lacks. Let's hope that we maintain these American traits in the years to come.

United States Army veteran Colonel Ola Lee Mize served in both the Korean and Vietnam Wars. In Korea he was assigned to 2D Platoon, Company K, 15TH Regiment, 3D Infantry Division and was awarded the Medal of Honor for his actions during the Korean War.

Mize was born in Albertville, Alabama, the son of a sharecropper. He left school after 9th grade to help support his family. After several years of working for low pay, he attempted to enlist in the Army, but was rejected for being too light, at 120 pounds. He tried repeatedly to enlist and was eventually accepted, joining the Army in 1950 from Gadsden, Alabama.


Assigned to the 82nd Airborne Division, Mize planned to finish his term of service and return to school. When the Korean War began, he changed his plans and

reenlisted in hopes of seeing combat. He volunteered for a front-line unit and ended up as a sergeant in Company K of the 15th Infantry Regiment, 3rd Infantry Division.

Mize later joined the Special Forces where he gained a commission and served three tours of duty in the Vietnam War. In 1965, he was assigned to the Special Forces Training Group, where he was the Advanced Training Committee chief for SCUBA, HALO, and the SKY HOOK schools. Colonel Mize is credited for being the officer responsible for starting the present-day Combat Divers Qualification Course in Key West, FL. From 1966 to 1967, he was again assigned to Vietnam with the 5th Special Forces Group where he was an Operational A, B, and C Detachment Commander and once more in 1969, where he was assigned to the 5th Special Forces Group as the Commander of the 3rd Mobile Strike Force Command (Cambodian Troops). During his tour while commander of B-36 3rd Mobile Strike Force he was awarded the Silver Star for Valor in 1969. Going on to meet president Eisenhower and Kennedy. He retired in 1981 as a colonel.

He was presented with his Medal of Honor at the White House on September 7, 1954 by President Dwight D. Eisenhower.

His Medal of Honor citation reads: M/Sgt. Mize, a member of



Company K, distinguished himself by conspicuous gallantry and outstanding courage above and beyond the call of duty in action against the enemy. Company K was committed to the defense of "Outpost Harry," a strategically valuable position, when the enemy launched a heavy attack. Learning that a comrade on a friendly listening post had been wounded, he moved through the intense barrage, accompanied by a medical aidman, and rescued the wounded soldier. On returning to the main position, he established an effective defense system and inflicted heavy casualties against attacks from determined enemy assault forces which had penetrated into trenches within the outpost area. During his fearless actions he was blown down by artillery and grenade blasts three times, but each time he dauntlessly returned to his position, tenaciously fighting and successfully repelling hostile attacks. When enemy onslaughts ceased, he took his few men and moved from bun-

ker to bunker, firing through apertures and throwing grenades at the foe, neutralizing their positions. When an enemy soldier stepped out behind a comrade, prepared to fire, M/Sgt. Mize killed him, saving the life of his fellow soldier. After rejoining the platoon, moving from man to man, distributing ammunition, and shouting words of encouragement he observed a friendly machine-gun position overrun. He immediately fought his way to the position, killing 10 of the enemy and dispersing the remainder. Fighting back to the command post, and finding several friendly wounded there, he took a position to protect them. Later, securing a radio, he directed friendly artillery fire upon the attacking enemy's routes of approach. At dawn he helped regroup for a counterattack which successfully drove the enemy from the outpost. M/Sgt. Mize's valorous conduct and unflinching courage reflect lasting glory upon himself and uphold the noble traditions of the military service.

Mize died of cancer on March 12, 2014 at Gadsden, Alabama, aged 82.



I have to either put a cone on her or socks on her paws so she doesn't chew them bloody during these episodes. I hear from other friends that their dogs have anxiety issues as well. Is this problem on the rise? — Sherri L., Kansas City, Mo.

DEAR SHERRI: Evidence isn't clear that anxiety in dogs is rising, but there is a rise in the understanding and diagnosis of anxiety in pets by veterinarians. This has led to an increase in diagnosis and treatment for pet anxiety.

While that is good for pets, there is no "magic bullet" to quickly cure a dog of an anxiety disorder. Tara's vet can diagnose the problem, and can help you determine different ways to treat her.

easing anxiety symptoms, but you also want to look for causes of Tara's anxiety, and trigger points that set off her paw-chewing. Thunderstorms are one trigger; your leaving the house is another.

There are a number of different techniques, both training or interaction, to turn off those triggers. While there's not room in this column to list them, do some quick research and look for dog training manuals that stress positive reinforcement. Ask the vet and your friends about local dog trainers or specialists who treat pet anxiety issues.

In evaluating such professionals, ask what therapies they use or are open to, and make sure they emphasize your role in working with Tara (owners have to put in the time with their dogs). Be circumspect about pet therapists who insist they have a single, one-sizefits-all solution for anxiety.

High-speed Rail Is a Progressive Fantasy

California progressives tried to build a European-style high-speed rail network and alienated the French in the process.

A big New York Times piece on the rail project reports that the French, who wanted to work with California, decided the state was simply too dysfunctional and departed to help complete a high-speed line in Morocco instead.

The ongoing unraveling of California's rail plan is an object lesson in how infrastructure as eschatology is a bad idea. If transportation is conceived as a way to save the planet and fulfill a deep-seated, quasi-religious fixation rather than a means to move people around more efficiently, it is bound to fail. Throw on top California's politicized decision-making and regulatory and legal obstacles to building, and it's a formula for a boondoggle for the ages.

No matter how high California has estimated the cost of the project, it hasn't been enough, even as almost nothing has been built. It started out at \$33 billion in 2008. Now, it's \$113 billion, with no one knowing where the funding is going to come from.

Not that the California experience will diminish the progressive ardor for high-speed rail. As far as its enthusiasts are concerned, it is like socialism -- never failed, just never truly tried.

President Barack Obama proposed an 8,600-mile highspeed rail system, and Transportation secretary Pete Buttigieg wants the U.S. to be the "global leader" in high-speed rail. Progressives think of bullet trains like windmills on rails, a symbol of enlightenment and modernity, a way to free ourselves from the selfish, small-minded tyranny of the automobile and adopt a sleeker, greener, more virtuous future.

Then, the wheel meets the rail. In California, it might have sounded appealing to build a high-speed rail link between Los Angeles and San Francisco -- if you abstracted the project from all the topographical and other difficulties. For political reasons, a less direct, less economical route between the cities was selected. And the decision was made to start building between the two megalopolises, in the Central Valley, creating the possibility that California may end up with a bullet train to and from nowhere.

Of course, we already have cheap, high-speed transport between population centers. It is called air travel.

As Randal O'Toole of the Cato Institute points out, planes cruise at roughly 500 miles per hour. The Amtrak Acela, on the other hand, has a top speed of 150 miles per hour. Yes, airplanes need infrastructure, but not expensive, complex new infrastructure all along their routes.

O'Toole notes that Japan's high-speed trains seemed like the future in the 1960's, when air travel was more expensive than rail. Also, Japan's high-speed trains had a ready-made customer base in the substantial proportion of the country's population that already traveled by train.

In the U.S. today, in contrast, the average cost per mile of traveling by air is cheaper than traveling by rail, and a minuscule 0.1% of all passenger travel is via Amtrak.

If we built the Interstate Highway System, why can't we build a comparable high-speed network? As O'Toole observes, the highway system basically paid for itself and accounts for a substantial 20% of the country's passenger-miles and a roughly comparable proportion of freight ton-miles.

Suicide Rates Are Down

The Department of Veterans Affairs recently released its 2022 National Veteran Suicide Prevention Annual Report. Suicide numbers are down, they say, for the second year in a row.

At the same time, they announced the Staff Sergeant Parker Gordon Fox Suicide Prevention Grants, a program that gives money to community organizations to create suicide prevention programs, and authorized \$174 million to be handed out over the course of three years to provide those services.

The list of groups that received the grants is impressive, with most receiving the maximum amount of \$750,000. But it's the groups that received lesser amounts that arouse curiosity. War Horses for Veterans received one-third the maximum amount, yet they're very hands-on, matching horses with veterans and first responders under stress to help them recover from trauma. United States Veterans Initiative provides job assistance, rental assistance and much more, but they received only a small grant. Community

Building Art Works received a similarly small grant to provide writing and art workshops for veterans and family members in all counties of three states. Legal Aid Society got half the largest amount to handle legal assistance for the whole state of Kentucky.

Declining suicide numbers are no guarantee that veterans are under less stress. In 2020, there were 6,146 veteran suicides. That year had the lowest number since 2006, but we need to look at overall rates to see what it really means. While veteran suicide numbers fell by 9.7% between 2018 and 2020, the civilian numbers fell by 5.5%.

And just so you know, Staff Sgt. Parker Gordon Fox, for whom the grant is named, was a sniper instructor at Fort Benning, Georgia, when he died in 2020 of suicide at age 25. Fox, a talented musician, left his parents and many relatives, as well as his dog, Willie Nelson Fox, and a 1962 Gibson guitar.

High-speed rail could never be a match. Even if you put aside the endemic cost overruns, the inevitable construction delays, and the considerable maintainable costs, it can only carry passengers, not freight.

While progressives swoon over high-speed rail as the shiny future, some other genuinely futuristic technology is likely to emerge. If the age of self-driving cars ever arrives, people will be able to experience a car more like a personal train, except unlimited by rails.

California hasn't created a railroad to the future but a warning to the rest of the country to avoid its delusion and folly.



Tuesday (October 11), shutting out the Lady Tiger Waves 5-0 in the District tournament semifinal to advance to the championship game at Cumberland Gap.



Who Is Ready for Pumpkin Spice Whoopie Pies? Everyone!

Nestled snugly between "everything BBQ-flavored time" and "everything peppermint-flavored time" we have my personal favorite: "everything pumpkin-spice-flavored time"! This week I have a wonderful dessert overflowing with the nectar of the pumpkin spice gods. How can we confront this problem in the United States? I gave a Ted Talk last year

PUMPKIN SPICE WHOOPIE PIES Total Time: 45 minutes Yield: 15 decadent whoopie pies

1 cup canned pumpkin 1/3 cup butter, softened 1 (15.25 ounce) package spice cake mix 2 eggs 1/2 cup milk

Filling (see recipes below)

Preheat oven to 375 F. Line two cookie sheets with parchment paper or greased foil. In a stand mixer or large mixing bowl with an electric mixer on medium speed, beat pumpkin and butter until smooth. Add cake mix, eggs and milk, then mix until well-combined. Chill batter for 15 minutes to firm up a little.

Drop batter by heaping tablespoonfuls, 3 inches apart, on cookie sheets. Aim for 30 cookies total. Smoothe the together like glue! To assemble, prepare filling of choice (recipes below) and chill filling for one hour. Pipe or spoon about 2 tablespoons of filling on the flat side of one cookie and top with a second cookie. Repeat for remaining pairs. Serve immediately or store in the refrigerator.

For each filling recipe below, begin by creaming together 1/2 cup softened butter with an 8-ounce brick of softened cream cheese until smooth. Then add the remaining ingredients.

Marshmallow Pumpkin Spice — Add 2 cups powdered sugar, about half of a 7 ounce container of marshmallow cream (incentive to make a double batch?), 1 teaspoon vanilla, 1 teaspoon pumpkin pie spice and a pinch of salt.

Maple Vanilla — Add 3 cups powdered sugar, 1 teaspoon vanilla and 3 in Boston, MA with some different ideas. One idea: is there a phone app for that? Could the private or public sectors create an

Remember whoopie pies? If a cake, a cookie, frosting and a sandwich somehow managed to have a baby, it'd be a whoopie pie. Two round, pillowy cakelike cookies with a creamy cloudlike filling sandwiched between them. So soft and dreamy, they're bound to please the most discerning sweet tooth.

Traditionally, whoopie pies are chocolate cakes with vanilla filling, but not today! We're making pumpkin spice whoopie pies with several fillings to choose from. We have marshmallow pumpkin spice, maple vanilla, salted caramel and, for making pumpkin spice latte whoopies, coffee latte filling. How to choose? You might have to make this more than once! I sure did.

This pumpkin spice cookie recipe has been around forever and is very easy to prepare. I've chosen to use a boxed cake mix as an ingredient because I find it not only easier, but when you compare the cost of assembling all the cake ingredients, it's less expensive. Look for cake mix on sale when possible.

tops of the cookie batter with moist fingertips. Bake for 15 minutes. I did one sheet at a time, but you can do two at once. Just rotate pans halfway through.

Place cookies on a wire rack to cool completely before assembling into whoopie pies — seriously; let them cool or it's a big mess. If storing before assembling, place in single layers in a storage container with wax paper between layers to prevent sticking. These soft cookies will stick tablespoons maple syrup. Salted Caramel — Add 1/2 teaspoon each almond and vanilla extracts, 1/2 cup salted caramel sauce (found near the ice cream at the store) and 1/2 teaspoon kosher salt. Gradually add 3 cups powdered sugar.

Coffee Latte — Dissolve 1 1/2 teaspoons instant coffee or instant espresso granules into 1 teaspoon vanilla extract. Add to mixture, then gradually add 3 cups powdered sugar.

IRS crackdown on improper PPP forgiveness

The PPP loan program was established to help small businesses that were adversely affected by the COVID-19 pandemic. Many people who received the PPP loan forgiveness were qualified and used the loan proceeds properly to pay eligible expenses. However, the IRS has discovered that some businesses that received loan forgiveness did not meet one or more of the eligibility conditions. A recent IRS news bulletin encourages

people who inappropriately obtained forgiveness of their PPP loans to take steps to become compliant. Becoming compliant will allow people to avoid the potential consequences.

The news bulletin highlighted the Chief Council Advice which addressed misrepresentations and omissions of facts regarding loan forgiveness.

IRS Commissioner Chuck Rettig said, "This action underscores the Internal Revenues Services' commitment to ensuring that all taxpayers are paying their fair share of taxes". He added, "We want to make sure that those who are abusing such programs are held accountable, and we will consider all available treatment and penalty streams to address the abuses."

If you misrepresented facts for PPP loan forgiveness, filing an amended tax return can enable you to become compliant.

Under the terms of the PPP loan program, lenders can forgive the full amount of the loan if the loan recipient meets three conditions.

The loan recipient was eligible to receive the PPP loan. An eligible loan recipient:

is a small business, independent contractor, eligible self-employed individual, sole proprietor, business, or a certain type of tax-exempt entity; was in business on or before February 15, 2020; and

had employees or independent contractors who were paid for their services, or was a self-employed individual, sole proprietor or independent contractor.

The loan proceeds had to be used to pay eligible expenses, such as payroll costs, rent, interest on the business' mortgage, and utilities.

The loan recipient had to apply for loan forgiveness. The loan forgiveness application required a loan recipient to attest to eligibility, verify certain financial information, and meet other legal qualifications.

If the three conditions above are met, then under the PPP loan program the forgiven portion is excluded from income. If the conditions are not met, then the amount of the loan proceeds that were forgiven but do not meet the conditions must be included in income and any additional income tax must be paid.

Anyone who has abused the PPP forgiveness rules can avoid potential IRS penalties by correcting their information with an amended return.

Cutting Down on Scam Phone Calls

Welcome to the season of increased scam telemarketer phone calls, either political or holiday related.

The National Do Not Call Registry is a government program intended to block unwanted sales calls. It's a free service, and all you have to do is sign up either on your phone or on the internet. the whole problem. The FAQ on the site says that certain types of calls are allowed: political, charitable, debt collection, informational and surveys. Think about the holes those leave.

I maintain that receiving a political call is still a sales call -- they're trying to sell us on the idea of voting a certain way, and therefore political calls also should be blocked in the Do Not Call Registry. Surveys can be just as bad if the questions they ask are clearly skewed in one direction or another.

I see charitable calls as scams if they take your personal banking or credit-card information. Additionally, if you've ever done business with a company, they're allowed to call you.

2 Thessalonians Chapter 3

(2 Thes. 3:1-5) Request for prayers: As the apostle works toward the conclusion of this epistle, he petitions their prayers on behalf of himself and his companions (Silas and Timothy). He wishes that the "word of the Lord" may have unimpeded progress and a glorious effect, even as it has with the Christians in Thessalonica (what a compliment to them!). He hopes he and his co-workers might be delivered (rescued) from the "unreasonable" and "evil" men. He may be referring to a particular situation and a definite class of persecutors. "Unreasonable" carries the idea of that which is outrageous, and "evil" denotes active malice. These enemies have not "the faith" (the force of the Greek); this may signify that they stand outside the body of Christian doctrine, or else they do not possess "the (quality of) faith" essential to please God (v.2).

But (a contrast follows) the Lord is faithful. The difference between faithless men and the faithful God is dramatic indeed (2 Tim. 4:16-17). To those who yield themselves to him, he will strengthen (make firm) and guard them from "the evil one" (Satan). Help for both the inward and outward man! This would not totally insulate them from persecution, but their faith would not be ravaged beyond their power to overcome (v.3; 1 Cor. 10:13).

The apostle encourages them by expressing genuine confidence in their intention to progress in the gospel. He believes they are practicing their religion and will continue in that effort, yielding to apostolic instruction. He prays that the Lord will bless them with the abiding realization of "the love of God." This could be God's love for them or theirs for him---or both. Each is grammatically possible. The expression, "patience of Christ," may denote their patience in view of their ultimate union with the Lord or the exemplary patience displayed by the Savior.

(2 Thess. 3:6-15) Church discipline: The issue of church discipline is a sensitive and painful theme, but one of absolute necessity, though seriously neglected in today's church---both by avoidance and brutal abuse. Discipline involves a broad range of potential actions---from plain teaching to eventual excommunication. It is not an option; it is an apostolic "command." This admonition is buttressed by the "name (authority) of the Lord" (Mt. 18:15-17). "Withdraw" designates a cessation of purely social activity (1 Cor. 5:9). It is not to be used in a discriminating fashion, but is applicable to every rogue church member capable of understanding the nature of the ordinance. Their actions are "disorderly," out of step with inspired teaching and apostolic practice.

The apostles" pattern of conduct was to be emulated; they did not behave themselves in a disorderly fashion. Neither were they mercenary. They did not "sponge off" the brethren, but worked hard night and day so as not to burden the local church. The divine ideal was that they be supported, but under special circumstances, for expediency's sake, they abstained (v. 9; 1 Cor. 9:3-14; 1 Tim. 5:18). The apostle appears to have had some critics---even at Thessalonica. Clearly there was an element of lazy saints, who refused to work (maybe becom-



ing a burden to the church). Their employment was unemployment! Working did not excite them. In such cases the church was forbidden to indulge the abuse. Where did the idea originate that "everyone" (even able-bodied people who can work, but won't) has the "right" to be cared for by others? Such is contrary to divine instruction and does nothing more than reinforce laziness (v.10)!

Paul obviously had heard the report that some at Thessalonica were walking "disorderly." They refused to get a job, and instead spent their time in minding other folks' business. Busybodies are condemned (v.11; 1 Tim. 5:13). Those of this caliber were both commanded and exhorted by the authority of Christ to quietly work (with contentment), eat their own food (which they earned), and stop mooching off others (v.12). The brothers were to not grow tired of doing good (v.13).

Back to the issue of discipline. In a mode of sternness, Paul warns: "If any man (person) obeys not (the sense is that of an arrogant refusal) our word (instruction) by this epistle..." The apostle had warned about discipline in his first letter (4:11; 5:14); this is a second warning. There won't be a third! The rebel is to be subject to the full force of disciplinary action. Thus, "note" that man. "Put a tag on the man" (Robertson). Identify him to the whole church as an impenitent offender. It is not a procedure done behind closed doors (1 Cor. 5:4). It is not a vengeful, hateful act. It is not a tool for venting personal animosity. It is an effective method of restoring the lost---if there is a residue of honesty remaining in the transgressor's soul.

In order for the discipline to be effective it must be honored by the church, and association with the offender that is strictly social must cease (Rom. 16:17; 1 Cor. 5; 1 Tim. 1:19-20; Tit. 3:10). Does that mean ceasing all communication? No. Does it imply that the disciplined person cannot be visited and lovingly urged to return to the Lord? Of course not. But sufficient social pressure must be applied so that the wayward soul will miss the warmth of Christian fellowship and long to return. Sometimes such is difficult because the disciplined person has himself been reclusive and distance is what he prefers!

A part of the process is to bring the sinful person to a sense of shame. He has sinned against God, against the church, against his family, and against his own soul. Tragically, however, the ability to be ashamed (a valuable quality), has long disappeared in some (Jer. 6:15). At the same time, the church must ever bear in mind that this offender, no matter how obstinate, is not to be treated as an enemy, but rather admonished as a kindred spirit in the Lord (v.14-15).


(2 Thess. 3:16-18) Closing: Having dictated the epistle to a faithful scribe, the apostle closes with a loving salutation in his own handwriting, which was his customary practice. He prays that the

favor of Jesus, who is his "Lord" (with absolute authority over him) his Messiah (so profusely heralded in the literature of the Old Testament), may abide with them.

uninformed, brethren, about those who are asleep, so that you will not grieve as do the rest who have no hope. For if we believe that Jesus died and rose again, even so God will bring with Him those who have fallen asleep in Jesus (4:13-14). The Christians who have died are dead in the physical body but are alive or asleep in the spiritual body.


