

Ruth Huddleston

A Calutron Girl for me for the past few years has recently passed away. She was certainly one of the most articulate of the several women who assisted me telling the story of Oak Ridge and Y-12 history. She never hesitated when asked to tell her story, even though she went most of her life without even telling her family of the time in her life when she worked on the Manhattan Project as a cubicle operator at the Y-12 electromagnetic separation plant helping to separate the Uranium 235 used in Little Boy.

That all changed when her granddaughter was at her house working on homework for school. Ruth asked her what she was working on. Her granddaughter explained that she was writing a paper for school on Oak Ridge. Ruth responded, "Well, I can help with that. I used to work there." That was the first her family knew of Ruth's early work on the atomic bomb.

Later she would tell her story to approximately 400 people at the University of Tennessee as well as to high level administrators of the Department of Energy when they visited Oak Ridge. When a Japanese film company came to Oak Ridge to make a documentary film, I suggested they might interview Ruth. Well, they did and then they changed the entire focus of the documentary film to focus on Ruth's story as seen through the eyes of her granddaughter.

Ruth would always tell the part of her story that included how she felt when she learned what she had been working on. As you know, the young girls who were recent high school graduates formed most of the women working on the calutrons at Y-12 (CALifornia University CyclosTRONS). She would say how proud she was when her supervisor told the group working the day Little Boy was dropped on Hiroshima that the uranium for the bomb had come from Oak Ridge. They knew only then what they had been doing. She thought the war will be over and her boyfriend who was in Germany would not have to go to invade Japan. He had written her telling her that he was scheduled to go to Japan next.

Then Ruth would quickly add, "But when I got home that night and heard on the radio how many people we had killed, I became so depressed I could not sleep for a week!"

Terry Futrell is a friend I knew while working at the Y-12 National Security Complex. He shared his thoughts about Ruth Huddleston with me and I think you will appreciate what he had to say about his relationship with Ruth.

THERE'S A HOLE IN THE WORLD TONIGHT

Immediately after the terrorist attack on the World Trade Center in 2001, the Eagles went into the studio and recorded a new song that stated simply "There's a hole in the world tonight." For those who knew Ruth Huddleston – her family, friends, and former students – there is perhaps an even greater hole in the world since her passing earlier this week at the age of 97.

The hole in my world is especially great. You see, Mrs. Huddleston was not only my teacher, mentor, and friend, she was also my "other" mother. Whereas my biological mother molded my character and work ethic, it was through the efforts and assistance of Mrs. Huddleston that I was able to fulfill my dreams of becoming an engineer and to have a successful career working with the technology that I loved.

I first met Mrs. Huddleston when she was a customer on my paper route when I was only 12 or 13 years old. However, I never really knew her until she became my 10th grade English teacher a few years later.

She previously taught first grade but had recently obtained her master's degree in guidance and counseling. As a result, she took on the role of guidance counselor at Coalfield High School in 1961. She was also assigned to teach English to the sophomore boys. While the girls in my class learned how to diagram sentences under another teacher, the boys in Mrs. Huddleston's class

learned to write – to put together sentences in a way that effectively communicated thoughts and ideas.

Little did I know at the time that this would be a major factor in my future success. Mrs. Huddleston also served as my senior English teacher. While the other senior class spent their time memorizing the "Rime of the Ancient Mariner," we wrote, and wrote, and wrote some more. It is no small wonder that college English classes were no challenge for me.

Mrs. Huddleston also sponsored the Beta Club at Coalfield. She worked tirelessly helping us to raise funds to attend the annual Beta Club convention while mentoring us at the same time. My senior year in school, she arranged for the Beta Club members to serve on the food line in the school cafeteria. Not only did we learn to serve others, but it also gave some of us an opportunity to have a free hot, nutritious lunch every day that we otherwise could not afford.

Though I had dreams of becoming an electrical engineer, going to college was a financial impossibility for me. Little did I know how far Mrs. Huddleston was willing to go to see that I had that opportunity. She took me to the University of Tennessee one day where we met privately with the Dean of Admissions. I am convinced that meeting had much to do with me being awarded a scholarship. While there, she also took me to meet with the Director of Food Services and lined up a job for me to work in the Student Center Cafeteria. She also worked tirelessly to assist me in obtaining other financial aid.

Because of Mrs. Huddleston's love for her students, she always had our back, offering sage advice in her quiet, unassuming way. I recall one instance when I went to help in the concession

stand during halftime of a football game. She cautiously steered me aside and told me not to go in there. She had witnessed one of my classmates take money from the money box and feared that I might be falsely accused. On another occasion, she cautioned me about a certain girl that I was interested in. This time I ignored her and, though completely innocent of wrongdoing, I placed myself in a situation that could have cost me my life. Never again did I question or ignore her advice.

After a few years serving as Guidance Counselor at Coalfield, Mrs. Huddleston transferred to Oliver Springs High School where she served as Guidance Counselor for many years, providing the same loving care and assistance to hundreds of Oliver Springs students.

Even though she lived a quiet, modest lifestyle, Ruth Huddleston kept a deep secret hidden for years, even from those of us who knew her best. Only in recent years did her secret become public – she was a "Calutron Girl," one of the young women who operated the calutron machines at the Y-12 Plant that were used to enrich uranium for the atomic bomb that was dropped on Hiroshima.

At the time, Mrs. Huddleston had no idea what the calutron machines were doing – it was top secret, and the machine operators did not have a need to know. It was only after the bomb was dropped and World War II ended that she and the other Calutron Girls were made aware of the significance of their work. Happy for the successful end to the war, but troubled by the loss of so many lives, Mrs. Huddleston tucked her secret away for the next 60 years.

As her story was made public, she became an international celebrity. Even Japanese Public Television came to Oliver Springs to film a special about her. I was honored to be a part of that show. Even with the attention, Mrs. Huddleston remained the quiet, unassuming person that she had been all her life.

Ironically, I find that because of Mrs. Huddleston's influence, my life has come full circle. Our relationship began as she taught me to write. After a long successful career in engineering and technology management and assessment, I find myself once again spending most days writing books or other papers. In our last conversation just a few days ago, Mrs. Huddleston praised my work on a chapter of a new book that I had sent to her a few weeks earlier. Even to the end, she was the same loving, caring, encouraging person who helped so many throughout her life.

Mrs. Huddleston ran life's race, not to claim victory for herself, but to enable countless students to have the opportunity to win. If good works could get one into Heaven, then Ruth Huddleston would be at the front of the line. But her hope was not in her own works, because her good works resulted from her faith in the perfect works and righteousness of Jesus Christ. I will most certainly shed tears at her funeral, but my tears will be for my own loss, not hers. She has achieved the ultimate victory and is in the presence of Jesus – I will move beyond the tears of my loss and rejoice in knowing that.

Thank you, Terry, for your thoughts in honor of Ruth Huddleston. She was a special person for sure to many and a blessing to you and many others she helped in her career in the school system. She was an excellent Calutron Girl for me as I used her often to help convey the history of the Manhattan Project. She was a veteran of that era and was most capable of telling her story well. She will certainly be missed by many who knew her



How to Stop an Overweight Dog From Howling for Food

DEAR PAW'S CORNER: My Labrador-mix, Seeker, has always been a pretty big guy. But lately he's turned into a very round dog. If I don't feed him throughout the day, he sits beside his bowl and howls — making it impossible for me to work at my desk. What can I do to calm him down and help him lose weight? — Jim G., Quincy, Massachusetts

DEAR JIM: It's difficult to help overweight pets lose those extra pounds, and it's clear that Seeker has no qualms about complaining about it!

Since you're working from home, one way to mitigate the howling is to implement a divert-and-reward system to take his mind off his empty bowl. In essence, keep Seeker away from the kitchen and as busy as your schedule allows.

Immediately after his breakfast, close off the kitchen. Use a baby gate or shut the door, and hide the food bowl out of sight. Take Seeker outside for a short walk to burn off extra energy and a few calories. If you're in a high-rise apartment or another situation where going outside frequently is more difficult, opt for a five-minute training and play session instead.

While you're working, Seeker should be separated from the kitchen — either in a closed-off room or with you in your office (but in his own corner) — and given plenty of toys to chew on. Spend time with Seeker on each break from work. Play, work on basic obedience, or just hang out. Once you're finished with work for the day, take Seeker out for a long walk before giving him dinner.

Stick with the diet prescribed by the vet. Be patient but consistent with Seeker to change his behavior. He can and will lose the weight, because you care about him!





Take action if you missed the deadline

If you missed the filing deadline and owe the IRS, file as soon as possible. Some people tend to procrastinate further once they have missed the filing deadline. Procrastinating can cause you to pay more penalties and interest.

The Failure to File Penalty is 5% of the amount of unpaid taxes for each month or part of a month that a tax return is late. The maximum late penalty is 25% of your unpaid taxes. Don't panic if you don't owe the IRS. There is no late filing penalty if you are due a refund or don't

owe anything. The reason for this is simple. For example, suppose you are a month late, the late penalty is 5%. However, 5% of zero is zero.

Suppose both a Failure to File and a Failure to Pay Penalty are applied by the IRS in the same month. In that case, the Failure to File Penalty will be reduced by the amount of the Failure to Pay Penalty for that month, for a combined penalty of 5% for each month or part of a month that your return was late.

If you are more than 5 months late and still haven't paid, the Failure to File Penalty will max out. Still, the Failure to Pay Penalty will continue until the tax is paid, up to its maximum of 25% of the unpaid tax as of the due date.

Suppose your return was over 60 days late. In that case, the minimum Failure to File Penalty is \$435 (for tax returns required to be filed in 2020, 2021, and 2022) or 100% of the unpaid tax, whichever is less.

You should request First Time Abate for a penalty if you have been and are currently compliant with the IRS.

You are considered to be compliant by the IRS if you:

Filed the same return type, if required, for the last three tax years before the tax year you received the Penalty.

Didn't receive any penalties during the prior three years, or any penalty was removed for an acceptable reason other than First Time Abate.

You can request the First Time Abate for the penalty even if you haven't fully paid the tax liability. However, the Failure to Pay Penalty will accrue until you pay the tax in full.

You can call the toll-free number at the top right corner of your IRS letter to request the First Time Abatement. You don't need to provide supporting documentation when requesting relief. The IRS will review your information and see if you meet the First Time Abatement requirements.

You can also request reasonable relief for circumstances beyond your control. The events include filing late due to a death, serious illness, fire, casualty, or natural disaster.

Why Are Seniors Targeted for Scams?

In one year alone, seniors lost over \$3 billion to scammers, and it's gotten worse every year. The 60-69 age group was bad enough, but the dollar losses rose even more after age 70, and much more after age 80.

Why are we targeted?

The thieves believe two things about us: We're all rich and have great credit, having worked our whole lives, and, worst of all, that we won't tell anyone if we lose money to them. Those two things alone make us constant targets.

All scammers have to do to turn us into victims, according to a study by Stanford and AARP, is raise our emotions. Whether happiness or anger, it doesn't matter, because either will push us to hand over our information or our money.

For example, scammers will say we've won a big prize, like the lottery, but to claim that prize we need to send them processing fees in advance. We think about that prize and our good sense goes out the window.

Emotions come into play when a scammer calls pretending to be a grandchild in trouble. We're asked to send money right away. We're upset, and we do. But the emotional pleas for money don't end there. Romance scams are huge, and too many lonely seniors send cash to their new love without questioning it.

Scammers who pretend to be from the government, such as the IRS, who frighten us into paying money, raise our emotions as well.

The list of scams directed at the elderly is nearly endless: investments, lottery wins, IRS tax bills, low-cost prescriptions, charities, tech repair, cemetery debts, romance, reverse mortgage, help signing up for Medicare, auto warranties ...

Beware. If you allow yourself to be scammed once, they will be back, because you'll be on a list of people who can be fooled.

MOMENTS IN TIME

- * On May 14, 1796, Edward Jenner, an English country doctor, gave the first vaccination against smallpox to 8-year-old James Phipps. While he did not discover vaccination, he was the first person to confer scientific status on the procedure and to pursue its scientific investigation. His work is widely considered the foundation of immunology.
- * On May 8, 1912, Adolph Zukor founded the Famous Players Film Company, now known as Paramount Pictures. With partners Daniel and Charles Frohman, he planned to offer feature-length films that would appeal to the middle class. The company's first film was "Les Amours de la Reine Elisabeth," and starred Sarah Bernhardt.
- * On May 12, 1921, National Hospital Day was first observed on what would have been Florence Nightingale's 101st birthday. Originally a oneday holiday, it turned into a week-long event to educate the public about medical care.
- * On May 9, 1926, Commander Richard E. Byrd announced that he and his copilot, Floyd Bennett, had made the first flight over the North Pole in Byrd's Fokker tri-motor airplane, the Josephine Ford. While Byrd's navigational records were verified by the U.S. Navy and a committee of the National Geographic Society, some skepticism still remains about the claim.
- * On May 11, 1978, Margaret A. Brewer became the first female general in the U.S. Marine Corps. Because the Marines did not allow women to achieve such a rank at the time, President Jimmy Carter made a special nomination on her behalf to the grade of brigadier general, which was approved by both houses of Congress.
- * On May 13, 1983, right fielder Reggie Jackson became the first major league baseball player to strike out 2,000 times. He would eventually retire with a total of 2,597 strikeouts and was inducted into the National Baseball Hall of Fame in 1993.
- * On May 10, 1994, serial killer Jeffrey Dahmer was baptized by Roy Ratcliff while in prison at Columbia Correctional Institution in Wisconsin, in a whirlpool type of tub normally used for inmates with back issues. Ratcliff continued to meet weekly with Dahmer until the latter's death at the hands of another prisoner.

The creator of the universe, takes Job behind the veil of eternity to teach Job he is the sovereign creator of everything! God is the teacher, Job is the student, and a worm is the subject.

The third letter in the TWLA worm in Hebrew is the Lahmed. It is a shepherd's staff. It is represented by the English letter L. The shepherd's staff has two ends. One for correction and one for mercy. Grace and mercy proceed from our good shepherd only when we recognize the need for correction.

The fourth letter is the letter A. It is the Aleph in biblical Hebrew. It is the first letter in the creation name of God. It is represented by an Ox. James Chapter 2

(James 2:1-4) Respect of Persons: There will always be those who discriminate against others on superficial bases. James issues a strong rebuke against such. Christians must stop deceiving themselves by thinking they can hold to genuine faith in Christ while being partial to, or prejudiced against, others on the basis of externals, ethnicity or wealth. "Respect of persons" literally is "on the appearance of face."

(James 2:5-13) The consequence of respecting persons: "Listen, dear brothers, you have demonstrated how very unlike God you are. The Lord has not discriminated." James speaks of those "chosen" by God: (a) They have been chosen irrespective of financial standing. While the poor tend to be neglected by their contemporaries, the Lord doesn't check their bank balance. (b) People are chosen on the nature of their faith. If their faith reflects their love for the Lord (v.5), as expressed in obedience, they are "rich in faith," regardless of material considerations. (c) The blessing attached to their obedience is that they become "heirs of the kingdom," they will inherit the reward of heaven.

The "royal law" (v.8) is the equivalent of the "perfect law" (1:25), the new covenant law. It is a colossal blunder to contend that the Christian is "not under law" (see Rom. 4:15; 1 Cor. 9:21). It is a "royal" law because it emanates from the King. One expression of it is this: "You shall love your neighbor as yourself" (v.8). This precept was also a part of Moses' law. It is here mentioned not because the law of Moses was binding still, but because it is eternal in governing human relationships; it thus spans the ages. Christians who "fulfill" it submit to it) do well. On the other hand, those who practice showing "respect of persons" (literally, face-discrimination) are convicted "by the law (law of Christ) as transgressors" (v.9). It might be noted that to be prejudiced against another because of his skin pigmentation is evil; to override moral considerations and prefer someone because of race likewise violates biblical principle.

How much law does one have to violate to be a "lawbreaker"? The person who professes to keep the entire law, but then violates it in but one matter, is he not a lawbreaker? Must he violate every ordinance to be a spiritual criminal (v.10)? The question answers itself! This does not nullify, of course, another reality---namely that men can dredge themselves deeper and deeper into sin (2 Tim. 3:13) or that some sins carry greater consequences than others (Mt. 11:22; Jn. 19:11; Heb. 10:29).

Since he speaks to those of Jewish extraction, it is not inappropriate to illustrate the principle here annunciated by their own law (through that law already was technically cancelled) (Col. 2:14). The Old Testament law said: "Do not commit adultery. Do not murder." Some might conclude that adultery was not as bad as murder, since the former did not involve the taking of a human life. But both violate law; both perpetrators are lawbreakers (v. 11). Christians, therefore, must practice speaking the truth and, with consistency, keep on living the truth. There are many motivations for such dedication, not the least of which is the reality that we will be judged by a "law of liberty" (v. 12). This new covenant law is from the sovereign God and is designed to regulate and restrict human conduct. No man is a law unto himself. Paradoxically, at the same time, it provides him with "liberty." Release from the choke-hold that sin has upon the unregenerate (Jn. 8:32). By this law we will be judged ultimately (Rom. 2:16). The discriminators need to remember: those who show no mercy will receive none---a frightening prospect indeed.

(James 2:14-26) Living faith versus dead faith: The following dozen verses are the most controversial of this book, and perhaps rival anything else in the New Testament for gross misunderstanding. The term "works" is employed thirteen times in this segment, and not once is it correctly interpreted by those who walk in the steps of Martin Luther. A brief preliminary statement is in order. The term "works" is a perfectly noble word; yet, in the larger community of Christendom, there is a distorted view of this biblical term. Especially has the Protestant world reacted negatively to Catholicism's "works system"---a radical ideology contrary to the divine plan of redemption. This reaction, however, is itself an extreme, equally as dangerous as Catholic dogma.

Note some of the various categories of works discussed in Scripture: (a) The law of Moses was characterized by works. These were works, however, through which there was no final justification (Rom. 3:28), because no one could keep that law

perfectly; hence, all under the system were "cursed" by it (Gal. 3:10-11). Christ was absolutely essential as a sacrifice for those who lived under Mosaic law (Gal. 4:4-5; Heb. 9:15-17). (b) There are works of human merit, which, through perhaps benevolent in motive and effect, cannot save a person (Eph. 2:8-9; 2 Tim. 1:9; Tit. 3:5). A good work per se has no intrinsic power to cancel sin. (c) Actions implemented in response to commands of God are also called works (Eph. 3:10; Tit. 3:8; Rev. 2:26). Faith is a work (Jn. 6:27-29; 1 Thes. 1:3; 2 Thes. 1:11; Jas. 2:14)., and so is repentance (Mt. 12:41; Jonah 3:10). Baptism is a work only in the sense that it expresses obedience to a divine command (Acts 2:38; 10:48). Baptism is called the "washing of regeneration," and it is distinguished from works of human "righteousness" (Tit. 3:5). (d) At the day of judgment, men will be judged by their earthly works (2 Cor. 11:15; 1 Pet. 2:12; Rev. 20:12-13; 22:12).

James begins this segment with a series of rhetorical questions, deadly in their aim. "Where is the profit, brother, if a man claims to have faith---yet it is a faith unaccompanied by works? Can that kind of faith save him?" (v.14). (The Greek construction anticipates a negative answer; faith without works cannot save!) Luther's heirs answer affirmatively; in fact, that is the only kind of faith they believe can save! Let no one quibble that "salvation" is not the issue. The verbal form, "save", is used! Acts of benevolence contain the same principle. Pleasant platitudes, void of actions, are meaningless (v. 15-16). Faith, if unaccompanied by implementation, is totally dead (inside and out) (v. 17; 1 Pet. 2:7-8).

Then there is the "scientific" test. Suppose one claims saving "faith" exists independent of "works" (action). Challenge him. "If faith exits apart from works, show me that faith. On the other hand, by my works (obedience) I will demonstrate my faith." If you have "faith" without the divinely appointed expression of it, lay it on the table. What color, shape, or size is it? There is not a syllable of endorsement within this context for "faith alone." A number of examples illustrating valid faith now follow.

Consider the case of "demons." They "believe" (give intellectual assent to the unity of the Godhead), but are these malevolent, disobedient spirits to be saved? Hardly. They "tremble" at the prospect of their destiny (v.19). The next question reveals the absurdity of the "faith-alone" theory. "Do you not know, you empty-headed (a literal translation) man, that faith apart from obedience is sterile?" Such is the Holy Spirit's assessment of Luther's dogma!

Next the case of Abraham, father of the Hebrew nation, is introduced. This time James frames a question that demands an affirmative response. "Abraham was justified by works, was he not, in that he offered Isaac on the altar?" While Abraham's case is not analogous to ours in every detail, there is sufficient parallel in principle to use the term "justified." Had James wanted to make certain that his readers adopted the dogma of "salvation by faith alone," he certainly would have avoided that term! In fact, he is quite emphatic: faith energized his response to God's command, and by "works" (obedience) the patriarch's faith was brought to completion (v.22; Heb. 11:17). What if he had not obeyed, but had argued the case that his "faith" was sufficient, and that it was needless to offer his son? Need we answer? The Scripture, affirming that "Abraham believed God" (Gen. 15:6), was "fulfilled" only after he had obeyed. That is the historical fact. He was accounted as "righteous" because of his obedient faith and was designated as God's "friend" (Isa. 41:8). What might he have been "called" had he refused to obey on the ground that his "work" would have nullified his faith?

What, then, is James' conclusion? "You see that by works (response to God's commands) a person is justified (saved) (v.14), and not by faith alone" (v.24). Luther's theological descendants remove the "not" from its proper place in the inspired sentence as a modifier of "faith alone," and thrust it back in the sentence, making it a modifier of "justified." Thus, as they see it, a "man is not justified by his yielding faith, but by faith alone." This constitutes a deceitful handling of the word of God (2 Cor. 4:2).

Next there is the case of a Gentile woman, Rahab of Jericho, who was taken into the family of God in connection with the conquest of that city. She "was justified by works," she was "obedient" ("not disobedient") (Heb. 11:13) in that she "received the spies" and was responsible for saving their lives (v.25). One final point: just as a body minus its spirit is "dead" (v.26), so faith minus works (obedience) is dead.

ONEIDA AT TOP OF DISTRICT AS THEY MAKE TURN INTO POST-SEASON

Coming off a tough, 1-0 road win at Anderson County Friday (April 14), after which OHS Head Coach Derek Keeton said about the Mavericks,"You have to give AC credit. Those kids played their hearts out, and the AC keeper played a phenomenal game," the Indians had two straight home appearances, against the Knox Central Panthers on Tuesday (April 18), followed by the final District game for the regular season, versus Rockwood on Friday, April 21.

At Hoffman Field against Knox Central, Oneida and the Panthers battled to a 2-2 tie. No overtime period was played, since the game's results had no bearing on District standings, but after the contest, a physically challenging one with both sides giving their all, Knox Central Head Coach Chris Quinn told the Morgan County Today, "We were lucky to get out of here with a tie. I knew we'd be in for a dogfight."

The match was a defensive battle all the way, with each side getting about the same number of shots on goal. Central put in a score in the first half, and that was the only goal in the frame, as the Panthers held a 1-0 margin at the break. Early in the second half, Indian senior Nick Gilbert took an assist from Levi James and tied it, 1-1. At the 18 minute mark, Oneida's Luke Barna sent a rocket, a penalty kick into the upper right corner of Central's goal, giving Oneida a 2-1 lead. Six minutes later, Central answered with a score, tying the game at 2-2. That was the final.

OHS Head Coach Derek Keeton told his team after the game,"You guys played every minute of every play, and executed perfectly out there. I'm extremely proud of you guys. You didn't quit."

The Indians wrapped up their regular District season with a huge home 8-0 win over Rockwood on Senior Night Friday, April 21, securing first place and home field advantage for the District Tournament in May. Oneida posted shutout victories over all their District opponents this season.

Against the Tigers, Indian senior Luke Barna put on an offensive clinic, with a hat trick in the first half as he scored the Indians' first three goals, first unassisted, then assisted by Nick Gilbert, and another unassisted. Gilbert took an assist from Mason Keeton toward the end of the frame to put Oneida up, 4-0 at the half.

Barna nailed a goal early in the second half, his fourth score to give the Indians a 5-0 lead, followed by goals by George Kline, freshman Justyn Lynch and sophomore Ashton Morland, who took the ball 50 yards unassisted on a breakaway, putting Oneida up, 8-0, which was the final score. Head Coach Keeton said," Our team chemistry was so good tonight, just where we need it to be late in the season. I saw how we've developed as a team, and our seniors, with their leadership, and our younger guys' enthusiasm and energy is fantastic." Oneida is scheduled to play at Scott High on Thursday, April 27, followed by a game at Halls

May 2.

HIGHLANDERS HAVE TOUGH WEEK

Scott battled Northview on the road Tuesday (April 18), and returned with a disappointing 2-1 loss in which the Highlanders never gave up, as Scott scored first on a Skye Babb goal, assisted by Hugo Henry, answered quickly by a Northview score, tying the contest at 1-1, which was the tally at the break. Northview put in a goal late in the second frame, and Scott had a penalty kick opportunity with 14 minutes remaining, but couldn't convert, resulting in the Northview 2-1 win. Scott head Coach Eric Henry told the Morgan County Today,"I'm not happy with the score, but our guys played well against a very talented team on the road."

In District action Friday (April 21) at Highlander Field against Kingston, Scott faced a combination of dubious officiating combined with missed opportunities, and fell to the Yellowjackets, 2-1. A defensive battle with the first half ending with neither team scoring, saw Kingston put in a goal at the 30 minute mark of the second half. Five minutes later, the Yellow jackets scored again to go up, 2-0. Scott junior Skye Babb, assisted by junior Toby Garrett, drove in a Highlander goal minutes later to cut the Kingston lead to 2-1, and that was the final score of the contest. In comments after the game, Highlander Head coach Eric Henry said,"We had a lot of opportunities, we just didn't convert. We had two corner kicks in the second half within minutes apart, and couldn't make anything happen. We out-possessed them, keeping the ball on our side of the field a long time, but we missed a lot of shots." Speaking about the upcoming postseason, Henry said, "We beat AC, lost to both Clinton (in overtime) and Kingston by one goal. We'll be the third seed when the tournament comes around. We need to go to Clinton and play like we know we can, and we should secure a home field for the tournament final, given our regular season win over AC, but we need to take care of business." Scott is scheduled to play C-Gap (Tuesday, 4/25) and Oneida Thursday (4/27), both at home next week.

Scott is scheduled to play at Northview Academy on Tuesday, April 18.








ONEIDA PRIMITIVE BARN OPENS FOR 12th SEASON
