He says his heart belongs to Mimi and Mimi says that hearts are very special and that we need to take care of our hearts because, Jesus and love live there.

My question is this: How do you take care of doggie and kitty hearts? Do our hearts get sick, too?

Greetings! I hope that you had a wonderful Valentine's Day, Ms. Avery Pearl. I'm sure that your Mimi gave you the most beautiful bouquet of flowers or a nice heart-shaped box of dog treats. She has such a big heart and loves you so much!

Did you know, Ms. Avery, that we actually hate diagnosing a "big heart" in our dog and cat patients? This is usually a sign of an underlying medical disease such as a thickened heart valve, heartworm disease, etc. Certain heart conditions such as valve disease are much more common in small breeds of dogs like you, Ms. Avery. Symptoms of heart disease include coughing, congestion, increased respiratory rate, and exercise intolerance. We always encourage people to call their vets immediately if they notice any of these symptoms as dogs with congestive heart failure can require aggressive emergency treatment and oxygen therapy if the symptoms are not addressed promptly. Early diagnostics and therapy can save lives with heart disease. This is one of the reasons that yearly or twice yearly wellness exams are so important. Your vet may alert you to a heart murmur during a routine exam. Then, they can begin therapy early and/or help you monitor for progression more closely.

There are several forms of heart disease that are more common in large dog breeds as well, so we also ask pet owners to call us immediately if they notice that their big boys/girls aren't as active,

have exercise intolerance, and/or develop a cough. It's also important that pet owners avoid feeding a grain-free diet unless their vet specifically prescribes this diet. Several studies have indicated that grain-free diets can contribute to dilated cardiomyopathy, and this can often be very difficult to manage.

Cats can develop heart disease as well, and they can have very subtle symptoms early in the disease process. They may not even develop a heart murmur before they develop symptoms, so routine evaluation of our geriatric feline friends is critical to keeping them healthy.



Often times, heart disease can occur no matter how well we take care of our furry friends. We can, however, completely prevent one of the most devastating cardiovascular diseases of all – heartworms. Dogs and cats can both be exposed to heartworms through a mosquito bite. Mosquitos transmit microfilaria (immature heartworms) into the bloodstream, and these "babies" mature into adults within the

pulmonary artery. This will lead to heart disease and eventually heart failure if not diagnosed and treated early. We have treatment options for heartworm disease, but this can be quite expensive and can have several severe adverse potential complications as well. The good news, though, is that this disease is almost 100% preventable with a variety of products including monthly chews, topical monthly products, and injectable products. Your vet can help you determine the most appropriate preventive product for you and your pet. In the south, we need to give our critters heartworm prevention year-round because we have mosquitoes all year-round. You can also help minimize risk to your pet by removing standing, stagnant water from near your home. You're a lucky girl, Ms. Avery, because your Mimi has been giving you heartworm prevention ever since you were a little puppy! I bet you don't even mind taking your monthly pill because it takes so good!

Well, Ms. Avery, I hope that you've enjoyed this nice, warm winter that we've had. Just remember... A warm winter means early bugs. Please make sure all of your furry friends are taking their heartworm prevention and flea/tick meds year-round. And, don't forget to thank your Mimi for taking such good care of you!

who both have successful careers in teaching and management in the energy sector respectively.



## Should I Buy a Pet on an Online Marketplace?

**DEAR PAW'S CORNER:** I was scrolling through my social media account and an ad popped up showing a really cute puppy for sale. What are people's experiences buying pets online? — Curtis, via email

**DEAR CURTIS:** The short answer is, don't. It's unlikely that what you saw was an approved ad, because most social media companies do not allow pet sales or advertising for the sale of pets. Probably, someone created a post and made it public.

Avoid responding to the post, even if you think you know the person who posted it or think you know the location. Chances are it's either a scam to part you from your hard-earned money, or you will receive a puppy that is not the one advertised or is very ill and needs a lot of medical care. I've heard too many stories from owners who got scammed from such online transactions.

If you just want a cute animal companion, adopt a pet through your local shelter. You'll be able to see and interact with a potential pet, and the shelter will help you evaluate whether you're ready for a dog at this point. There is a cost involved with adoption, but those fees are upfront. And I guarantee it is substantially less than what you will pay a shady pet dealer (or pay out in medical bills later on).

If you absolutely want a specific breed of dog, do the homework required. Find nearby breeders who specialize in the breed you're interested in. Read up on the breed. Find out the financial requirements to match with, purchase, train and care for that dog.

No matter which path you pick, know that pets are an investment of money and time. The dividend is a healthy, happy pet that adores you. Don't take a shortcut.



**Trump's futile attack on DeSantis**

Donald Trump hasn't been impressing anyone with his political acuity lately, but at least he is fully aware of one of his own vulnerabilities.

His early attacks on the COVID-19 record of Ron DeSantis show that he knows the Florida governor has outflanked him on the populist right -- indeed, outflanked him in general -- regarding one of the most central issues of the last couple of years.

In typical style, Trump isn't tiptoeing around the issue, but driving right at the governor in an attempt to take away one of his foremost strengths.

The "free state of Florida"? No, despite what you might recall, it was really the "shut down Sunshine state."

"Florida was actually closed, for a great, long period of time," Trump told reporters during his first campaign swing. "Remember, he closed the beaches and everything else? They're trying to rewrite history."

This is brazen even by Trump's standards. It will take all of his powers as a political sloganeer, marketer and wrecking-ball to counter the DeSantis brand on the coronavirus, which has the advantage of being grounded in reality.

For Republicans, the DeSantis approach of getting out of shutdowns as soon as possible and resisting mandates and restrictions has been vindicated and has appeal to nearly all factions.

For populists, he resisted the elites and self-appointed experts. For limited-government conservatives, he (although this is complicated) lightened the heavy hand of government. For everyone right of center, he forged his own path in the face of conventional wisdom and got attacked for it in the media and the left -- demonstrating the paramount GOP virtues of having courage and the right enemies.

DeSantis would have much to brag about in his record in Florida absent COVID-19, but it is his response to the pandemic that sets him apart and makes him, for the moment, a near-legend for many Republicans.

Trump is correct that DeSantis issued shutdown orders like nearly everyone else at the outset of the pandemic. In March 2020, the governor issued statewide restrictions and then more far-reaching measures in Palm Beach and Broward counties. Beaches, as Trump said, were shut down.

The trouble Trump has is that DeSantis was initially acting in keeping with the guidance of the federal government that Trump led.

Despite some grouching, Trump had at his right hip during the entire pandemic the man that has come to represent for Republicans all that was wrong with the pandemic response -- Dr. Anthony Fauci.

It tends to be forgotten, but Georgia went first in reopening in late April 2020 and Trump hit Brian Kemp for it.

At his coronavirus briefing, Trump said, "I told the governor of Georgia, Brian Kemp, that I disagree strongly with his decision to open certain facilities."

When DeSantis, too, moved to reopen, Fauci attacked the state for moving too quickly.

By May 2020, Florida had a clearly distinguishable approach to the pandemic. DeSantis was already skeptical of shutdowns and focused on protecting the most vulnerable rather than population-wide measures. Crucially, the state was absolutely insistent that schools return to in-person instruction.

Over time, DeSantis shifted from simply lifting restrictions to using the power of his office and the state to block further COVID-19 restrictions by localities, school boards and private businesses. He kept localities from obstructing businesses from opening or fining people for violating mask ordinances. He forbid vaccine passports. He prevented schools from forcing parents to mask their children.

DeSantis' response to the coronavirus isn't going to be decisive in a prospective 2024 primary battle with Trump. It is, however, what has put him in the game. It also is a large part of the reason that Republicans feel vested in and defensive of the governor, making it harder for Trump to mock and belittle him -- not that he isn't going to try. Trump accuses DeSantis of disloyalty and, if developing an issue that is going to be almost impossible for Trump to counteract counts, he's guilty as charged.

## Things my Children will find it hard to Believe

As I write this my children are in their forties. Two were born in the sixties and one in seventy-two. When they came into the world, we had all the modern conveniences that we needed to make life comfortable. We had an air-conditioned home and cars. In 1953 Eisenhower approved the building of the interstate highways which by 1972 was moving ahead rapidly.

I would like to go back around twenty-eight years, 1936, when I came into the world. Following are a few things that you will find hard to believe. Most rural area especially in the south and Midwest had no electricity.

Only one in five families had an automobile.

About half of the public roads were impassable most of the year.

Poverty rate was over 25%.

Many schools were heated by coal or wood burning stoves.

Air travel was still years away (on a large scale).

### *Here are a few things our family went through*

In the winter time we only had heat in the living room. If you put a glass of water in one of our bedrooms it would freeze to solid ice overnight.

A few nights when it snowed, we woke up with snow on the top quilt.

We walked everywhere we went; to the grocery store, to church, to neighbors. There were no fat kids back then. Winters were more severe back then.

Most children went barefooted in the summertime. We usually owned one pair of shoes which were worn to school and church.

Mom did not allow us to play in the house, even during winter time. We always found something to do outside. In good weather we played football, or board-on-deck ball, kick-the-can, or Annie over. In the winter time we went rabbit hunting, ice skating, or sled riding.

There was no T.V. until the 1950's. Most of the time we had no radio. We had to go down to the neighbor's home who had a radio.

Telephones were very rare in our

neighborhood. We got our first phone in 1953.

In our high school usually, no student had a car. Only about half of the teachers had a car. I got my first car in 1954 when I was a senior.

All nine of Mom and Dad's children were born at home. All lived to be at least 70.

Parents did not take their children to the doctor very often. It usually had to be an emergency.

At Christmas we usually got one or two toys. We made our own things to play with like; sling shots (flippers), bow and arrows, boats, sleds, click and wheels, and whistles.

It was tough back then but we had fun and very few of our failed our military tests.

We trusted our government, more.

We had fair elections.

We had very few divorces.

Neighbors helped neighbors.

Schools had good discipline because homes had discipline.

Children did chores at home.

College was hard and most students didn't go.

Most boys wanted to serve their time in the military.

Schools were for education. Sports were secondary.

Leaders loved their country.

Crime was low. Rural people didn't lock their doors.

The military was tough. Most men who lead

the training were WWII and Korea Vets.

## Filing your return with a paystub

If you can't get your W-2 or other documents, there may be a way to file without them.

The IRS Form 4852 may be able to be used if you are unable to attain forms such as your W-2. Form 4852 can also be used for 1099-R which reports retirement distributions.

Form 4862 can also be used if the forms are incorrect. If you received an incorrect W-2 or 1099-R, you should always

attempt to have them send a corrected form.

The IRS requests that this form only be used after unsuccessful attempts to retrieve your W-2 or 1099-R.

Form 4852 is not designed to help you get your refund quicker, but it's an option when forms aren't provided in a timely manner.

The IRS assists people in getting their tax forms from employers or financial institutions if the forms haven't arrived by the end of February. However, this may not be their top priority if the IRS is understaffed.

Your last paystub may provide only some of the information needed to file your tax return correctly. Missing data includes amounts contributed to your retirement and employer contributions to health savings accounts.

Suppose you later receive your W-2 or other document and determine that your return was not correctly filed. In that case, you will need to file an amended return.

When filing Form 4852, you will be required to certify that you were unable to get the forms or that you received incorrect forms. It also requires you to certify that you contacted the

IRS before filing your return. You will need to explain how you arrived at your amounts. A simple statement such as "amounts taken from final paystub".

The IRS does not currently accept Form 4852 for e-filing. Your return will need to be mailed to the IRS.

Fill out Form 4852 to the best of your ability. However, there are several potential penalties for anyone who uses Form 4852 to attempt to avoid or evade their tax liability. These penalties can be steep. The 20% accuracy penalty is based on the amount that should have been paid. Civil fraud penalties equal to 75% of the tax that should have been paid can also be charged. The penalty for filing a frivolous tax return is a \$5,000 penalty.

IRS transcripts of your W-2 and 1099-R are another option for obtaining your information. However, the transcripts are typically unavailable until late May or early June.

## Are There Recalled Foods in Your Freezer?

How many food items in your freezer, refrigerator or kitchen cabinet are on recall lists?

I spotted a food recall alert on the news, but I only heard part of the announcement. On to the internet I went, looking for the information. And sure enough, for the first time ever, I actually had a recalled food item. It was a bit unnerving to realize that I hadn't been reading all the recall alerts I get in my email inbox.

While looking for more sites that provide alerts, I came across one I hadn't known about: FoodManufacturing.com. Just in the past few weeks, they've put out alerts for a certain soup because of an error on the label, several brands of Vienna sausages, hot chocolate K-cups (it might contain peanut products), a pot roast meal, sprouts, fro-

zen chicken entrees, popcorn, frozen manicotti, diced beef ... and more.

To look at their list, go to the site and click on the "Recalls/Alerts" tab.

The Food Safety and Inspection Service arm of the Department of Agriculture issues alerts as well at [www.fsis.usda.gov/recalls](http://www.fsis.usda.gov/recalls). Note the advanced search feature on the left side of the screen where you can filter by cause, risk level, states and more.

Food Safety ([www.foodsafety.gov](http://www.foodsafety.gov)) provides information on the safe handling and storage of food.

Recalls.gov is another good site for recall notices. Click on the "Food" tab to see your on-line choices.

And what should I do with that recalled product I found in my freezer? I'm going to take it back to the store for a refund, of course.

On a sad note, did you see the Consumer Reports research on the amount of lead and cadmium in our favorite dark chocolate bars? Go to [ConsumerReports.org](http://ConsumerReports.org) and put "Lead and Cadmium Could Be in Your Dark Chocolate" in the search box.



# Hebrews Chapters 3 & 4

(Hebrews 3:1-6) Christ in contrast to Moses: The readers are addressed as “holy brothers” who are “partakers of a heavenly calling”. They were called by the gospel (2 Thes. 2:14) into a special saved and set-apart relationship with God, namely the church (the origin of that term signifying “called out). Jesus is, in a special sense, designated as an “Apostle” because the word means “sent forth”, and God “sent” his Son to earth to die for sin (Jn. 4:34). Christ’s role as high priest is the major theme of this book (see 4:14). “Confession” suggests the Christian’s commitment to Christ in obedience.

Jesus was faithful to God to the point of perfection; Moses, Israel’s great leader, was “faithful” (relatively so) as well. Moses was faithful in God’s house (v. 2). The argument now unfolds that Christ was superior to Moses in several particulars, the point being the new covenant (of Christ) is greater than the old covenant (of Moses). (a) Jesus was the builder of God’s house; Moses was an inhabitant in God’s house. The builder is worthy of “more glory” than the resident (v. 3). (b) Every house is built by someone. This is the law of causation. Every effect must have an adequate cause! God is the builder of all things (v. 4)! The pre-incarnate Word (Christ (Jn. 1:14) was the active agent in the construction of the entire universe (Jn. 1:3; Col. 1:16; Heb. 1:2, 10). (c) Moses was faithful in his house as a servant; Jesus was over his house as a Son (v.5).

The argument is clear; Judaizing apostates are leaving the greater for the lesser! These Jewish Christians must hold fast their hope to the very end (v. 6). Christians can forfeit their salvation, Calvinism to the contrary notwithstanding.

(Hebrews 3:7-11) Israel’s unbelief in the wilderness: the sacred writer quotes from the Holy Spirit, a divine person who speaks, and who speaks through Scripture (Psa. 95:7). There is an urgent warning to the reader. “Today”, do not “harden your hearts”. Hardening is a gradual process, and if allowed to continue, becomes fatal. Many church members today have religious arteriosclerosis. This is what the nation of Israel did during the days of Moses in the wilderness of Sinai, even though they saw the wonderful works of the Lord; God was not pleased with them (v. 10). Jehovah, with the measured “wrath” of justice, took an oath that they would not enter into his rest. As will be apparent subsequently, the “rest” was a symbolic picture of heaven. The unfaithful Christian risks losing his hope of heaven.

(Hebrews 3:12-19) the application of the example: the Old Testament example had an appropriate application to straying Christians in the first century. Note: (a) The warning is addressed to “brothers”, not those outside of Christ. (b) It is possible to develop an “evil heart of unbelief”. (c) Such results in “falling away” from God. (d) That falling away leads to eternal punishment (10:27; 30-31).

Accordingly, the saints are to exhort (encourage) one another every day, while there still is a today (of opportunity), so that sin does not “harden” them to the point of being beyond feeling (v. 13; Eph. 4:19). (The inference is that there is no postmortem plan of salvation---contra the theories of purgatory, baptism for the dead, a second chance after death, etc.)

If, therefore, one is to be a “partaker of Christ”, he must “hold fast” the confession (pledge of faithful obedience) which he made at the beginning of his Christian life; yes, grasp firmly to the very end (v. 14). Again the psalm is cited to buttress the point (v. 15). Was it not Israel who was led from Egypt by Moses? Was not God displeased with them for forty years? Did not their sins cause them to die in the wilderness (v. 17)? Those disobedient unbelievers were forbidden to enter his rest. The suggestion is: “Those of you flirting with apostasy had better take note; learn the lesson of history!” (Ps. 95:7-11).

(Hebrews 4:1-13) the conditional promised rest: the warning about missing the “rest” is repeated. Four times in this chapter the author seeks to encourage by the repetitious, “Let us”---an expression of exhortation. One must have a reverential “fear” of not receiving God’s “promise” of rest (non-rest is too horrible to contemplate!). While the promise remains, everyone should take advantage of it. It is

possible to “come short” of it. We Christians have had access to the gospel, just as ancient Israel had God’s word, but it did not profit them. Why not? Because that word did not express itself in faithful obedience (v. 2; Rom. 9:31-33).

Those who live their faith, according to divine guidance, can enter in (Rom. 6:1-5). God has undergirded his promises and warnings with a solemn oath (v. 3; Psa. 95:11). The present tense of the verb suggests a contemporary rest (Mt. 11:28), which ancient Israel never really enjoyed. It was not because Jehovah’s plan was ill-prepared; not at all, his plan was finished when the creation events were concluded on the initial week of earth’s history (v. 3).

Alluding to the final day of the creation week (Gen. 2:2), “rest” was used in the sense of the Lord’s cessation from creating activity (God never grows tired). The writer transitions to a different type of “rest”. It is a divine rest yet available, but which ancient Israel did not appreciate and never entered, Israel missed out because they were stubbornly rebellious (v. 4-6). And these wavering saints who are being addressed were on the precipice of missing the rest as well. Again, David’s psalm (95:7) is cited to make the point: “Pay attention to Scripture immediately”. The ever-present “Today” is defined as the time to “hear” God’s truth, refrain from hardening your heart (v. 7), and “obey” (implied from v. 6) him.

While the rest was never obtained under Joshua, nonetheless, the writer contends, “There remains a sabbath rest for the people of God” (v. 9). This passage has been seriously perverted by two groups---Sabbatarians and those under the spell of Darwinism. The Sabbatarians allege that the text constitutes proof that the Sabbath is binding in the Christian age. Those who seek to accommodate the Bible to evolutionary chronology contend that this is proof that the “day” of Genesis 1 were long eons of time. This supposedly accommodates evolution’s gradual development. Even Darwinists admit that without billions of years of time, evolution could never have occurred. Time is called the “key” to Darwinism.

Both groups commit the same interpretative error. They substitute a figurative use of the term Sabbath (here in Hebrews 4) for the literal use in Genesis 1. This irresponsible confusing of the two contexts is a colossal blunder. Back, then, to the Hebrews theme, the inspired author affirms that whoever enters into God’s rest enjoys a cessation from labor, just as the Lord did on the original Sabbath (v. 10).

Again, there comes the “let us” call to faithful service. Christians must give diligence to enter that rest, and not fall after Israel’s bad example of disobedience. There is an emphasis in this book on “obedience” versus “disobedience”---in glaring contrast to the notion that salvation is by “faith alone” (v 11). The point now to be made is that unfaithfulness never remains undetected.

The “word of God” (that issuing from God) is not a dead document. It contains intrinsic power to enliven and energize. Its penetrating power is depicted as shaper than a sword with two edges. It divides between the “soul” and “spirit” (sometimes used interchangeable; always considered intimately connected) and between the “joints” and “marrow” (a hyperbolic statement representing its surgical-like precision in discrimination). It probes the thoughts and intentions of the mind. No creature is hidden from God; all things are exposed before him to whom we must give account ultimately.

(Hebrews 4:4-16) a preview of our high priest: next is preparatory introduction to a lengthy section concerning the high priesthood of our Lord. We, as sinful creatures, have a tremendous need for someone to intercede for us before the perfectly holy God (Isa. 6:3), who is too pure to tolerate sin (Heb. 1:13). Thank the Lord, therefore, that we have a “great high priest” in heaven, Jesus Christ. He is touched by our infirmities and helps us with our burdens. He knows what temptation is like, for he was tempted in the major avenues of temptation while he was on earth (Mt. 4:1; 1 Jn. 2:15-16). We must, therefore, hold fast our confession (commitment to the Savior), and with boldness draw near to the throne from which he dispenses divine favor for our assistance in times of need.

Kim Michele Richardson is a NEW YORK TIMES, LOS ANGELES TIMES and USA TODAY bestselling author. She lives in Kentucky and writes historical fiction set in familiar surroundings, with characters easily identifiable with the rural Kentucky setting.

Richardson has said of her writing, "I stumbled across the heroic librarians of the Great Depression and the rare blue skinned Kentuckians. I could not stop thinking about them and wanted to embrace their strengths and uniqueness in story." And that she has most certainly done. The lead characters in her books are strong-willed women who face hardship head on and demonstrate the strength of character often found in women who have struggles in life.

Richardson captures the impact of such odd colored skin as well as other struggles of the region during the Great Depression and shows the determination of a single woman who was convinced books could bring meaning to the depressed area and their people who were struggling just to make a living. His Medal of Honor citation reads: For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty in the afternoon while serving as commander of River Assault Division 152 during combat operations against enemy aggressor forces. Lt. Comdr. (then Lt.) Kelley was in charge of a column of eight river assault craft which were extracting one company of U.S. Army infantry troops on the east bank of the Ong Muong Canal in Kien Hoa Province, when one of the armored troop carriers reported a mechanical failure of a loading ramp. At approximately the same time, Viet Cong forces opened fire from the opposite bank of the canal. After issuing orders for the crippled troop carrier to raise its ramp manually, and for the remaining boats to form a protective cordon around the disabled



craft, Lt. Comdr. Kelley, realizing the extreme danger to his column and its inability to clear the ambush site until the crippled unit was repaired, boldly maneuvered the monitor in which he was embarked to the exposed side of the protective cordon in direct line with the enemy's fire, and ordered the monitor to commence firing. Suddenly, an enemy rocket scored a direct hit on the coxswain's flat, the shell penetrating the thick armor plate, and the explosion spraying shrapnel in all directions. Sustaining serious head wounds from the blast, which hurled him to the deck of the monitor, Lt. Comdr. Kelley disregarded his severe injuries and attempted to continue directing the other boats. Although unable to move from the deck or to speak clearly into the radio, he succeeded in relaying his commands through one of his men until the enemy attack was silenced and the boats were able to move to an area of safety. Lt. Comdr. Kelley's brilliant leadership, bold initiative, and resolute determination served to inspire his men and provide the impetus needed to carry out the mission after he was medically evacuated by helicopter. His extraordinary courage under fire and his selfless devotion to duty sustain and enhance the finest traditions of the U.S. Naval Service.

## Law Enforcement Officer of the Week



Supervisory Officer Jacqueline Montanaro of the United States Department of Homeland Security died tragically on Saturday, January 14, 2023 from injuries she sustained while trying to rescue her daughter from a fire in Hazlet, New Jersey.

When the fire broke out around midnight, Officer Montanaro evacuated from her burning home with her husband and eight-year-old daughter. She re-entered the home in an attempt to rescue their six-year-old daughter who was still inside.

Officer Montanaro was found unconscious, trapped inside with trauma to her arms and hands. She was transported to Cooperman Barnabas Medical Center where she succumbed to her injuries at 1:40 am. Her six-year-old daughter did not survive the fire.

Officer Montanaro had served with the United States Department of Homeland Security – Customs and Border Protection – Office of Field Operations for sixteen years and was assigned to the Newark Liberty International Airport.

She was forty-years-old and is survived by her husband, daughter, parents, grandmother, sister, and two brothers.

## Pan Seared Seasoned Lamb and Potato Casserole



### Ingredients

2 pounds of Lamb Chops  
 2 cups of crushed kettle cooked chips  
 30 ounces of shredded hash browns  
 1 stick Butter divided  
 1 yellow onion  
 ¼ cup of flour  
 1 cup sour cream  
 2 cups chicken broth  
 1 cup of 2% milk  
 1-3/4 cups of Monterey Jack Cheese  
 1 cup mild Cheddar Cheese  
 ¼ cup of Parmesan Cheese  
 Salt and pepper to taste  
**Grandma Nancy's Lamb Rub Ingredients**  
 2 tablespoons of dried rosemary  
 1 tablespoon of marjoram  
 1 tablespoon dried parsley  
 1 tablespoon cumin  
 1 tablespoon smoked paprika  
 3 teaspoons of garlic salt  
 1 teaspoon of lemon pepper  
 1 teaspoon ground mustard  
 1 teaspoon kosher salt  
 1 teaspoon ground black pepper

### Step one:

Mix contents of Grandma Nancy's lamb rub together in a bowl.

### Step two:

Place 2 pounds of sliced lamb chops on a ceramic plate and allow meat to get to near room temperature. Coat meat liberally with olive oil and sprinkle both sides with lamb rub and allow to rest for a minimum of one hour.

### Step three:

Slice one yellow onion in small dices, place in a large sauté pan with six tablespoons of butter. Sauté onions in butter till they become translucent (approximately 2 minutes). Add ¼ cup flour and cook for an additional 1 minute while whisking vigorously. Add 1 cup of milk, continue whisking

ensuring there are no lumps. When it begins to thicken, add two cups of chicken broth. Whisk together until ingredients begin to thicken (2-4 minutes).

### Step four:

Remove sauté Pan from heat. Add 1-3/4 cups of Monterey Jack Cheese and 1 cup mild Cheddar Cheese, and 1 cup sour cream to creamy base. Whisk until all ingredients are combined. Should be a smooth, creamy mix. Taste base and add salt and pepper to taste. (In my recipe I added a teaspoon of salt and pepper).

### Step five:


Add shredded hash browns to mixture. Whisk hash browns into creamy mix. (Approximately 1 minute whisking time)

### Step six:

Coat 9 x 13-inch pan with one tablespoon of butter, pour hash brown creamy mix into pan. Top with 2 cups of crushed kettle cooked chips mixed with ¼ cup of parmesan cheese

### Step seven:

Place Potato Casserole in 350-degree preheated oven. Bake for 45 minutes.



### Step eight:

#### Cook Lamb Chops:

Using a large iron skillet, place two tablespoons of olive oil in skillet with stove set on high temperature. Sear lamb chops for 3 ½ minutes on each side and remove from pan and allow to rest for 5 minutes before serving.

## Huntsville Mayor Dennis Jeffers Has Wonderful News for Entire County: New Mexican Restaurant Coming To Town

Since that day, work has begun to prepare the site for the new building (see photo below). Carlos said he is already ordering custom made furniture and fixtures for the restaurant with hopes of opening near the end of Spring, weather permitting.

Carlos Perez said he was aware of quite a few folks coming down Highway 27 from Scott County to his Wartburg location, attracted by both his very reasonably priced menu and several items on his menu that are unique. “We try to have both the traditional Mexican items, as well as some things we feel like are house spe-



cialties. ## \$30 Million for Homeless Veterans Grants

The Department of Veterans Affairs is gearing up to award \$30 million to organizations to hire case managers across the country to support homeless veterans for two years beginning this October. Those 150 case managers will assist with searching for and obtaining permanent housing and troubleshooting any barriers to keeping that housing.

Those barriers to finding and keeping housing can range from having a poor credit history, to being behind in rent, to having legal problems and more.

The VA goes by the Housing First philosophy: The veteran needs the stability of housing before taking additional steps to improve quality of life. Once the veteran is in permanent housing, the rest of the work starts -- job training, mental health care, education assistance, medical care ... whatever it takes to keep them in their home. The Housing First model was tested early on, and the results were promising: In a test of the first 177 homeless veterans, the program reduced the waiting time for housing placement from 235 days to 35.

If you're a homeless veteran or know someone who is, call the National Call Center for Homeless Veterans at 877-4AID-VET (877-424-3838) or see [www.va.gov/homeless](http://www.va.gov/homeless). If you know that you're likely to be homeless soon, don't wait until the last minute. Reach out for help now. There are resources to help you with health care, employment, housing and much more. You can also go to your closest VA medical center. While you're there, ask about Community Resource and Referral Centers (CRRCs) and their list of contacts who have the resources to help.


