

Who is New York, Democrat Hakeem Jeffries, Minority Leader in the House of Representatives?

Everyone is waiting to see how the newly elected Republican Speaker of the House Kevin the Democratic minority leader Hakeem Jeffries

work together in Congress. It doesn't look promising as Jeffries recently attempted to reappoint Representatives Eric Swalwell and Adam Schiff, both Democrats from California to the intelligence committee. He attempted this move despite House Speaker Kevin McCarthy being previously on the record that he would reject such a reappointment. This article gives a brief glimpse of Jeffries biography, career and voting record that can be contrasted against McCarthy's. It appears from the data, that Jeffries and McCarthy are on opposite ends of the political spectrum, not a good sign for bipartisan legislation.

Hakeem Sekou Jeffries was born on August 4, 1970, in Brooklyn, New York. He grew up, and called home, Brooklyn's Crown Heights neighborhood. He attended the State University of New York at Binghamton, obtaining a bachelor's degree in political science in 1992. In 1994, he earned a master's degree in public policy from Georgetown University in Washington, D.C. He then later attended New York University law school and graduated in 1997. After clerking for Judge Harold Baer, Jr., of the U.S. District Court for the Southern District of New York in 1997–98,

Jeffries entered private legal practice working for the law firm Paul, Weiss, Rifkind, Wharton & Garrison LLP. Jeffries was eventually offered a partnership, but instead decided to pursue a career in politics. Beginning in 2000, Jeffries began to criticize fellow democrat incumbent New York State Assemblyman Roger Green. Jeffries pointed at Green's focus on running for higher office and subordinating the concerns of his constituents as complaints. Jeffries challenged Green in the 2000 state election but lost in the democratic primary. In 2006, Green set his sights on congress and sought to unseat 10th congressional district Representative Edolphus Towns. His bid for congress was unsuccessful but he had to resign his New York State Assembly post to run in the congressional election which gave Jeffries the opportunity to run for the state seat. Jeffries won the election and became a New York State Assemblyman in 2006.

During his six years in the New York Assembly, Jeffries was politically active, introducing over 70 bills of legislation. Soon, Jeffries also looked towards capitol hill and ran for election in the U.S. Congress

Jeffries was elected to the House of Representatives in 2013. He defeated both his democratic primary challengers and Republican Alan Bellone in the general election by huge majorities.

Being in congress less than 6 years, Jeffries challenged California Congresswoman Barbara Lee to become the chairman of the House Democratic Caucus. On November 28, 2018, Jeffries defeated

her gaining this very powerful position within the democratic political machine in Washington. Reviewing his current net worth, most sources indicate that he is worth an estimated at 1.5 million dollars. Reading his voting record, on many subjects it is diametrically opposed to the position of House Speaker Kevin McCarthy. AA brief summary of his voting record is listed below. According

Representative Jeffries opposes big business, hawkish foreign policy, taxing the middle class, domestic surveillance and supports taxing businesses, consumer protection, disaster relief, funding education, environmental protection, financial sector regulation, gun control, public health, foreign and humanitarian aid, humane



immigration policy, labor rights and wages, lgbt rights, avoiding default, poverty amelioration, racial equality, increasing revenues, taxing the wealthy, countering Russian interference, a robust safety net, higher spending, women's rights.

DEAR PAW'S CORNER: This winter, a lot of my family has had colds and flu. Can my cat catch a cold from us? — Darlene, via email

DEAR DARLENE: Cats don't catch colds directly from humans, but they can suffer from upper respiratory infections that are just as uncomfortable.

A number of viral and bacterial infections can make your cat sick. Some of these, such as FVR (feline rhinotracheitis) and FVC (feline calicivirus) can be prevented by making sure your cat gets an annual checkup and vaccinations. An underlying health condition also can make your cat more susceptible to upper respiratory infections. Again, regular checkups and shots can keep it healthy.


What symptoms does a cat with a URI have? It may be sniffling and sneezing, along with a clear or cloudy discharge from the eyes or nose. Your cat also may have little to no appetite and might be lethargic.

Contact the veterinarian right away if your cat has any of these symptoms. The vet will want to examine your cat to confirm what kind of URI it has. Use a cat carrier so other cats in the waiting room won't be exposed, and to keep your cat safe.

Follow the vet's instructions on caring for your sick cat. You may be given a prescription, and you will be asked to keep the cat comfortable and warm, and to try to get it to drink water and eat some food. Dry food may be a turnoff, but it may eat a little wet food. If your cat won't eat or drink, contact the vet again — an IV may be needed to keep it hydrated.

- * Save smaller bits of leftover veggies in a large freezer-safe container or bag, in the freezer. When it's full, make vegetable soup.

Memphis is not about racism

There's nothing white supremacy can't do.

It is supposedly so pervasive and powerful that it can cause Black men to sign up to serve as police officers in a majority Black city and severely beat a Black arrestee.

It is to the contemporary left what capital was to Marx, sex was to Freud, and gravity was to Newton.

It is the King Charles head of American public life, a matter of obsession that comes up in debates and contexts where it has no possible relevance.

An opinion piece at CNN by former Obama official Van Jones was headlined, "The police who killed Tyre Nichols were Black. But they might still have been driven by racism."

A piece at The New York Times on Memphis related the view that it "is the system and the tactics that foster racism and violence," not "the specific racial identities of officers."

This argument gets points for novelty but none for plausibility. The Memphis officers who brutalized Tyre Nichols may be guilty of many things -- incompetence, malice, criminal wrongdoing -- but white supremacy is unlikely to be one of them.

Presumably these officers don't all hate their parents, children, neighbors, and colleagues as unworthy, racially inferior people who deserve no protection under our laws.

Maybe it's only as police officers that these men become unwitting tools of white supremacy? This makes no sense, either. The Atlantic noted in an article last year that FBI data showed Memphis to be the most violent metropolitan jurisdiction in the United States in 2020. According to The New York Times, Memphis had nearly 350 murders in 2021, when New York City -- 13 times larger -- had about 480.

Of course, these murders disproportionately affect young Black men. Isn't this just how a white supremacist would like it -- overwhelmingly Black neighborhoods under siege as Black men kill other Black men? Why would white supremacism want to interfere with this dynamic by deploying police units to try to quell the disorder?

Indeed, the false consciousness in Memphis must run deep. Cerelyn Davis, the city's first African American woman police chief, created the just-disbanded special police unit implicated in the Nichols beating. Understandably, she thought it was very important to get a handle on rising homicides and dangerous reckless driving, but, unbeknownst to her, she was just serving the man.

The obsession with white supremacy is perverse and insulting on several levels. It implies that if urban neighborhoods are under-policed and dangerous, that is their natural state, whereas if they are robustly policed to try to make them safer -- a worthy project that tends to be supported by people of all races -- that is somehow an inherently "white" initiative.

It suggests that good African American, Hispanic and Asian cops are dupes, puppets on the string of nefarious white people using them to perpetuate white rule. And, finally, if taken seriously, it would vitiate the agency of the cops involved in the abuse of Tyre Nichols. How can they fully take the blame if an ineradicable, unavoidable force was ultimately responsible for their behavior?

The explanation for what happened in Memphis is more straightforward than any of this. Police are given considerable authority, and human beings -- of all races and creeds, in all times and places -- have a natural tendency to abuse authority unless constrained by institutions, norms and accountability.

If you are unwilling to believe that the cops in this case were self-loathing Black men, then their behavior becomes a function of poor training and supervision, abysmal decision-making, anger in the moment, free-floating cruelty, or some combination of these things.

The left elevates race above all the other factors that might play into a police encounter gone horribly wrong because the racial interpretation allows it to make a broader critique of American society and force wide-ranging political and social changes.

This is a very useful narrative, which is why it is loath to give it up even in an incident involving Black cops.

Have you heard of a disease by the name of Charcot-Marie-Tooth (CMT)? Well I hadn't until I did a little research on neuropathy to see

how Alan Jackson was doing with his problem.

It appears that Alan has a little more than neuropathy. It is called (CMT)

or Charcot-Marie-Tooth. A weird name for a hereditary condition that Alan Jackson inherited from his father. It is strange that I have the same disease that Mr. Jackson has so it looks like I could be following the same path he will travel. He has had the disease for ten years and I have had mine for twelve years.

Alan Jackson reported his condition in 2021 because he was afraid that he would fall on stage and he didn't want his fans to think he was drunk. He has had to call off some of his tours and in the future, he thinks things will get worse.

How does CMT affect a person's body? Like Parkinson's it is a neurological disease. This means it affects the nerves in your feet, legs, and hands. I remember when neuropathy first came on. My doctor in Florida diagnosed it as arthritis but I got no relief from what he recommended. The next time I went to him he was at the hospital and his wife took care of his patients. I told her how I hurt and when it comes on. She said, "that is not arthritis that is neuropathy.

I had never heard of neuropathy, but I sure have heard of it lately. To make sure of my diagnosis when I came back to Tennessee, Dr. Eric Redmon assigned me a doctor and they ran me through a few tests and neuropathy was confirmed. The doctor recommended a medicine, in which didn't work, so here I was a guinea pig on the way to trying several medications until I found something that would work.

Now along comes CMT, a progressive nerve disease. It affects one in 2,500; nearly 3 million worldwide. In Alan Jackson it affects the peripheral nervous system that controls sensory information and muscle function in the lower legs and forearms, impacting touch, movement, and balance. So you can see why he came forward on T.V. to tell all his fans if they saw him stumbling around on the stage he was not drunk but the real reason is CMT.

Jackson said he had been stumbling around on stage for years but now I'm

having a little trouble balancing even in front of the microphone, and so I just feel very uncomfortable, and I just want people to know why I look like I do.

There is no cure for CMT. It usually progresses slowly and doesn't affect expected life spans. That is about the only good thing about the disease.

Although Alan has been performing on stage for over 35 years and he has made millions on his records he still doesn't want to give up touring. He says

he wants to be like George Jones, Loretta Lynn, and Charley Pride who went on performing until their deaths, but he knows what this disease did to his Dad. It put him in a wheelchair for a lot of his life.

Alan could go on writing songs, because he writes great songs, and he could go on recording and give up tours, but it seems that performing live is what these singers live for.

I'm experiencing the same things

that Alan Jackson is and my biggest fear is falling. I use a walking stick but the other Sunday even a walking stick didn't keep me from falling; two people did. I also have another fear. My daughter has Parkinson's and I'm wondering since CMT is inherited did Robin get this from me. The two diseases are related. I sure hope she didn't. It would kill me to think I handed Parkinson's down to her. She has really suffered.

I pray for all of you who have neu-

ropathy. It doesn't mean you have CMT, but it could. I hope for you it is only neuropathy, because it is bad enough. Both neuropathy and CMT are hard to diagnose and so is Parkinson's. My daughter had to go to the large city of Tampa to find a doctor that could tell her what she had so she could be treated. She has had a very difficult time and she has had to put in for early retirement from her difficult job.

I do not know what my future holds but I know that my condition

has already progressed to the point where I have a problem in standing and balance is terrible. When I sit a long time and get up I need to stand still a while to get my equilibrium back. Believe me it makes you want to stay home and give up doing anything, but I could have given up a long time ago. I don't think I'm ready to give up. I'll still try to visit folks who are worse off than me. I'll see you soon Donna.

Avoid refund delays

Delays can be caused by many reasons.

The National Taxpayer Advocate reported that paper tax returns are like "kryptonite" to the IRS. IRS employees must manually enter the data from paper returns into their computer system, which creates a backlog due to limited staffing. The IRS had a backlog of about 10 million returns at the beginning of this year's tax season.

Unfortunately, some people don't have the option of efiling. Some IRS forms can only be filed using paper forms. In a recent report, the National Taxpayer Advocate informed Congress that some forms aren't available for efiling

formed Congress that some forms aren't available for efiling. If you are concerned that an ex-spouse might incorrectly claim any of your dependent children, you should file as early as possible. Suppose your ex-spouse files first and incorrectly claims your dependent. In that case, your return will be rejected if you efile and claim your dependent. Consequently, you must mail your return or efile the return without claiming your dependent. You can amend your return later and claim your dependent to get the remainder of your refund. However, amended returns can take several months to be processed.

Receiving your refund by direct deposit to your bank account is faster than receiving your check in the mail. Eighty percent of filers get their refunds by using direct deposit. It's safe and secure. There's no chance of it your check getting lost, stolen, or destroyed. This is the same transfer system used to deposit over 95 percent of Social Security and Veterans Affairs benefits.

It's crucial to use accurate numbers. The IRS compares

your numbers to the numbers that third parties have reported. For instance, your refund could be delayed if you estimate your mortgage interest and it's more than reported by third parties. If your numbers don't match third parties' numbers, the IRS may send you a letter notifying you of the discrepancy. Due to the IRS mail backlog, it could take months for the IRS to process your response and get your refund.

Be sure to include all income, such as interest, dividends, or any 1099, which reports your income. W2s and 1099s are not required to be mailed until January 31, and you may not receive them for several more days. If a form doesn't arrive that you are expecting you will need to notify whoever is sending the form. Wait until you have all your tax forms before filing your return. Sometimes people are in a hurry to get their tax refund or want to finish the filing process.

Filing an accurate return and verifying it for correctness can help to avoid refund delays.

Lowering Our Drug Costs

I got a shock the other day when I went to the pharmacy to pick up the latest refill of my three drugs and realized that the pharmacy assistant had neglected to run it through GoodRx, the program that helps reduce the price of our drugs. Once he did that, the cost dropped significantly.

It made me realize just how much other seniors are paying for the drugs we need to stay healthy. There are ways to cut those costs. It just takes a little work and a lot of monitoring on our part to make sure it happens.

As mentioned, there's GoodRx (www.goodrx.com), which I've used for several years. Their website isn't the easiest to use, but after you try it once, you'll appreciate being able to cut the costs of your drugs every time you need a refill.

There are other ways as well:

RxAssist (www.rxassist.org) has programs that are run by the pharmaceutical companies to help those who can't afford their prescriptions. If your drugs cost more than \$10, present your RxAssist card to get the lowest price. Check the website for a long directory of patient assistance programs. Beware that some programs involve a small fee to be a member and many have eligibility requirements.

Consider Walmart pharmacies for their generic program. A 30-day prescription will cost \$4 and only \$10 for a 90-day prescription. Not all generic drugs will qualify for those prices, but it's worth making a call to your local Walmart pharmacy to find out if your drugs are on that list.

NeedyMeds website (www. needymeds.org) was started by a physician in 1997 to help gather information about reduced drug and health care costs. The website says over \$337 million has been saved so far.

And finally, check the prices at Mark Cuban's Cost Plus Drugs (costplusdrugs.com). For some drugs, this one is the lowest of all.

Hebrews Chapter 2

(Heb. 2:1-4) The danger of neglect: In view of the exalted position of Jesus Christ, the recipients of this document ought to give surpassing attention to the message they had heard (the gospel), otherwise they certainly will drift away. Apostasy frequently comes slowly. This is not a light matter. The "word that came through angels" was Moses' law. Under that system, violators (all the disobedient) were justly punished (v. 2; 10:28-29). That being the case, how would it be possible to "escape" God's wrath if one neglects the salvation revealed by his Son (in the new covenant)? The new covenant is a divine system authenticated by supernatural manifestations that were "signs" pointing to Jesus' deity, works that excited "wonder," and demonstrations of divine "power" by means of gifts bestowed by the Holy Spirit (v. 3-4).

(Heb. 2:5-9) Subjection of the world: Now comes another argument of the superiority of Christ over angels. The "world to come" is not the "millennial age," but a reference to the Christian age. This era was not subjected to angels, but to man (particularly to be exercised by the perfect man, Christ) (v. 9). A quotation from Psalm 8 asks: "What is a man that God has been so mindful of him?" Though as to his nature man was made a little lower than the angels, he has been crowned with glory and honor, and placed over the works that issued from God's hands, with all things put under his feet (v. 6-8). When man departed from the ideal authoritative role he was intended to have, it remained for the perfect Man to achieve the task. Again, there is no reference in the context to the mythical "millennium," as dispensationalists contend. Acts 2:29-30 "Men and brethren, let me freely speak unto you of the patriarch David, that he is both dead and buried, and his sepulchre is with us unto this day. 30 Therefore being a prophet, and knowing that God had sworn with an oath to him, that of the fruit of his loins, according to the flesh, he would raise up Christ to sit on his throne." Hebrews 1:8 "But unto the Son he saith, Thy throne, O God, is for ever and ever: a sceptre of righteousness is the sceptre of thy kingdom."

Christ himself was made lower than the angels. The verbal tense indicates that the "lower" (human) identification remains at the time of this writing, even after Christ has returned to heaven. By virtue of his suffering death and subsequent resurrection, Jesus has been crowned with glory and honor; he "tasted of death" so that every person who so chooses could be saved (v. 9; Mt. 23:37). Here is affirmed the doctrine of universal atonement (through not universal salvation), in contrast to right-wing Calvinism and its dogma of "limited" atonement.

(Heb. 2:10-18) Christ our brother: God is spoken of as the one for whom the creation exists (it is his); and he is its source as well. He is exercising his plan to bringing many spiritual sons (not national Israel) to a state of glory. The Author (trailblazer, Jesus) of that salvation has achieved the goal by means of his suffering (Rom. 3:21). This involved Christ becoming flesh (Jn. 1:14), so that the sanctified, along with the sanctifier, are of the same human nature (v. 11). This is not a denial of Jesus' deity; it is an affirmation of the retention of his human nature resulting from the emptying of himself and taking upon himself of manhood (see Phil. 2:5). For this cause the ascended Christ is not ashamed to be identified with the redeemed as brothers. The mystery in this is breathtaking! He thus is happy to declare

and praise Jehovah's name in the congregation of his people, even as the psalmist had foretold centuries earlier (v. 12; Psa. 22:22). This quotation, along with others, identifies Psalm 22 as messianic (Psa. 22:1, 16-18). The unity of Christ and his people is reinforced from Isaiah 8:17 by the term "children" (v. 13).

Since his "children" (Isa. 53:10) are "flesh and blood" humans, he himself "partook" of the same to render inoperative him who currently (though temporarily) (1 Cor. 15:25-26) holds the power of death, namely the devil (v.14). This does not mean that Satan determines who or when someone is to die, but is a reference to his initial malevolent murder of the human race (Jn. 8:44). Human beings are enslaved to the fear of death throughout their lives, but the power of Christ's death and resurrection, as conveyed through the gospel message, has significantly delivered the Christian form the dread of that (v. 15; 2 Tim. 1:10; Phil. 1:23).

The reference to "angels" (v.16) is capable of two possible views: (1) Christ did not lay hold on (assume the nature of) angels in order to assist them; instead, he came to deliver the spiritual "seed of Abraham" (Gal. 3:24-29 "Wherefore the law was our schoolmaster to bring us unto Christ, that we might be justified by faith. But after that faith is come, we are no longer under a schoolmaster. For ye are all the children of God by faith in Christ Jesus. For as many of you as have been baptized into Christ have put on Christ. There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female: for ye are all one in Christ Jesus. And if ye be Christ's, then are ye Abraham's seed, and heirs according to the promise." Galatians 6:15-16 "For in Christ Jesus neither circumcision availeth any thing, nor uncircumcision, but a new creature. And as many as walk according to this rule, peace be on them, and mercy, and upon the Israel of God)." (2) Jesus did not become incarnate to deliver angels, but to deliver men---specifically the spiritual "seed of Abraham." This may indirectly suggest that there is no plan of salvation for those rebellious angels who lived in such close proximity to God, yet sought to be his rivals (2 Pet. 2:4; Jude 6). The two ideas are not mutually exclusive.

Another aspect of "being made like his brothers" in all things (without sin, of course) lies in the fact that he wanted to be a merciful and faithful high priest in divine matters. He is a "faithful" (trustworthy) priest, thus dependable for the role; he is a merciful priest with the passion to deliver. He functioned as a "high priest" in the offering of his life as a sacrifice. In this sacrificial act he would "make propitiation" for the people (v. 17). Christ's role as high priest---one flawless in character and permanently effective with the offering of one sacrifice (rather than many repetitiously) (10:1)---marks him as unique and is the major theme of this document. The aim was to provide "propitiation," the price necessary to satisfy the justice of God required to atone for sin. He was eminently qualified for this role in that, being tempted himself (4:15), he is able to wholly empathize with


his people when they are similarly tempted. What wonderful comfort is to be found in Christ our high priest!



Oak Ridge Enhanced Technology & Training Center – the latest in a long line of training successes, Part 2By Ray

This is the second and final part of the series on the history of training in Oak Ridge and the most recent enhanced training capability brought by the Y-12 National Security Complex's Oak Ridge Enhanced Technology & Training Center.

At Oak Ridge National Laboratory, training is provided by developers and experts, with courses such as: nuclear criticality safety; light water reactor and advanced reactor modeling; reactor safety analysis; radiation shielding; spent nuclear fuel characterization for transportation/storage

package designs, decommissioning and disposition; verification, validation, and uncertainty quantification; nuclear safeguards and security applications; and nuclear data processing and libraries generation.

At Y-12 National Security Complex, specialized training in manufacturing skills, engineering applications in uranium processing, nuclear nonproliferation, and many other generalized skills are routine. Because of unique applications of special nuclear materials at Y-12, the on-site training is highly specialized.

This documentation of a few of the more significant training programs over the years in Oak Ridge does not include the training provided by the University of Tennessee or Roane State Community College, both of which have several highly successful and specialized training programs. Nor does it include the Oak Ridge Schools where much basic education is provided.

Throughout Y-12's history, the complex manufacturing mission required a large skilled workforce that could keep pace with technological advances on the manufacturing floor. Y12's apprentice programs have evolved with technologies over the centuries. They taught maintenance crafts to fix uniquely designed pumps, tools, switchgears, and motors. The introduction of computers required training on increasingly more complex digital machines without reduction in quality. In recent years, the focus has been on training the

next generation of workforce as many of the cold war era workforce began to retire.

As threats across the world change, Y-12 is there to train those expected to respond. Advanced in nuclear medicine and radiation therapy saves lives, but also places such materials in "open environments" such as universities and hospitals. In 2007, the Alarm Response Training Academy, the precursor to ORETTC, opened at Y-12 to train safety and security professionals, and law-enforcement officers to respond well in emergency scenarios to protect and secure the material. Since opening, over 6,000 professionals have been trained from every state in the Union as well as participants from more than 20 countries.

With this background of some of the history of training pro-

grams in Oak Ridge, it is surely obvious that excellence in training programs is a valued Oak Ridge tradition. The Oak Ridge Enhanced Technology & Training Center is one in a long list of effective training programs in Oak Ridge, TN!

Now for the most recent example of the continuing exceptional Oak Ridge training tradition.

The COVID pandemic forced many to adapt to a new way of work and training at Y-12 was no exception. Safety and security professionals could no longer travel to Y-12 for Alarm Response Training, so Y-12 developed distance learning platforms to continue this vital mission. A green screen production studio allowed Y-12 instructors to recreate radiological source theft scenarios as short video clips to help participants visualize their response strategy at a distance. This technology was just the beginning. Tabletop exercises are a vital part of challenging the funda-

ORETTC continues to develop and deploy training technologies to provide the most effective, immersive training into the future. The new facility includes advanced video production tools including an LED wall more likely to be found on a Hollywood movie set.

the scenario and then it can be reset to practice again.

"The LED wall allows us to extend the simulated environment much further so that the participant is fully immersed into the scenario. This makes a high consequence emergency training scenario feel real without exposing the trainee to hazardous situations," described Director Stowe. The center will soon combine these technologies to create a mixed reality training experience where trainees can reach out and touch virtual objects, communicate with other trainees and with digital game characters.

The online training concept was created to support the needed training during the COVID pandemic and is continuing to be provided to assist those who may need refresher training or cannot travel to Oak Ridge

mentals being taught in training classes.

The Y-12 team developed an augmented reality tool using the latest game design engines allowing instructors and trainees to interact in the same scenarios despite great distances between them. Augmented reality headsets are sent to a university or hospital where participants join the scenario to find Y-12 instructors waiting for them online. In this live training, each participant role—radiological security officer, law-enforcement, site security—plays their part as the instructor steps through the simulation.

Participants get to see how well their tactics work as the simulation proceeds. Beyond the advantage of bringing training participants together at a distance, they can see in real time how well their decisions and actions worked in

The campus will also bring trainees back to real life with emergency response drills utilizing the campus itself. Each of the buildings and structures on campus can be adapted such that trainees must defend, protect, or respond to a variety of emergency response situations.

The grand opening of ORETTC well-positions Oak Ridge to build upon its tradition of providing the United States and her allies with best-in-class training, leveraging its unique expertise born through the Manhattan

Project and continuing through enduring missions at the Y-12 National Security Complex.

Veteran of the Week

United States Marine Corps veteran Colonel Robert Joseph Modrzejewski served our country during the Vietnam War while assigned to Company K, 3D Battalion, 3TH Marines, 3D Marine Division (REIN) FMF in the Republic of Vietnam.

While serving at the time the rank of Major During July 15-18, 1966, he went above and beyond the call of duty in combat. In doing so he was awarded the Medal of Honor by President Lyndon B. Johnson at the White House on March 12, 1968.

His Medal of Honor citation reads: For conspicuous gallantry and intrepidity at the risk of

his life above and beyond the call of duty. On 15 July, during Operation Hastings, Company K was landed in an enemy-infested jungle area to establish a blocking position at a major enemy trail network. Shortly after landing, the company encountered a reinforced enemy platoon in a well-organized, defensive position. Maj. Modrzejewski led his men in the successful seizure of the enemy redoubt, which contained large quantities of ammunition and supplies. That evening, a numerically superior enemy force counterattacked in an effort to retake the vital supply area, thus setting the pattern of activity for the next 2 1/2 days. In the first series of attacks, the enemy assaulted repeatedly in overwhelming numbers but each time was repulsed by the gallant marines. The second night, the enemy struck in battalion strength, and Maj. Modrzejewski was wounded in this inten-



sive action which was fought at close quarters. Although exposed to enemy fire, and despite his painful wounds, he crawled 200 meters to provide critically needed ammunition to an exposed element of his command and was constantly present wherever the fighting was heaviest, despite numerous casualties, a dwindling supply of ammunition and the knowledge that they were surrounded, he skillfully directed artillery fire to within a few meters of his position and courageously inspired the efforts of his company in repelling the aggressive enemy attack. On 18 July, Company K was attacked by a regimental size enemy force. Although his unit was vastly out-

numbered and weakened by the previous fighting, Maj. Modrze-jewski reorganized his men and calmly moved among them to encourage and direct their efforts to heroic limits as they fought to overcome the vicious enemy onslaught. Again, he called in air and artillery strikes at close range with devastating effect on the enemy, which together with the bold and determined fighting of the men of Company K, repulsed the fanatical attack of the larger North Vietnamese force. His unparalleled personal heroism and indomitable leadership inspired his men to a significant victory over the enemy force and reflected great credit upon himself, the Marine Corps, and the U.S. Naval Service.

Law Enforcement Officer of the Week

The Loudon County Sheriff's Office shared the following on their Facebook page to the honor and memory of fallen Officer Chris Jenkins. We want to honor him now by sharing their heartfelt tribute with you now.

When they say "one of the good ones," it doesn't even come close to describing the greatness Chris Jenkins was. Scottish writer Thomas Carlyle, at the beginning of the century, once wrote that "The history of the world is but the biography of great men." Another well know man, Winston Churchill, said "History will be kind to me, for I intend to write it."

Now, if you were to ask Sergeant Chris Jenkins if he thought he could be compared to Winston Churchill, he'd give you one of his signature looks, quickly followed by a smile, and then say "you've lost your mind."

Today marks one year since Chris Jenkins laid his life down, in the ultimate act of service, protecting his community. As painful as it is to think of Chris's death, there's so much to actually reflect on - things that we want you to know about him, and truth be known, things that he wouldn't ever think to tell you about himself.

Chris wasn't just an average cop, but rather a great one. He wasn't an average father, but an extremely committed one. And he sure wasn't a normal son, brother, fiancé, or uncle, he was a dedicated family man to the very core of his body. Chris didn't just work at the Sheriff's Office, but instead he embodied what it meant to be a teammate. He didn't just work a shift and go home but instead, always in a class of his own, he stayed over if it was busy, he responded at all hours of the night from his home, and he was the first one on his shift to go in-service and start answering calls right out the gate. Chris wasn't just another "leader" in the agency that filled a spot. He was the guy who took his role seriously and saw it as



a responsibility to be an advocate for his team. He stood for a lot of things, and one of those things was his people Chris didn't have to tell you that he had our backs, we already knew it because time and time again, he proved it by his actions. He was an example for old and young alike. He was the epitome of what it means to wear the badge with honor, integrity, and professionalism. In fact, besides backing his patrol car in reverse, he was pretty much one of the greatest men to have ever walked our hallways and protected our streets.

Now, back to those quotes by Carlyle and Churchill. If the history of our world is but the biography of great men, then the history of the Loudon County Sheriff's Office is inked in the many impacts that Chris has on all

of us, his squad, and his community. His is a story that will live on forever in the stories we tell of him to new deputies and by the many memorials of Chris that line our walls. Long after we are all gone from LCSO, Chris Jenkins will be a living piece of its history. And when Churchill said he intended to write history, we are pretty sure that Chris never would have said such a thing. But in comparison to Churchill's quote, little did Jenkins know that just through his actions, his work, his leadership, and his friendship, he was doing just that. He set the bar high and he continues to have a presence in our agency. May we always treat our employees, our team, like Chris would have - with all the love in the world, with a slice of humor on the side and with the greatness he was.

We love you, Chris. Rest easy knowing you are alive in our hearts and in our actions and in our purpose, each and every day we represent this agency - that you loved so deeply.



In Tennessee Code Annotated, Title 11, Chapter 11, Part 1, also known as the Tennessee Trails System Act (the "Act"), the Tennessee General Assembly has declared that the policy of this state is to provide for the ever-increasing outdoor-recreation needs of a growing population, and to promote public access to, travel within, and enjoyment and appreciation of the natural and remote areas of the state, by establishing trails in both natural, scenic areas of the state and in and near urban areas. According to the Act, state scenic trails should be extended trails that provide maximum potential for the appreciation of natural areas and for the conservation and enjoyment of the significant scenic, historic, natural, ecological, geological, or cultural qualities of the areas through which such trails pass. In accordance with T.C.A. § 11-11-109(1), the Tennessee Department of Environment and Conservation hereby provides notice of the selected route of the Cumberland Trail State Scenic Trail, which is managed as part of the Justin P. Wilson Cumberland Trail State Park. The law requires that before locating routes of state scenic trails such as the Cumberland Trail State Scenic Trail, the Department must select a route which is compatible with preservation or enhancement of the environment it traverses. The Department must also publish notice of the selected route in a newspaper of general circulation in the area in which the trail is located, together with appropriate maps and descriptions. Pictured with this notice is a map of the selected trail route. Within each map/parcel identified on the map, the trail would run through a corridor between thirty (30) to one hundred (100) feet in width. 
On the court this season, at the time of this article, the Centre Colonels are 15-5 overall, 9-0 in SAA Conference



Fast Help for Suicidal Veterans

It has a very long title, but a short, concise purpose. The Veterans Comprehensive Prevention, Access to Care, and Treatment Act of 2020, or the Veterans COMPACT Act of 2020, section 201, allows eligible suicidal veterans to go to an emergency room for help. This opens the door for 9 million veterans to get the care they need.

But the scope is much wider. An acutely suicidal veteran can go to not only a Department of Veterans Affairs emergency room, but any emergency room.

The VA will pick up the tab, at no cost to the veteran, for inpatient or crisis residential care for up to 30 days and then outpatient care for up to 90 days, as well as any necessary transportation. The veteran doesn't need to be enrolled in VA health care.

After getting that care, they'll determine eligibility for any other VA services and benefits and refer the veteran to appropriate programs.

Even though the VA believes that there are 9 million veterans who can take advantage of this, if necessary, there are a few eligibility requirements.

Veterans must have been discharged or released from active duty after serving more than 24 months, and leave under conditions other than dishonorable.

Eligible individuals are former members of the armed forces (including reserves) who served more than 100 days "under a combat exclusion or in support of a contingency operation either directly or by operating an unmanned aerial vehicle from another location" and again, be discharged under conditions other than dishonorable.


And thirdly, former members of the armed forces who were the victims of sexual assault or sexual harassment are eligible.

If you or someone you know needs help, there are a number of ways to get it. Go online to www.veteranscrisisline.

net and view the choices. You can call them by dialing 988 and then pressing 1. You can chat online at that website. Or you can text a message to 838255. Help is available 24/7 from qualified, trained people.

Or, per this Act, help is as close as the nearest emergency room.
