
Pet Perspective with Ms. Avery Pearl

Covid-19 Pandemic Policies, Almost Four Years Later

In March of 2020, I first wrote about Covid-19 in The

Morgan County Today. The headlines of the paper read: "Covid-19: "Morgan County Has First Confirmed Case of Coronavirus." In an accompanying article, I speculated that the policies spawned pandemic would affect the very social and economic fabric of America. So, where are we now and what con-

sequences has America faced as a result of the pandemic policies our government adopted?

In this article, I will focus on how government and scientific experts have seen public confidence fade and skepticism rise.

To be honest, American trust in the government has been declining since the 1960s. Scholarly organizations have linked the eroding of trust to the Vietnam War, Watergate, the oil embargos for the 1970s, and so on. But government responses and censorship during the Covid-19 pandemic have added onto an already skeptical American public in a hyperpolarized political cli-

In May of 2022, The PEW Research Center conducted a survey which verifies Americans have lost confidence in Government institutions resulting from the Covid-19 response. The New York Times, reporting on the Pew Study, stated the following:

As the coronavirus pandemic entered its third year, the American public had lost much of its trust both in public health experts and in government leaders, and was less worried than before about Covid-19, according to a survey conducted in early May and released Thursday by the Pew Research Center.

Also in June of 2022, Gallup conducted a survey as well, below is a quote from the report outlining the survey:

This year's poll marks new lows in confidence for all three branches of the federal government -- the Supreme Court (25%), the presidency (23%) and Congress. Five other institutions are at their lowest points in at least three decades of measurement, including the church or organized religion (31%), newspapers (16%), the criminal justice system (14%), big business (14%) and the police.

According to the British Academy, even the world's most recognized monarchy is having difficulty in public to trust after the Covid-19 policies. The following is a quote from their report:

Following a brief initial increase, trust in the UK Government and feelings of national unity are in decline. Trust in local government and feelings of local unity have been higher and steadier. Declining trust is a major challenge that needs to be addressed because it undermines the ability to mobilize public behavior for wider social and health benefits.

The available data leaves no room for debate, the pandemic policies of



politically motivated reasons. Potentially, the most damaging facet of the Covid-19 policies was the censorship that occurred in the United States. Diverging opinions were silenced

of credibility, in many cases for selfish, one-sided, and

the U.S. Government and governments throughout the world resulted in the loss

and anyone questioning the government's position received rapid retribution. To be fair, this occurred across the globe, especially in autocratic and dictatorial nations like China and Venezuela. That is no excuse for the same to happen in the U.S., we are better than that.

Crisis always provides a gateway to censorship, extreme legislation, and one-sided policies. In democracies, the public always has an insatiable thirst for information during a crisis, which accelerates public consumption of mass media. These circumstances dictate that any censorship activities will have exaggerated effects on public opinion. Our founding fathers realized the impact of censorship and placed protections against censorship activities, those protections were subverted due to the "emergency circumstances" of the Covid-19 pandemic.

Even the courts have ruled in this matter, A September 8th ruling in Missouri v. Biden prevents federal officials from

pressuring social media platforms to take down protected free speech. It was the suspension of social media accounts of accomplished author Alex Berenson which was mentioned in the case. Berenson, former winner of the Edgar Award, and New York Times best selling author attempted to expose information concerning Covid-19 policies, which resulted in his Twitter account being removed.

On the topic of scientists, many news outlets are now calling for them to admit their mistakes during Covid. A quote from the Financial Review, stated this on the subject:

During the pandemic years, Americans' trust in scientists fell, according to a Pew poll released this month. In 2019, only 13 per cent of Americans were distrustful enough to say they weren't confident in scientists to act in the public's best interest. Now that figure is 27 per cent – despite recent triumphs in astronomy, cancer research, genetics and other fields.

The United States famed scientific expert, Dr. Fauci, is not even worthy of a discussion. The only statement I will make is review his steering of the public during the crisis and see what science has revealed now, make your own decision.

So, where do we go from here as a country? Our elected officials and government offices should immediately attempt to restore creditability to their institutions. How do they accomplish that in today's environment? Good question, not sure that anyone has that answer, but they better begin to formulate a plan. If the public trust in our government continues to erode it is bad for everyone, republican, democrat and independent alike. Let's hope and pray that we soon see policies that bring sanity back to the government.





Here today I am sitting in my son's and daughter-in-law's house. It cost my kids a lot of "Jim how was your trip?" and he had traveled all of 46 miles and he said, "boy it was a long one." He went in a T-model Ford.

Ramey Potter. Now he was a good carpenter but he didn't have the best lumber or the best tools. The houses built back then had very little or no insulation in them and sometimes you could see daylight through the cracks. This house was a two-story with a full 2 nd floor and three fire-places. I remember going over to ride my sled in winter time and going inside to warm my hands. Grandpa was always sitting there in a chair that Ramey made. I'd love to have one of those chairs today. The wood in the fireplace would be popping and sometimes we would slip a few little fire crackers in there and Grandpa would laugh and say that wood really had spirit.

I loved to sit on the front porch in the summertime and talk to Grandpa or just look at the beautiful mountain view. East Tennessee sure is pretty.

Grandpa didn't talk much but he always asked, "what was your dad doing today?"

I think sitting on that porch was the best therapy a man could get and we had quite a few Redmon reunions there. They had a large family of five girls and three boys and all of them, except two, had a lot of children. Every summer we could meet there and get to know our cousins better. All the girls settled in Knoxville and Greeneville, while all the males were momma's boys and they stayed close to Momma. They also got most of the land.

The farm consisted of 90 acres of the bigger spread owned by John Redmon my reat-grandfather.

My dad had the other two sons built their homes real close to my grandpa's house. That was good because we played a lot with our two first cousins, who are still living today.

Before the big house on the hill was torn down it was rented out to several families. It was cheap rent. Two of my brothers lived there. It was cold in the winter time and hot in the summer but to me that house was precious. Today the land that it stood on is owned by a Redmon.

Life was simple back then and although we had little in the way of riches, I would give anything to go back to those days.

It is hard to estimate how much that big house cost to build back then but I would say less that a \$1,000 but today it would be worth a lot. I would give a million.

Notice: The location of the house today would be on Redmon Road. At one time only Redmon's lived on this road.

Beware of New Law with Enormous Penalties

Many businesses will have a new filing requirement with civil penalties of up to \$500 a day with a maximum of \$10,000. Additionally, the penalty includes imprisonment of up to two years for anyone who willfully provides false information or fails to update the information.

The new federal filing requirement will affect about 32 million small businesses and rental property owners.

If you are an owner of a corporation, limited liability company (LLC), or limited partnership you may be affected by the new law. The Treasury's financial intelligence unit, the Financial Crimes Enforcement Network (FinCEN) enforces the filing requirement.

Congress enacted the Corporate Transparency Act (CTA) to help prevent the use of anonymous shell companies for tax evasion, money laundering, and other illegal activities. The CTA primarily applies to smaller businesses that the government doesn't heavily regulate.

If your business is subject to the CTA, your business is called a "reporting company" and must file a beneficial owner information (BOI) report with FinCEN on or before December 31, 2024. The BOI report is filed online at a new FinCEN database called BOSS (Beneficial Ownership Secure System). You can begin filing the report on January 1, 2024. There is no filing fee.

The beneficial owners are individuals who own and/or control a reporting company.

There are two different types of beneficial owners:

- Individuals who own or control at least 25 percent of the ownership interests in the company.
- Individuals who exercise "substantial control" over the company.

The company BOI report never expires and never has to be renewed. However, you need to update it within 30 days if any information in the report changes.

If you are the owner of a one-shareholder corporation or a one-member LLC, you are personally responsible for abiding by CTA compliance.

The BOI report includes the names and contact information of the individuals who own or control the company.

Larger businesses are exempt from the new filing requirement. Exempt large businesses include: more than 20 full-time employees, who work more than 30 hours a week, \$5 million in domestic gross receipts or sales on their prior-year tax return, and a physical presence in the U.S.

The CTA does not apply to sole proprietors that aren't an LLC. Owners and managers of small businesses should determine whether their business is a reporting company and subject to the CTA reporting requirement. They should gather the required information and make sure it is current when their initial report is filed. They should also implement a procedure to keep track of any information changes so that it's updated before the deadline.

Historically Speaking What I learned from Jack Case

This Historically Speaking column is written by Gordon Fee and I have chosen to let it follow the last column featuring the letter from Jack Case to Tom Tuck that initiated the conversation between Gordon and I resulting in him agreeing to write it. I think you will find that Gordon's "Lessons I learned from Jack" is insightful into the success of Y-12 and forms excellent basic leadership principles. Principles as applicable today as they were when Gordon learned them and applied them to his leadership of Y-12 and later the Martin Marietta Energy Systems and Lockheed Martin Energy Systems company that had responsibility for all Department of Energy facilities in Oak Ridge, Paducah, KY, and Portsmouth, OH.

Enjoy Gordon's reflections on Jack Case leadership principles:

In reading the letter that Ray Smith recently received (from Tom Tuck's daughter – Ray), that showed how it was in 1962 under the leadership of Jack Case, it made me think about the "lessons I learned from Jack." You see when it was announced in 1981, that the longest serving plant manager of Y-12 was going to retire, I was given the honor of being selected to follow in his footsteps as Plant Manager of Y-12.

For a year I was Jacks understudy and worked with him every day, learning what leading Y-12 really meant. Jack was not the type of leader that would give motivational speeches in front of an audience. He was the type of leader that led by example and who used good old "common sense" as his best tool to solve problems. Jack was at Y-12 during ethe Manhattan Project days and came up through the ranks from being a machinist to Plant Manager, so he knew the plant inside and out. Here are some of the lessons I learned from Jack, a man who, in my opinion, did more to shape Y-12 into what it is today than anyone else.

1. There are no weapons parts manufactured in the Administration Building. You solve problems by getting out in the plant and going to the site of the problem. Jack expected those in administration to go out to the shops and not take valuable time away from the primary mission of making weapons parts. He taught me that the more you "walked the floors" of the chemical processing area or the machine shops the more you will understand about how the plant functions and is known for doing the impossible when it comes to manufacturing.

2. Remember every person on the payroll is an important member of the team. Treat every person with respect and they will treat you with respect. Yes, there are people who have great skills at what they do but they don't function very well when there is lousy food in the cafeteria, or the bathrooms are filthy. So, remember the janitorial folks are just as important to the team as the smartest person in Development. So at Jack's retirement party he only thanked one person, ethe janitor who cleaned his office every day for his last two years.

3. Remember you are not near as smart as half the people who are working for you. Listen to them, listen to them, listen to them. Listen to Dr. John Googin, when he tells you how to solve a complex technical problem, listen to Charlie Robinson, Bob Keil and Jim Hamby when it comes to handling union relations, listen to Hershel Hickman when it comes to working with the Feds. The more you keep your mouth shut the better the plant will run. I must admit I sometimes had a hard time listening to Jack's advice in this area.

4. Remember a leader's main function is to handle conflict between different factions in the plant or different people. Jack was not exact-

ly known for using the most politically correct language, so about once a month he would remind me that a true leader is one who listens to two sides of *&^0% story, knowing both sides of an argument are exaggerating their stories and decide which of (*&^0%\$ people is lying the least. Every time I faced a major problem, I remembered Jack's advice.

5. Remember to take care of each other. In at least six times during my year under Jack, he called me into his office and handed me a one-page resume of someone and said, "Hire this one today." I, of course, would say, "why is this some specialist in the skills we need, what can they do?" To which Jack would respond, "It doesn't matter what they can do, their hus-

band passed away yesterday, he worked here 20 years, and she will need work to pay the bills. Get her on the payroll." Today I suppose we would all be fired for doing this and not following procedures, but this was the kind of leader Jack was.

Y-12 has always been known for its ability to do the impossible when it comes to manufacturing weapons parts and Jack loved to brag on this point. There are several stories of a time gone by that may be a little more myth than truth" as they have been told over the years. One is "The Funeral of Killed Parts." Y-12 had received a challenging assignment to make a very difficult part that required precise machining.

The shop was struggling with getting

parts that met specifications and only about 50% of the parts were acceptable. Jack gave the instruction to buy a casket and put it in the center of the shop and every time an out of specification part was produced you had to put it in the casket with your name on a tag. At the end of the week when the casket was very heavy, a funeral was held in the cafeteria for the dead parts and the supervisors were pall bearers. Guess what, "the next week the yield went up to 85% and the week after 95%, proving once again Y-12 could deliver."

Another story that may be a little more myth occurred at the quarterly plant managers' meeting. At this meeting a decision was made as to where a particularly difficult part would be mane, i.e., which plant would get the assignment. Jack was not known for speaking a lot at these meetings but when he did it was like the old advertisement says, "When Jack speaks everyone listens."

This time in the heat of the debate about this assignment, Jack bragged about his team being able to do the job better than any other site. When the decision was made to give Y-12 the assignment the losing plant manager said to the group, Jack, I sure am tired of hearing you brag about how Y-12 can do anything, why I bet you guys could even build a metal outhouse."

Well, Jack took this literally and at the next meeting presented his rival with - you guessed it - a brass outhouse! And it was made from an exotic brass metal that was known to be almost impossible to weld.

As I hope you can tell, I admired this man a lot and he rightly deserved having a building named for him at "HIS PLANT," i.e., the Jack Case Center.

People often asked me what he told me as he left his office for the last time. Well, at the time Oak Ridge National Laboratory had the mouse house on the Y-12 site where there were over two hundred thousand mice in residence. Y-12 had nothing to do with the scientific work going on at the mouse house, but Y-12 was responsible for keeping them warm in the winter and cool in the summer.

So, Jack's last profound advice to me was, "Remember, boy, you can miss a weapons delivery schedule and you will get your wrists slapped but if one of them little buggers dies because they were too cold in the winter just clean out your desk because they will fire your a%#." To me Jack Case will always be Y-12!

Thank you, Gordon, for a unique and most interesting perspective on a legend at Y-12. You readers will recognize that I included the brass outhouse story last week and then also Gordon's version this week. I felt it deserved the telling both ways. Gordon did not tell you what he was instructed to do with the special belt buckles stashed in the bottom drawer of Jack's desk. You see, some workers would cut stainless steel pipe into short sections and weld them together in the shape of a belt buckle and often someone would present Jack with one. He just took them a put them in his desk drawer. When he retired, he told Gordon to send them up to the foundry and get them melted down.

The lessons Gordon learned from Jack are valuable ones and leaders today would do well to adapt some of the commonsense ideas. I think it is a fact that Y-12 never missed a weapons parts shipping schedule all during the Cold War and maybe even beyond. It is not something talked about outside Y-12 much, but within the ranks at the plant a lot of pride is taken in Y-12's success over the years. I am proud to have worked there for 47 years!

The American Dream Under Biden: Out of Reach for Too Many

According to a new Wall Street Journal poll, only 36% of Americans believe the American dream still holds true, down from 53% in 2012. It is clear that Americans are losing hope under Biden, and who can blame them? The average Tennessee household has to spend an extra \$10,344 per year in order to enjoy the same standard of living as in January, 2021. Compounding these issues is the fact that the U.S. is facing a major housing shortage, with the housing market short 6.5 million homes. While Biden wants to dodge accountability for this crisis, his policies are largely to blame. Because of Biden's rampant spending, the Federal Reserve was forced to raise rates so drastically that it has robbed many Americans of the ability to buy a house. It is no wonder that scores of Americans believe the American dream is no longer a reality.

We must tackle the economic crisis facing our nation head-on. We can do this by extending former President Trump's Tax Cuts and Jobs Act in order to spur business growth and guarantee that middle-income Americans end the year with more money in their pockets. It's time we freeze federal hiring in order to crack down on the increasingly bloated administrative apparatus. Finally, this means slashing federal spending. Congress should adopt my across-the-board 1%, 2%, and 5% spending cuts that I introduce every Congress in order to tackle the deficit and steer our country toward fiscal responsibility. Americans have to balance their budget every year – the federal government should have to do the same.

Americans are financially strained because of Biden's reckless spending policies that have fueled inflation and forced the Fed to raise rates, to the detriment of American families. The American dream should be attainable for Americans once again. We need to restore sound economic policies to Washington so that Tennesseans can receive the economic relief they deserve.



In the charity scams, you'll be asked to give money over the phone. Don't do it. If you want to give, send a check directly to the charity.


In the grandparent scam, a fake grandchild will call and say he's in trouble and needs bail money. No, you'll simply hang up.

Nothing Makes Sense

I was released exactly 6 months to the day I reported to prison. While incarcerated I learned a lot about the man I saw when I looked in the mirror. I had made a commitment to follow Dan Busch's example and never care what men think about me again. The only thing that matters is what God thinks.

I now had the Bible to lean on anytime I encounter tribulation and temptation. I returned to Columbus, got a job building fences, received my back pay for service-connected disability payments now that I left the prison.

I eventually rented a house and joined a church. As I enquired of the beliefs of the Assemblies of God, I decided I would discover their history before committing to any doctrines I may find as unscriptural. I enrolled my daughter in Christian pre-k, and began a life as part of the church community.

I decided to study the history of the Bible and how we got the English King James translation. My journey took me through every empire in the book of Daniel, and I realized so many things church was practicing were not scriptural and bordering on polytheism.

I could not believe how the pastor justified prosperity when half of his congregation was in the military or retired and living just below the poverty line. I realized the only man to get paid for the gospel in the New Testament was Judas.

I searched for a new church home. They all were violating the first commandment. They had married the world system and were accepting tax breaks from the government for being designated as non-profits.

Jesus Christ said render unto Caesar that which is Caesars. Accepting tax breaks will lead to eventual persecution. The state controls which messages are now appropriate in Christian pulpits. There are now ministers serving in the Senate. Jesus Christ separated church and state when he washed his disciples' feet. True Christian leadership!

I began to rely wholly on the words of scripture which ignited my desire to learn biblical Hebrew and Koine Greek. The Holy Spirit ignited a fire in my brain that has been in overdrive for 22 years and counting. I have become a Berean Christian out of Acts 17:11.

I began to reverse engineer the Bible by beginning my study of the book of Revelation. It caused me to study every other book of the bible to understand its contents. Revelation was the only book of the bible I read in prison that promised a blessing for reading it.

Now it was guiding every study I have ever done. I realized that most Christian denominations are antisemitic in their practice. They cling to New Testament only theology, denying 87% of the rest of the Bible. Their religious traditions imported from Babylon, have replaced sound Old Testament mercy.

Here is an abject lesson in double minded thinking JB style. I had been trained as a leader by the 75 th Ranger Regiment. I never quit anything. Somehow, now I was rationalizing leaving the accountability of a Church which was craving Christian leadership. I knew I should stay and continue studying and praying for what God wanted me to do. I got ahead of God.

Relapse was right around the corner. My frustration led me once again to link up with addict friends who were now smoking crack and shooting heroine. I was on supervised release. It was only a matter of time before I tested positive for dope. It came sooner than I expected.

My new probation officer required I go into an inpatient rehabi-

litation program. The next two years of my life would see me enter and complete six programs and relapse within moments of finishing. I also got kicked out of no less than three programs for using in the program.

I was now living in a van my buddy gave me. My wife and daughter had moved to Utah. My only structure of friends were all using dope of some form. I was working to support my addiction and in some sick way, trying to get closer to God by studying the Bible every night in my Van.

I was within a few months of completing probation. Anxiety had me get on methadone as I met the woman I would eventually marry and spend the last 21 years with. She was living in Atlanta and, as long as I stuck to methadone, I could travel to see her.

There are no words to describe my wife. She endured insanity in my life while I fought a war to get off illegal narcotics. I have had old injuries and even newer injuries that were serious enough to be prescribed narcotics.

I had to find the answer in the Bible.

For the weapons we fight with are spiritual not carnal, for the pulling down of strongholds. In the koine Greek tongue, strongholds are the word Pharmakia. It is men who give us narcotics for the control of the mind. If America wanted to win the drug war it could? Drugs make money.

Government exists to sow chaos. Politics require crisis. Politicians manufacture crisis, in order to increase budgets, for the purpose of printing incredible amounts of money, to deal with the crisis they manufactured. The money makes its way to the lobbyists in neighborhoods where it can be laundered. Then taxes are raised to demand we foot the bill for the crisis they manufactured. Our grandchildren and six generations after them could work 100 years each and our national debt would not be paid. Our entire system requires a political elite class of people ordering our footsteps.

My faith is at odds with those who took the Bible and prayer out of public school. Now people who have never read the bible are teaching our children he does not exist. My life had reached the point of no return. Christian insurrection is now my lot, and words are my tool.

He was crucified upon a cross of wood, yet he created the hill upon which it stood.

Revelation Chapter 14



(Rev. 14: 1-5) The 144,000: John saw a Lamb standing on Mt. Zion, along with 144,000 men, each of whom had the names of God and Christ on their foreheads (in contrast to those who had the "mark" of the beast (13:17). A loud voice, together with harpers playing their harps, were singing a "new song" (5:9) before the throne, the four living creatures, and the elders (5:6, 8). The new song was known by none except the 144,000, because it is the song of redemption, the "lyrics" of which melvin Howard rebels know not! These have been "purchased" out of the earth, out of the this-world crowd; they are

the church of Christ (Acts 20:28; 1 Cor. 6:19-20). They are symbolically described as: (a) virgins, never defiled with women, they maintained their purity; (b) followers of the Lamb (their example); (c) having been purchased by the Lamb's blood as a result of their obedience to the gospel plan of salvation (5:9; 12:11; 1 Pet. 1:18, 22). These were the "first fruits," set aside for God (Ex. 23:19; 34:26), and the promise of a harvest to come (Lev. 23:9-14). They spoke the truth, and their lives were upright.

(Rev. 14:6-12) Three angelic messengers: John now sees three angels which, in the symbolism of the text, bring messages to men. The first angel delivers a message regarding the "everlasting gospel" given for the benefit of all people on the earth. It is a message of repentance. God must be reverenced and glorified (in contrast to idols, etc.). The Creator is to be worshipped. (The doctrine of creation---not naturalistic evolution---is a reoccurring biblical theme.)

The second messenger announces the eventual fall of apostate "Babylon"---the past tense suggests the certainty of the event. Babylon pompously proclaims herself as "great." Her influence has been near universal, and highly corrupting.

The third angel with a loud voice warns of the consequences of receiving the "mark of the beast" (see 13:16). This involves giving "worship," religious devotion, to apostate "Christianity." Similarly, those who receive the beast's "mark" upon their foreheads or their hands will be lost. These two expressions probably imply giving mental assent or extending the "right hand of fellowship" (Gal. 2:9) to the false teaching of the system that has abandoned the gospel (1 Tim. 4:1; 2 Tim. 4:1). What follows is possibly the most terrifying illustration of hell in the entire New Testament. The person who dies lost will: (a) drink of the wine of the "wrath" of God; (b) suffer punishment "unmixed" (undiluted) in the cup of his anger; (c) experience "torment" (conscious punishment) with "fire and brimstone" (a figure for exceptional intensity): (d) suffer in the presence of the Lamb and the holy angels, accelerating one's consciousness of just guilt; (e) suffer unending torment (no annihilation). Sadly there are many religious people who are anti-Christ. The bible does not mention (quote: the anti-Christ). 1 John 2:18 "Little children, it is the last time: and as ye have heard that antichrist shall come, even now are there many antichrists; whereby we know that it is the last time." Those who denieth that Jesus is deity (God) come in human flesh are anti-Christ. If Jesus was not God, his blood would be no more effective than the blood of bulls and goats.

Thus, God's people must remain steadfast and determined to be obedient, maintaining "the faith" (fidelity to the gospel system) of Jesus.

(Rev. 14:13) The blessed dead: To the contrary, "blessed (happy, spiritually rewarded) are the dead who die in the Lord." This phrase involves the initial entrance "into Christ" (Jn. 3:5; Acts 2:38; 8:12; 8:35-39; 16:15; 22:16; 16:32-33; 19:1-7; Rom. 6:3-4; Gal. 3:26-27; 1 Pet. 3:20-21) and maintenance of one's integrity to the Savior. Indeed, the 'Spirit says" (clearly the Spirit is a divine person) that they may "rest'

(Mt. 11:28) from their "hard labor," for their "works," their acts of obedience, will accompany them. These are not "works" of human ingenuity or innate merit. They are the equivalent of submission to the divine will. "Works" is not a dirty word in the sacred lexicon. Noah did not earn his salvation, but by God's grace he labored for many, many years. Genesis 6:22 "Thus did Noah; according to all that God commanded him, so did he."

(Rev. 14:14-16) A fourth angel: John saw a vision of one "like unto a son of man." Clearly it is Christ. Daniel 7:13-14 "I saw in the night visions, and, behold, one like the Son of man came with the clouds of heaven, and came to the Ancient of days, and they brought him near before him. And there was given him dominion, and glory, and a kingdom, that all people, nations, and languages, should serve him: his dominion is an everlasting dominion, which shall not pass away, and his kingdom that which shall not be destroyed." He is sitting on a white cloud (Acts 1:9-11), adorned with a golden crown (signifying victory (Mt. 24:31), and holding a sharp sickle. A message comes from "the temple" (from God) through an angel; the hour has come for the harvest, and Christ is so informed. Matthew 24:36-39 "But of that day and hour knoweth no man, no, not the angels of heaven, but my Father only. But as the days of Noe were, so shall also the coming of the Son of man be. For as in the days that were before the flood they were eating and drinking, marrying and giving in marriage, until the day that Noah entered into the ark, And knew not until the flood came, and took them all away; so shall also the coming of the Son of man be." Thus, the reaping of the earth was initiated. Some see this as a primary reference to the gathering of the saints to be with the Lord (1 Thes. 4:15-17).

(Rev. 14:17-20) Two angelic reapers: Now John sees two additional angels coming from the temple-altar (Mt. 13:39). The emphasis now appears to be upon the punishment of the wicked. Earth's "grapes" were "fully ripe," and the time for "gathering" had arrived (Joel 3:13). The grapes therefore were gathered and cast into the "winepress," which signified the "wrath of God" (v. 19; Isa. 63:1-3). (In 19:13 Christ is represented as also taking part in the judgment upon earth's rebels.) The winepress was said to be "outside the city." This likely is a veiled reference to the place where Jesus was crucified (Heb. 13:12; Jn. 19:20); there may be a judicial irony in the fact that in this imagery the punishment is rendered at the site of the crime!

The carnage of the scene taxes even the symbolism of biblical drama. The "blood" of the harvest poured from the winepress and rose up to the height of a horse's bridle, and flowed to some 184 miles distant. Both the depth and distance (significantly beyond Palestine) are obvious figures of speech depicting both the horror and completeness of divine judgment. (Observe that there is no hint in this imagery that there is a thousand-year span between the judgment of the righteous and the wicked, as dispensational premillennialism alleges.)


