Pet Perspective with Ms. Avery Pearl

Hello Dr. Bristol!

Thank you for taking such good care of me and all my furry friends! You and Dr. Spence are just the sweetest vets, ever!

I've had a little talk with Ms Ivory and told her to not be scared when she visits. She promised that she will be an easy patient to care

for, just like me.

Mimi has been concerned about this new virus that seems to be making dogs like us sick. Could you tell everyone what to watch out for? So, that us kids with fur don't get too sick.

Wuff, Ms Avery Pearl

P.S. Ms Ivory didn't like the cold white stuff. I wuffed it and I played in it as long as Mimi and Pappy would allow me, too. Then, I would come in and we would snuggle. I hope you stay warm and safe during all of this stuff, that Mimi calls winter.

Greetings, Ms. Avery Pearl! It was so wonderful to see you last week. You're such an amazing patient... and much tougher than I am when it comes to vaccinations.

While you were in the clinic last week, your Mimi asked us some great questions about the new mystery respiratory illness that has been in the news recently. As you may have heard, the currently unidentified respiratory disease is causing a long-lasting cough that is poorly responsive to antibiotics and cough suppressants.



Historically, we have always treated a lot of respiratory illnesses based on chest x-rays rather than PCR and serology to identify the underlying virus or bacteria due to diagnostic expenses. Thus, we suspect that the current infectious disease may be a previously identified viral infection that has mutated to wreak more havoc on the body.

Additionally, a lot of respiratory illnesses can be cleared by the body naturally; so, when our furry friends present with a cough, the original inciting cause has often already run its course leaving behind secondary inflammation and a chronic cough. At this stage, specific testing will be negative because the underlying infectious organism is no longer in circulation within the body.

Currently, our best recommendations for you and our other canine friends are to minimize your exposure to unfamiliar dogs and to ensure that your four-legged friends are vaccinated for all of the respiratory diseases for which we have effective vaccinations. These respiratory vaccinations include Bordetella, influenza, and parainfluenza. The decision to vaccinate for these diseases has always been based on exposure risk. We always want our pups completely vaccinated for core diseases including distemper, hepatitis, parainfluenza, parvovirus, and rabies. We also recommend additional vaccinations including Leptospirosis, Lyme, Bordetella, and influenza based on exposure.

I'm so glad that you, Mimi, and I got a chance to visit last week, Ms. Avery Pearl, and I can't wait to meet your new friend Ivy soon. We're supposed to have some cold weather this month, so you may have to share some of your warm dresses with her during the next few weeks!

Winter Storm and Cold Snap, January 2024

Beginning Monday January 15th Morgan County and the greater area experienced snow and bitter cold temperatures. Everyone was concerned about power outages after the rolling blackouts we all experienced last year.

The good news is that TVA and Plateau Electric came through with flying colors. On Mon-Michael Nance day morning at about 3:30 am a small section in Wartburg, (which included me), was without power for about an hour and a half. Plateau crews quickly

responded and solved the issue. Below is a picture I took at 4:30 am of the crew working that morning.



TVA also experienced a real stress test of the power grid and there winter preparations as the bitterly cold temperatures extended across the Tennessee Valley.

On 1-17-2024 TVA experienced a peak power demand of 34,526 megawatts at a system average temperature of 4 degrees - setting an alltime TVA record. The previous record was 33,482 MW in Aug. 2007.

On 1-21-2024 TVA experienced a peak power demand of 34,284 megawatts at 9 am ET at a system average temperature of 12°. This was

the highest weekend peak and the second highest all-time peak in TVA history.

TVA met the historic load demands, and all the work TVA and Plateau did to prepare for a winter storm like we just experienced worked. Hopefully we don't see another storm of this caliber this winter, I am ready for summer!



What was impressive was that in the pre-service two teenagers



I know a lot of churches are struggling but not First Baptist Church of Plant City. I know the church in the 2 nd service was not full but from what I was told the 1st service is almost full and I would guess that the sanctuary holds at least 800 to 1,200 people.

I know me seeing one church in Central Florida with this kind of service does not tell you that our nation has returned to God but at least it tells us that all churches are not dying.

Plant City a Town with a Small-Town Atmosphere



Plant City is a town of around 40,000 people and the people who live there would like to keep it that way. With the money that's being offered for the land and property there that might be hard to do.

Plant City is located around 20 miles East of Tampa. It is the winter strawberry capital of the world. It is located right off I-4 that will take you to Orlando and all the way to the East Coast of Florida.

If you stay away from the interstate and drive south and east you will find acres and acres of strawberry fields and other crops.

If you go further to Myakka City, Arcadia, Wauchula you will find small town folks who are trying to keep their small towns from growing larger. In the future its going to get harder and harder to hold onto this land. All the land on the gulf is already taken so the only place people can settle in Florida is inland. When big cooperations or investors come in and offer them big money the land owners feel that maybe its time to retire from farming and take care of this big piece of property. I asked Dawn if she considered the people of Plant City as being really friendly and helpful, she said, "Oh! yes Tommy I really do. These people have come and asked us if there was anything they could do to help out." She said they remind me of folks back in the old days.

Historically Speaking QualPro and Multivariable Testing (MVT) – the amazing application of a Y-12 technology By Ray Smith - Oak Ridge City Historian

In the 47 years I worked at Y-12 which was first the Y-12 Electromagnetic Separation Plant, then the Oak Ridge Y-12 Plant, and later the Y-12 National Security Complex, I saw many changes and were involved in bringing about some of them. One was Foundations of Y-12 Supervision, another Targeted Selection and another the Pride Circle Program. Each of these initiatives were intended to bring about continuous improvement.

The Pride Circles (Productivity through Recognition, Involvement, and Development of Employees) were small groups of employees working together to measure and improve productivity in their own work areas using statistical process control. It was patterned after the Japanese originated Quality Circles.

This was happening at about the same time as Dr. W. Edwards Deming statistical process control was gaining much attention in the United States after he had successfully taught it to the Japanese. I well remember attending one of his seminars in Trenton, New Jersey. He was a unique lecturer who could really make his point.

One of the senior managers from Y-12 was in the same seminar and he asked Dr. Deming a question. I do not recall the exact question, but here is how Dr.

Deming handled it. He said, "What is your name? And your position?" The senior manager answered and stated he was from Y-12 in Oak Ridge, TN. Dr. Deming said, "And you don't know the answer to that question? I am not going to tell you!" He then moved on and I watched as the manager's face got bright red. He did not ask another question.

The thing I also remember is statistical process control was not new to Y-12. Introducing it at the employee level across all portions of the plant was and that is what Pride Circles did. But that was just a small thing compared to what else resulted from the surge in interest and application of statistical process control.

One of the managers at Y-12 at the time was Charles (Chuck) Holland. He was the Quality Manager, and his focus was on assuring the nation's nuclear weapons program would achieve its intended mission. Y- 12 is a vital part of that assurance. It is with pride that Y-12 can claim to never have missed a scheduled shipment of nuclear weapons secondaries during the entire Cold War.

Y-12 was already ahead of most if not all other manufacturing operations in the nation and likely the world. Chuck says of the article linked below: "Here is a recent success story written by the CEO of a QualPro client company. The procedure that he is describing is the same as we were using in A-Wing Machining, H-1 Foundry, and the different assembly areas in 1964." Of course, he is referencing operations at Y-12.

Just what is MVT? Dr. Holland took what he had been implementing at Y-12 for several years and along with the interaction with Dr. Deming took what Y-12 was doing and standardized it through designing experiments in which several variables

were altered all at once. This varied from the more commonly accepted approach of examining only one variable at a time. Unfortunately doing one at a time allowed missing the interaction between multiple variables.

Dr. Holland is quoted in a Forbes magazine article entitled, "The new mantra: MVT" published in 1996, as saying, "If you test factors one at a time there's a very low probability that you're going to hit the right one before everybody gets sick of it and quits."

Further quoting from the Forbes article, "Using the MVT discipline, a factory, a utility, a retail chain, a hospital or almost any kind of organization can experiment with how changes in its processes affect the outcome. By tweaking the inputs, the factory gets a higher yield, or the open-heart surgery department gets a lower mortality rate, or the utility gets a faster collection of its accounts receivables."

The first area of focus for QualPro was major automotive companies and their key suppliers. Soon it was apparent that consulting support was necessary to help the companies use the process improvement tools including MVT.





Babylonian Time vs Jerusalem Time

Is the Garden of Eden, the city of Jerusalem? The garden had many varieties of trees. Yet, only one tree held the knowledge of good and evil. Was the reason, Adam and Eve were told that they could not touch or eat of this tree, a time equation?

Leviticus 25 teaches us about when to plant a sapling, how often the sapling needs pruning, when not to eat the fruit, and when exactly to harvest the fruit of the tree. We are taught that fruit

is to be harvested and shared in the fourth season. What millennium held the key to Christ crucifixion?

Does the Bible identify how old Jesus Christ was during the crucifixion? Jesus Christ is the seed, the vine, the Branch, and was crucified upon the tree of the knowledge of good and evil. Why? Because Jesus Christ is the only man ever born for the purpose of dying upon a tree.

And God said 'Let Light Be!' If there was ever an argument for light being instantaneous, this should qualify. God established light as being the source of life. Find the origin of light, and life becomes real.

The mathematics of creation points to light being instantaneous and, in a vacuum, existing outside of how human time is reckoned. Humans measure time through artificial means. They time how long light waves take to bend around objects. Can God time be measured?

Day one ended with the framing of how God rightly views human time. The evening and the morning were the first day. The Hebrew states the Erev and the Boker.

Erev is evening. It is when darkness makes all things appear indiscernible. Morning was Boker. This is an allusion to light appearing. In God's economy, light always replaces darkness! The Bible Day begins at sunset/moonrise. It lasts 24 hours until the next moonrise.

This is a very important biblical principle to begin understanding that every day in human history appears to occur in the Bible chronology. The entire Bible is written upon the Babylonian Luni-solar calendar of 30 day months, from moon cycle to moon cycle.

The Babylonians under Nimrod, gave us the pagan calendar of 12 months based on the 12 constellations found common to all who view them. The Babylon calendar begins in January, ending in December. The Bible calendar is an agricultural calendar based upon three trees.

The fig tree, The Almond tree, The olive. All three of these fruits can be harvested twice in a single season. The Bible outlines national Israel and the Body of Christ as allegories. Is it a coincidence, the world East of Jerusalem is on a 360 day Luni-solar calendar, and the world West of Jerusalem is on a Solar 365 day calendar? Is it a coincidence that every language East of Jerusalem is written from Right to Left, whilst every language West of Jerusalem is written from Left to Right?

Prophecy in the Bible is about prologue and pattern. God wrote the Bible and the entire timeline of human history in advance. A return to the Bible calendar in dealing with all things God, makes the Bible easy to discern for all those Christ has called.

Western religion has married the world with it's Babylonian pantheon. Believing grace is about God overlooking paganism in Church is both naïve and wanting! Will God forgive preachers for leading their flocks in the mixing of a little bit of baby Jesus with a whole lot of Nimrod?

Revelation Chapter 21

As the previous chapter contained a vision of the great day of judgment, it is entirely fitting that the following section contains a description of the vast blessing that await the victorious people of God.

(Revelation 21:1-8) The new heaven and earth: In this first section, John sees a vision of a "new" heaven and earth. What is this? It is not, as alleged by some, a renovation of this present earthly environment. The term "new" translates Greek term which denotes a newness of quality.

The first heaven and earth, the material universe, have "passed away" (Mt. 24:35; 2 Pet. 3:10-13) and the sea is "no more." The "new heaven" and "new earth" represent a new realm of existence, Heaven itself. These verses are devastating to those who claim that God will renovate the earth and heaven will be on this planet. Jesus drew a clear distinction between heaven and earth (Matthew 6:19-21). "Lay not up for yourselves treasures upon earth, where moth and rust doth corrupt, and where thieves break through and steal: But lay up for yourselves treasures in heaven, where neither moth nor rust doth corrupt, and where thieves do not break through nor steal: For where your treasure is, there will your heart be also."

In a mixture of figures, the victorious church is described as both a "holy city," the "new Jerusalem, and a "bride" (9-10). Elsewhere Jeruslem is depicted as a symbol of heavenly things (Gal. 4:26; Heb. 11:10; 12:22; 13:14). This glorious Jerusalem stands in obvious contrast to corrupt "Babylon" (17:5; 18:2). One writer has said that the message of Revelation as a whole is a "Tale of Two Cities." It also constitutes a contrast between a pure bride and a harlot---the clean versus the corrupt! The church-bride connection is common in the New Testament (Rom. 7:4; 2 Cor. 11:2; Eph. 5:22; Rev. 3:12; 19:7-8). The perfect tense of the verb, "made ready," suggest that the preparation has been completed, and the passive voice gives glory to God for the accomplishment. No one can abide eternally with the Creator who is not "ready."

The heavenly state is one in which God dwells with his people and is their God. Note the "no mores" emphasized in this section. The final state of the redeemed is one in which "all things" have been made "new." Observe that the water of life is a promised gift to those who thirst for it (v. 6), who exercise their will and come (in obedience) seeking it (22:17). Notice that the eternal state will be characterized by the absence of certain wicked ones, whose part shall be in the lake that burns (present tense---continually) with fire and brimstone (a figure for intense suffering). There is eternal retribution for rebels.

(Revelation 21:9-15) The security of the city: This reflects a symbolic description of the heavenly city itself. The community is surrounded by a wall, great and high. This likely emphasizes the fact of security. The gates are ever open, another indication of safety (v.25), and are inscribed with the names of the twelve tribes of Israel, while the foundations have the names of the twelve apostles. These dual "twelve's" perhaps suggest the presence of God's faithful from both the Old and New Testament eras. Here is an important point: the fact that the apostles are only twelve (when actually there were thirteen faithful apostles), illustrates how numbers are symbolically employed in the Apocalypse. Millennialists should learn something from this.

(Revelation 21:16-21) The beauty of the city: The city of God is represented as a huge area with length, breadth, and height---figuratively about fifteen hundred miles in each direction. Coffman has shown that these dimensions could accommodate many times the earth's capacity for dwelling; this is another clue that this heavenly domain is not upon the earth

The cubed dimensions would likely remind the serious student of the holy of holies, the dwelling place of God in the temple (1 Kgs. 6:20). The heavenly city is symbolically portrayed as that of precious metal and stones of unparalleled beauty. As one illustration of this, the term "jasper" likely refers to a diamond. The Greek term rendered "building" (v.18) is found only here in the New Testament. The original word is used by Josephus to signify "that which is built in," inlaid, and so here it may suggest a diamond-studded wall. Fran Pack has well observed that "language breaks down in endeavoring to describe the radiance, the glory, the wealth, the beauty, and the magnificence of this great city."

(Revelation 21:22-27) The sufficiency of the city: Both God and Christ become the divine sanctuary. No "temple" is required; we will worship the Godhead directly. Again, both God and the Lamb provide the light. One can hardly read these passages and not conclude that Christ receives divine glory along with the Father. The cultists (the Jehovah Witnesses) who would rob Jesus of his deity are seriously in error. The international flavor of the heavenly company is indicated. One cannot but think of such prophetic passages as Isaiah 2:2-4 and Jesus' statement that "many" from "the east and the west" would sit with the patriarchs in the kingdom of heaven (Mt. 8:11). Some have suggested that the phrase, "there shall be no night there," contradicts 7:15, which affirms divine service "day and night." There is no conflicts. The idiomatic phrase in 7:15 merely denotes continual service, whereas the language of 21:25 is designed to emphasize the glory of God. Only a crude literalist would see a discrepancy.

We are again reminded that the filthy, abominable, and the untrue are excluded from the heavenly environment. Note that John declares that "anything" that is unclean will be barred from heaven. If infants are born in sin, as many religionists allege, and then die in that state, how could they, as "unclean" beings, be elsewhere but in hell? Yet such a concept violates many biblical truths (Matthew 18:3-4 "And said, Verily I say unto you, Except ye be converted, and become as little children, ye shall not enter into the kingdom of heaven. Whosoever therefore shall humble himself as this little child, the same is greatest in the kingdom of heaven." The Lamb's book of life contains the redemptive record of all for whom he died---of every dispensation (Gal. 4:4-5; Heb. 9:15). How great will be our final reward!
