Hope everyone has a great week and stays warm.



I called them and they sent us up at the center in Tulsa, Oklahoma. They said my wife and I would have four doctors to work with us. The three main ones would be responsible for the physical, mental, and spiritual side, and the fourth would be a counselor. We would be there an entire week.

At the time I was going through the building of a new school on the campus. I found out right away that the Manatee County School System was going to help me in anyway they could. Gene Witt sent an assistant principal out to fill in for me. He told me not to be concerned about a thing at my school. We are here for you. Let me tell you they were. My teachers and staff bent over backward to keep the problems to a minimum: Little problems they

It has been too long for me to remember the doctor's name but I'll have to hand it too him he brought it to us as gentle as he could. The first question was from, Wanda, "How long do I have?" The good doctor said "well that depends."

When we found out what kind of cancer she had we decided to try to find the best treatment that we could find for Wanda. We found out the best nearby was Moffett Cancer Cen-



tried to solve themselves. When I got back from Tulsa there were no school problems for me to solve.

The flight to Tulsa was eventful. Somewhere over Missouri our plane went straight down at a fast speed. I looked at Wanda and asked if she had experienced anything like this. She said, "no but this was really bad." The pilot came on the mic and said, "Sorry folks we just hit some rough weather."

ter around sixty miles north of our home. We also found out that pancreatic cancer was one of the worst and hardest to treat. I didn't want to believe any of the negative things about pancreatic cancer. I just thought every case was different and our Lord could heal her. We would take her all over the country if necessary.

reached Tulsa airport, we found a big car waiting for us. They took us to our room and handed me an agenda of our week. I cannot remember any of the doctors' names but they were all excellent. The spiritual doctor was from Harriman, Tennessee and she became a good friend to us. We met some good people who like us were praying for a miracle.

I called Gene Witt to see if he could get her in a lot faster. It proved not to be a problem and I ended up taking her up there many times. Every time I took her up there, I hated to know from the doctors and nurses how she was doing, not that she was doing okay. I wanted to know if the tumor had decreased in size. One time Wanda got a call from the lab that the tumor had decreased in size by 25%. She came through the house praising the Lord. As time went on everything seemed to be at a standstill. My family and I were not certain that Moffett was doing everything for Wanda that they should or could. That is when Robin, my daughter, came to me with an idea. She said, "Dad I saw this ad on T.V. about Cancer Centers of Ameri-



The wife of one couple we met looked like she was in bad shape. I often wounder about all the people we met. I know that cancer is a killer and when we someone goes to a Cancer Center of America, they are pretty close to the bottom, meaning this could be their last hope. 

Trump picks new IRS Commissioner

President-elect Donald Trump has chosen former Missouri Representative Billy Long to become the new IRS commissioner.

"I am pleased to announce that former Congressman Billy Long, of the Great State of Missouri, will be appointed to serve as the Commissioner of the Internal Revenue Service," Trump said in a Truth Social post. "Billy brings 32 years of experience running his own businesses in real estate and, as one of the premier auctioneers in the country."

Trump also shared in the Truth Social post that since Long left Congress, he has worked as a tax adviser and helped people interpret IRS regulations.

"Taxpayers and the wonderful employees of the IRS will love having Billy at the helm. He is the consummate 'people person,' well respected on both sides of the aisle." Trump said.

Republicans have been in opposition to the Biden administration's vision for the IRS. The Inflation Reduction Act provided \$80 billion in additional funding to the IRS over the next 10 years. The plan included hiring 87,000 IRS employees over the 10-year period. G.O.P. lawmakers have already successfully canceled \$20 billion of the funding.

Danny Werfel was chosen to be the IRS Commissioner by President Biden in March 2023 and has been implementing the IRS expansion and technology changes.

House Ways and Means committee member Kevin Hern (R-Okla) said "a Republican mandate from the people and the voters that we need to rescind as much as possible, and I think that will part be part of this going forward" regarding the Republicans' plan to pass a reconciliation bill.

Since Presidents don't typically select the new Commissioner when they come into office, the Senate will need to confirm Billy Long for him to take over the position immediately after Trump becomes President.

Major tax legislation is expected now that is Trump in office. Without legislative action, Trump's 2017 Tax Cuts and Jobs Act tax changes will expire after 2025. The changes include lower individual income tax rates, higher standard deduction, larger child tax credit, larger lifetime estate and gift tax exemptions, and the Qualified Business Income (QBI) deduction.

Tax changes are a top priority on Trump's legislative agenda.

Trump has proposed abolishing the income tax on Social Security benefits, letting individuals deduct their car interest, use tax incentives and tax credits to promote home ownership, and bring back 100% first-year bonus depreciation and allow more expensing.t

#### Historically Speaking Meet Kenneth D. Nichols, the Father of Oak Ridge: The Manhattan Project Underway, Part 2 By Ray Smith - Oak Ridge City Historian

Barbara Scollin, grandniece of Major General Kenneth D. Nichols continues her series on his life. \*\*\*

Ample reasons, most notably leadership skills, personality traits and qualifications, led to choosing General (then Colonel) Kenneth D. Nichols as Deputy

District Engineer and subsequently as District Engineer of the Manhattan Engineer District (MED). In this capacity he had supervision of the research and development connected with, and the design, construction and operation of all plants required to produce plutonium-239 and uranium-235, including the construction of the towns of Oak Ridge, Tennessee, and Richland, Washington.

The responsibility of his position was massive as he oversaw a workforce of both military and civilian personnel of approximately 125,000; his Oak Ridge office became the center of the wartime atomic energy's activities. He also was responsible for internal security operations in the production facilities that helped keep the development of the atomic bomb secret.

In this eighth installment of several articles covering the life and accomplishments of Kenneth D. Nichols, we learn of command restructuring in the Manhattan Project.

Early in September 1942, General Styer requested Lt Colonel Nichols meet with him and bring Colonel Groves. Styer relayed certain concerns of Dr. Vannevar Bush, informed them of President Roosevelt's approval for a new Manhattan Project setup (including changing Colonel Groves' duties), and ordered completion of a higher priority rating for the project from AA-3 to AA-1 (aka AAA).

Groves, when informed he would be the Officer in Charge of the entire Manhattan Project, was not pleased, but Nichols recalls, "Despite his initial unhappiness with the assignment, once Groves fully took over the reins of the project, on September 23, 1942, I never again heard him voice a single word of regret. Once in charge, he quickly moved to assume de facto control not only of construction but also control of all research and development, operation of the plants, development of the bomb and the military aspects of the projection."

Marshall said, "I was told by Styer that Groves would handle the end down... [in Washington D.C.] and do whatever is necessary. ... I had written orders designating me District Engineer of the Manhattan District to report directly to the Chief of Engineers. That was the written orders, and the secret orders or verbal orders, was to do whatever this S-1 committee [wanted] – get the money for them, and see where we are going to build these plants and so forth... "

For the next 10 months Nichols worked for two bosses – Marshall (in New York) and Groves (in Washington D.C.). His time was stretched thin. Marthey didn't need me - that Nichols could relieve me...

Nichols explains the segregation of duties: "The way it finally was settled after Marshall left was that I was the District Engineer and would have full responsibility, considering the way Groves operated, for the design, construction and operation of all the plants and for all the project except for Intelligence, overseas work, the training for the bomb delivery, and Los Alamos. I had administrative responsibility for Los

Alamos, but not technical."

It was now clear to Nichols that he would not be going into combat duty. He said, "My own advancement, while indeed welcomed, ended for all practical purposes my hopes for an overseas assignment as a combat engineer. By this time, however, I realized the importance, urgency, and challenge of my work, so I did not mind giving up my dream of commanding engineers in combat."

Colonel Nichols recalls the routing of reports to inform those further up the chain of command including the President, "The [MED] District made a narrative report once a month... addressed to [Brig] General Groves, but before delivering it to General Groves, I would visit either General [Thomas M.] Reybold [Chief of Engineers] or General [Eugene] Robins, let them read the report and explain what we were doing. In ... no case I recall did General Robins or General Reybold ever try to revoke a procedure that we were following. Occasionally, they would give us good advice on some particular problem that we had, but they considered that General Groves was running this project and that they would not interfere.

"However, we got on many occasions good advice and offers of assistance through some part of the Chief's office... we recognized that the Chief's office had a vast wealth of knowledge and experience that could help us.

"... every six months, I would assist Groves in writing a report... to the President, and [Groves] would have frequent meetings with the Policy Committee for various other authorities that he needed. Then [he would] pass to me [what] was done verbally at a meeting... Because of secrecy, we had nothing between Oak Ridge and Washington flowing in the line of letters.

"I did not see how it would be possible to cover in writing all the informal decisions that were made at the numerous meetings involved. Formal procedures would be time-consuming for both of us and definitely would slow the work.

"Between General Groves and [I], there was never any written directive except in one case. You see, I always helped him prepare the letters to the President and I would keep a copy of them in my safe. I knew what authority he had, what had been approved. The understanding was as long as I was working within those limits, why, he was aware of what was going on, that was it.

"I had the same relationship with my Area Engineers and subordinates that they would give the

them and did an excellent job of it. He left after a year ... it was Marshall that got... the bulk of the people for the Manhattan Project."

By July 20, 1943, Dr. Vannevar Bush had initiated Marshall's reassignment. Nichols recalled that Bush's main objections to Marshall were: he hadn't stayed in Washington D.C.; he was not high-ranking enough; and, he had not purchased the Oak Ridge site soon enough. Marshall was promoted to Brigadier General and eventually designated Assistant Chief of Staff of the US Army Services of Supply in the Southwest

Pacific area. Marshall's Manhattan Project duties and Manhattan Engineer District duties were split between Groves and Nichols.

Nichols was tasked by General Styers to inform Groves of his promotion to Brigadier General. With his first star, Brig General Groves was put in charge of the Manhattan Project as Commanding General. Groves acted as an Assistant Chief of Engineers reporting directly to Chief of Staff, General George C.



shall recalls, "Immediately, I got Nichols... to accompany me practically every time I went over to these S-1 committees or went over to deal with Bush. "So gradually, Nichols and I together got the word across to Vannevar Bush and Conant and all the Nobel Prize people over there on these committees that this was a big engineering job ...

"I left more and more of the Washington work to Nichols, who being a PhD and a very bright fellow and more personable than I ever was, got along with the scientists."

Nichols and Marshall recall their secret journal,

Nichols: "We [Groves & amp; Nichols] coordinated our efforts by telephone, short meetings and by entries in the project diary that Marshall had started the day Styer appointed him district engineer."

Marshall: "I started a secret journal ... and the only ones that had access to that time... was Colonel [Robert] Blair, the Chief Engineer, ...Nichols who was my Deputy District Engineer, and my secretary Ms. [Virginia] Olsson."

Eventually Marshall strategically decided to

Marshall, to the Military Policy Committee and to the Secretary of War, Mr. Henry Stimson. (Groves never was part of the Manhattan Engineer District.)

Nichols explains, "Initially... we didn't know what authority we had. We didn't worry. ... '43 or '44 [when] actually signing the DuPont contract ... was the first time that we formalized ... the authority [Brig] General Groves had and the authority [I had as] the District Engineer ... General Groves' authorities were quite extensive. In fact, I believe that in certain aspects they were greater than the Chief of Engineers' [Lt Gen Eugene Reybold]. [General Groves' authority] derived directly from Mr. Stimson, Secretary of War...in effect, the Secretary of War delegated practically all of his war powers to General Groves in so far as it pertained to the Manhattan Project. ... Much of that authority was in turn delegated to me as District Engineer."


Marshall and Groves ensured Nichols was promoted to full Colonel; Nichols was designated District Engineer, entirely responsible for the Manhattan Engineer District. Nichols reported directly to Groves on all matters instead of to the Chief of Engineers. necessary approval that would be required of a contractor-like approving a drawing. ... We figured that we would get on the job the best man and therefore you would not be approving his work. The only thing you were doing was coordinating it with some other activity."

In summary: Leadership on full display.



### **The Achaemenid Empire**

Nebuchadnezzar would rule Babylon for 43 years from 605 BC until his son Amel-Marduk would become heir in 562 BC. He is most famous for releasing King Jeconiah of Judah after 43 years in confinement. He would be assassinated in 560 BC by his brother-in-law Nereglissar.

He was of Aramean descent and he became a prominent official during the reign of Nebuchadnezzar. His reign would last for 4 years until his death in 556 BC. He is most fa-

mous for his campaign to capture the kingdom of Appuwashu in Anatolia and bringing the Babylonian pantheon into the west.

His son would reign for two months before being assassinated by Nabonidus. He is the Bible king Belshazzar who would be the last Neo-Babylonian king during the time of Daniel. Cyrus the great would enter Babylon, ending the Neo-Assyrian line of kings in Babel.

Cyrus would enter Babylon as Belshazzar mocked the God of creation and his plans for the people of Daniel. Cyrus dammed the Euphrates River and his men entered Babylon without a battle and unseated Nabonidus who himself usurped the Babylonian throne.

Cyrus begins the prophesied reign of the Medo-Persian empire destined to replace Babylon while adopting the Babylonian pantheon and mixing it with the Persian religion centered in astronomy and science. Egypt, Assyria, Babylon and Persian religions were melded first under Cyrus the great.

Cyrus proves God is indeed ordering our footsteps as men. We first hear of Cyrus in the book of Isaiah who prophesied the reign of Cyrus in Chapter 45:1. Thus saith the Lord to his anointed, to Cyrus, whose right hand I have holden, to subdue nations before him, and I will loose the loins of kings, to open before him the two leafed gates, and the gates shall not be shut.

Isaiah prophesied the events occurring in the book of Daniel, when Cyrus entered the palace to find Nabopollasser, mocking the God of Daniel. Daniel opens the scroll of Isaiah, penned 200 years prior, to read to him what God has ordained for his life.

The mighty Medo-Persian empire begins with the overthrow of Babylon, and the introduction to the Zoroastrian beliefs of Cyrus. It is a form of monotheism. The Achaemenid dynasty now ruled over the largest empire in history. The year is 550 BC.

Cyrus would issue the decree found in the book of Ezra, allowing him to return to Jerusalem to begin the rebuilding of the temple. Cyrus would fund his journey, and he would issue decrees guaranteeing their protection. Jeremiah's prophecy of the 70-year captivity was coming to a close.

Daniel would serve Cyrus faithfully. I believe Nabopollaserr's mother possibly played a role. Cyrus executed the last Babylonian king, establishing control of Babylon under his Medo-Persian line. To save her skin, she would advise the king on matters of history dealing with Daniel.

Daniel had been carried away by Nebuchadnezzar in 605 BC. His destiny and the destiny of the wife of Nebuchadnezzar were intertwined. She alone understood that Daniel heard from the living God of creation. Her and Daniel had known each other since 605 BC.

Cyrus entered Babylon in 539 BC during the Hebrew feast of tabernacles. It was October 12th on the Pagan Babylonian calendar. 

### Luke Chapter 13

(Luke 13:1-5) The murderous Pilate: An unsettling report came to Jesus concerning Pilate, the sixth Roman procurator of Judaea (A.D. 26-36; see 3:1). He had slaughtered a number of Galilean Jews who had come to Jerusalem to offer sacrifices, which bloody deed apparently created a rift between the governor and Herod Antipas, ruler of Galilee (23:12). While this incident is unrecorded in secular history, it is perfectly consistent with the character of this ruler as revealed in contemporary literature.

The Lord addressed the commonly held idea that those who suffer the most obviously are the most evil (the same philosophy of Job's friends). Was it the case, then, that these slaughtered Galileans were more evil than others? The answer was, "No." He then alludes to a natural tragedy. A tower near the Pool of Siloam had fallen and eighteen people were killed. Did this horrible accident logically lead to the conclusion that these victims were more corrupt than others? It did not. Here is the lesson to be learned: when tragedy comes, many will be unprepared unless they repent (a change of heart manifested by a reformation of life). Repentance is not the only condition of salvation, but it is the one being emphasized on this occasion. It stands for the entire process of reconciliation with God.

The warning contained a subtle prophecy as well. Forty years later, at the destruction of Jerusalem, thousands of Jews were killed by the Romans as they worshipped in the temple, offering their sacrifices (having rejected the true sacrifice for sin). In addition, multitudes were crushed as the Roman armies battered down the city walls. Those who do not learn from the mistakes of history are destined to repeat them---and suffer the consequences.

(Luke 13:6-9) The parable of the fruitless fig tree: The foregoing narrative hinted of the coming destruction of the Jewish nation. The parable that follows provides the reason for that judgment---fruitlessness! A man planted a fig tree. Some background is important here. Under Hebrew law, the fruit of the tree was not consumed for the first three years (Lev. 19:23). When it came time for the first harvest, the man came to the tree looking for fruit, but it had none, though every possible advantage had been supplied (v.8). Two more years of fruitlessness followed. After six years of nothingness, it was judged to be hopelessly barren.

The man who planted the tree represents God, the tree was the Hebrew nation, and their barrenness reflected their lack of response to the training and advantages Jehovah had been providing them over the centuries since the selection of the nation for its redemptive role. Not only were they generally not productive, they "cumbered the ground"---in the sense they did everything imaginable to frustrate the growth of Christianity during that period from A.D. 30 to 70 (as demonstrated in the book of Acts). Finally, ever since the destruction of national Judaism by the Roman invasion, the Hebrew "tree" has not sprouted again. And it never will!

(Luke 13:10-17) The deformed woman: Jesus was teaching in one of the local synagogues on the Sabbath when he observed a pitiful woman who was horribly disfigured, bent far over and unable to straighten up. She had been afflicted in this fashion for eighteen years. It was not a passing psychosomatic ailment. The Lord called to her and, in anticipation of what he was about to do, said, "Woman, you are loosed from your infirmity" (v. 12; the present tense emphasizing the certainty of the miracle). He laid his hands upon her and immediately she was made straight; she gave glory to God. The passive form of the verb indicates the force of the recovery was from beyond the woman herself.

Incredibly, the synagogue ruler was furious because the miracle had been performed on the Sabbath. Since a miracle could only be accomplished by the power of God, this was an action of the Creator himself. The Lord blasted the ruler and those nearby who were murmuring their agreement with the critic. "You hypocrites, any one of you will loose his ox or donkey on the Sabbath and lead it to water. And yet you deny this woman the right of being "loosed" from her illness on the Sabbath." The conclusion obviously was: "You elevate dumb animals above one created in the image of God!" Moreover, she was a "daughter of Abraham," which intensified the point. Christ's argument took the common from-the-lesser-to-the-greater form, a valid use of logic. The woman is described as having "been bound of Satan" (v. 16). Commentators generally connect this back to verse eleven and the phrase "spirit of infirmity," concluding that the woman had been demon-possessed, the debilitation being the effect. If that was the case, it seems the demon had left the woman earlier, for Luke mentions no casting out of a spirit. As

a general proposition, all human ailments are ultimately traceable to Satan who, by his original temptation, has murdered the human family (Jn. 8:44) and left us with a lot of collateral damage.

The Lord's adversaries were "put to shame," and the crowd rejoiced for the things done by him (v.17).

(Luke 13:18-21) The mustard seed and the leaven (read Mt. 13:31-33; Mk. 4:30-32).

(Luke 13:22-30) Will few be saved?: As the Lord traveled through various cities en route to Jerusalem, someone raised a serious question (echoed by many today): "Will only a few be saved?" The Savior's response was indirect, but packed with objective propositions: (a) Entering heaven will not be easy in view of man's usual self-centered disposition. Especially would it be hard for many Jews who refused to identify Jesus as their Messiah. (b) It will involve striving (Greek "agony") because the door is "narrow." Sacrifices will be required and many will not be able---due to their own self-limitation-to enter (2 Peter 3:9). (c) Opportunities will be chronologically limited. There will be no postmortem plan of salvation. Pleading with the Lord after the "door is shut" will not avail (2 Cor. 6:2). (d) Past association will not prevail in the absence of present preparedness (v. 26). (e) The Savior's judgment will be final. (f) There will be conscious suffering for the wicked. (g) The Gentiles will be offered an opportunity to be in the kingdom (v.29). (h) Whereas the Jews had enjoyed a first-place prominence as the nation through whom the Messiah came, they would be placed last, with the Gentiles exalted above them.


(Luke 13:31-35) The rabid fox: It is difficult to assess the motive of those Pharisees who warned Jesus that Herod Antipas wanted to kill him; hence, he must leave the area. Some maintain these were sincere men who feared for Jesus' life. Others, speculating that Jesus was in Herod's territory and that he would be slow to act negatively against the Lord, speculate this was a plan to goad him nearer to Jerusalem and the deadly Sanhedrin. It is a fact that this rebel beheaded John the Baptist and, if left to his own devices, might well commit murder again.

With a cryptic and courageous message, Jesus responded: "Go and say to that fox [that weak and wily varmint---not a compliment], 'Look, today and tomorrow [the remaining portion of my ministry], I continue to work signs. The third day I am perfected [brought to completion]" (v.32). The "third day" most likely is a reference to his triumphant resurrection. He must make his way on toward Jerusalem, for it is the city that relishes the blood of the prophets! Note the lament: "O Jerusalem, Jerusalem." Someone has aptly said: "The fox was after the chicks, but Christ was the Hen guarding them." Unfortunately, they kept leaving their source of protection. Note the acknowledgement of free will: "You would not!"

Thus, their "house" (probably the entire city, including the temple) was therefore to be "left desolate." They were responsible for the "leaving," and "desolation" would be the city's fate (Mt. 24:15). The Lord then stated they would not see him again until they said: "Blessed is he who comes in the name of the Lord" (v.35). They would rise up to "see" him at the time of his Second Coming (Rom. 14:11), but then it would be too late to remedy their stubborn unbelief. Millennialists contend that the text refers to the national conversion of the Jews just prior to the alleged millennial reign. Such a view is the epitome of exceptical irresponsibility. How could anyone reflect upon the personal pronouns "you" and "your" in the text and conclude that it refers to a people thousands of years later? The Second Coming, which concludes earth's history, fits both the context and the universal reality of that event.
