MORGAN, COUNTY Tenn. – Morgan County voters can continue to utilize the convenience of the early voting period to cast a ballot for the Nov. 5 State and Federal General Election.

"During early voting, Morgan County residents have the convenience and flexibility of evening and Saturday hours", says Tim Sweat the Morgan Administrator of Elections. "I encourage voters to take advantage of this early voting opportunity and cast their ballot."

Early voting runs through Thursday, Oct. 31. Morgan County residents can find hours, and polling locations and view sample ballots on MorganElections.com. or the Secretary of State's website <u>GoVoteTN.gov</u> and the <u>GoVoteTN app</u> is free in the App Store or Google Play.

"We want all eligible Tennessee voters to cast a ballot during the early voting period," said Secretary of State Tre Hargett. "Tennessee and our nation are stronger when every eligible voter participates. Head to the polls now and make your voice be heard."

Morgan County voters need to bring valid photo identification to the polls. A driver's license or photo ID issued by the Tennessee Department of Safety and Homeland Security, Tennessee state government, or the federal government is acceptable even if expired. A student ID or out-of-state driver's license is not acceptable. For more information about what types of IDs are permitted, visit **GoVoteTN.gov**.



### In the Path of Hurricane Milton

As I sit here in my daughter's and son-in-law's home, I have the TV on, warning all citizens in Florida about a hurricane named Milton with a CAT-5 storm. In the Tampa Bay region, it is predicted that the storm is expected to have eight to twelve feet surges which has never happened before.

We just had a hurricane two weeks ago and the clean-up hasn't beencompleted. The Tampa

Bay area was damaged by the storm surge of 6.5 feet. This hurricane could be the worst to ever hit Florida in recordedhistory. As a matter-of-fact it was in 1921; over a hundred years ago when Tampa had a direct hit from a hurricane.

They are warning the people who are in low lying areas: here they are called zones A, B, and C with A being the lowest. There is a mandatory evacuation for the people who live in those zones. They estimate that over 1.5 million will have to leave their homes.

We are now at Scott and Dawn's house near Plant City. Dawn is still working at Chick-fil-a and Scott is helping us get settled. Others in our family are on their way here. They live in Sarasota and their house is closer to the ocean. When hurricane Debbie came through the street in front of their house was like a river. Boys were paddling boats down the street.

The news we have now tells us that Milton has slowed down and will not make land-fall until about 2:00 am, Thursday morning. The storm surges will be ten to fifteen feet around Bradenton and Sarasota.

I really hate to see the destruction this monstruous hurricane will leave us. Helene was bad enough but this one will be like none we have seen in over a hundred years. In 1921 the last hurricane to hit Tampa (directly); none of us were here. But this area called Tampa Bay, has grown so much in the last 102 years that Bradenton, Sarasota, St. Petersburg, Clearwater, Plant City, Lakeland, and many smaller towns and cities have increased this area so much that they have doubled the population many times over. They now have professional teams in football (Buccaneers), baseball (Rayes), hockey (lighting), and recently have gotten pro soccer. New roads and streets have been built in all these counties since traffic has increased three-fold or more in the last twenty years. It is unbelievable and this is when both hurricanes Helene and Milton is hitting at the moment.

I am writing this on Wednesday, October 9 th, in Plant City, Florida and the wind and rain has increased greatly. The hurricane is still a stage 4 but will be a 3 when it hits shore somewhere in the Tampa Bay area. It looks like it will be around a little south of Sarasota. I have grandchildren who have chosen to stay in their homes in the areas that Milton will hit. We have kept in touch with them by phone. It is now 4:12 PM, Wednesday, October 9th and although things are looking bad it is nothing like it will be tonight and Thursday morning.

At 4:45 PM Governor DeSantis has just given his last announcement of preparation and told people to stay off the streets and roads. It is too late to get out of the area where the storm is predicted to affect which is large and will get larger before it makes landfall. It looks like most of Florida will get a little of Milton. I have been in Florida off and on for fifty-three-years and I have never experienced a hurricane here in the Tampa Bay area.

Back to our great Governor DeSantis, he has to be the best leader in the U.S. He has stayed awake ever since the power of these latest two hurricanes were announced. I have never seen a leader that loves his people as much as this man does. When he appeared on TV it looks like he can barely keep his eyes open. He had dedicated his life to this state. Here at 7:50 pm, Wednesday the governor is giving another update on Hurricane Milton.

Landfall, 8:00 pm, Wednesday night – Hurricane Milton has hit between Sarasota and Venice. We will not know how much damage as been done until the storm is over. I'm hoping and praying for the best. We know this was a stage 3 hurricane when it came ashore and it was predicted it would be a stage 2 when it reached Orlando and a stage 1 when it reached the East Coast.

The governor has announced a total of 19 tornadoes have touched down in Florida. No word of damage was reported. Wind speed of storm is 115 mph as the storm wall moves on shore rain will exceed 16' in places.

12:00 pm, Thursday, October 10 th – It was a rough night for a lot of people, not only in West, Central Florida and even the West Coast. There are no deaths reported at this time. The total number of houses without power is over three million. Manatee and Sarasota counties were had the most homes without power. One of the major problems all over the areas was downed trees over roadways and some fell on houses. I am thankful to report that all my children and grandchildren endured the hurricane without death or injury. My daughter's house's roof and fence were damaged but we hope to go back tomorrow. My grandson's roof was seriously damaged and some of the interior will have to be replaced. I would say we were lucky. Tornadoes broke out in Central Florida and East Florida and killed several people. St. Lucia in the East Coast reported five deaths from tornadoes.

If there's one thing that I have learned from this horrific storm it is

that they know how to build homes and schools that can survive hurricane forced winds. My son's home that we stayed in, in Plant City was hit by



strong state 2 or 3 winds between 85 and 110 mph and escaped damage. Their store was also undamaged.

It has now been confirmed that at least twenty-one deaths have been reported. I'm pretty sure this total will rise. I thank the governor and officials in every county did a great job which kept fatalities down.

I have tried to keep the folks back home abreast of the happenings here in Florida. I haven't got to travel around yet but I think I have done an accurate job of reporting.

A couple of things I failed to tell you about was that Tropicana Field lost most of its roof. That is where the Tampa Bay Rays play baseball and

special events are held. Also, a crane blew over unto the streets of St. Petersburg. No one was injured in either accident but I feel sorry for St. Pete because of the damage these two storms did to that city.

Aftermath – I feel that many of you up there in paradise have tuned in to follow hurricanes Helen and Milton.

First of all, I am thankful that all my children and grandchildren are safe and their homes are repairable. I have seen the damage done on our drive from Plant City to Bradenton and it will take a long time to get back to the way it looked when I returned. The beaches are in terrible shape, especially on Bradenton Beach. This is not a good time to visit Central Florida.


The folks who live by or close to rivers are still in danger, especially along Hillsborough River. The best thing that happened during the storm if there is a best thing is that the ten to fifteen feet surges that were predicted did not come about but the winds did the damage as expected.

The tornadoes that hit Central Florida came in great numbers and many of them were on the East Coast. Several deaths can be contributed to these killer tornadoes. People who weathered theses storms said they were not like Florida tornadoes of the past but they looked more like the one's from Oklahoma.

I am now in Bradenton watching ballgames on TV. I just wish I was able to go out with churches to help people who were not as lucky as my children were. My heart goes out for these people. Some didn't have insurance and some just came to Florida and lost everything.

Someone in Tennessee asked me how they could help these people. I said I guess give to the Red Cross and pray for all of these people who were hurt by these two hurricanes in Florida, North Carolina, South Carolina, Georgia, and East Tennessee.





#### IRS penalty relief

The IRS can impose significant penalties if you fail to file or pay your taxes on time. If the IRS claims the failure to file is fraudulent, the late filing penalty can be as high as 75 percent. However, the penalties can often be forgiven by the IRS if you know the rules for having them removed.

The IRS can impose penalties for failure to file, failure to pay, and failure to deposit employment taxes, but all of them can be abated.

The IRS offers first-time abatement of penalties if you have a good tax compliance history.

Relief is available for anyone who didn't receive any penalties for the same type of tax return in the three previous years. You can still qualify if penalties were removed during that period, so long as they were for anything other than first-time abatement.

First-time abatement can be achieved by simply calling the IRS and requesting it. The IRS will look at your history for the three previous years to determine if you are eligible. You can also retrieve transcripts for the last three years online to decide whether you qualify before making the call. Be sure to write the IRS employee's name, badge number, and the time and date of the call anytime you speak with the IRS.

If you don't qualify for first-time abatement, you may meet the requirements for reasonable cause relief. However, you will need to provide a valid reason.

There are many reasons for qualifying for reasonable cause relief, including:

Inability to obtain records needed to file the return Death or serious illness of an immediate family member Fire, casualty, and natural disaster

When claiming reasonable cause relief, you must provide a detailed explanation of the events, the dates, how you were impacted, and how you complied with the law. Provide as much information and documentation as possible to make a compelling case. If you are in a region officially designated as a disaster area, please include that information.


Claiming that you forgot, made a mistake, or were unaware of the law is not considered a valid reason for reasonable cause. Additionally, blaming your tax preparer for failure to file or pay does not justify reasonable cause relief.

You can request a refund using Form 843 if you already paid the penalty. The request for a refund must be made within three years from the filing date or two years from the penalty payment date.

If you are denied abatement of penalty the IRS will send you a letter explaining how it can be appealed. Don't be afraid of filing an appeal; there is nothing frightening about the process. An appeals purpose is to offer a fair and unbiased review of your case. If you believe you have a valid reason, you should consider submitting an appeal to have your case reassessed. The appeal process is usually conducted through an informal phone conference. Appeals Officers tend to be quite easy to work with.

Requesting a first-time abatement of penalties is relatively simple. To effectively pursue a reasonable cause abatement, it's beneficial to research your specific case type. If the penalty is large, you might consider seeking help from a tax expert to resolve the issue.

#### Historically Speaking Meet Kenneth D. Nichols, the Father of Oak Ridge Manhattan

Barbara Scollin, grandniece of Major General Kenneth D. Nichols continues her series on his life.

\*\*\*

Ample reasons, most notably leadership skills, personality traits and qualifications, led to choosing General (then Colonel) Kenneth D. Nichols as Deputy District Engineer and subsequently as District Engineer of the Manhattan Engineer District (MED). In this capacity he had supervision of the research and development connected with, and the design, construction and operation of all plants required to produce plutonium-239 and uranium-235, including the construction of the towns of Oak Ridge, Tennessee, and Richland, Washington.

The responsibility of his position was massive as he oversaw a workforce of both military and civilian personnel of approximately 125,000; his Oak Ridge office became the center of the wartime atomic energy's activities. He also was responsible for internal security operations in the production facilities that helped keep the development of the atomic bomb secret.

In this fifth installment of several articles covering the life and accomplishments of Kenneth D. Nichols, we learn of his early work with General (then Colonel) James C. Marshall, the S-1 Committee, and the Manhattan Engineer District that reflects his unique leadership skills in a quickly changing environment.

1939 found Captain Kenneth D. Nichols looking forward to commanding combat engineer troops as soon as war broke out. But Colonel James C. Marshall intervened. Marshall had been one of Nick's West Point instructors and Marshall "thought greatly of him".

As District Engineer in charge of most military construction in New York state and Pennsylvania, Marshall requested Nichols handle all construction for the new Rome, NY, Air Depot, a military airport servicing the Air Corps. Promised no interference from Marshall, full authority, choice of personnel and a \$25 million budget (~\$550M in 2024), Nick agreed. It would be his first construction assignment and the first time other officers were reporting to him.

As Area Engineer and (just promoted to) Lieutenant Colonel, Nichols started 'from scratch' acquiring the land, determining design and hiring construction contractors. Politics entered the picture too. He remembers, "We had to get along with the town and newspapers. In other words, you had the problem of meeting all the objections of people and handling the Congressmen that wanted to investigate it."

Soon, Marshall expanded Nichols' responsibilities, "... later when after the war started the district got the [construction of a new TNT plant, the] Pennsylvania Ordnance Works [in White Deer Creek Valley in Northern Pennsylvania] and Marshall wanted me on it. He said 'You take over the Pennsylvania Ordnance Works, also handle the Rome Air Depot, and eventually I will try to get somebody for the Rome Air Depot because it's well on its way, and you start the Pennsylvania Ordnance Works. You started one project, and here's another one you start from scratch'. ... I was running both, commuting back and forth."

Nichols was promoted to Major in October 1941. Already working quickly to build the air depot when war was declared by America in December 1941, he was told to "expedite it". Si-

multaneously Colonel Leslie Groves came back into the picture. Nick recalls, "I'll always remember a piece of advice he gave me. He said, 'Now remember, on this one [the TNT ordnance work] the designs are complete.' In other words, ...if you have people that know what the hell they're doing, don't interfere with them. But again, you had to handle all the problems."

Supervising construction and procurement of materials, Nichols worked with Groves as well

as Stone and Webster (construction contractors) and DuPont (designers). This team was critical in the upcoming Manhattan Project.

In less than three months, Marshall contacted Nichols yet again. The rapid chain of events follows: President Franklin D. Roosevelt approved Dr. Vannevar Bush and Dr. James B. Conant's report of recommendations to the Policy Committee on June 17, 1942. (The Policy Committee members were Vice President Wallace, Secretary of War Stimson and Army Chief of Staff General George C. Marshall.)

Colonel Marshall met June 18th with Major General Styer, Deputy to General Somerville, head of the Army Service Forces. At the meeting Colonel Marshall received the Bush/Conant report containing the conclusion that the Army should take over responsibility of construction of facilities to produce uranium and plutonium for atomic weapons.

Colonel Marshall then contacted Nichols on June 19 th, and they met shortly thereafter and said, "I've just been assigned a new technical project. It's very, very important. It'd be a development project that may end the war... Nick, I am giving you fifteen seconds to volunteer for a very important technical project, or be drafted... With volunteering settled, Marshall handed me a large envelope that contained most of the top secret information he knew about the new project."

Soon Nichols recalls, "Marshall and I met at the Office of Scientific Research and Development (OSRD) with the S-1 executive committee, Vannevar Bush and General Styer. After listening to members of this distinguished committee (three of them were Nobel Laureates) outline the status and scope of the proposed atomic development program – and the significance of winning or losing the race with Germany – I quickly realized that working with these men on such an important project was a unique opportunity. I had volunteered properly."

Nichols describes the reasons behind the selection of Marshall and, in turn, Marshall selecting him: "The Chief of Engineers selected Colonel Marshall to direct the construction intended to make the bomb a reality because of his fine reputation and his previous construction experience, which included a good track record for starting projects. As he had demonstrated to me in beginning the Rome Air Depot and then Pennsylvania Ordnance Works, Marshall was a

great organizer who delegated both authority and responsibility well. He also was an astute judge of personnel. He would have to summon these skills promptly, since he did not have the luxury of time or the facts available to plan the entire operation before

beginning the construction phase. This is where matters stood when he brought me into the picture."

And, "The reason he selected me I think was because I had a Ph.D. and he talked Styer into the idea that he needed somebody with my background, with a technical background, to handle the scientists. And Styer agreed that for one year I would be available. In other words, you have to find out from the scientists what the hell they wanted – thought they wanted – to build. We knew that the job was to translate their desires to an architect engineer and engineering outfit to design and construct the plants... Another officer would

not have had [the status a Ph.D. gave]. Some [military officers] get along fine even though they don't have a Ph.D., but many officers tangle with them. Scientists are difficult people to work with."

Marshall and Nichols worked together on the BIG issues for what would be named the Manhattan Project:

- Funding;
- Administration;
- Prioritization of work;
- Procuring materials from around the world;
- Visiting sites vetted by the S-1 committee for production plants; and,
- Locating headquarters in New York City (hence the name 'Manhattan').

They chose Stone & Dichols had worked with them in New York. Bush and Styer laid all the groundwork to obtain AAA priority. (Colonel Groves completed obtaining authority.) Nichols recalls, "When we first got into the business, the scientists thought they were all ready to go. We found they were not. We engaged Stone and Webster to make an initial engineering study, to where we have an engineering force to appraise some of these ideas. We soon found there was nothing ready to go. That although the report to the President [FDR] was, we were ready to build plants, [in reality] we were still some ways away from it."

Of particular interest to Oak Ridgers – Marshall, Nichols and Colonel Blair spent 3 days in Tennessee, July 1 – 3, 1942, accompanied by TVA's Colonel Parker and Stone & Description of the Elza site of 26,000 acres and chose it as the best site for production needs. The S-1 committee approved their choice on July 30, 1942. Marshall named the new area Oak Ridge. (This comes from Colonel James C. #### **Historically Speaking** Meet Kenneth D. Nichols, the Father of Oak Ridge Manhattan

On July 6 th they met with Dr. Arthur Compton at the Metallurgical Lab at the University of Chicago. Nichols saw the overcrowding there; on his own initiative he established a new experimental site in the Argonne Forest (Argonne National Laboratory).

Marshall presented Groves, acting in concert with the Chief of Engineers, a general order draft dated August 11, 1942, that formed a new district they decided to call the Manhattan Engineering District (MED). Marshall was the 1st, Virginia Olsson, his secretary, the 2 nd, and Nichols the 3 rd government employee to sign on to the MED.

The Chief of Engineers issued Order No. 33 on August 13, 1942, establishing the military district without territorial limits to supervise projects assigned to it by the Chief of Engineers. The MED was tasked with quickly building four production plants to separate uranium and produce plutonium. Marshall served as the original District Engineer with Nichols as Deputy District

Engineer, forming a lifelong friendship.

As indicated in the organizational chart, the MED was quite organized by early 1943 thanks to Marshall and Nichols.

# Becoming the Qof, Psalm 119 Vs. 145-152

Vs. 145 I cried with my whole heart, Oh Lord: I will keep thy statutes.

Vs. 146 I cried unto thee; save me, and I shall keep your testimonies.

Vs. 147 I prevented the dawning of the morning, and cried; I hoped in thy word.

Vs. 148 Mine eyes prevent the night watches, that I might meditate in thy word.

Vs. 149 Hear thy voice according to thy lovingkindness; Oh Lord, quicken me according to thy judgements.

Vs. 150 They draw nigh that follow after mischief; they are far from thy law.

Vs. 151 Thou art near Oh Lord, and all thy commandments are truth. Vs. 152 Concerning thy testimonies, I have known of old. That thou hast founded them forever.

Today we encounter the Hebrew letter Qoph {pronounced, cough}. It is the 19th letter of the Hebrew alphabet with a numerical value of 100. It translates as the nap of the neck.

It is a paradoxical letter that is understood as an eye of a needle. In ancient Jerusalem, shepherds were required to bring sheep through the narrow gate defined as the eastern gate or shepherds' gate. It has been walled shut until now! Is the return of Yeshua to claim his bride imminent?

Jesus Christ used the alliteration of being easier for a camel to go through the eye of a needle than for a rich man to inherit Christ's coming kingdom. For the camel to fit in the narrow gate, on the narrow path, the shepherds first had to unload all of its burdens.

King David has given us an amazing view of the mind of God through the Hebrew alphabet, 22 characters, 8 verses in each scripture subset. Each verse beginning and ending with the Qoph. The Qoph is equivalent to the English letter q.

How many of you can find 16 different words beginning and ending with the letter Q? I cannot, but Daniel under the anointing of the Holy Spirit has done this for us. All as a lesson in how God views the importance of his two-edged sword we call the Bible.

## Luke Chapter 2

(Luke 2:1-7) The birth of Jesus: Luke explains how Jesus' birth happened to occur in Bethlehem (Mic. 5:2), instead of Nazareth. Augustus Caesar (31 B.C. 14) issued a taxation decree obligating citizens of the empire (called "the world") to enroll. This is identified as occurring when Quirinius was governor of Syria (v. 1-2). Critics have charged Luke with an error, but various possible solutions have nullified the allegation. Sir William Ramsay, after years of investigation, declared that Luke was "unsurpassed" in his "trustworthiness." This first-century his-

torian certainly had access to better information than today's self-described "scholars."

Joseph and Mary thus begin the trip "up" from Galilee to Judaea (note the elevational accuracy). It is rather amazing, in view of Mary's condition ("great with child"), that she accompanied Joseph on a seventy-mile or so journey from Nazareth to Bethlehem (either by walking or by donkey). While she was obligated to pay taxes, she was not required to go in person. She doubtless knew, however, that prophecy must be fulfilled (Mic. 5:2). While in Bethlehem, Mary delivered her "firstborn" (Mt 12:46-50). Since there was no room for them at an inn, they took refuge in a stable. Justin Martyr (A.D. 150) claimed it was a cave. Many still have "no room" in their lives for the Savior. Again, we must remind ourselves how compelling it is that a medical doctor endorsed the idea that this "virgin" gave birth to a child. Only the most compelling evidence could justify that conclusion.

(Luke 2:8-20) The Bethlehem shepherds: Somewhere near Bethlehem, the city of David, shepherds were watching their flocks. Out of the darkness of night, an angel appeared, surrounded by the light of divine glory. They were terrified, but the angel instructed them to "stop being afraid," for he was bringing them "good tidings" (the basis of our word "gospel"). A child has been born in the village; he is the "Messiah," the "Savior," and our "Lord" (v. 11)---three powerful thoughts! The shepherds were instructed how to find and identify the child. It would be a unique situation.

Suddenly, a heavenly chorus breaks forth in praise. Three magnificent ideas are expressed: (a) God is to glorified for the gift of his Son. (b) Peace will come as a result of the mission of this person. (c) The peace is available only to those "in whom he is well pleased." The peace is conditional. No universal salvation here. Peace, objectively considered, is being in harmony with God (Rom. 5:1); subjectively viewed, it is an inner tranquility (Phil. 4:7). The shepherds were determined to see this child; hence, they made their way into the village and found the manger. They then spoke of this matter to others (v.17). This is evangelism. Those who heard this report were astounded.

Mary treasured all these things in her heart and thought deeply about them. A thousand questions must have flooded her mind. The shepherds returned to their flocks (which may have been awaiting sacrifice in the temple), praising God (to him) and glorifying him (to others) for the things they had seen and heard.

(Luke 2:21-40) The journey to the temple: Jesus was always obedient to the law of Moses, and that training started when he was eight days old. All male Jews were administered the rite of circumcision when they were eight days of age. This was a parental obligation extending back to the time of Abraham. Joseph and Mary started Christ's life of service in right way. It was at this time the Savior was formally given his name, "Jesus." This signified he was the one to fulfill the entire thrust of God's promise to Abraham (v. 21).

Perhaps at this point a word should be said regarding the rite of circumcision, since critics of the Bible frequently mention this practice as an indictment of the sacred volume. Consider the following facts: (a) "Circumcision" translates the Greek word, peritome, "to cut around." It has to do with the surgical removal of the loose skin (prepuce) of the male sexual organ. (b) The procedure was not unique to the Hebrews; the ancient Egyptians practiced it (Herodotus 2:37), as did other nations. (c) Among the Hebrews, it was designated as a sign in the flesh reflecting their covenant relationship with Jehovah (Gen. 17:11). (d) It also may have been intended to symbolize Israel's need for sexual purity and the abstention from pagan worship, since heathenism was often intertwined with immoral sexual activity.

The Mosaic law demanded a thirty-three-day period of ceremonial "purification" following the circumcision (Lev. 12:3-4). A sacrifice was then required at the temple. Joseph and Mary's sacrifice, two birds, revealed their lack of prosperity (Lev. 12:8). Note that the expressions "law of Moses" and "law of the Lord" are used interchangeable (v. 22-23). This nullifies the modern sabbatarian quibble that while the law of Moses was abrogated, the law of the Lord (containing the Sabbath) was not. The distinction is false.

In the temple they encountered a devout and righteous man whose name was Simeon. This man was a serious student of the Scriptures, hence, had been looking for the "consolation of Israel," the fulfillment of the messianic hope. Previously, he had been granted a revelation from the Spirit that he would not die until he had seen the Lord's Messiah. By the guidance of the Spirit, he had entered the outer region of the temple (probably the court

of women); the timing was divinely orchestrated! Simeon met the holy couple, took the baby in his arms, and thanked God.

In a brief hymn of praise, Simeon declares: (a) He is ready to die now that he has seen him in whom the key to salvation resided. His death will be peaceful indeed. (b) This divine period of preparation ultimately had in mind "all the people"; even the Gentiles would be illuminated. (c) This child was the "glory of Israel." How tragic that so many of them rejected him (Jn. 1:11).

Joseph and Mary were amazed at the things spoken concerning Jesus. The incredible truths to which they earlier had been exposed had not been fully absorbed. Can any of us even yet fully appreciate them? Simeon prayed for them and gave Mary an ominous word of caution---the first clue of the tragedy to come. Her Son would be a separating influence in Israel; some would rise, others fall. And a "sword" would eventually pierce through Mary's soul (v. 35). An accelerating hatred culminating in the rage of crucifixion was in the future. Jesus would be the cause of bringing to light the condition of many hearts---revealing the good in contrast to the bad. After their obligations to the law were fulfilled, Joseph and Mary went to Nazareth in Galilee. The Child grew and became strong in all dimensions. He was filled with wisdom and the Lord's favor was constantly with him.

Another interesting person is introduced---Anna, of the tribe of Asher. Some of the northern kingdom had returned from Assyrian captivity. She was a devout woman who was continually in the temple. She had been a widow for eighty-four years but was far from useless. She is described as a "prophetess." In describing the temple, Josephus (War of the Jews 5.5.2) says: [T]here was a partition built for the women" that separated them from the men; this was "the proper place wherein they were to worship." She obviously ministered to Hebrew women. She worshipped with prayers and fasting day and night. She came upon the scene and thanked God for his Son. She spoke about Jesus to those who were looking for the 'redemption" of Jerusalem. They were looking for political deliverance; the Messiah would provide the opportunity for spiritual deliverance (v. 36-38).

(Luke 2:41-52) In the temple with the doctors: Being devout servants of the Lord, it was Joseph and Mary's practice to attend the Passover feast every year. Jesus was now twelve years old and they all went up to the holy city together. After the seven days of festival (Ex. 13:6), Joseph and Mary began the three-day trek home, assuming Jesus was somewhere in the caravan. At the end of the first day's travel, they searched for their son but could not locate him. Hence, they returned to Jerusalem, "seeking for him." The Greek participle indicates a sustained, fretful search (v. 45). Finally, they found him in the temple compound, sitting among the teachers, listening to them and asking questions. Moreover, he was amazing those who assessed his "understanding" and the "answers" he supplied to questions.

When his parents came upon the scene, they were both "astonished" and grieved. Mary issued a rebuke: "Child, why have you treated us like this? Your father and I have been searching for you, sorrowing" (v. 48). "Sorrowing" is an expression of great pain. Jesus responded (his first recorded words) with respect, but perhaps with a boy's lack of appreciation for a mother's anxiety: "Why were you searching for me?"---as if to suggest, did you not realize where I would be? "Did you not know that I must be in my Father's house?" Note" (a) He anticipated that by this time his true nature should have been understood. In spite of previous revelations, the full force of his mission had not been perceived. (b) He operated under a divine compulsion---that imperative "must." (c) The expression "my" father reveals a unique relationship enjoyed by none other upon the earth.

But they simply did not understand the full thrust of his response (v. 50). They all returned home and Christ was an obedient son. Mary continued to hold these thoughts in her heart, doubtless pondering them many a night. In the meantime, Jesus matured: in wisdom (intellectually), in statue (physically), in favor with God (spiritually), and with men (socially). It may be wondered how a perfect person can grow in favor with God. As his capacity for the spiritual increased, his favor with the Lord did so as well. God's expanding appreciation is an example of anthropopathism, where the Lord accommodates himself to the human level to make an important point.

Verse fifty-one and fifty-two summarize the next eighteen years of Jesus' life. No strictly human writer would have bypassed these years; but inspired authors were constrained by the Holy Spirit in restriction their material to areas of redemptive interest. This is a subtle evidence of diving inspiration.
